

A bill for an act
relating to appropriations; appropriating money for transportation, Metropolitan
Council, and public safety activities; providing for fund transfers, general
contingent accounts, and tort claims; providing for various fees and accounts;
amending Minnesota Statutes 2010, sections 168A.29, subdivision 1; 171.06,
subdivision 2; Laws 2008, chapter 363, article 11, sections 6; 9.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
