The bill was read for the first time and referred to the Committee on Transportation Policy and Finance

1.1 A bill for an act
1.2 relating to transportation; crediting surcharge on vehicle parking violations to
1.3 highway user tax distribution fund; amending Minnesota Statutes 2014, section
1.4 357.021, subdivision 7.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2014, section 357.021, subdivision 7, is amended to read:

1.7 Subd. 7. **Disbursement of surcharges by commissioner of management and**
1.8 **budget.** (a) Except as provided in paragraphs (b), (c), ~~and (d)~~, and (e), the commissioner
1.9 of management and budget shall disburse surcharges received under subdivision 6 and
1.10 section 97A.065, subdivision 2, as follows:

1.11 (1) one percent ~~shall~~ must be credited to the peace officer training account in the
1.12 game and fish fund to provide peace officer training for employees of the Department of
1.13 Natural Resources who are licensed under sections 626.84 to 626.863, and who possess
1.14 peace officer authority for the purpose of enforcing game and fish laws;

1.15 (2) 39 percent ~~shall~~ must be credited to the peace officers training account in the
1.16 special revenue fund; and

1.17 (3) 60 percent ~~shall~~ must be credited to the general fund.

1.18 (b) The commissioner of management and budget shall credit \$3 of each surcharge
1.19 received under subdivision 6 and section 97A.065, subdivision 2, except for the \$12
1.20 parking surcharge, to the general fund.

1.21 (c) In addition to any amounts credited under paragraph (a), the commissioner of
1.22 management and budget shall credit \$47 of each surcharge received under subdivision 6
1.23 and section 97A.065, subdivision 2, ~~and the \$12 parking surcharge,~~ to the general fund.

2.1 (d) If the Ramsey County Board of Commissioners authorizes imposition of the
2.2 additional \$1 surcharge provided for in subdivision 6, paragraph (a), the court administrator
2.3 in the Second Judicial District shall transmit the surcharge to the commissioner of
2.4 management and budget. The \$1 special surcharge is deposited in a Ramsey County
2.5 surcharge account in the special revenue fund and amounts in the account are appropriated
2.6 to the trial courts for the administration of the petty misdemeanor diversion program
2.7 operated by the Second Judicial District Ramsey County Violations Bureau.

2.8 (e) The commissioner of management and budget shall credit the \$12 parking
2.9 surcharge to the highway user tax distribution fund.

2.10 **EFFECTIVE DATE.** This section is effective July 1, 2015, and applies to
2.11 surcharges on parking violations committed on and after that date.
