1.26 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

1.27 **ARTICLE 1**

1.28 **MINNESOTA STADIUM AUTHORITY**

1.29 Section 1. Minnesota Statutes 2010, section 3.971, subdivision 6, is amended to read:

1.30 Subd. 6. **Financial audits.** The legislative auditor shall audit the financial

1.31 statements of the state of Minnesota required by section 16A.50 and, as resources permit,

1.32 shall audit Minnesota State Colleges and Universities, the University of Minnesota, state

2.1 agencies, departments, boards, commissions, courts, and other state organizations subject
2.2 to audit by the legislative auditor, including the State Agricultural Society, Agricultural
2.3 Utilization Research Institute, Enterprise Minnesota, Inc., Minnesota Historical
2.4 Society, Labor Interpretive Center, Minnesota Partnership for Action Against Tobacco,
2.5 Metropolitan Sports Facilities Commission, Minnesota Stadium Authority, Metropolitan
2.6 Airports Commission, and Metropolitan Mosquito Control District. Financial audits
2.7 must be conducted according to generally accepted government auditing standards. The
2.8 legislative auditor shall see that all provisions of law respecting the appropriate and
2.9 economic use of public funds are complied with and may, as part of a financial audit or
2.10 separately, investigate allegations of noncompliance.

2.12 to read:

2.13 Subd. 4. **Minnesota Stadium Authority.** Upon the audit of the financial accounts
2.14 and affairs of the Minnesota Stadium Authority, the authority is liable to the state for the
2.15 total cost and expenses of the audit, including the salaries paid to the examiners while
2.16 actually engaged in making the examination. The legislative auditor may bill the authority
2.17 either monthly or at the completion of the audit. All collections received for the audits
2.18 must be deposited in the general fund.

2.19 Sec. 3. Minnesota Statutes 2011 Supplement, section 10A.01, subdivision 35, is
2.20 amended to read:

2.21 Subd. 35. **Public official.** "Public official" means any:

2.22 (1) member of the legislature;

3.32 **Sec. 4. [16A.726] FOOTBALL STADIUM GRANTS; APPROPRIATIONS.**

3.33 (a) If state appropriation bonds have not been issued under section 16A.965, amounts
 3.34 not to exceed the increased revenues estimated by the commissioner of management and
 3.35 budget under section 297E.021, subdivision 2, are appropriated from the general fund to

4.1 the commissioner of management and budget to make grants to the Minnesota Stadium
 4.2 Authority for stadium costs as defined under section 473J.03, subdivision 8.

4.3 (b) The commissioner shall make grants to the Minnesota Stadium Authority
 4.4 required to make the state payments under section 473J.13, subdivisions 2 and 4, and
 4.5 for the amount of Minneapolis taxes withheld under section 297A.994, subdivision 4,
 4.6 paragraph (a), clause (5). Amounts sufficient to make the grants are appropriated to the
 4.7 commissioner from the general fund.

4.8 Sec. 5. Minnesota Statutes 2010, section 297A.71, is amended by adding a subdivision
 4.9 to read:

4.10 Subd. 43. **Building materials; football stadium.** Materials and supplies used or
 4.11 consumed in, and equipment incorporated into, the construction or improvement of the
 4.12 football stadium and stadium infrastructure as defined in section 473J.03, subdivisions 7
 4.13 and 9, are exempt. This subdivision expires one year after the date that the first National
 4.14 Football League game is played in the stadium for materials, supplies, and equipment used
 4.15 in the construction and equipping of the stadium, and five years after the issuance of
 4.16 the first bonds under article 2 for materials, supplies, and equipment used in the public
 4.17 infrastructure.

4.18 **EFFECTIVE DATE.** This section is effective the day following final enactment.

 4.20 amended to read:

4.21 Subdivision 1. **Cities.** (a) A city may issue an on-sale intoxicating liquor license to
 4.22 the following establishments located within its jurisdiction:

4.23 (1) hotels;

4.24 (2) restaurants;

4.25 (3) bowling centers;

4.26 (4) clubs or congressionally chartered veterans organizations with the approval of
 4.27 the commissioner, provided that the organization has been in existence for at least three
 4.28 years and liquor sales will only be to members and bona fide guests, except that a club
 4.29 may permit the general public to participate in a wine tasting conducted at the club under
 4.30 section 340A.419;

4.31 (5) sports facilities, restaurants, clubs, or bars located on land owned or leased by
 4.32 the Minnesota Stadium Authority;

5.2 (b) A city may issue an on-sale intoxicating liquor license, an on-sale wine license,
5.3 or an on-sale malt liquor license to a theater within the city, notwithstanding any law, local
5.4 ordinance, or charter provision. A license issued under this paragraph authorizes sales on
5.5 all days of the week to persons attending events at the theater.

5.6 (c) A city may issue an on-sale intoxicating liquor license, an on-sale wine license,
5.7 or an on-sale malt liquor license to a convention center within the city, notwithstanding
5.8 any law, local ordinance, or charter provision. A license issued under this paragraph
5.9 authorizes sales on all days of the week to persons attending events at the convention
5.10 center. This paragraph does not apply to convention centers located in the seven-county
5.11 metropolitan area.

5.12 (d) A city may issue an on-sale wine license and an on-sale malt liquor license to
5.13 a person who is the owner of a summer collegiate league baseball team, or to a person
5.14 holding a concessions or management contract with the owner, for beverage sales at a
5.15 ballpark or stadium located within the city for the purposes of summer collegiate league
5.16 baseball games at the ballpark or stadium, notwithstanding any law, local ordinance, or
5.17 charter provision. A license issued under this paragraph authorizes sales on all days of the
5.18 week to persons attending baseball games at the ballpark or stadium.

5.19 Sec. 7. Minnesota Statutes 2010, section 352.01, subdivision 2a, is amended to read:

5.20 Subd. 2a. **Included employees.** (a) "State employee" includes:

5.21 (1) employees of the Minnesota Historical Society;

5.22 (2) employees of the State Horticultural Society;

5.23 (3) employees of the Minnesota Crop Improvement Association;

5.24 (4) employees of the adjutant general whose salaries are paid from federal funds and
5.25 who are not covered by any federal civilian employees retirement system;

5.26 (5) employees of the Minnesota State Colleges and Universities who are employed
5.27 under the university or college activities program;

5.28 (6) currently contributing employees covered by the system who are temporarily
5.29 employed by the legislature during a legislative session or any currently contributing
5.30 employee employed for any special service as defined in subdivision 2b, clause (8);

5.31 (7) employees of the legislature who are appointed without a limit on the duration
5.32 of their employment and persons employed or designated by the legislature or by a
5.33 legislative committee or commission or other competent authority to conduct a special

6.2 performing the duties of the classified position for which they will be eligible to receive

6.6 Operating Division of the former Metropolitan Transit Commission and who are employed
6.7 by the labor organization which is the exclusive bargaining agent representing employees
6.8 of the Transit Operating Division;

6.9 (11) employees of the Metropolitan Council, Metropolitan Parks and Open Space
6.10 Commission, Metropolitan Sports Facilities Commission, or Metropolitan Mosquito
6.11 Control Commission unless excluded under subdivision 2b or are covered by another
6.12 public pension fund or plan under section 473.415, subdivision 3;

6.22 in the Insurance Fraud Prevention Division under section 45.0135 who have attained the
6.23 mandatory retirement age specified in section 43A.34, subdivision 4;

6.24 (16) employees of the University of Minnesota unless excluded under subdivision
6.25 2b, clause (3);

6.26 (17) employees of the Middle Management Association whose employment began
6.27 after July 1, 2007, and to whom section 352.029 does not apply; ~~and~~

6.28 (18) employees of the Minnesota Government Engineers Council to whom section
6.29 352.029 does not apply; and

6.30 (19) employees of the Minnesota Stadium Authority.

6.31 (b) Employees specified in paragraph (a), clause (13), are included employees under
6.32 paragraph (a) if employer and employee contributions are made in a timely manner in the
6.33 amounts required by section 352.04. Employee contributions must be deducted from
6.34 salary. Employer contributions are the sole obligation of the employer assuming operation
6.35 of the University of Minnesota heating plant facilities or any successor organizations to
6.36 that employer.

7.1 Sec. 8. **[473J.01] PURPOSE.**

7.2 The purpose of this chapter is to provide for the construction, financing, and
7.3 long-term use of a stadium and related stadium infrastructure as a venue for professional
7.4 football and a broad range of other civic, community, athletic, educational, cultural,
7.5 and commercial activities. The legislature finds and declares that the expenditure of
7.6 public money for this purpose is necessary and serves a public purpose, and that property
7.7 acquired by the Minnesota Stadium Authority for the construction of the stadium and
7.8 related stadium infrastructure is acquired for a public use or public purpose under chapter
7.9 117. The legislature further finds and declares that any provision in a lease or use
7.10 agreement with a professional football team that requires the team to play all of its home
7.11 games in a publicly funded stadium for the duration of the lease or use agreement, with the
7.12 occasional exception of a game played elsewhere as set forth in such agreement, serves
7.13 a unique public purpose for which the remedies of specific performance and injunctive
7.14 relief are essential to its enforcement. The legislature further finds and declares that
7.15 government assistance to facilitate the presence of professional football provides to the
7.16 state of Minnesota and its citizens highly valued intangible benefits that are virtually
7.17 impossible to quantify and, therefore, not recoverable even if the government receives
7.18 monetary damages in the event of a team's breach of contract. Minnesota courts are,
7.19 therefore, charged with protecting those benefits through the use of specific performance
7.20 and injunctive relief as provided in this chapter and in the lease and use agreements.

7.21 Sec. 9. **[473J.03] DEFINITIONS.**

7.22 Subdivision 1. **Application.** For the purposes of this chapter, the terms defined in
7.23 this section have the meanings given them, except as otherwise expressly provided or
7.24 indicated by the context.

7.25 Subd. 2. **Adjustment factor.** "Adjustment factor" means for any year the increase,
7.26 if any, in the amounts of the city of Minneapolis taxes, imposed under a special law
7.27 originally enacted in 1986, that are received by the commissioner of revenue in the
7.28 preceding year over the amount received in the year prior to the preceding year, expressed
7.29 as a percentage of the amount received in the year prior to the preceding year; provided,
7.30 that the adjustment factor for any year must not be less than zero percent nor more than
7.31 five percent.

7.32 Subd. 3. **Authority.** "Authority" means the Minnesota Stadium Authority
7.33 established under section 473J.07.

7.34 Subd. 4. **City.** "City" means the city of Minneapolis.

7.35 Subd. 5. **NFL.** The "NFL" means the National Football League.

8.1 Subd. 6. **NFL team.** "NFL team" means the owner and operator of the NFL
8.2 professional football team known, as of the effective date of this chapter, as the Minnesota
8.3 Vikings or any team owned and operated by someone who purchases or otherwise takes
8.4 ownership or control of or reconstitutes the NFL team known as the Minnesota Vikings.

8.5 Subd. 7. **Stadium.** "Stadium" means the stadium suitable for professional football
8.6 to be designed, constructed, and financed under this chapter. A stadium must have a roof
8.7 that covers the stadium, as set forth in section 473J.11, subdivision 3.

8.8 Subd. 8. **Stadium costs.** "Stadium costs" means the costs of acquiring land, the
8.9 costs of stadium infrastructure, and of designing, constructing, equipping, and financing a
8.10 stadium suitable for professional football.

8.11 Subd. 9. **Stadium infrastructure.** "Stadium infrastructure" means plazas, parking
8.12 structures, rights of way, connectors, skyways and tunnels, and other such property,
8.13 facilities, and improvements, owned by the authority or determined by the authority to
8.14 facilitate the use and development of the stadium.

8.15 Subd. 10. **Stadium site.** "Stadium site" means all or portions of the current site of
8.16 the existing football stadium and adjacent areas, bounded generally by Park and Eleventh
8.17 Avenues and Third and Sixth Streets in the city of Minneapolis, the definitive boundaries
8.18 of which shall be determined by the authority and agreed to by the NFL team.

8.19 **Sec. 10. [473J.07] MINNESOTA STADIUM AUTHORITY.**

8.20 Subdivision 1. **Established.** The Minnesota Stadium Authority is established as a
8.21 public body, corporate and politic, and political subdivision of the state. The authority is
8.22 not a joint powers entity or an agency or instrumentality of the city.

8.23 Subd. 2. **Membership.** (a) The authority shall consist of five members.

8.24 (b) The chair and two members shall be appointed by the governor. One member
8.25 appointed by the governor shall serve until December 31 of the third year following
8.26 appointment and one member shall serve until December 31 of the fourth year following
8.27 appointment. Thereafter, members appointed by the governor shall serve four-year terms,
8.28 beginning January 1. Each member serves until a successor is appointed and takes office.
8.29 The chair serves at the pleasure of the governor. Appointments under this paragraph are
8.30 subject to the advice and consent of the senate. Senate confirmation shall be as provided
8.31 by section 15.066.

8.32 (c) The mayor of the city shall appoint two members to the authority. One member
8.33 appointed by the mayor of the city shall serve until December 31 of the third year
8.34 following appointment and one member shall serve until December 31 of the fourth year
8.35 following appointment. Thereafter, members appointed under this paragraph shall serve

9.1 four-year terms beginning January 1. Each member serves until a successor is appointed
9.2 and takes office. Members appointed under this paragraph may reside within the city and
9.3 may be appointed officials of a political subdivision.

9.4 (d) The initial members of the authority must be appointed not later than 30 days
9.5 after the date of enactment of this chapter.

9.6 Subd. 3. **Compensation.** The authority may compensate its members, other than the
9.7 chair, as provided in section 15.0575. The chair shall receive, unless otherwise provided
9.8 by other law, a salary in an amount fixed by the authority, and shall be reimbursed for
9.9 reasonable expenses to the same extent as a member.

9.10 Subd. 4. **Chair.** The chair presides at all meetings of the authority, if present, and
9.11 performs all other assigned duties and functions. The authority may appoint from among
9.12 its members a vice-chair to act for the chair during the temporary absence or disability of
9.13 the chair, and any other officers the authority determines are necessary or convenient.

9.14 Subd. 5. **Removal.** A member, other than the chair, may be removed by the
9.15 appointing authority only for misfeasance, malfeasance, or nonfeasance in office, upon
9.16 written charges, and after an opportunity to be heard in defense of the charges.

9.17 Subd. 6. **Bylaws.** The authority shall adopt bylaws to establish rules of procedure,
9.18 the powers and duties of its officers, and other matters relating to the governance of the
9.19 authority and the exercise of its powers. Except as provided in this section, the bylaws
9.20 adopted under this subdivision must be similar in form and substance to bylaws adopted
9.21 by the Minnesota Ballpark Authority pursuant to section 473.755.

9.22 Subd. 7. **Audit.** The legislative auditor shall audit the books and accounts of the
9.23 authority once each year or as often as the legislative auditor's funds and personnel permit.
9.24 The authority shall pay the total cost of the audit pursuant to section 3.9741.

9.25 Subd. 8. **Executive director; employees.** The authority may appoint an executive
9.26 director to serve as the chief executive officer of the authority. The executive director
9.27 serves at the pleasure of the authority and receives compensation as determined by the
9.28 authority. The executive director may be responsible for the operation, management, and
9.29 promotion of activities of the authority, as prescribed by the authority. The executive
9.30 director has the powers necessarily incident to the performance of duties required and
9.31 powers granted by the authority, but does not have authority to incur liability or make
9.32 expenditures on behalf of the authority without general or specific directions by the
9.33 authority, as shown by the bylaws or minutes of a meeting of the authority. The executive
9.34 director is responsible for hiring, supervision, and dismissal of all other employees of
9.35 the authority.

10.1 Subd. 9. **Web site.** The authority shall establish a Web site for purposes of providing
10.2 information to the public concerning all actions taken by the authority. At a minimum, the
10.3 Web site must contain a current version of the authority's bylaws, notices of upcoming
10.4 meetings, minutes of the authority's meetings, and contact telephone, electronic mail, and
10.5 facsimile numbers for public comments.

10.6 Subd. 10. **Quorum; approvals.** Any three members shall constitute a quorum for
10.7 the conduct of business and action may be taken upon the vote of a majority of members
10.8 present at a meeting duly called and held. During the design and construction stages of the
10.9 stadium, a four-fifths vote of the authority is required for authority decisions related to
10.10 zoning, land use, exterior design of the stadium, related parking, the plaza area, and the
10.11 selection of the authority's lead representative during design and construction.

10.12 Sec. 11. **[473J.08] LOCATION.**

10.13 The stadium to be constructed under this chapter shall be located at the stadium
10.14 site in the city of Minneapolis.

10.15 Sec. 12. **[473J.09] POWERS, DUTIES OF THE AUTHORITY.**

10.16 Subdivision 1. **Actions.** The authority may sue and be sued. The authority is a public
10.17 body and the stadium and stadium infrastructure are public improvements within the
10.18 meaning of chapter 562. The authority is a municipality within the meaning of chapter 466.

10.19 Subd. 2. **Acquisition of property.** The authority may acquire from any public or
10.20 private entity by lease, purchase, gift, or devise all necessary right, title, and interest in
10.21 and to real property, air rights, and personal property deemed necessary to the purposes
10.22 contemplated by this chapter. The authority may acquire, by the exercise of condemnation
10.23 powers under chapter 117, land, other real property, air rights, personal property, and other
10.24 right, title, and interest in property, within the stadium site and stadium infrastructure.

10.25 Subd. 3. **Disposition of property.** The authority may sell, lease, or otherwise
10.26 dispose of any real or personal property acquired by the authority that is no longer required
10.27 for accomplishment of the authority's purposes. The property may be sold in accordance
10.28 with the procedures provided by section 469.065, except subdivisions 6 and 7, to the
10.29 extent the authority deems it to be practical and consistent with this chapter. Title to the
10.30 stadium must not be transferred or sold by the authority prior to the effective date of
10.31 enactment of any legislation approving such transfer or sale.

10.32 Subd. 4. **Data practices; open meetings.** Except as otherwise provided in this
10.33 chapter, the authority is subject to chapters 13 and 13D.

11.1 Subd. 5. **Facility operation.** The authority may develop, construct, equip, improve,
11.2 own, operate, manage, maintain, finance, and control the stadium, stadium infrastructure,
11.3 and related facilities constructed or acquired under this chapter, or may delegate such
11.4 duties through an agreement, subject to the rights and obligations transferred to and
11.5 assumed by the authority, the NFL team, other user, third-party manager, or program
11.6 manager, under the terms of a lease, use agreement, or development agreement.

11.7 Subd. 6. **Employees; contracts for services.** The authority may employ persons
11.8 and contract for services necessary to carry out its functions, including the utilization of
11.9 employees and consultants retained by other governmental entities. The authority shall
11.10 enter into an agreement with the city regarding traffic control for the stadium.

11.11 Subd. 7. **Gifts, grants, loans.** The authority may accept monetary contributions,
11.12 property, services, and grants or loans of money or other property from the United States,
11.13 the state, any subdivision of the state, any agency of those entities, or any person for any
11.14 of its purposes, and may enter into any agreement required in connection with the gifts,
11.15 grants, or loans. The authority shall hold, use, and dispose of the money, property, or
11.16 services according to the terms of the monetary contributions, grant, loan, or agreement.

11.17 Subd. 8. **Use agreements.** The authority may lease, license, or enter into use
11.18 agreements and may fix, alter, charge, and collect rents, fees, and charges for the use,
11.19 occupation, and availability of part or all of any premises, property, or facilities under
11.20 its ownership, operation, or control for purposes that will provide athletic, educational,
11.21 cultural, commercial, or other entertainment, instruction, or activity for the citizens of
11.22 Minnesota and visitors. The use agreements may provide that the other contracting party
11.23 has exclusive use of the premises at the times agreed upon, as well as the right to retain
11.24 some or all revenues from ticket sales, suite licenses, concessions, advertising, naming
11.25 rights, NFL team designated broadcast/media, club seats, signage, and other revenues
11.26 derived from the stadium. The lease or use agreement with an NFL team must provide for
11.27 the payment by the NFL team of an agreed-upon portion of operating and maintenance
11.28 costs and expenses and provide other terms in which the authority and NFL team agree. In
11.29 no case may a lease or use agreement permit smoking in the stadium.

11.30 Subd. 9. **Research.** The authority may conduct research studies and programs;
11.31 collect and analyze data; prepare reports, maps, charts, and tables; and conduct all
11.32 necessary hearings and investigations in connection with its functions.

11.33 Subd. 10. **Insurance.** The authority may require any employee to obtain and file
11.34 with the authority an individual bond or fidelity insurance policy. The authority may
11.35 procure insurance in the amounts the authority considers necessary against liability of the
11.36 authority or its officers and employees for personal injury or death and property damage or

12.1 destruction, consistent with chapter 466, and against risks of damage to or destruction of
12.2 any of its facilities, equipment, or other property.

12.3 Subd. 11. **Exemption from Metropolitan Council review; Business Subsidy Act.**

12.4 The acquisition and betterment of a stadium and stadium infrastructure by the authority
12.5 must be conducted pursuant to this chapter and are not subject to sections 473.165 and
12.6 473.173. Section 116J.994 does not apply to any transactions of the authority or other
12.7 governmental entity related to the stadium or stadium infrastructure or to any tenant or
12.8 other users of the stadium or stadium infrastructure.

12.9 Subd. 12. **Incidental powers.** In addition to the powers expressly granted in this
12.10 chapter, the authority has all powers necessary or incidental thereto.

12.11 Subd. 13. **Transfers to the authority.** In addition to any other payments required
12.12 under this act, for operating years 2016 to 2020, the NFL team shall annually transfer to
12.13 the authority amounts for operating costs and capital reserves under section 473J.13,
12.14 subdivisions 2, paragraph (b), and 4, paragraph (c). These amounts shall be repaid to
12.15 the NFL team by the state on behalf of the city of Minneapolis through a repayment
12.16 schedule to be specified in law, and agreed to in all subsequent agreements between the
12.17 city and the NFL team.

12.18 Subd. 14. **Study; raffle.** The authority shall study the feasibility of conducting a
12.19 raffle for chances to win a pair or other limited numbers of prime seats (such as lower
12.20 deck, 50 yard line seats) in the stadium for professional football games for the duration of
12.21 the lease or use agreement. In conducting the study, the authority must consult with the
12.22 NFL team. If the authority determines that conducting the raffle is financially feasible,
12.23 the authority in cooperation with the director of the Gambling Control Board shall
12.24 conduct the raffle. The proceeds of the raffle must be transmitted to the commissioner
12.25 of revenue for deposit in the general fund and are appropriated to the commissioner of
12.26 management and budget for prepayment of principal and interest on appropriation bonds
12.27 under section 16A.965.

12.28 Sec. 13. **[473J.11] STADIUM DESIGN AND CONSTRUCTION.**

12.29 Subdivision 1. **Contracts.** (a) The design, development, and construction of the
12.30 stadium shall be a collaborative process between the authority and the NFL team. The
12.31 authority and the NFL team shall establish a process to reach consensus on key elements
12.32 of the stadium program and design, development, and construction.

12.33 (b) Unless the authority and the NFL team agree otherwise:

13.1 (1) the authority shall create a stadium design and construction group, including
13.2 representatives of the authority and the NFL team, to manage the design of the stadium
13.3 and oversee construction;

13.4 (2) this group shall engage an owner's representative to act on behalf of the group.
13.5 The cost of the owner's representative shall be a stadium cost; and

13.6 (3) the authority and the NFL team shall enter into a development administration
13.7 agreement providing for rights and responsibilities of the authority and the NFL team, the
13.8 design and construction group, and the owner's representative for design and construction
13.9 of the stadium, including but not limited to establishment of minimum design standards.
13.10 This development administration agreement shall provide for binding arbitration in
13.11 the event that the authority and the NFL team are unable to agree on minimum design
13.12 standards or other material aspects of the design.

13.13 (c) The authority may enter into an agreement with the NFL team and any other
13.14 entity relating to the design, construction, financing, operation, maintenance, and use of
13.15 the stadium and related facilities and stadium infrastructure. The authority may contract
13.16 for materials, supplies, and equipment in accordance with section 471.345, except that
13.17 the authority may employ or contract with persons, firms, or corporations to perform one
13.18 or more or all of the functions of architect, engineer, construction manager, or program
13.19 manager with respect to all or any part of the design, construction, financing, operation,
13.20 maintenance, and use of the stadium and stadium infrastructure under the traditional
13.21 separate design and build, integrated design-build, construction manager at risk, or
13.22 public/private partnership (P3) structures, or a combination thereof.

13.23 The agreement must provide that at least 25 percent of the materials, supplies,
13.24 and equipment used in the construction, operation, maintenance, and use of the stadium
13.25 and related facilities and stadium infrastructure, other than the material subject to
13.26 section 473J.15, subdivision 11, paragraph (c), must be made or produced by Minnesota
13.27 businesses.

13.28 (d) The authority and the NFL team shall prepare a request for proposals for one or
13.29 more of the functions described in paragraph (c). The request must be published in the
13.30 State Register and shall include, at a minimum, such requirements that are agreed to by
13.31 the authority and the NFL team. The authority and the NFL team may prequalify offerors
13.32 by issuing a request for qualifications, in advance of the request for proposals, and select a
13.33 short list of responsible offerors prior to discussions and evaluations.

13.34 (e) As provided in the request for proposals, the authority, and the NFL team, may
13.35 conduct discussions and negotiations with responsible offerors in order to determine
13.36 which proposal is most advantageous to the authority and the NFL team and to negotiate

14.1 the terms of an agreement. In conducting discussions, there shall be no disclosure of any
14.2 information derived from proposals submitted by competing offerors and the content of all
14.3 proposals is nonpublic data under chapter 13 until such time as a notice to award a contract
14.4 is given by the authority. The agreement shall be subject to the approval of the NFL team.

14.5 (f) Prior to the time the authority enters into a construction contract with a
14.6 construction manager or program manager certifying a maximum price and a completion
14.7 date as provided in paragraph (h), at the request of the NFL team, the authority may
14.8 authorize, such authorization not to be unreasonably withheld or delayed, the NFL team
14.9 to provide for management of the construction of the stadium and related stadium
14.10 infrastructure, in which event the NFL team must assume the role and responsibilities
14.11 of the authority for completion of construction in a manner consistent with the agreed
14.12 minimum design standards and design documents, subject to the terms of this act,
14.13 including responsibility for cost overruns.

14.14 (g) The construction manager or program manager may enter into contracts with
14.15 contractors for labor, materials, supplies, and equipment for the construction of the
14.16 stadium and related stadium infrastructure through the process of public bidding, except
14.17 that the construction manager or program manager may, with the consent of the authority
14.18 or the NFL team if the NFL team has assumed responsibility for construction:

14.19 (1) narrow the listing of eligible bidders to those which the construction manager
14.20 or program manager determines to possess sufficient expertise to perform the intended
14.21 functions;

14.22 (2) award contracts to the contractors that the construction manager or program
14.23 manager determines provide the best value under a request for proposals as described in
14.24 section 16C.28, subdivision 1, paragraphs (a), clause (2), and (c), which are not required
14.25 to be the lowest responsible bidder; and

14.26 (3) for work the construction manager or program manager determines to be critical
14.27 to the completion schedule, award contracts on the basis of competitive proposals, or
14.28 perform work with its own forces without soliciting competitive bids if the construction
14.29 manager or program manager provides evidence of competitive pricing.

14.30 (h) The authority and the NFL team shall require that the construction manager or
14.31 program manager certify, before the contract is signed, a fixed and stipulated construction
14.32 price and completion date to the authority and post a performance bond in an amount
14.33 at least equal to 100 percent of the certified price or such other security satisfactory to
14.34 the authority, to cover any costs which may be incurred in excess of the certified price
14.35 including, but not limited to, costs incurred by the authority or loss of revenues resulting
14.36 from incomplete construction on the completion date. The authority may secure surety

15.1 bonds as provided in section 574.26, securing payment of just claims in connection with
15.2 all public work undertaken by the authority. Persons entitled to the protection of the
15.3 bonds may enforce them as provided in sections 574.28 to 574.32 and are not entitled to a
15.4 lien on any property of the authority under the provisions of sections 514.01 to 514.16.
15.5 The construction of the stadium is a project as that term is defined in section 177.42,
15.6 subdivision 2, and is subject to the prevailing wage law under sections 177.41 to 177.43.

15.7 Subd. 2. **Changes.** Unless otherwise agreed to by the authority and the NFL team,
15.8 if either party requests an agreed upon change in minimum design standards, and this
15.9 change is responsible for requiring the project to exceed the stated budget, the requesting
15.10 party is liable for any cost overruns or associated liabilities.

15.11 Subd. 3. **Stadium design.** The stadium and stadium infrastructure shall be designed
15.12 and constructed incorporating the following general program and design elements:

15.13 (1) Unless otherwise agreed to by the authority and the NFL team, the stadium
15.14 shall comprise approximately 1,500,000 square feet with approximately 65,000 seats,
15.15 expandable to 72,000, shall meet or exceed NFL program requirements, and include
15.16 approximately 150 suites and approximately 7,500 club seats or other such components as
15.17 agreed to by the authority and the NFL team;

15.18 (2) space for NFL team-related exhibitions and sales, which shall include the
15.19 following: NFL team museum and Hall of Fame, retail merchandise and gift shop retail
15.20 venues, and themed concessions and restaurants;

15.21 (3) year-round space for the NFL team administrative operations, sales, and
15.22 marketing, including a ticket office, team meeting space, locker, and training rooms;

15.23 (4) space for administrative offices of the authority;

15.24 (5) 2,000 parking spaces within one block of the stadium, connected by skyway or
15.25 tunnel to the stadium, and 500 parking spaces within two blocks of the stadium, with a
15.26 dedicated walkway on game days;

15.27 (6) elements sufficient to provide community and civic uses as determined by the
15.28 authority; and

15.29 (7) a roof that is fixed or retractable, provided that if the roof is retractable, it is
15.30 accomplished without any increase to the funding provided by the state or the city.

15.31 Subd. 4. **Cost overruns, savings.** (a) Within the limits of paragraph (b), the
15.32 authority may accept financial obligations relating to cost overruns associated with
15.33 acquisition of the stadium site, stadium infrastructure, and stadium design, development,
15.34 and construction, provided that the authority shall bid project construction in a manner
15.35 that any cost overruns are the responsibility of the successful bidder and not the authority
15.36 or the state. The authority shall not accept responsibility for cost overruns and shall not

16.1 be responsible for cost overruns if the authority has authorized the NFL team to provide
16.2 for management of construction of the stadium under subdivision 1. Cost savings or
16.3 additional funds obtained by the authority or the NFL team for the stadium or stadium
16.4 infrastructure may be used first to fund additional stadium or stadium infrastructure, as
16.5 agreed to by the authority and the NFL team, if any, and then to fund capital reserves.

16.6 (b) The state share of stadium costs shall be limited to \$293,000,000 for construction
16.7 of a new stadium, as permitted under article 2, section 2. The city of Minneapolis share
16.8 shall be limited to a \$150,000,000 contribution for construction, and the annual operating
16.9 cost and capital contributions contained under article 1, section 17.

16.10 Sec. 14. **[473J.112] COMMEMORATIVE BRICKS.**

16.11 The authority shall sell commemorative bricks to be displayed at a prominent
16.12 location in the new stadium, for an amount to be determined by the authority. Funds raised
16.13 through this section shall be appropriated to the commissioner of management and budget
16.14 for transfer to the Minnesota Stadium Authority.

16.15 **EFFECTIVE DATE.** This section is effective the day following final enactment.

16.16 Sec. 15. **[473J.113] NAMING RIGHTS.**

16.17 The NFL team and the authority shall make their best efforts to sell naming rights
16.18 for the stadium at the maximum reasonable price promptly upon passage of this act.
16.19 The proceeds of the sale of the naming rights must be used to reduce proportionately
16.20 the following amounts:

16.21 (1) the \$532,000,000 NFL team/private contribution under section 473J.15,
16.22 subdivision 4;

16.23 (2) the state contribution of \$293,000,000 under section 16A.965; and

16.24 (3) the city contribution of \$150,000,000 to be funded by the issuance of state
16.25 appropriation bonds under section 16A.965 and required to be recaptured under section
16.26 297A.994, subdivision 4, paragraph (a), clause (1).

16.27 Sec. 16. **[473J.12] EMPLOYMENT.**

16.28 Subdivision 1. **Hiring and recruitment.** In the design, development, construction,
16.29 management, operation, maintenance and capital repair, replacement and improvement of
16.30 the stadium and stadium infrastructure, the authority shall make every effort to employ,
16.31 and cause the NFL team, the construction manager and other subcontractors, vendors, and
16.32 concessionaires to employ women and members of minority communities when hiring.
16.33 In addition, the authority shall contract with an employment assistance firm, preferably

17.1 minority-owned, or owned by a disabled individual or a woman, to create an employment
17.2 program to recruit, hire, and retain minorities for the stadium facility. The authority
17.3 shall hold a job fair and recruit and advertise at Minneapolis Urban League, Sabathani,
17.4 American Indian OIC, Youthbuild organizations, and other such organizations. Further,
17.5 goals for construction contracts to be awarded to women- and minority-owned businesses
17.6 will be in a percentage at least equal to the minimum used for city of Minneapolis
17.7 development projects, and the other construction workforce will establish workforce
17.8 utilization goals at least equal to current city goals and include workers from city zip
17.9 codes that have high rates of poverty and unemployment.

17.10 Subd. 2. **Other required agreements.** The NFL team or the authority shall give
17.11 food, beverage, retail, and concession workers presently employed by the NFL team or
17.12 the Metropolitan Sports Facilities Commission or its vendors at the existing football
17.13 stadium the opportunity to continue their employment in comparable positions at the new
17.14 stadium. Workers who are presently represented under a collective bargaining agreement
17.15 may seek to continue such representation in the facility and designate such, or another
17.16 collective bargaining unit, as their representative.

17.17 Sec. 17. **[473J.13] STADIUM OPERATIONS; CAPITAL IMPROVEMENTS.**

17.18 Subdivision 1. **Stadium operation.** The stadium shall be operated in a first-class
17.19 manner, similar to and consistent with other comparable NFL stadiums, such as the
17.20 stadium known as Lucas Oil Field, as of the effective date of this act. The authority and
17.21 the team will mutually agree on a third-party management company or individual to
17.22 manage the stadium and on certain major vendors to the stadium. The authority, with the
17.23 approval of the NFL team, may enter into an agreement with a program manager for
17.24 management of the stadium, for a maximum of 30 years.

17.25 Subd. 2. **Operating expenses.** (a) The authority must pay or cause to be paid
17.26 all operating expenses of the stadium. The authority must require in the lease or use
17.27 agreement with the NFL team that the NFL team pay the authority, beginning January 1,
17.28 2016, or other date as mutually agreed upon by the parties, toward operating costs of the
17.29 stadium, \$8,500,000 each year, increased by a three percent annual inflation rate.

17.30 (b) Beginning January 1, 2016, or other date as mutually agreed upon by the
17.31 parties, and continuing through 2020, the NFL team shall pay the authority operating
17.32 expenses, \$6,000,000 each year, increased by an annual adjustment factor. The payment
17.33 of \$6,000,000 per year beginning in 2016 is a payment by the team, which shall be repaid
17.34 to the team by the state, using funds as provided under section 297A.994, subdivision 4,

18.1 clause (4). After 2020, the state shall assume this payment, using funds generated in
18.2 accordance with the city of Minneapolis as specified under section 297A.994.

18.3 (c) The authority may establish an operating reserve to cover operating expense
18.4 shortfalls and may accept funds from any source for deposit in the operating reserve. The
18.5 establishment or funding of an authority operating reserve must not decrease the amounts
18.6 required to be paid to the authority toward operating costs under this subdivision unless
18.7 agreed to by the authority.

18.8 (d) The NFL team is responsible for operating cost overruns.

18.9 (e) After the joint selection of the third-party manager or program manager, the
18.10 authority may agree with a program manager or other third-party manager of the stadium
18.11 on a fixed cost operating, management, or employment agreement with operating
18.12 cost protections under which the program manager or third-party manager assumes
18.13 responsibility for stadium operating costs and shortfalls. The agreement with the manager
18.14 must require the manager to prepare an initial and ongoing operating plan and operating
18.15 budgets for approval by the authority in consultation with the NFL team. The manager
18.16 must agree to operate the stadium in accordance with the approved operating plan and
18.17 operating budget.

18.18 Subd. 3. **Public access.** The authority shall work to maximize access for public and
18.19 amateur sports, community, and civic events, and other public events in type and on terms
18.20 consistent with those currently held at the existing football stadium, as defined in section
18.21 473.551, subdivision 9. The authority may provide that these events have exclusive use
18.22 of the premises at agreed-upon times subject to the scheduling rights of the NFL team
18.23 under the lease or use agreement.

18.24 Subd. 4. **Capital improvements.** (a) The authority shall establish a capital
18.25 reserve fund. The authority shall be responsible for making, or for causing others to
18.26 make, all capital repairs, replacements, and improvements for the stadium and stadium
18.27 infrastructure. The authority shall maintain, or cause others to maintain, the stadium and
18.28 stadium infrastructure in a safe, clean, attractive, and first-class manner so as to cause
18.29 them to remain in a condition comparable to that of other comparable NFL facilities of
18.30 similar design and age. The authority shall make, or cause others to make, all necessary
18.31 or appropriate repairs, renewals, and replacements, whether structural or nonstructural,
18.32 interior or exterior, ordinary or extraordinary, foreseen or unforeseen, in a prompt and
18.33 timely manner. In addition, the authority, with approval of the NFL team, may enter into
18.34 an agreement with a program manager to perform some or all of the responsibilities of the
18.35 authority in this subdivision and to assume and accept financial liability for the cost of
18.36 performing the responsibilities.

19.1 (b) The NFL team must contribute \$1,500,000 each year, beginning in 2016 or as
19.2 otherwise determined for the term of the lease or use agreement to the capital reserve fund,
19.3 increased by a three percent annual inflation rate.

19.4 (c) The state shall contribute \$1,500,000 each year, beginning in 2016 or as otherwise
19.5 determined for the term of the lease to the capital reserve fund. The contributions of the
19.6 state are subject to increase by an annual adjustment factor. The contribution under this
19.7 paragraph shall be assumed by the team from 2016 through 2020, and repaid to the team
19.8 by the state using funds in accordance with section 297A.994, subdivision 4, clause (4).

19.9 (d) The authority with input from the NFL team shall develop short-term and
19.10 long-term capital funding plans and shall use those plans to guide the future capital needs
19.11 of the stadium and stadium infrastructure. The authority shall make the final determination
19.12 with respect to funding capital needs. Any capital improvement proposed by the NFL
19.13 team intended primarily to provide revenue enhancements to the NFL team shall be paid
19.14 for by the NFL team, unless otherwise agreed to with the authority.

19.15 Subd. 5. **Game-day payments.** In addition to operating expense contributions
19.16 of the NFL team under subdivision 2, the NFL team shall pay all NFL game day, NFL
19.17 team-owned major league soccer, as provided in section 473J.15, subdivision 15, and
19.18 other NFL team-sponsored event expenses within the stadium and stadium plaza areas.

19.19 Subd. 6. **Cooperation with financing.** The authority shall cooperate with the
19.20 NFL team to facilitate the financing of the NFL team's contribution. Such agreement to
19.21 cooperate shall not require the authority to incur any additional costs or provide conduit
19.22 financing. The lease, license, and other transaction documents shall include provisions
19.23 customarily required by lenders in stadium financings.

19.24 **Sec. 18. [473J.15] CRITERIA AND CONDITIONS.**

19.25 Subdivision 1. **Binding and enforceable.** In developing the stadium and entering
19.26 into related contracts, the authority must follow and enforce the criteria and conditions in
19.27 this section, provided that a determination by the authority that those criteria or conditions
19.28 have been met under any agreement or otherwise shall be conclusive.

19.29 Subd. 2. **NFL team/private contribution; timing of expenditures.** (a) The NFL
19.30 team/private contribution, including stadium builder license proceeds, for stadium costs
19.31 must be made in cash in the amount of at least \$532,000,000.

19.32 (b) Prior to the initial deposit of funds under this section, the team must provide
19.33 security or other credit worthiness in the amount of \$50,000,000, subject to the satisfaction
19.34 of the authority. Prior to the first issuance of bonds under section 16A.965, the first portion

20.1 of the NFL team/private contribution in the amount of \$50,000,000 must be deposited as
20.2 costs are incurred to the construction fund to pay for the initial stadium costs.

20.3 (c) After the first \$50,000,000 of stadium costs have been paid from the initial
20.4 NFL team/private contribution, state funds shall be deposited as costs are incurred to the
20.5 construction fund to pay for the next \$50,000,000 of costs of the project. Prior to any state
20.6 funds being deposited in the construction fund, the NFL team must provide security or a
20.7 financing commitment reasonably satisfactory to the authority for the balance of the
20.8 required NFL team/private contribution and for payment of cost overruns if the NFL
20.9 team assumes responsibility for stadium construction under section 473J.11. Thereafter,
20.10 budgeted project costs shall be borne by the authority and the NFL team/private
20.11 contributions in amounts proportionate to their remaining funding commitments.

20.12 (d) In the event the project terminates before the initial \$100,000,000 in contributions
20.13 are expended by the parties under this subdivision, the parties shall be reimbursed in the
20.14 amounts they have deposited to the construction fund proportionate to project funding
20.15 percentages, in the amounts of 56 percent by the authority and 44 percent by the NFL
20.16 team/private contributions.

20.17 Subd. 3. **Lease or use agreements; 40-year term.** The authority must enter into
20.18 a long-term lease or use agreement with the NFL team for the NFL team's use of the
20.19 stadium. The NFL team must agree to play all preseason, regular season, and postseason
20.20 home games at the stadium. Training facilities must remain in Minnesota during the term
20.21 of the lease or use agreement. The lease or use agreement must be for a term of at least
20.22 40 years from the date of substantial completion of the stadium for professional football
20.23 games. The lease or use agreement may provide options for the NFL team to extend the
20.24 term for up to four additional periods of five years. The lease or use agreement must
20.25 include terms for default, termination, and breach of the agreement. Recognizing that
20.26 the presence of professional football provides to the state of Minnesota and its citizens
20.27 highly valued, intangible benefits that are virtually impossible to quantify and, therefore,
20.28 not recoverable in the event of the NFL team owner's breach of contract, the lease and
20.29 use agreements must provide for specific performance and injunctive relief to enforce
20.30 provisions relating to use of the stadium for professional football and must not include
20.31 escape clauses or buyout provisions. The NFL team must not enter into or accept any
20.32 agreement or requirement with or from any entity that is inconsistent with the NFL team's
20.33 binding commitment to the 40-year term of the lease or use agreement or that would in
20.34 any manner dilute, interfere with, or negate the provisions of the lease or use agreement,
20.35 providing for specific performance or injunctive relief. The legislature conclusively

21.1 determines, as a matter of public policy, that the lease or use agreement, and any grant
21.2 agreement under this chapter that includes a specific performance clause:

21.3 (1) explicitly authorizes specific performance as a remedy for breach;

21.4 (2) is made for adequate consideration and upon terms which are otherwise fair
21.5 and reasonable;

21.6 (3) has not been included through sharp practice, misrepresentation, or mistake;

21.7 (4) if specifically enforced, does not cause unreasonable or disproportionate hardship
21.8 or loss to the NFL team or to third parties; and

21.9 (5) involves performance in a manner and the rendering of services of a nature and
21.10 under circumstances that the beneficiary cannot be adequately compensated in damages.

21.11 Subd. 4. **Lease or use agreements; revenues, payments.** A lease or use agreement
21.12 shall include rent and other fees and expenses to be paid by the NFL team. The authority
21.13 shall agree to provide in the lease or use agreement for the NFL team to receive all NFL
21.14 and team event related revenues, including but not limited to, suite revenues, advertising,
21.15 concessions, signage, broadcast and media, and club seat revenue. The agreement shall
21.16 also provide that all naming rights to the stadium are retained by the NFL team, subject to
21.17 the approval of the name or names by the authority consistent with those criteria set out
21.18 in the lease or use agreement. The agreement shall provide for the authority to receive
21.19 all general ticket revenues and other event revenues other than from NFL team games,
21.20 NFL team-owned major league soccer games, and other NFL team events agreed to by
21.21 the authority.

21.22 Subd. 5. **Notice of breach or default.** Until 30 years from the date of stadium
21.23 completion, the NFL team must provide written notice to the authority not less than 180
21.24 days prior to any action, including any action imposed upon the NFL team by the NFL,
21.25 which would result in a breach or default of provisions of the lease or use agreements
21.26 required to be included under subdivision 3. If this notice provision is violated and the
21.27 NFL team has already breached or been in default under the required provisions, the
21.28 authority or the state of Minnesota may specifically enforce the lease or use agreement
21.29 and Minnesota courts shall fashion equitable remedies so that the NFL team fulfills the
21.30 conditions of the lease and use agreements.

21.31 Subd. 6. **Enforceable financial commitments.** The authority must determine before
21.32 stadium construction begins that all public and private funding sources for construction,
21.33 operating expenses, and capital improvements and repairs of the stadium are included in
21.34 written agreements. The committed funds must be adequate to design, construct, furnish,
21.35 and equip the stadium, and pay projected operating expenses and the costs of capital
21.36 improvements and repairs during the term of the lease or use agreement with the NFL

22.1 team. The NFL team must provide the authority access to NFL team financial or other
22.2 information, which the authority deems necessary for such determination. Any financial
22.3 information obtained by the authority under this subdivision is nonpublic data under
22.4 section 13.02, subdivision 9.

22.5 Subd. 7. **Environmental requirements.** The authority must comply with all
22.6 environmental requirements imposed by regulatory agencies for the stadium, site, and
22.7 structure, except as provided by section 473J.09, subdivision 11, or by section 473J.17.

22.8 Subd. 8. **Public share on sale of NFL team.** The lease or use agreement must
22.9 provide that, if the NFL team is sold or an interest in the NFL team is sold after the
22.10 effective date of this chapter, a portion of the sale price must be used to pay down the
22.11 remaining debt service. If any portion remains after the debt service is paid, that amount
22.12 must be deposited in the general fund. The portion required to be so paid is 25 percent
22.13 of the amount in excess of the purchase price of the NFL team by the selling owner or
22.14 owners, declining to 15 percent ten years after commencement of stadium construction in
22.15 increments of 1.0 percent each year. The agreement must provide exceptions for sales
22.16 to members of the owners' families and entities and trusts beneficially owned by family
22.17 members, sales to employees of equity interests aggregating up to ten percent, sales related
22.18 to capital infusions not distributed to the owners, and sales amongst existing owners not
22.19 exceeding 20 percent equity interest in the NFL team.

22.20 Subd. 9. **Authority's access to NFL team financial information.** A notice
22.21 provision for a material breach shall be agreed to between the authority and the NFL team.
22.22 In the event there is a material breach by the NFL team under the lease or use agreement,
22.23 the lease or use agreement must provide the authority access to audited financial statements
22.24 of the NFL team and other financial information that the authority deems necessary to
22.25 enforce the terms of any lease or use agreements. Any financial information obtained by
22.26 the authority under this subdivision is nonpublic data under section 13.02, subdivision 9.

22.27 Subd. 10. **NFL team name retained.** The lease or use agreement must provide
22.28 that the NFL team and NFL will transfer to the state of Minnesota the Minnesota Vikings'
22.29 heritage and records, including the name, logo, colors, history, playing records, trophies,
22.30 and memorabilia in the event of relocation of the NFL team is in violation of the lease
22.31 or use agreement.

22.32 Subd. 11. **Stadium design.** (a) The authority and the NFL team will strive to
22.33 build a stadium that is environmentally and energy efficient and will make an effort to
22.34 build a stadium that is eligible to receive the Leadership in Energy and Environmental
22.35 Design (LEED) certification or the Green Building Initiative Green Globes certification

23.1 for environmental design, and to the extent practicable, will strive to make the stadium
23.2 design architecturally significant.

23.3 (b) The stadium design must, to the extent feasible, follow sustainable building
23.4 guidelines established under section 16B.325.

23.5 (c) The authority and the team must ensure that the stadium be built with
23.6 American-made steel that is made from Minnesota iron ore.

23.7 Subd. 12. **Necessary approvals.** The authority and the NFL team must secure
23.8 any necessary approvals to the terms of the lease and use agreement and the design and
23.9 construction plans for the stadium, including prior approval of the NFL.

23.10 Subd. 13. **Affordable access.** The lease or use agreement must provide for an
23.11 agreed-upon number of affordable tickets to the professional sporting events held in the
23.12 stadium.

23.13 Subd. 14. **Stadium builder's licenses.** The authority shall own and retain the
23.14 exclusive right to sell stadium builder's licenses in the stadium. The authority will retain
23.15 the NFL team to act as the authority's agent in marketing and selling such licenses.

23.16 Subd. 15. **Major league soccer.** The authority shall, for five years after the first
23.17 NFL team home game is played in the stadium, grant the NFL team the exclusive right to
23.18 establish major league soccer at the stadium. The authority and the NFL team may enter
23.19 into an agreement providing the terms and conditions of such an arrangement, provided:

23.20 (1) if any of the NFL team owners whose family owns at least three percent of
23.21 the NFL team purchases full or partial ownership in a major league soccer franchise,
23.22 such franchise may play in the stadium under a use agreement with similar terms as are
23.23 applicable to the NFL team at no additional rent, but including a provision of payment
23.24 of game-day costs and reasonable marginal costs incurred by the authority as a result of
23.25 the major league soccer team; and

23.26 (2) capital improvements required by a major league soccer franchise must be
23.27 financed by the owners of the major league soccer team, unless otherwise agreed to by
23.28 the authority.

23.29 Subd. 16. **NFL team-related entities.** Subject to the prior approval of the authority,
23.30 which shall not be unreasonably withheld, any of the obligations by the NFL team may
23.31 be performed by the NFL team, a related entity, or a third party, and the NFL team, any
23.32 entity related to the NFL team or third party may receive any revenues to which the NFL
23.33 team is entitled hereunder; provided, however, the NFL team shall remain liable if any
23.34 obligations are assigned to a related entity or third party.

23.35 Sec. 19. **[473J.17] MUNICIPAL ACTIVITIES.**

24.1 Subdivision 1. **Property acquisition and disposition.** The city may, to the extent
24.2 legally permissible, acquire land, air rights, and other property interests within the
24.3 development area for the stadium site and stadium infrastructure and convey it to the
24.4 authority with or without consideration, prepare a site for development as a stadium, and
24.5 acquire and construct any related stadium infrastructure. To the extent property parcels or
24.6 interests acquired are more extensive than the stadium infrastructure requirements, the city
24.7 may sell or otherwise dispose of the excess.

24.8 Subd. 2. **Claims.** Except as may be mutually agreed to by the city and the authority,
24.9 the city has no interest in or claim to any assets or revenues of the authority.

24.10 Subd. 3. **Environmental; planning and zoning.** The authority is the responsible
24.11 governmental unit for an environmental impact statement for the stadium prepared under
24.12 section 116D.04, if an environmental impact statement is necessary. Notwithstanding
24.13 section 116D.04, subdivision 2b, and implementing rules: (1) the environmental
24.14 impact statement shall not be required to consider alternative stadium sites; and (2) the
24.15 environmental impact statement must be determined to be adequate before commencing
24.16 work on the foundation of the stadium, but the stadium and stadium infrastructure may
24.17 otherwise be started and all preliminary and final government decisions and actions may
24.18 be made and taken including, but not limited to, acquiring land; obtaining financing;
24.19 granting permits or other land use approvals; entering into grant, lease, or use agreements;
24.20 or preparing the site or related stadium infrastructure prior to a determination of the
24.21 adequacy of the environmental impact statement.

24.22 Subd. 4. **Local government expenditure.** The city may make expenditures or
24.23 grants for other costs incidental and necessary to further the purposes of this chapter and
24.24 may, by agreement, reimburse in whole or in part, any entity that has granted, loaned, or
24.25 advanced funds to the city to further the purposes of this chapter. The city may reimburse
24.26 the authority or a local governmental entity or make a grant to the authority or such a
24.27 governmental unit or be reimbursed by the authority or local governmental entity for site
24.28 acquisition, preparation of the site for stadium development, and stadium infrastructure.

24.29 Subd. 5. **Municipal authority.** The legislature intends that, except as expressly
24.30 limited herein, the city may acquire and develop stadium infrastructure, enter into contracts
24.31 with the authority and other governmental or nongovernmental entities, appropriate funds,
24.32 and make employees, consultants, and other revenues available for those purposes.

24.33 Subd. 6. **Stadium Implementation Committee; city review.** In order to accomplish
24.34 the objectives of this act within the required time frame, it is necessary to establish an
24.35 alternative process for municipal land use and development review. It is hereby found
24.36 and declared that the construction of a stadium within the development area is consistent

25.1 with the adopted area plan, is the preferred stadium location, and is a permitted land use.
25.2 This subdivision establishes a procedure for all land use and development reviews and
25.3 approvals by the city of Minneapolis for the stadium and related stadium infrastructure
25.4 and supersedes all land use and development rules and restrictions and procedures
25.5 imposed by other law, charter, or ordinance, including without limitation section 15.99.
25.6 No later than 30 days after timely compliance of the city as provided in article 3, section 4,
25.7 of this act, the city of Minneapolis shall establish a stadium implementation committee
25.8 to make recommendations on the design plans submitted for the stadium, and stadium
25.9 infrastructure, and related improvements. The implementation committee must take
25.10 action to issue its recommendations within the time frames established in the planning
25.11 and construction timetable issued by the authority which shall provide for no less than 60
25.12 days for the committee's review. The recommendations of the implementation committee
25.13 shall be forwarded to the city of Minneapolis Planning Commission for an advisory
25.14 recommendation and then to the city council for final action in a single resolution, which
25.15 final action must be taken within 45 days of the submission of the recommendations to the
25.16 planning commission. The city council shall not impose any unreasonable conditions on
25.17 the recommendations of the implementation committee, nor take any action or impose
25.18 any conditions that will result in delay from the time frames established in the planning
25.19 and construction timetable or in additional overall costs. Failure of the city council to act
25.20 within the 45-day period shall be deemed to be approval. The authority may seek de novo
25.21 review in the district court of any city council action. The district court or any appellate
25.22 court shall expedite review to the maximum extent possible and timely issue relief, orders,
25.23 or opinions as necessary to give effect to the provisions and objectives in this act.

25.24 Sec. 20. **[473J.19] PROPERTY TAX EXEMPTION; SPECIAL ASSESSMENTS.**

25.25 Any real or personal property acquired, owned, leased, controlled, used, or occupied
25.26 by the authority for any of the purposes of this chapter, is acquired, owned, leased,
25.27 controlled, used, and occupied for public, governmental, and municipal purposes. The
25.28 stadium and stadium infrastructure are exempt from ad valorem taxation by the state
25.29 or any political subdivision of the state provided that the properties are subject to
25.30 special assessments levied by a political subdivision for a local improvement in amounts
25.31 proportionate to and not exceeding the special benefit received by the properties from the
25.32 improvement. No possible use of any of the properties in any manner different from their
25.33 use under this chapter may be considered in determining the special benefit received by
25.34 the properties. Notwithstanding section 272.01, subdivision 2, or 273.19, real or personal
25.35 property which is subject to a lease or use agreement between the authority and another

26.1 person for uses related to the purposes of this chapter, including the operation of the
26.2 stadium and related parking facilities, is exempt from taxation regardless of the length of
26.3 the lease or use agreement or the characteristics of the entity leasing or using the property.
26.4 This section, insofar as it provides an exemption or special treatment, does not apply to
26.5 any real property that is leased for residential, business, or commercial development or to
26.6 a restaurant that is open for general business more than 200 days a year, or other purposes
26.7 different from those contemplated in this chapter.

26.8 Sec. 21. **[473J.21] LIQUOR LICENSES.**

26.9 At the request of the authority, the city may issue intoxicating liquor licenses that are
26.10 reasonably required for the premises of the stadium site. These licenses are in addition to
26.11 the number authorized by law. All provisions of chapter 340A not inconsistent with this
26.12 section apply to the licenses authorized under this section.

26.13 Sec. 22. **[473J.23] LOCAL TAXES.**

26.14 No new or additional local sales or use tax shall be imposed on sales at the stadium
26.15 site unless the tax is applicable throughout the taxing jurisdiction. Except for a tax
26.16 imposed under article 6, no new or additional local tax shall be imposed on sales of tickets
26.17 and admissions to NFL team, NFL team-owned major league soccer, or other team related
26.18 events at the stadium, notwithstanding any law or ordinance, unless the tax is applicable
26.19 throughout the taxing jurisdiction. The admissions and amusements tax currently imposed
26.20 by the city of Minneapolis pursuant to Laws 1969, chapter 1092, may apply to admissions
26.21 for football and NFL team related events, including NFL team-owned major league soccer,
26.22 as provided in section 473J.15, subdivision 15, at the stadium.

26.23 Sec. 23. **[473J.25] METROPOLITAN SPORTS FACILITIES COMMISSION**
26.24 **ASSETS; LIABILITIES TO AUTHORITY.**

26.25 Subdivision 1. **Authority expenses.** The Metropolitan Sports Facilities Commission
26.26 shall pay the operating expenses of the authority including salaries, compensation, and
26.27 other personnel, office, equipment, consultant and any other costs, until the commission is
26.28 abolished pursuant to subdivision 3.

26.29 Subd. 2. **Transfer.** Within 90 days of the enactment of this chapter, the Metropolitan
26.30 Sports Facilities Commission shall pay its outstanding obligations, settle its accounts, and
26.31 transfer its remaining assets, liabilities, and obligations to the authority, for its purposes.

26.32 Subd. 3. **Metropolitan Sports Facilities Commission abolished; interim powers**
26.33 **conferred on authority.** Upon transfer to the authority of all remaining assets, liabilities,

27.1 and obligations of the Metropolitan Sports Facilities Commission, in subdivision 2, the
27.2 Metropolitan Sports Facilities Commission is abolished. When the remaining assets,
27.3 liabilities, and obligations of the Metropolitan Sports Facilities Commission have been
27.4 transferred to the authority and the commission has been abolished, the powers and duties
27.5 of the commission under sections 473.551 to 473.599, and any other law shall devolve
27.6 upon the authority, in addition to the powers and duties of the authority under chapter
27.7 473J, until the first NFL home game is played at the stadium.

27.8 Subd. 4. **Employees.** Upon transfer of ownership all persons employed by the
27.9 Metropolitan Sports Facilities Commission shall be transferred to the Minnesota Stadium
27.10 Authority without loss of right or privilege. Nothing in this section shall be construed to
27.11 give any such person the right or privilege to continue in the same level or classification
27.12 of employment previously held. The Minnesota Stadium Authority may assign any such
27.13 person to an employment level and classification which it deems appropriate and desirable
27.14 in accordance with its personnel code.

27.15 Subd. 5. **Conforming changes.** The Metropolitan Sports Facilities Commission
27.16 shall submit a technical bill to the 2013 legislature making any cross-reference,
27.17 grammatical, or other conforming changes necessary as a result of this act. This bill
27.18 shall be submitted by February 12, 2013.

27.19 Sec. 24. **EFFECTIVE DATE.**

27.20 Except as otherwise provided, this article is effective the day following final
27.21 enactment.

27.22 **ARTICLE 2**

27.23 **STATE STADIUM FUNDING**

27.24 Section 1. **[16A.6455] MINNESOTA FIRST BONDS.**

27.25 Subdivision 1. **Program established.** The commissioner of management and
27.26 budget may establish the Minnesota First bond program to encourage individuals to invest
27.27 in state general obligation or appropriation bonds to provide revenues for the purposes
27.28 of reducing the state's and the city of Minneapolis's financial obligations under this act.
27.29 The program consists of:

27.30 (1) issuing a portion of the state general obligation or appropriation bonds in
27.31 denominations and maturities that will be attractive to individuals; and

27.32 (2) developing a program for marketing the bonds to investors.

27.33 Subd. 2. **Denominations.** The commissioner shall determine the appropriate
27.34 denominations and maturities for the Minnesota First bonds. It is the intent of the

28.1 legislature to make bonds available in as small denominations as is feasible given the
28.2 costs of marketing and administering the bond issue. Minimum denominations of \$1,000
28.3 must be made available. The minimum denomination bonds need not be made available
28.4 for bonds of all maturities. If a zero coupon bond is sold, "denomination" means the
28.5 compounded maturity amount of the bond.

28.6 Subd. 3. **Direct sale permitted.** The commissioner may sell any series of savings
28.7 bonds directly to the public or to financial institutions for prompt resale to the public
28.8 upon the terms and conditions and the restrictions the commissioner prescribes. The
28.9 commissioner may enter into all contracts deemed necessary or desirable to accomplish
28.10 the sale in a cost-effective manner including a private or negotiated sale, but the
28.11 commissioner may contract for investment banking and banking services only after
28.12 receiving competitive proposals for the services.

28.13 Subd. 4. **Marketing plan.** The commissioner shall develop a plan for marketing
28.14 Minnesota First bonds. The plan must include strategies to:

- 28.15 (1) inform the public about the availability of the bonds;
28.16 (2) take orders for the bonds;
28.17 (3) target the sale of the bonds to Minnesota residents; and
28.18 (4) market the bonds at the lowest cost to the state.

28.19 Subd. 5. **Allocation of revenue.** The commissioner of management and budget
28.20 shall allocate the revenue generated to offset the public financial obligations under this
28.21 act equally between the city of Minneapolis and the state.

28.22 **Sec. 2. [16A.965] STADIUM APPROPRIATION BONDS.**

28.23 Subdivision 1. **Definitions.** (a) The definitions in this subdivision and in chapter
28.24 473J apply to this section.

28.25 (b) "Appropriation bond" means a bond, note, or other similar instrument of the state
28.26 payable during a biennium from one or more of the following sources:

- 28.27 (1) money appropriated by law from the general fund in any biennium for debt
28.28 service due with respect to obligations described in subdivision 2, paragraph (b);
28.29 (2) proceeds of the sale of obligations described in subdivision 2, paragraph (b);
28.30 (3) payments received for that purpose under agreements and ancillary arrangements
28.31 described in subdivision 2, paragraph (d); and
28.32 (4) investment earnings on amounts in clauses (1) to (3).

28.33 (c) "Debt service" means the amount payable in any biennium of principal, premium,
28.34 if any, and interest on appropriation bonds.

29.1 Subd. 2. **Authorization to issue appropriation bonds.** (a) Subject to the limitations
29.2 of this subdivision, the commissioner may sell and issue appropriation bonds of the state
29.3 under this section for public purposes as provided by law, including, in particular, the
29.4 financing of all or a portion of the acquisition, construction, improving, and equipping
29.5 of the stadium project of the Minnesota Stadium Authority as provided by chapter 473J.
29.6 Proceeds of the appropriation bonds must be credited to a special appropriation stadium
29.7 bond proceeds fund in the state treasury. Net income from investment of the proceeds,
29.8 as estimated by the commissioner, must be credited to the special appropriation stadium
29.9 bond proceeds fund.

29.10 (b) Appropriation bonds may be sold and issued in amounts that, in the opinion of
29.11 the commissioner, are necessary to provide sufficient funds, not to exceed \$443,000,000
29.12 net of costs of issuance, revenue generated under section 16A.6455, and allocated by the
29.13 commissioner of management and budget for this purpose and costs of credit enhancement
29.14 for achieving the purposes authorized as provided under paragraph (a), and pay debt
29.15 service including capitalized interest, pay costs of issuance, make deposits to reserve
29.16 funds, pay the costs of credit enhancement, or make payments under other agreements
29.17 entered into under paragraph (d); provided, however, that appropriation bonds issued and
29.18 unpaid shall not exceed \$530,000,000 in principal amount, excluding refunding bonds sold
29.19 and issued under subdivision 4.

29.20 (c) Appropriation bonds may be issued from time to time in one or more series on
29.21 the terms and conditions the commissioner determines to be in the best interests of the
29.22 state, but the term on any series of appropriation bonds may not exceed 30 years. The
29.23 appropriation bonds of each issue and series thereof shall be dated and bear interest,
29.24 and may be includable in or excludable from the gross income of the owners for federal
29.25 income tax purposes.

29.26 (d) At the time of, or in anticipation of, issuing the appropriation bonds, and at any
29.27 time thereafter, so long as the appropriation bonds are outstanding, the commissioner may
29.28 enter into agreements and ancillary arrangements relating to the appropriation bonds,
29.29 including but not limited to trust indentures, grant agreements, lease or use agreements,
29.30 operating agreements, management agreements, liquidity facilities, remarketing or
29.31 dealer agreements, letter of credit agreements, insurance policies, guaranty agreements,
29.32 reimbursement agreements, indexing agreements, or interest exchange agreements. Any
29.33 payments made or received according to the agreement or ancillary arrangement shall be
29.34 made from or deposited as provided in the agreement or ancillary arrangement. The
29.35 determination of the commissioner included in an interest exchange agreement that the
29.36 agreement relates to an appropriation bond shall be conclusive.

30.1 (e) The commissioner may enter into written agreements or contracts relating to the
30.2 continuing disclosure of information necessary to comply with, or facilitate the issuance
30.3 of appropriation bonds in accordance with federal securities laws, rules, and regulations,
30.4 including Securities and Exchange Commission rules and regulations in Code of Federal
30.5 Regulations, title 17, section 240.15c 2-12. An agreement may be in the form of covenants
30.6 with purchasers and holders of appropriation bonds set forth in the order or resolution
30.7 authorizing the issuance of the appropriation bonds, or a separate document authorized
30.8 by the order or resolution.

30.9 (f) The appropriation bonds are not subject to chapter 16C.

30.10 Subd. 3. **Form; procedure.** (a) Appropriation bonds may be issued in the form
30.11 of bonds, notes, or other similar instruments, and in the manner provided in section
30.12 16A.672. In the event that any provision of section 16A.672 conflicts with this section,
30.13 this section shall control.

30.14 (b) Every appropriation bond shall include a conspicuous statement of the limitation
30.15 established in subdivision 6.

30.16 (c) Appropriation bonds may be sold at either public or private sale upon such terms
30.17 as the commissioner shall determine are not inconsistent with this section and may be sold
30.18 at any price or percentage of par value. Any bid received may be rejected.

30.19 (d) Appropriation bonds must bear interest at a fixed or variable rate.

30.20 (e) Notwithstanding any other law, appropriation bonds issued under this section
30.21 shall be fully negotiable.

30.22 Subd. 4. **Refunding bonds.** The commissioner from time to time may issue
30.23 appropriation bonds for the purpose of refunding any appropriation bonds then
30.24 outstanding, including the payment of any redemption premiums on the bonds, any

Section 1. [297A.994] CITY OF MINNEAPOLIS SALES TAX; ALLOCATION OF REVENUES.

Subdivision 1. **Scope.** Notwithstanding the provisions of section 297A.99, subdivision 11, the provisions of this section govern the remittance of the proceeds of taxes imposed by the city of Minneapolis under the special law.

Subd. 2. **Definitions.** (a) For purposes of this section, the following definitions apply.

(b) "City" means the city of Minneapolis.

(c) "Special law" means Laws 1986, chapter 396, sections 4 and 5, as amended.

(d) "Tax" means the sales taxes imposed by the city under the special law.

(e) The terms defined under section 473J.03 apply for purposes of this section.

Subd. 3. **General allocation of revenues.** The commissioner shall remit the proceeds of the tax, less the deductions listed in this subdivision, to the city at least quarterly. The commissioner shall make the following deductions in the order listed before distribution to the city:

(1) the direct and indirect costs of the department to administer, audit, and collect the tax, according to the applicable law and agreements between the commissioner and the city. For revenues from the general local sales and use tax, the commissioner must deduct a proportionate share of costs described in section 297A.99, subdivision 11;

(2) refunds of any of these taxes due to taxpayers, if any; and

(3) notwithstanding the provisions of any agreement between the commissioner and the city providing for collection and remittance of these taxes, the commissioner must deposit to the general fund the amounts specified in subdivision 4.

Subd. 4. **General fund allocations.** (a) The commissioner must retain and deposit to the general fund the following amounts, as required by subdivision 3, clause (3):

(1) for state bond debt service support beginning in calendar year 2021, and for each calendar year thereafter through calendar year 2046, periodic amounts so that not later than December 31, 2046, an aggregate amount equal to a present value of \$150,000,000 minus the revenue generated under Minnesota Statutes, section 16A.6455, and allocated by the commissioner of management and budget for this purpose has been deposited in the general fund; provided that this clause does not constitute a pledge of tax revenues as security for the payment of principal and interest on appropriation bonds issued under section 16A.695. To determine aggregate present value, the commissioner of management

35.1 and budget must consult with the commissioner regarding the present value dates, discount
35.2 rate or rates, and schedules of annual amounts. The present value date or dates must be
35.3 based on the date or dates bonds are sold under section 16A.965, or the date or dates
35.4 other state funds, if any, are deposited into the construction fund. The discount rate or
35.5 rates must be based on the true interest cost of the bonds issued under section 16A.965, or
35.6 an equivalent 30-year bond index, as determined by the commissioner of management

80.27 themes to generate a minimum of \$2,100,000 in additional revenue for the fiscal year
80.28 for the general fund.

80.29 **EFFECTIVE DATE.** This section is effective pursuant to the authority granted
80.30 under section 1, on the day following final enactment.

80.31 **Sec. 3. [473J.14] ADMISSIONS TAX.**

80.32 (a) Upon notification by the commissioner of management and budget under section
80.33 16A.1524, the commission shall by resolution impose and maintain a ten percent tax
80.34 on either or both of:

81.1 (1) the gross receipts received for the rental of box seats, suites, sky boxes, and
81.2 similar in the NFL stadium; or

81.3 (2) the granting, issuance, sale, or distribution, by any private or public person,
81.4 association, or corporation, of the privilege of admission to professional sporting events
81.5 at the NFL stadium.

81.6 (b) Each tax must be imposed in the years specified by the commissioner of
81.7 management and budget. The suites rental tax under paragraph (a), clause (1), applies to
81.8 the gross receipts, as defined under section 297A.61, received by the seller, as defined
81.9 in section 297A.61, and is a debt owed by the seller to the commission. The admission
81.10 tax under paragraph (a), clause (2), must be stated and charged separately from the sales
81.11 price so far as practicable and the grantor, seller, or distributor must collect the tax from
81.12 the person admitted and the tax is a debt from that person to the grantor, issuer, seller, or
81.13 distributor, and the tax required to be collected is a debt owed by the grantor, issuer, seller,
81.14 or distributor to the commission. Any tax imposed under this section is recoverable at
81.15 law by the commission from the grantor, issuer, seller, or distributor in the same manner
81.16 as other debts. Every person granting, issuing, selling, or distributing tickets for taxable
81.17 admissions or renting boxes, suites, or similar may be required, as provided in resolutions
81.18 of the commission, to secure a permit, to file returns, to deposit security for the payment
81.19 of the tax, and to pay the penalties for nonpayment and interest on late payments, as the
81.20 commission deems necessary or expedient to assure the prompt and uniform collection of
81.21 either or both of the taxes.

81.22 (c) The commission shall remit the proceeds of any taxes imposed under this section
81.23 to the commissioner of management and budget for deposit in the state's general fund.

81.24 (d) Notwithstanding any other provisions of this section, the imposition of an
81.25 admission tax upon a national superbowl football game conducted at the NFL stadium is
81.26 discretionary with the commission.

81.27 **Sec. 4. [473J.145] MINNEAPOLIS; CONVENTION CENTER TAX**
81.28 **EXTENSION.**

81.29 The taxes under Laws 1986, chapter 396, sections 4 and 5, may be extended by
81.30 order of the commissioner of management and budget beyond the 2047 sunset specified
81.31 under article 3, as an additional source of revenue for repayment of the bonds sold under
81.32 article 2. Any revenues collected from the extension of these taxes through 2048, 2049,
81.33 and 2050 are deposited in the general fund.
