1.20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.21 Section 1. Minnesota Statutes 2014, section 168.012, subdivision 1, is amended to read:

1.22 Subdivision 1. **Vehicles exempt from tax, fees, or plate display.** (a) The following
1.23 vehicles are exempt from the provisions of this chapter requiring payment of tax and
1.24 registration fees, except as provided in subdivision 1c:

1.25 (1) vehicles owned and used solely in the transaction of official business by the
1.26 federal government, the state, or any political subdivision;

1.27 (2) vehicles owned and used exclusively by educational institutions and used solely
1.28 in the transportation of pupils to and from those institutions;

1.29 (3) vehicles used solely in driver education programs at nonpublic high schools;

2.1 (4) vehicles owned by nonprofit charities and used exclusively to transport disabled
2.2 persons for charitable, religious, or educational purposes;

2.3 (5) vehicles owned by nonprofit charities and used exclusively for disaster response
2.4 and related activities;

2.5 (6) vehicles owned by ambulance services licensed under section 144E.10 that
2.6 are equipped and specifically intended for emergency response or providing ambulance
2.7 services; and

2.8 (7) vehicles owned by a commercial driving school licensed under section 171.34,
2.9 or an employee of a commercial driving school licensed under section 171.34, and the
2.10 vehicle is used exclusively for driver education and training.

2.11 (b) Provided the general appearance of the vehicle is unmistakable, the following
2.12 vehicles are not required to register or display number plates:

2.13 (1) vehicles owned by the federal government;

2.14 (2) fire apparatuses, including fire-suppression support vehicles, owned or leased by
2.15 the state or a political subdivision;

2.16 (3) police patrols owned or leased by the state or a political subdivision; and

2.17 (4) ambulances owned or leased by the state or a political subdivision.

2.18 (c) Unmarked vehicles used in general police work, liquor investigations, or arson
2.19 investigations, and passenger automobiles, pickup trucks, and buses owned or operated by
2.20 the Department of Corrections or by conservation officers of the Division of Enforcement
2.21 and Field Service of the Department of Natural Resources, must be registered and must
2.22 display appropriate license number plates, furnished by the registrar at cost. Original and
2.23 renewal applications for these license plates authorized for use in general police work and
2.24 for use by the Department of Corrections or by conservation officers must be accompanied
2.25 by a certification signed by the appropriate chief of police if issued to a police vehicle,
2.26 the appropriate sheriff if issued to a sheriff's vehicle, the commissioner of corrections if
2.27 issued to a Department of Corrections vehicle, or the appropriate officer in charge if
2.28 issued to a vehicle of any other law enforcement agency. The certification must be on a
2.29 form prescribed by the commissioner and state that the vehicle will be used exclusively
2.30 for a purpose authorized by this section.

2.31 (d) Unmarked vehicles used by the Departments of Revenue and Labor and Industry,
2.32 fraud unit, in conducting seizures or criminal investigations must be registered and must
2.33 display passenger vehicle classification license number plates, furnished at cost by the
2.34 registrar. Original and renewal applications for these passenger vehicle license plates
2.35 must be accompanied by a certification signed by the commissioner of revenue or the
2.36 commissioner of labor and industry. The certification must be on a form prescribed by

3.1 the commissioner and state that the vehicles will be used exclusively for the purposes
3.2 authorized by this section.

3.3 (e) Unmarked vehicles used by the Division of Disease Prevention and Control of the
3.4 Department of Health must be registered and must display passenger vehicle classification
3.5 license number plates. These plates must be furnished at cost by the registrar. Original
3.6 and renewal applications for these passenger vehicle license plates must be accompanied
3.7 by a certification signed by the commissioner of health. The certification must be on a
3.8 form prescribed by the commissioner and state that the vehicles will be used exclusively
3.9 for the official duties of the Division of Disease Prevention and Control.

3.10 (f) Unmarked vehicles used by staff of the Gambling Control Board in gambling
3.11 investigations and reviews must be registered and must display passenger vehicle
3.12 classification license number plates. These plates must be furnished at cost by the
3.13 registrar. Original and renewal applications for these passenger vehicle license plates must
3.14 be accompanied by a certification signed by the board chair. The certification must be on a
3.15 form prescribed by the commissioner and state that the vehicles will be used exclusively
3.16 for the official duties of the Gambling Control Board.

3.17 (g) Unmarked vehicles used in general investigation, surveillance, supervision, and
3.18 monitoring by the Department of Human Services' Office of Special Investigations' staff;
3.19 the Minnesota sex offender program's executive director and the executive director's
3.20 staff; and the Office of Inspector General's staff, including, but not limited to, county
3.21 fraud prevention investigators, must be registered and must display passenger vehicle
3.22 classification license number plates, furnished by the registrar at cost. Original and
3.23 renewal applications for passenger vehicle license plates must be accompanied by a
3.24 certification signed by the commissioner of human services. The certification must be on a
3.25 form prescribed by the commissioner and state that the vehicles must be used exclusively
3.26 for the official duties of the Office of Special Investigations' staff; the Minnesota sex
3.27 offender program's executive director and the executive director's staff; and the Office
3.28 of the Inspector General's staff, including, but not limited to, contract and county fraud
3.29 prevention investigators.

3.30 (h) Each state hospital and institution for persons who are mentally ill and
3.31 developmentally disabled may have one vehicle without the required identification on
3.32 the sides of the vehicle. The vehicle must be registered and must display passenger
3.33 vehicle classification license number plates. These plates must be furnished at cost by the
3.34 registrar. Original and renewal applications for these passenger vehicle license plates must
3.35 be accompanied by a certification signed by the hospital administrator. The certification

4.1 must be on a form prescribed by the commissioner and state that the vehicles will be used
4.2 exclusively for the official duties of the state hospital or institution.

4.3 (i) Each county social service agency may have vehicles used for child and
4.4 vulnerable adult protective services without the required identification on the sides of the
4.5 vehicle. The vehicles must be registered and must display passenger vehicle classification
4.6 license number plates. These plates must be furnished at cost by the registrar. Original
4.7 and renewal applications for these passenger vehicle license plates must be accompanied
4.8 by a certification signed by the agency administrator. The certification must be on a form
4.9 prescribed by the commissioner and state that the vehicles will be used exclusively for the
4.10 official duties of the social service agency.

4.11 (j) Unmarked vehicles used in general investigation, surveillance, supervision, and
4.12 monitoring by tobacco inspector staff of the Department of Human Services' Alcohol and
4.13 Drug Abuse Division for the purposes of tobacco inspections, investigations, and reviews
4.14 must be registered and must display passenger vehicle classification license number
4.15 plates, furnished at cost by the registrar. Original and renewal applications for passenger
4.16 vehicle license plates must be accompanied by a certification signed by the commissioner
4.17 of human services. The certification must be on a form prescribed by the commissioner
4.18 and state that the vehicles will be used exclusively by tobacco inspector staff for the
4.19 duties specified in this paragraph.

4.20 (j) (k) All other motor vehicles must be registered and display tax-exempt number
4.21 plates, furnished by the registrar at cost, except as provided in subdivision 1c. All
4.22 vehicles required to display tax-exempt number plates must have the name of the state
4.23 department or political subdivision, nonpublic high school operating a driver education
4.24 program, licensed commercial driving school, or other qualifying organization or entity,
4.25 plainly displayed on both sides of the vehicle. This identification must be in a color
4.26 giving contrast with that of the part of the vehicle on which it is placed and must endure
4.27 throughout the term of the registration. The identification must not be on a removable
4.28 plate or placard and must be kept clean and visible at all times; except that a removable
4.29 plate or placard may be utilized on vehicles leased or loaned to a political subdivision or
4.30 to a nonpublic high school driver education program.

4.31 Sec. 2. Minnesota Statutes 2014, section 245A.035, subdivision 1, is amended to read:

4.32 Subdivision 1. **Emergency placement.** Notwithstanding section 245A.03,
4.33 subdivision 2a, or 245C.13, subdivision 2, a county agency may place a child with a
4.34 relative who is not licensed to provide foster care, provided the requirements of this

5.1 section are met. As used in this section, the term "relative" has the meaning given it under
5.2 section 260C.007, subdivision 26b or 27.

5.3 Sec. 3. Minnesota Statutes 2014, section 245A.035, subdivision 5, is amended to read:

5.4 Subd. 5. **Child foster care license application.** (a) The relatives with whom the
5.5 emergency placement has been made shall complete the child foster care license application
5.6 and necessary paperwork within ten days of the placement. The county agency shall assist
5.7 the applicant to complete the application. The granting of a child foster care license to a
5.8 relative shall be under the procedures in this chapter and according to the standards in
5.9 Minnesota Rules, chapter 2960. In licensing a relative, the commissioner shall consider
5.10 the importance of maintaining the child's relationship with relatives as an additional
5.11 significant factor in determining whether a background study disqualification should be
5.12 set aside under section 245C.22, or a variance should be granted under section 245C.30.

5.13 (b) When the county or private child-placing agency is processing an application
5.14 for child foster care licensure of a relative as defined in section 260B.007, subdivision
5.15 12, or 260C.007, subdivision 26b or 27, the county agency or child-placing agency must
5.16 explain the licensing process to the prospective licensee, including the background study
5.17 process and the procedure for reconsideration of an initial disqualification for licensure.
5.18 The county or private child-placing agency must also provide the prospective relative
5.19 licensee with information regarding appropriate options for legal representation in the
5.20 pertinent geographic area. If a relative is initially disqualified under section 245C.14, the
5.21 commissioner must provide written notice of the reasons for the disqualification and the
5.22 right to request a reconsideration by the commissioner as required under section 245C.17.

5.23 (c) The commissioner shall maintain licensing data so that activities related to
5.24 applications and licensing actions for relative foster care providers may be distinguished
5.25 from other child foster care settings.

5.26 Sec. 4. Minnesota Statutes 2014, section 245C.10, is amended by adding a subdivision
5.27 to read:

5.28 Subd. 1a. **Expenses.** Section 181.645 does not apply to background studies
5.29 completed under this chapter.

5.30 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.31 Sec. 5. Minnesota Statutes 2014, section 245C.22, subdivision 7, is amended to read:

5.32 Subd. 7. **Classification of certain data.** (a) Notwithstanding section 13.46, except
5.33 as provided in paragraph (f), upon setting aside a disqualification under this section, the

6.1 identity of the disqualified individual who received the set-aside and the individual's
6.2 disqualifying characteristics are public data if the set-aside was:

6.3 (1) for any disqualifying characteristic under section 245C.15, when the set-aside
6.4 relates to a child care center or a family child care provider licensed under chapter 245A; or

6.5 (2) for a disqualifying characteristic under section 245C.15, subdivision 2.

6.6 (b) Notwithstanding section 13.46, upon granting a variance to a license holder
6.7 under section 245C.30, the identity of the disqualified individual who is the subject of
6.8 the variance, the individual's disqualifying characteristics under section 245C.15, and the
6.9 terms of the variance are public data, when the variance:

6.10 (1) is issued to a child care center or a family child care provider licensed under
6.11 chapter 245A; or

6.12 (2) relates to an individual with a disqualifying characteristic under section 245C.15,
6.13 subdivision 2.

6.14 (c) The identity of a disqualified individual and the reason for disqualification
6.15 remain private data when:

6.16 (1) a disqualification is not set aside and no variance is granted, except as provided
6.17 under section 13.46, subdivision 4;

6.18 (2) the data are not public under paragraph (a) or (b);

6.19 (3) the disqualification is rescinded because the information relied upon to disqualify
6.20 the individual is incorrect;

6.21 (4) the disqualification relates to a license to provide relative child foster care.

6.22 As used in this clause, "relative" has the meaning given it under section 260C.007,
6.23 subdivision 26b or 27; or

6.24 (5) the disqualified individual is a household member of a licensed foster care
6.25 provider and:

6.26 (i) the disqualified individual previously received foster care services from this
6.27 licensed foster care provider;

6.28 (ii) the disqualified individual was subsequently adopted by this licensed foster
6.29 care provider; and

6.30 (iii) the disqualifying act occurred before the adoption.

6.31 (d) Licensed family child care providers and child care centers must provide notices
6.32 as required under section 245C.301.

6.33 (e) Notwithstanding paragraphs (a) and (b), the identity of household members who
6.34 are the subject of a disqualification related set-aside or variance is not public data if:

6.35 (1) the household member resides in the residence where the family child care is
6.36 provided;

7.1 (2) the subject of the set-aside or variance is under the age of 18 years; and

7.2 (3) the set-aside or variance only relates to a disqualification under section 245C.15,
7.3 subdivision 4, for a misdemeanor-level theft crime as defined in section 609.52.

7.4 (f) When the commissioner has reason to know that a disqualified individual has
7.5 received an order for expungement for the disqualifying record that does not limit the
7.6 commissioner's access to the record, and the record was opened or exchanged with the
7.7 commissioner for purposes of a background study under this chapter, the data that would
7.8 otherwise become public under paragraph (a) or (b) remain private data.

7.9 Sec. 6. Minnesota Statutes 2014, section 253B.212, is amended by adding a
7.10 subdivision to read:

7.11 Subd. 1b. **Cost of care; commitment by tribal court order; any federally**
7.12 **recognized Indian tribe within the state of Minnesota.** The commissioner of human
7.13 services may contract with and receive payment from the Indian Health Service of the
7.14 United States Department of Health and Human Services for the care and treatment of
7.15 those members of any federally recognized Indian tribe within the state, who have been
7.16 committed by tribal court order to the Indian Health Service for care and treatment of
7.17 mental illness, developmental disability, or chemical dependency. The tribe may also
7.18 contract directly with the commissioner for treatment of those members of any federally
7.19 recognized Indian tribe within the state who have been committed by tribal court order
7.20 to the respective tribal Department of Health for care and treatment of mental illness,
7.21 developmental disability, or chemical dependency. The contract shall provide that the
7.22 Indian Health Service and any federally recognized Indian tribe within the state shall not
7.23 transfer any person for admission to a regional center unless the commitment procedure
7.24 utilized by the tribal court provided due process protections similar to those afforded
7.25 by sections 253B.05 to 253B.10.

7.26 Sec. 7. Minnesota Statutes 2014, section 253B.212, subdivision 2, is amended to read:

7.27 **Subd. 2. Effect given to tribal commitment order.** When, under an agreement
7.28 entered into pursuant to subdivisions 1 ~~or~~ 1a, or 1b, the Indian Health Service or the
7.29 placing tribe applies to a regional center for admission of a person committed to the
7.30 jurisdiction of the health service by the tribal court as a person who is mentally ill,
7.31 developmentally disabled, or chemically dependent, the commissioner may treat the
7.32 patient with the consent of the Indian Health Service or the placing tribe.

7.33 A person admitted to a regional center pursuant to this section has all the rights
7.34 accorded by section 253B.03. In addition, treatment reports, prepared in accordance with

8.1 the requirements of section 253B.12, subdivision 1, shall be filed with the Indian Health
 8.2 Service or the placing tribe within 60 days of commencement of the patient's stay at the
 8.3 facility. A subsequent treatment report shall be filed with the Indian Health Service or
 8.4 the placing tribe within six months of the patient's admission to the facility or prior to
 8.5 discharge, whichever comes first. Provisional discharge or transfer of the patient may be
 8.6 authorized by the head of the treatment facility only with the consent of the Indian Health
 8.7 Service or the placing tribe. Discharge from the facility to the Indian Health Service or the
 8.8 placing tribe may be authorized by the head of the treatment facility after notice to and
 8.9 consultation with the Indian Health Service or the placing tribe.

8.10 Sec. 8. **[256.041] CULTURAL AND ETHNIC COMMUNITIES LEADERSHIP**
 8.11 **COUNCIL.**

8.12 Subdivision 1. **Establishment; purpose.** There is hereby established the Cultural
 8.13 and Ethnic Communities Leadership Council for the Department of Human Services. The
 8.14 purpose of the council is to advise the commissioner of human services on reducing
 8.15 disparities that affect racial and ethnic groups.

8.16 Subd. 2. **Members.** (a) The council must consist of:

8.17 (1) the chairs and ranking minority members of the committees in the house of
 8.18 representatives and the senate with jurisdiction over human services; and

8.19 (2) no fewer than 15 and no more than 25 members appointed by and serving at
 8.20 the pleasure of the commissioner of human services, in consultation with county, tribal,
 8.21 cultural, and ethnic communities; diverse program participants; and parent representatives
 8.22 from these communities.

8.23 (b) In making appointments under this section, the commissioner shall give priority
 8.24 consideration to public members of the legislative councils of color established under
 8.25 chapter 3.

8.26 (c) Members must be appointed to allow for representation of the following groups:

8.27 (1) racial and ethnic minority groups;

8.28 (2) the American Indian community, which must be represented by two members;

8.29 (3) culturally and linguistically specific advocacy groups and service providers;

8.30 (4) human services program participants;

8.31 (5) public and private institutions;

8.32 (6) parents of human services program participants;

8.33 (7) members of the faith community;

8.34 (8) Department of Human Services employees; and

9.1 (9) any other group the commissioner deems appropriate to facilitate the goals
9.2 and duties of the council.

9.3 Subd. 3. **Guidelines.** The commissioner shall direct the development of guidelines
9.4 defining the membership of the council; setting out definitions; and developing duties of
9.5 the commissioner, the council, and council members regarding racial and ethnic disparities
9.6 reduction. The guidelines must be developed in consultation with:

9.7 (1) the chairs of relevant committees; and

9.8 (2) county, tribal, and cultural communities and program participants from these
9.9 communities.

9.10 Subd. 4. **Chair.** The commissioner shall appoint a chair.

9.11 Subd. 5. **Terms for first appointees.** The initial members appointed shall serve
9.12 until January 15, 2016.

9.13 Subd. 6. **Terms.** A term shall be for two years and appointees may be reappointed
9.14 to serve two additional terms. The commissioner shall make appointments to replace
9.15 members vacating their positions by January 15 of each year.

9.16 Subd. 7. **Duties of commissioner.** (a) The commissioner of human services or the
9.17 commissioner's designee shall:

9.18 (1) maintain the council established in this section;

9.19 (2) supervise and coordinate policies for persons from racial, ethnic, cultural,
9.20 linguistic, and tribal communities who experience disparities in access and outcomes;

9.21 (3) identify human services rules or statutes affecting persons from racial, ethnic,
9.22 cultural, linguistic, and tribal communities that may need to be revised;

9.23 (4) investigate and implement cost-effective models of service delivery such as
9.24 careful adaptation of clinically proven services that constitute one strategy for increasing the
9.25 number of culturally relevant services available to currently underserved populations; and

9.26 (5) based on recommendations of the council, review identified department
9.27 policies that maintain racial, ethnic, cultural, linguistic, and tribal disparities, and make
9.28 adjustments to ensure those disparities are not perpetuated.

9.29 (b) The commissioner of human services or the commissioner's designee shall
9.30 consult with the council and receive recommendations from the council when meeting the
9.31 requirements in this subdivision.

9.32 Subd. 8. **Duties of council.** The council shall:

9.33 (1) recommend to the commissioner for review identified policies in the Department
9.34 of Human Services that maintain racial, ethnic, cultural, linguistic, and tribal disparities;

9.35 (2) identify issues regarding disparities by engaging diverse populations in human
9.36 services programs;

10.1 (3) engage in mutual learning essential for achieving human services parity and
10.2 optimal wellness for service recipients;

10.3 (4) raise awareness about human services disparities to the legislature and media;

10.4 (5) provide technical assistance and consultation support to counties, private
10.5 nonprofit agencies, and other service providers to build their capacity to provide equitable
10.6 human services for persons from racial, ethnic, cultural, linguistic, and tribal communities
10.7 who experience disparities in access and outcomes;

10.8 (6) provide technical assistance to promote statewide development of culturally
10.9 and linguistically appropriate, accessible, and cost-effective human services and related
10.10 policies;

10.11 (7) provide training and outreach to facilitate access to culturally and linguistically
10.12 appropriate, accessible, and cost-effective human services to prevent disparities;

10.13 (8) facilitate culturally appropriate and culturally sensitive admissions, continued
10.14 services, discharges, and utilization review for human services agencies and institutions;

10.15 (9) form work groups to help carry out the duties of the council that include, but are
10.16 not limited to, persons who provide and receive services and representatives of advocacy
10.17 groups, and provide the work groups with clear guidelines, standardized parameters, and
10.18 tasks for the work groups to accomplish;

10.19 (10) promote information sharing in the human services community and statewide;
10.20 and

10.21 (11) by February 15 each year, prepare and submit to the chairs and ranking minority
10.22 members of the committees in the house of representatives and the senate with jurisdiction
10.23 over human services a report that summarizes the activities of the council, identifies
10.24 the major problems and issues confronting racial and ethnic groups in accessing human
10.25 services, makes recommendations to address issues, and lists the specific objectives that
10.26 the council seeks to attain during the next biennium. The report must also include a list of
10.27 programs, groups, and grants used to reduce disparities, and statistically valid reports of
10.28 outcomes on the reduction of the disparities.

10.29 Subd. 9. **Duties of council members.** The members of the council shall:

10.30 (1) attend and participate in scheduled meetings and be prepared by reviewing
10.31 meeting notes;

10.32 (2) maintain open communication channels with respective constituencies;

10.33 (3) identify and communicate issues and risks that could impact the timely
10.34 completion of tasks;

10.35 (4) collaborate on disparity reduction efforts;

11.1 (5) communicate updates of the council's work progress and status on the
11.2 Department of Human Services Web site; and

11.3 (6) participate in any activities the council or chair deems appropriate and necessary
11.4 to facilitate the goals and duties of the council.

11.5 Subd. 10. **Expiration.** The council expires on June 30, 2020.

11.6 **EFFECTIVE DATE.** This section is effective retroactively from March 15, 2015.

11.7 Sec. 9. Minnesota Statutes 2014, section 256B.0625, is amended by adding a
11.8 subdivision to read:

11.9 Subd. 17b. **Documentation required.** (a) As a condition for payment,
11.10 nonemergency medical transportation providers must document each occurrence of a
11.11 service provided to a recipient according to this subdivision. Providers must maintain
11.12 odometer and other records sufficient to distinguish individual trips with specific vehicles
11.13 and drivers. The documentation may be maintained in an electronic or paper form but
11.14 must be made available and produced upon request. Program funds paid for transportation
11.15 that is not documented according to this subdivision shall be recovered by the department.

11.16 (b) A nonemergency medical transportation provider must compile transportation
11.17 records that meet the following requirements:

39.35 **MEDICAL SUPPLIES AND EQUIPMENT.**

40.1 (a) The commissioner of human services shall amend Minnesota Rules, part
40.2 9505.0310, subpart 3, to remove the following medical supplies and equipment from the
40.3 list for which prior authorization is required as a condition of medical assistance payment:
40.4 a nondurable medical supply that costs more than the performance agreement limit;
40.5 and durable medical equipment, prostheses, and orthoses if the cost of their purchase,
40.6 projected cumulative rental for the period of the recipient's expected use, or repairs
40.7 exceeds the performance agreement limit.

40.8 (b) The commissioner of human services shall amend Minnesota Rules, part
40.9 9505.0365, subpart 3, to remove the requirement that prior authorization for an ambulatory
40.10 aid is required for an aid that costs in excess of the limits specified in the provider's
40.11 performance agreement.

40.12 (c) The commissioner may use the good cause exemption in Minnesota Statutes,
40.13 section 14.388, subdivision 1, clause (3), to adopt rules under this section. Minnesota
40.14 Statutes, section 14.386, does not apply except as provided in Minnesota Statutes, section
40.15 14.388.
