1.16 **CRIMINAL JUSTICE-RELATED DATA PRACTICES**

1.17 Section 1. Minnesota Statutes 2016, section 171.306, subdivision 1, is amended to read:

1.18 Subdivision 1. **Definitions.** (a) As used in this section, the terms in this subdivision have

1.19 the meanings given them.

1.20 (b) "Ignition interlock device" or "device" means equipment that is designed to measure

1.21 breath alcohol concentration and to prevent a motor vehicle's ignition from being started

1.22 by a person whose breath alcohol concentration measures 0.02 or higher on the equipment.

1.23 (c) "Location tracking capabilities" means the ability of an electronic or wireless device

1.24 to identify and transmit its geographic location through the operation of the device.

1.25 ~~(e)~~(d) "Program participant" means a person who has qualified to take part in the ignition

1.26 interlock program under this section, and whose driver's license has been:

2.1 (1) revoked, canceled, or denied under section 169A.52, 169A.54, or 171.04, subdivision
2.2 1, clause (10); or

2.3 (2) revoked under section 171.17, subdivision 1, paragraph (a), clause (1), or suspended
2.4 under section 171.187, for a violation of section 609.2113, subdivision 1, clause (2), item
2.5 (i) or (iii), (3), or (4); subdivision 2, clause (2), item (i) or (iii), (3), or (4); or subdivision
2.6 3, clause (2), item (i) or (iii), (3), or (4); or 609.2114, subdivision 2, clause (2), item (i) or
2.7 (iii), (3), or (4), resulting in bodily harm, substantial bodily harm, or great bodily harm.

2.8 ~~(d)~~ (e) "Qualified prior impaired driving incident" has the meaning given in section
2.9 169A.03, subdivision 22.

2.10 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.11 Sec. 2. Minnesota Statutes 2016, section 171.306, subdivision 2, is amended to read:

2.12 Subd. 2. **Performance standards; certification; manufacturer and provider**
2.13 **requirements.** (a) The commissioner shall establish performance standards and a process
2.14 for certifying devices used in the ignition interlock program, except that the commissioner
2.15 may not establish standards that, directly or indirectly, require devices to use or enable
2.16 location tracking capabilities without a court order.

2.17 (b) The manufacturer of a device must apply annually for certification of the device by
2.18 submitting the form prescribed by the commissioner. The commissioner shall require
2.19 manufacturers of certified devices to:

2.20 (1) provide device installation, servicing, and monitoring to indigent program participants
2.21 at a discounted rate, according to the standards established by the commissioner; and

2.22 (2) include in an ignition interlock device contract a provision that a program participant
2.23 who voluntarily terminates participation in the program is only liable for servicing and
2.24 monitoring costs incurred during the time the device is installed on the motor vehicle,
2.25 regardless of whether the term of the contract has expired.

2.26 (c) The manufacturer of a certified device must include with an ignition interlock device
2.27 contract a separate notice to the program participant regarding any location tracking
2.28 capabilities of the device.

2.29 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.5 agreed to abide by the program guidelines.

3.6 (b) The commissioner must enter a notation on a person's driving record to indicate that
3.7 the person is a program participant.

3.8 (c) A person under the age of 18 years is not eligible to be a program participant.

3.9 (d) A program participant shall pay costs associated with an ignition interlock device
3.10 on every motor vehicle that the participant operates or intends to operate.

3.11 (e) A program participant shall participate in any treatment recommended in a chemical
3.12 use assessment report.

3.13 (f) A program participant shall bring the device-equipped motor vehicle or vehicles
3.14 operated by the program participant to an approved service provider for device calibration
3.15 and servicing according to the schedule established by the commissioner and as indicated
3.16 by the ignition interlock device.

3.17 (g) The commissioner shall not permit location tracking capabilities on any ignition
3.18 interlock device to be enabled except as provided in this paragraph. The commissioner shall
3.19 require the activation of location tracking capabilities on an ignition interlock device when
3.20 ordered by a court.

5.2 (cancellation); 171.16 (court may recommend suspension); 171.165 (commercial driver's

8.8 for test failure or refusal), a person may petition the court for review. The petition must be
8.9 filed with the district court administrator in the county where the alleged offense occurred,
8.10 together with proof of service of a copy on the commissioner, and accompanied by the
8.11 standard filing fee for civil actions. Responsive pleading is not required of the commissioner,
8.12 and court fees must not be charged for the appearance of the commissioner in the matter.

8.25 that prehearing discovery is mandatory and is limited to:

8.27 (2) the test record or, in the case of blood or urine tests, the certificate of analysis;

9.4 Subd. 3. **Judicial hearing; issues, order, appeal.** (a) A judicial review hearing under
9.5 this section must be before a district judge in any county in the judicial district where the
9.6 alleged offense occurred. The hearing is to the court and may be conducted at the same time
9.7 and in the same manner as hearings upon pretrial motions in the criminal prosecution under
9.8 section 169A.20 (driving while impaired), if any. The hearing must be recorded. The
9.9 commissioner shall appear and be represented by the attorney general or through the
9.10 prosecuting authority for the jurisdiction involved. The hearing must be held at the earliest
9.11 practicable date, and in any event no later than 60 days following the filing of the petition
9.12 for review. The judicial district administrator shall establish procedures to ensure efficient
9.13 compliance with this subdivision. To accomplish this, the administrator may, whenever

9.25 (5) If the screening test was administered, did the test indicate an alcohol concentration
9.26 of 0.08 or more?

9.27 (6) At the time of the request for the test, did the peace officer inform the person of the
9.28 person's rights and the consequences of taking or refusing the test as required by section
9.29 169A.51, subdivision 2?

9.30 (7) Did the person refuse to permit the test?

9.31 (8) If a test was taken by a person driving, operating, or in physical control of a motor
9.32 vehicle, did the test results indicate at the time of testing:

- 10.1 (i) an alcohol concentration of 0.08 or more; or
- 10.2 (ii) the presence of a controlled substance listed in Schedule I or II or its metabolite,
10.3 other than marijuana or tetrahydrocannabinols?
- 10.4 (9) If a test was taken by a person driving, operating, or in physical control of a
10.5 commercial motor vehicle, did the test results indicate an alcohol concentration of 0.04 or
10.6 more at the time of testing?
- 10.7 (10) Was the testing method used valid and reliable and were the test results accurately
10.8 evaluated?
- 10.9 (11) Did the person prove the defense of necessity?
- 10.10 (12) Did the person prove the defense of controlled substance use in accordance with a
10.11 prescription?
- 10.12 (c) It is an affirmative defense for the petitioner to prove that, at the time of the refusal,
10.13 the petitioner's refusal to permit the test was based upon reasonable grounds.
- 10.14 (d) Certified or otherwise authenticated copies of laboratory or medical personnel reports,
10.15 records, documents, licenses, and certificates are admissible as substantive evidence.
- 10.16 (e) The court shall order that the revocation or disqualification be either rescinded or
10.17 sustained and forward the order to the commissioner. The court shall file its order within
10.18 14 days following the hearing. If the revocation or disqualification is sustained, the court
10.19 shall also forward the person's driver's license or permit to the commissioner for further
10.20 action by the commissioner if the license or permit is not already in the commissioner's
10.21 possession.
- 10.22 (f) Any party aggrieved by the decision of the reviewing court may appeal the decision
10.23 as provided in the Rules of Appellate Procedure.
- 10.24 (g) The civil hearing under this section shall not give rise to an estoppel on any issues
10.25 arising from the same set of circumstances in any criminal prosecution.
- 10.26 (h) It is an affirmative defense for the petitioner to prove a necessity.

11.7 who does not have a qualified prior impaired driving incident, is subject to the mandatory
11.8 revocation provisions of subdivision 1, clause (1) or (2), in lieu of the mandatory revocation
11.9 provisions of section 169A.52 or 171.177.

11.10 (b) Paragraph (a) does not apply to:

19.4 records, documents, licenses, and certificates are admissible as substantive evidence.

19.6 sustained and forward the order to the commissioner. The court shall file its order within
19.7 14 days following the hearing. If the revocation or disqualification is sustained, the court

(3) the person has refused to take the preliminary screening test provided for in section 97B.065, subdivision 3; or

(4) the screening test was administered and indicated an alcohol concentration of 0.08 or more.

(c) Taking or submitting to a test of the person's blood or urine is mandatory when requested by a peace officer under the conditions described in paragraph (b) if the officer is acting pursuant to a search warrant under sections 626.04 to 626.18.

EFFECTIVE DATE. This section is effective July 1, 2017, and applies to acts committed on or after that date.

Sec. 2. Minnesota Statutes 2016, section 97B.066, is amended by adding a subdivision to read:

Subd. 1a. **Blood or urine test; search warrant required.** Notwithstanding any contrary provision in this section, a blood or urine test may be conducted only pursuant to a search warrant under sections 626.04 to 626.18, or a judicially recognized exception to the search
