1.16 Section 1. Minnesota Statutes 2018, section 256I.03, subdivision 3, is amended to read:

1.17 Subd. 3. **Housing support.** "Housing support" means ~~a group living situation~~ assistance

1.18 that provides at a minimum room and board to ~~unrelated~~ persons who meet the eligibility

1.19 requirements of section 256I.04. To receive payment for ~~a group residence rate~~ housing

1.20 support, the residence must meet the requirements under section 256I.04, subdivisions 2a

1.21 to 2f.

1.22 Sec. 2. Minnesota Statutes 2018, section 256I.03, subdivision 8, is amended to read:

1.23 Subd. 8. **Supplementary services.** "Supplementary services" means housing support

1.24 services provided to individuals in addition to room and board including, but not limited

1.25 to, oversight and up to 24-hour supervision, medication reminders, assistance with

2.1 transportation, arranging for meetings and appointments, ~~and~~ arranging for medical and
2.2 social services, and services identified in section 256I.03, subdivision 12.

2.3 Sec. 3. Minnesota Statutes 2018, section 256I.03, subdivision 15, is amended to read:

2.4 Subd. 15. **Supportive housing.** "Supportive housing" means housing ~~with support~~
2.5 ~~services according to the continuum of care coordinated assessment system established~~
2.6 ~~under Code of Federal Regulations, title 24, section 578.3~~ where people receive services
2.7 necessary to maintain housing stability and where the duration of stay is at the person's
2.8 choice.

2.9 Sec. 4. Minnesota Statutes 2018, section 256I.04, subdivision 1, is amended to read:

2.10 Subdivision 1. **Individual eligibility requirements.** An individual is eligible for and
2.11 entitled to a housing support payment to be made on the individual's behalf if the agency
2.12 has approved the setting where the individual will receive housing support and the individual
2.13 meets the requirements in paragraph (a), (b), or (c).

2.14 (a) The individual is aged, blind, or is over 18 years of age with a disability as determined
2.15 under the criteria used by the title II program of the Social Security Act, and meets the
2.16 resource restrictions and standards of section 256P.02, and the individual's countable income
2.17 after deducting the (1) exclusions and disregards of the SSI program, (2) the medical
2.18 assistance personal needs allowance under section 256B.35, and (3) an amount equal to the
2.19 income actually made available to a community spouse by an elderly waiver participant
2.20 under the provisions of sections 256B.0575, paragraph (a), clause (4), and 256B.058,
2.21 subdivision 2, is less than the monthly rate specified in the agency's agreement with the
2.22 provider of housing support in which the individual resides.

2.23 (b) The individual meets a category of eligibility under section 256D.05, subdivision 1,
2.24 paragraph (a), clauses (1), (3), (4) to (8), and (13), and paragraph (b), if applicable, and the
2.25 individual's resources are less than the standards specified by section 256P.02, and the
2.26 individual's countable income as determined under section 256P.06, less the medical
2.27 assistance personal needs allowance under section 256B.35 is less than the monthly rate
2.28 specified in the agency's agreement with the provider of housing support in which the
2.29 individual resides.

2.30 (c) The individual receives licensed residential crisis stabilization services under section
2.31 256B.0624, subdivision 7, and is receiving medical assistance. The individual may receive
2.32 concurrent housing support payments if receiving licensed residential crisis stabilization
2.33 services under section 256B.0624, subdivision 7.

3.1 (d) An individual who receives ongoing rental subsidies is not eligible for housing
3.2 support payments under paragraph (a) or (b).

3.3 Sec. 5. Minnesota Statutes 2018, section 256I.04, subdivision 2a, is amended to read:

3.4 Subd. 2a. **License required; staffing qualifications.** (a) Except as provided in paragraph
3.5 (b), an agency may not enter into an agreement with an establishment to provide housing
3.6 support unless:

3.7 (1) the establishment is licensed by the Department of Health as a hotel and restaurant;
3.8 a board and lodging establishment; a boarding care home before March 1, 1985; or a
3.9 supervised living facility, and the service provider for residents of the facility is licensed
3.10 under chapter 245A. However, an establishment licensed by the Department of Health to
3.11 provide lodging need not also be licensed to provide board if meals are being supplied to
3.12 residents under a contract with a food vendor who is licensed by the Department of Health;

3.13 (2) the residence is: (i) licensed by the commissioner of human services under Minnesota
3.14 Rules, parts 9555.5050 to 9555.6265; (ii) certified by a county human services agency prior
3.15 to July 1, 1992, using the standards under Minnesota Rules, parts 9555.5050 to 9555.6265;
3.16 (iii) licensed by the commissioner under Minnesota Rules, parts 2960.0010 to 2960.0120,
3.17 with a variance under section 245A.04, subdivision 9; or (iv) licensed under section 245D.02,
3.18 subdivision 4a, as a community residential setting by the commissioner of human services;
3.19 or

3.20 (3) the establishment is registered under chapter 144D and provides three meals a day.

3.21 (b) The requirements under paragraph (a) do not apply to establishments exempt from
3.22 state licensure because they are:

3.23 (1) located on Indian reservations and subject to tribal health and safety requirements;

3.25 ~~(2) a supportive housing establishment that has an approved habitability inspection and~~
3.26 ~~an individual lease agreement and that serves people who have experienced long-term~~

3.31 (c) Supportive housing establishments that serve individuals who have experienced
3.32 long-term homelessness and emergency shelters must participate in the homeless management
3.33 information system and a coordinated assessment system as defined by the commissioner.

4.1 (d) Effective July 1, 2016, an agency shall not have an agreement with a provider of
4.2 housing support unless all staff members who have direct contact with recipients:

4.3 (1) have skills and knowledge acquired through one or more of the following:

4.4 (i) a course of study in a health- or human services-related field leading to a bachelor
4.5 of arts, bachelor of science, or associate's degree;

4.6 (ii) one year of experience with the target population served;

4.7 (iii) experience as a mental health certified peer specialist according to section 256B.0615;

4.8 or

4.9 (iv) meeting the requirements for unlicensed personnel under sections 144A.43 to
4.10 144A.483;

4.11 (2) hold a current driver's license appropriate to the vehicle driven if transporting
4.12 recipients;

4.13 (3) complete training on vulnerable adults mandated reporting and child maltreatment
4.14 mandated reporting, where applicable; and

4.15 (4) complete housing support orientation training offered by the commissioner.

4.16 Sec. 6. Minnesota Statutes 2018, section 256I.04, subdivision 2b, is amended to read:

4.17 Subd. 2b. **Housing support agreements.** (a) Agreements between agencies and providers
4.18 of housing support must be in writing on a form developed and approved by the commissioner
4.19 and must specify the name and address under which the establishment subject to the
4.20 agreement does business and under which the establishment, or service provider, if different
4.21 from the ~~group residential housing~~ establishment, is licensed by the Department of Health
4.22 or the Department of Human Services; the specific license or registration from the
4.23 Department of Health or the Department of Human Services held by the provider and the
4.24 number of beds subject to that license; the address of the location or locations at which
4.25 ~~group residential housing support~~ is provided under this agreement; the per diem and monthly
4.26 rates that are to be paid from housing support funds for each eligible resident at each location;
4.27 the number of beds at each location which are subject to the agreement; whether the license
4.28 holder is a not-for-profit corporation under section 501(c)(3) of the Internal Revenue Code;
4.29 and a statement that the agreement is subject to the provisions of sections 256I.01 to 256I.06
4.30 and subject to any changes to those sections.

4.31 (b) Providers are required to verify the following minimum requirements in the
4.32 agreement:

- 5.1 (1) current license or registration, including authorization if managing or monitoring
5.2 medications;
- 5.3 (2) all staff who have direct contact with recipients meet the staff qualifications;
- 5.4 (3) the provision of housing support;
- 5.5 (4) the provision of supplementary services, if applicable;
- 5.6 (5) reports of adverse events, including recipient death or serious injury; ~~and~~
- 5.7 (6) submission of residency requirements that could result in recipient eviction; and
- 5.8 (7) that the provider complies with the prohibition on limiting or restricting the number
5.9 of hours an applicant or recipient is employed, as specified in subdivision 5.

5.10 (c) Agreements may be terminated with or without cause by the commissioner, the
5.11 agency, or the provider with two calendar months prior notice. The commissioner may
5.12 immediately terminate an agreement under subdivision 2d.

5.15 Subd. 2h. **Required supplementary services.** A provider of supplementary services
5.16 shall ensure that a recipient has, at a minimum, assistance with services as identified in the

5.18 of supplementary services shall maintain case notes with the date and description of services
5.19 provided to each recipient.

5.22 Subd. 5. **Employment.** A provider is prohibited from limiting or restricting the number
5.23 of hours an applicant or recipient is employed.

5.25 Subd. 1c. **Rate increases.** An agency may not increase the rates negotiated for housing
5.26 support above those in effect on June 30, 1993, except as provided in paragraphs (a) to (f).

5.27 (a) An agency may increase the rates for room and board to the MSA equivalent rate
5.28 for those settings whose current rate is below the MSA equivalent rate.

5.29 (b) An agency may increase the rates for residents in adult foster care whose difficulty
5.30 of care has increased. The total housing support rate for these residents must not exceed the

6.1 maximum rate specified in subdivisions 1 and 1a. Agencies must not include nor increase
6.2 difficulty of care rates for adults in foster care whose difficulty of care is eligible for funding
6.3 by home and community-based waiver programs under title XIX of the Social Security Act.

6.4 (c) The room and board rates will be increased each year when the MSA equivalent rate
6.5 is adjusted for SSI cost-of-living increases by the amount of the annual SSI increase, less
6.6 the amount of the increase in the medical assistance personal needs allowance under section
6.7 256B.35.

6.8 (d) When housing support pays for an individual's room and board, or other costs
6.9 necessary to provide room and board, the rate payable to the residence must continue for
6.10 up to 18 calendar days per incident that the person is temporarily absent from the residence,
6.11 not to exceed 60 days in a calendar year, if the absence or absences ~~have received the prior~~
6.12 ~~approval of~~ are reported in advance to the county agency's social service staff. Prior approval
6.13 Advance reporting is not required for emergency absences due to crisis, illness, or injury.

6.14 (e) For facilities meeting substantial change criteria within the prior year. Substantial
6.15 change criteria exists if the establishment experiences a 25 percent increase or decrease in
6.16 the total number of its beds, if the net cost of capital additions or improvements is in excess
6.17 of 15 percent of the current market value of the residence, or if the residence physically
6.18 moves, or changes its licensure, and incurs a resulting increase in operation and property
6.19 costs.

6.20 (f) Until June 30, 1994, an agency may increase by up to five percent the total rate paid
6.21 for recipients of assistance under sections 256D.01 to 256D.21 or 256D.33 to 256D.54 who
6.22 reside in residences that are licensed by the commissioner of health as a boarding care home,
6.23 but are not certified for the purposes of the medical assistance program. However, an increase
6.24 under this clause must not exceed an amount equivalent to 65 percent of the 1991 medical
6.25 assistance reimbursement rate for nursing home resident class A, in the geographic grouping
6.26 in which the facility is located, as established under Minnesota Rules, parts 9549.0051 to
6.27 9549.0058.

6.29 Subd. 1n. **Supplemental rate; Mahnomen County.** Notwithstanding the provisions of

7.23 or treatment of a substance use disorder. An individual remains a client until the license
7.24 holder no longer provides or intends to provide the individual with treatment service. Client
7.25 also includes the meaning of patient under section 144.651, subdivision 2.

7.26 Sec. 2. Minnesota Statutes 2018, section 245G.01, is amended by adding a subdivision to
7.27 read:

7.28 Subd. 8a. **Client education group.** "Client education group" means gatherings designed
7.29 to teach clients about substance abuse, related behaviors, and consequences and present
7.30 structured, group-specific content to expand awareness of the behavioral, medical, and

8.1 psychological consequences of a substance use disorder and to help clients incorporate
8.2 information to establish and maintain recovery.

8.3 Sec. 3. Minnesota Statutes 2018, section 245G.01, is amended by adding a subdivision to

8.5 Subd. 10a. **Day of service initiation.** "Day of service initiation" means the day the
8.6 license holder begins the provision of a treatment service identified in section 245G.07.

8.20 informed choices about the client's own goals, objectives, and the services the client receives
8.21 in collaboration with the client's identified natural supports.

8.24 Subd. 20b. **Staff or staff member.** "Staff" or "staff member" means an individual who

10.5 counselor within three calendar days ~~after~~ from the day of service initiation for a residential

10.20 include sufficient information to complete the assessment summary according to subdivision
10.21 2 and the individual treatment plan according to section 245G.06. The comprehensive
10.22 assessment must include information about the client's needs that relate to substance use
10.23 and personal strengths that support recovery, including:

10.24 (1) age, sex, cultural background, sexual orientation, living situation, economic status,
10.25 and level of education;

10.26 (2) a description of the circumstances on the day of service initiation;

10.27 (3) a list of previous attempts at treatment for substance misuse or substance use disorder,

256I.05 MONTHLY RATES.

Subd. 3. **Limits on rates.** When a room and board rate is used to pay for an individual's room and board, the rate payable to the residence must not exceed the rate paid by an individual not receiving a room and board rate under this chapter.
