Section 1. Minnesota Statutes 2010, section 182.666, subdivision 1, is amended to read: Subdivision 1. Willful or repeated violations. Any employer who willfully or repeatedly violates the requirements of section 182.653, or any standard, rule, or order adopted under the authority of the commissioner as provided in this chapter, may be assessed a fine not to exceed \$70,000 for each violation. The minimum fine for a willful violation is \$5,000. In addition, notwithstanding section 182.671 or any other law to the contrary, the employer shall be liable for damages to a seriously injured employee or legal representative or, if death results from the injury, the employee's heirs or next of kin where the violation was a major contributing cause of the injury or death. A recovery under this subdivision must be reduced by any benefits paid or payable under chapter 176. For purposes of this subdivision, "serious injury" means an injury that causes: (1) more than \$200,000 in medical expenses for its cure and relief; or
