1.2 relating to human services; modifying nonemergency medical transportation
1.3 services provisions; amending Minnesota Statutes 2012, section 256B.0625,
1.4 subdivisions 17a, 18a, 18b, 18c, 18d, 18g; Minnesota Statutes 2013 Supplement,
1.5 section 256B.0625, subdivisions 17, 18e; repealing Minnesota Statutes 2013
1.6 Supplement, section 256B.0625, subdivision 18f.

1.7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.8 Section 1. Minnesota Statutes 2013 Supplement, section 256B.0625, subdivision 17,
1.9 is amended to read:

1.10 Subd. 17. **Transportation costs.** (a) "Nonemergency medical transportation
1.11 service" means motor vehicle transportation provided by a public or private person
1.12 that serves Minnesota health care program beneficiaries who do not require emergency
1.13 ambulance service, as defined in section 144E.001, subdivision 3, to obtain covered
1.14 medical services. Nonemergency medical transportation service includes, but is not
1.15 limited to, service provided by specially equipped buses, vans, taxis, and volunteers
1.16 driving private automobiles as provided for in section 174.29, subdivision 1.

1.17 ~~(a)~~ (b) Medical assistance covers medical transportation costs incurred solely for
1.18 obtaining emergency medical care or transportation costs incurred by eligible persons in
1.19 obtaining emergency or nonemergency medical care when paid directly to an ambulance
1.20 company, common carrier, or other recognized providers of transportation services.

1.21 Medical transportation must be provided by:

1.22 (1) ~~an ambulance~~ nonemergency medical transportation providers who meet the
1.23 requirements of this subdivision;

1.24 (2) ambulances, as defined in section 144E.001, subdivision 2;

1.25 ~~(2) special transportation; or~~

2.1 (3) ~~common carrier including, but not limited to, bus, taxicab, other commercial~~
2.2 ~~carrier, or private automobile~~ public transit, as defined in section 174.22, subdivision 7; or

2.3 (4) not-for-hire vehicle, including volunteer drivers.

2.4 ~~(b) (c) Medical assistance covers special transportation, as defined in Minnesota~~
2.5 ~~Rules, part 9505.0315, subpart 1, item F, if the recipient has a physical or mental~~
2.6 ~~impairment that would prohibit the recipient from safely accessing and using a bus,~~
2.7 ~~taxi, other commercial transportation, or private automobile.~~ nonemergency medical
2.8 transportation provided by nonemergency medical transportation providers enrolled in
2.9 the Minnesota health care programs. All nonemergency medical transportation providers
2.10 must comply with the operating standards for special transportation service as defined in
2.11 sections 174.29 to 174.30 and all applicable Minnesota Rules, and in consultation with
2.12 the Minnesota Department of Transportation. All nonemergency medical transportation
2.13 providers shall bill for nonemergency medical transportation services in accordance with
2.14 Minnesota health care programs criteria. Publicly operated transit systems, volunteers,
2.15 and not-for-hire vehicles are exempt from the requirements outlined in this paragraph
2.16 and paragraph (b).

2.17 (d) The administrative agency of nonemergency medical transportation must:

2.18 (1) adhere to the policies defined by the commissioner in consultation with the
2.19 Nonemergency Medical Transportation Advisory Committee;

2.20 (2) pay nonemergency medical transportation providers for services provided to
2.21 Minnesota health care programs beneficiaries to obtain covered medical services;

2.22 (3) provide data monthly to the commissioner on appeals, complaints, no-shows,
2.23 canceled trips, and number of trips by mode; and

2.24 (4) by July 1, 2016, in accordance with subdivision 18e, utilize a Web-based single
2.25 administrative structure assessment tool that meets the technical requirements established
2.26 by the commissioner, reconciles trip information with claims being submitted by
2.27 providers, and ensures prompt payment for nonemergency medical transportation services.

2.28 (e) Clients shall obtain their level of service certificate from an entity that does not
2.29 dispatch rides for clients using assisted transport, lift-equipped/ramp transport, protected
2.30 transport, and stretcher transport.

2.31 (f) The commissioner may use an order by the recipient's attending physician
2.32 or a medical or mental health professional to certify that the recipient requires
2.33 special transportation services nonemergency medical transportation services. Special
2.34 Nonemergency medical transportation providers shall perform driver-assisted services for
2.35 eligible individuals, when appropriate. Driver-assisted service includes passenger pickup
2.36 at and return to the individual's residence or place of business, assistance with admittance

3.1 of the individual to the medical facility, and assistance in passenger securement or in
 3.2 securing of wheelchairs or stretchers in the vehicle. ~~Special~~ Nonemergency medical
 3.3 ~~transportation providers must obtain written documentation from the health care service~~
 3.4 ~~provider who is serving the recipient being transported, identifying the time that the~~
 3.5 ~~recipient arrived. Special~~ have trip logs, which include a time stamp, signed by the
 3.6 medical provider or client attesting mileage traveled to obtain covered medical services,
 3.7 whichever is deemed most appropriate. Nonemergency medical transportation providers
 3.8 may not bill for separate base rates for the continuation of a trip beyond the original
 3.9 destination. Special Nonemergency medical transportation providers must take recipients
 3.10 clients to the health care provider, using the most direct route, and must not exceed 30
 3.11 miles for a trip to a primary care provider or 60 miles for a trip to a specialty care provider,
 3.12 unless the recipient client receives authorization from the local agency. The minimum
 3.13 medical assistance reimbursement rates for special transportation services are:

3.14 (1)(i) ~~\$17 for the base rate and \$1.35 per mile for special transportation services to~~
 3.15 ~~eligible persons who need a wheelchair-accessible van;~~

3.16 (ii) ~~\$11.50 for the base rate and \$1.30 per mile for special transportation services to~~
 3.17 ~~eligible persons who do not need a wheelchair-accessible van; and~~

3.18 (iii) ~~\$60 for the base rate and \$2.40 per mile, and an attendant rate of \$9 per trip, for~~
 3.19 ~~special transportation services to eligible persons who need a stretcher-accessible vehicle;~~

3.20 (2) Clients requesting client mileage reimbursement must sign the trip log attesting
 3.21 mileage traveled to obtain covered medical services.

3.22 (g) The covered modes of nonemergency medical transportation include
 3.23 transportation provided to a client who needs a stretcher-accessible vehicle, a lift/ramp
 3.24 equipped vehicle, a vehicle that is not stretcher-accessible or lift/ramp equipped designed
 3.25 to transport seven or fewer persons, and a protected vehicle that is not an ambulance or
 3.26 police car and has safety locks, a video recorder, and a transparent thermoplastic partition
 3.27 between the passenger and the vehicle driver.

3.28 (h) The administrative agency shall use the level of service process established
 3.29 by the commissioner in consultation with the Nonemergency Medical Transportation
 3.30 Advisory Committee to determine the client's most appropriate mode of transportation.
 3.31 If public transit or a certified transportation provider is not available to provide the
 3.32 appropriate service mode for the client, the client may receive a onetime service upgrade.
 3.33 Clients can be found eligible for the most appropriate of the following modes:

3.34 (1) client reimbursement, which includes client mileage reimbursement provided
 3.35 to clients who have their own transportation or family who provides transportation to
 3.36 the client;

4.1 (2) volunteer transport, which includes transportation by volunteers using their
4.2 own vehicle;

4.3 (3) unassisted transport, which includes transportation provided to a client by
4.4 public transit. If a publicly operated transit system is not available, the client can receive
4.5 transportation from a nonemergency medical transportation provider;

4.6 (4) assisted transport, which includes transport provided to clients who require
4.7 assistance by a nonemergency medical transportation provider;

4.8 (5) lift-equipped/ramp transport, which includes transport provided to a client who
4.9 is dependent on a device and requires a nonemergency medical transportation provider
4.10 with a vehicle containing a lift or ramp;

4.11 (6) protected transport, which includes transport to a client who has received a
4.12 prescreening that has deemed other forms of transportation inappropriate and who requires
4.13 a provider certified as a protected transport provider; and

4.14 (7) stretcher transport, which includes transport for a client in a prone or supine
4.15 position and requires a nonemergency medical transportation provider with a vehicle that
4.16 can transport a client in a prone or supine position.

4.17 (i) Local agencies shall administer and reimburse for modes defined in paragraph
4.18 (h), clauses (1) to (3). The commissioner shall administer and reimburse for modes
4.19 defined in paragraph (h), clauses (4) to (7). In accordance with subdivision 18e, by July 1,
4.20 2016, the local agency shall be the single administrative agency and shall administer and
4.21 reimburse for modes defined in paragraph (h), clauses (1), (2), (3), (4), (5), (6), and (7).

4.22 (j) The commissioner shall:

4.23 (1) in consultation with the Nonemergency Medical Transportation Advisory
4.24 Committee, verify that the mode and use of nonemergency medical transportation is
4.25 appropriate;

4.26 (2) verify that the client is going to an approved medical appointment; and

4.27 (3) investigate all complaints and appeals.

4.28 (k) The administrative agency shall pay for the services provided in this subdivision
4.29 and seek reimbursement from the commissioner if appropriate. As vendors of medical
4.30 care, local agencies are subject to the sanctions and monetary recovery actions in sections
4.31 256B.041 and 256B.064, and all applicable Minnesota Rules.

4.32 (l) Payments for nonemergency medical transportation shall be paid based on the
4.33 client's assessed mode, not the type of vehicle used to provide the service. The medical
4.34 assistance reimbursement rates for nonemergency medical transportation services payable
4.35 by or on behalf of the commissioner for nonemergency medical transportation services are:

5.1 (1) up to 80 percent of the Internal Revenue Service standard mileage rate for client
 5.2 reimbursement;

5.3 (2) up to 200 percent of the Internal Revenue Service standard mileage rate for
 5.4 volunteer transport;

5.5 (3) equivalent to the standard fare when provided by public transit and \$11 for the
 5.6 base rate and \$1.30 per mile for unassisted transport when provided by a nonemergency
 5.7 medical transportation provider;

5.8 (4) \$13 for the base rate and \$1.30 per mile for assisted transport;

5.9 (5) \$17 for the base rate and \$1.35 per mile for lift-equipped/ramp transport;

5.10 (6) \$75 for the base rate and \$3.30 per mile for protected transport; and

5.11 (7) \$60 for the base rate, \$2.40 per mile, and \$9 per trip for an additional attendant
 5.12 for stretcher transport if deemed medically necessary.

5.13 (m) The mileage reimbursement rates for nonemergency medical transportation in
 5.14 paragraph (l), clauses (3) to (7), are subject to a quarterly fuel adjustment. Reimbursement
 5.15 rates shall be adjusted quarterly by the commissioner within existing, identified, and
 5.16 available appropriations when the statewide average price of regular grade gasoline is over
 5.17 \$3.50 per gallon, as calculated by the Oil Price Information Service. The average price of
 5.18 regular grade gasoline will be determined on the first business day of each quarter, with
 5.19 the corresponding rate adjustment to be effective on the first business day of the following
 5.20 quarter. Rate adjustments shall be one percent for each ten-cent increment change in the
 5.21 statewide average price of regular grade gasoline.

5.22 (n) The base rates for ~~special~~ nonemergency medical transportation services in areas
 5.23 defined under RUCA to be super rural shall be equal to the reimbursement rate established
 5.24 in clause (1) plus 11.3 percent₂; and

5.25 (3) for ~~special~~ nonemergency medical transportation services in areas defined under
 5.26 RUCA to be rural or super rural areas:

5.27 (i) for a trip equal to 17 miles or less, mileage reimbursement shall be equal to 125
 5.28 percent of the respective mileage rate in ~~clause (1)~~ paragraph (l), clauses (1) to (7); and

5.29 (ii) for a trip between 18 and 50 miles, mileage reimbursement shall be equal to
 5.30 112.5 percent of the respective mileage rate in ~~clause (1)~~ paragraph (l), clauses (1) to (7).

5.31 (e) (o) For purposes of reimbursement rates for ~~special~~ nonemergency medical
 5.32 transportation services under paragraph (b), the zip code of the recipient's place of residence
 5.33 shall determine whether the urban, rural, or super rural reimbursement rate applies.

5.34 (d) (p) For purposes of this subdivision, "rural urban commuting area" or "RUCA"
 5.35 means a census-tract based classification system under which a geographical area is
 5.36 determined to be urban, rural, or super rural.

6.1 ~~(e)~~ (q) Effective for services provided ~~on or after~~ between September 1, 2011, and
6.2 June 30, 2014, nonemergency transportation rates, including special transportation, taxi,
6.3 and other commercial carriers, are reduced 4.5 percent. Payments made to managed care
6.4 plans and county-based purchasing plans must be reduced for services provided on or after
6.5 January 1, 2012, to reflect this reduction.

6.6 Sec. 2. Minnesota Statutes 2012, section 256B.0625, subdivision 17a, is amended to
6.7 read:

6.8 Subd. 17a. **Payment for ambulance services.** (a) Medical assistance covers
6.9 ambulance services. Providers shall bill ambulance services according to Medicare
6.10 criteria. Nonemergency ambulance services shall not be paid as emergencies. Effective
6.11 for services rendered on or after July 1, 2001, medical assistance payments for ambulance
6.12 services shall be paid at the Medicare reimbursement rate or at the medical assistance
6.13 payment rate in effect on July 1, 2000, whichever is greater.

6.14 (b) Effective for services provided ~~on or after~~ between September 1, 2011, and June
6.15 30, 2014, ambulance services payment rates are reduced 4.5 percent. Payments made to
6.16 managed care plans and county-based purchasing plans must be reduced for services
6.17 provided on or after January 1, 2012, to reflect this reduction.

6.20 Subd. 18a. **Access to medical services.** (a) Medical assistance reimbursement for
6.21 meals for persons traveling to receive medical care may not exceed \$5.50 for breakfast,
6.22 \$6.50 for lunch, or \$8 for dinner.

6.23 (b) Medical assistance reimbursement for lodging for persons traveling to receive
6.24 medical care may not exceed \$50 per day unless prior authorized by the local agency.

6.25 (c) Medical assistance direct mileage reimbursement to the eligible person or the
6.26 eligible person's driver may not exceed ~~20 cents~~ 80 percent of the Internal Revenue
6.27 Service standard mileage rate per mile.

6.28 (d) Regardless of the number of employees that an enrolled health care provider
6.29 may have, medical assistance covers sign and oral language interpreter services when
6.30 provided by an enrolled health care provider during the course of providing a direct,
6.31 person-to-person covered health care service to an enrolled recipient with limited English
6.32 proficiency or who has a hearing loss and uses interpreting services. Coverage for
6.33 face-to-face oral language interpreter services shall be provided only if the oral language

 7.2 established under section 144.058.

7.5 Subd. 18b. **Broker dispatching prohibition.** The commissioner shall not use a
 7.6 broker or coordinator for any purpose related to nonemergency medical transportation
 7.7 services under subdivision 18.

7.8 Sec. 5. Minnesota Statutes 2012, section 256B.0625, subdivision 18c, is amended to
 7.9 read:

7.10 Subd. 18c. **Nonemergency Medical Transportation Advisory Committee.**

7.11 (a) The Nonemergency Medical Transportation Advisory Committee shall advise the
 7.12 commissioner on the administration of nonemergency medical transportation covered
 7.13 under medical assistance. The advisory committee shall meet at least quarterly the first
 7.14 year following January 1, 2015, and at least biannually thereafter and may meet more
 7.15 frequently as required by the commissioner. The advisory committee shall annually
 7.16 elect a chair from among its members, who shall work with the commissioner or the
 7.17 commissioner's designee to establish the agenda for each meeting. The commissioner, or
 7.18 the commissioner's designee, shall attend all advisory committee meetings.

Subd. 18f. **Enrollee assessment process.** (a) The commissioner shall require that the administrator of nonemergency medical transportation adhere to the assessment process recommended by the Nonemergency Medical Transportation Advisory Committee. The commissioner shall implement, by July 1, 2014, the comprehensive, statewide, standard assessment process for medical assistance enrollees seeking nonemergency medical transportation services recommended by the Nonemergency Medical Transportation Advisory Committee. The assessment process must identify a client's level of needs, abilities, and resources, and match the client with the mode of transportation in the client's service area that best meets those needs.

(b) The assessment process must:

(1) address mental health diagnoses when determining the most appropriate mode of transportation;

(2) base decisions on clearly defined criteria that are available to clients, providers, and counties;

(3) be standardized across the state and be aligned with other similar existing processes;

(4) allow for extended periods of eligibility for certain types of nonemergency transportation when a client's condition is unlikely to change; and

(5) increase the use of public transportation when appropriate and cost-effective, including offering monthly bus passes to clients.
