.6	Section 1. STUDENT DISCIPLINE WORKING GROUP.
.7	(a) A Student Discipline Working Group is created to review the substance,
.8	application, and effect of Minnesota's Pupil Fair Dismissal Act under Minnesota Statutes,
.9	sections 121A.40 to 121A.56, and related student discipline provisions in Minnesota
.10	Statutes, chapter 121A, and submit written recommendations to the legislature by
.11	February 1, 2017, on improving disciplinary policies, practices, and procedures as they
.12	affect students and school officials and the effects on student outcomes.
.13	(b) Consistent with paragraph (a), the working group must analyze:
.14	(1) available summary data on elementary and secondary students' removal from
.15	class, suspensions, exclusions, and expulsions, disaggregated by categories of race,
.16	ethnicity, poverty, disabilities, homelessness, English language proficiency, gender, age,
.17	and foster care status;
.18	(2) the meaning and effect of "willful" in establishing grounds for dismissal under
