1.19 and sickness insurance as defined in section 62A.01; a health service plan licensed under

1.20 chapter 62C; a health maintenance organization licensed under chapter 62D; the Minnesota

1.21 Comprehensive Health Association created under chapter 62E; a community integrated

1.22 service network licensed under chapter 62N; an accountable provider network operating

2.14 admission, extension of stay, or health care service on the basis that it is not medically
2.15 necessary.

2.16 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to health
2.17 plans offered, sold, issued, or renewed on or after that date.

2.22 meets it satisfies the utilization review requirements of the applicable health plan and the
2.23 health plan company will then pay for the covered benefit, provided the preexisting limitation
2.24 provisions, the general exclusion provisions, and any deductible, co-payment, coinsurance,
2.25 or other policy requirements have been met.

3.20 includes prior authorization and review conducted after the admission of the enrollee. It
3.21 includes situations where the enrollee is unconscious or otherwise unable to provide advance
3.22 notification. Utilization review does not include a referral or participation in a referral
3.23 process by a participating provider unless the provider is acting as a utilization review
3.24 organization.

5.8 a verified number, or by electronic mail to a secure electronic mailbox ~~within one working~~
5.9 ~~day after making the determination~~ to the attending health care professional and hospital
5.10 or physician office as applicable. Written notification must also be sent to the hospital or
5.11 physician office as applicable and attending health care professional if notification occurred
5.12 by telephone. For purposes of this subdivision, notification may be made by facsimile to a
5.13 verified number or by electronic mail to a secure electronic mailbox. Written notification
5.14 must be sent to the enrollee and may be sent by United States mail, facsimile to a verified
5.15 number, or by electronic mail to a secure mailbox. The written notification must include
5.16 ~~the principal reason or all~~ reasons relied on by the utilization review organization for the
5.17 adverse determination and the process for initiating an appeal of the adverse determination.

5.25 must inform the enrollee and the attending health care professional of the right to submit
5.26 an appeal to the internal appeal process described in section 62M.06 and the procedure for
5.27 initiating the internal appeal. The written notice shall be provided in a culturally and
5.28 linguistically appropriate manner consistent with the provisions of the Affordable Care Act
5.29 as defined under section 62A.011, subdivision 1a.

6.5 (b) Notification of an expedited ~~initial~~ determination to ~~either certify or not to certify~~
6.6 authorize or an expedited adverse determination must be provided to the hospital, the
6.7 attending health care professional, and the enrollee as expeditiously as the enrollee's medical
6.8 condition requires, but no later than ~~72~~ 48 hours from and must include at least one business
6.9 day after the initial request. When an expedited ~~initial~~ adverse determination is made ~~not~~
6.10 ~~to certify~~, the utilization review organization must also notify the enrollee and the attending

6.18 must have written procedures to address the failure of a provider or enrollee to provide the
6.19 ~~necessary information for review~~ necessary to make a determination on the request. If the
6.20 enrollee or provider will not release the necessary information to the utilization review
6.21 organization, the utilization review organization may ~~deny certification~~ make an adverse
6.22 determination in accordance with its own policy or the policy described in the health benefit
6.23 plan.

6.32 cannot make a determination within ~~30~~ 15 days due to circumstances outside the control of

7.1 the utilization review organization, the utilization review organization may take up to ~~14~~
7.2 four additional days to notify the enrollee, attending health care professional, and claims

7.15 communicated to the enrollee and attending health care professional when the ~~initial~~

7.18 attempt to reverse a an adverse determination ~~not to certify~~ shall, consistent with section
7.19 72A.285, be provided the following:

7.20 (1) a complete summary of the review findings;

7.21 (2) qualifications of the reviewers, including any license, certification, or specialty
7.22 designation; and

7.23 (3) the relationship between the enrollee's diagnosis and the review criteria used as the
7.24 basis for the decision, including the specific rationale for the reviewer's decision.

7.26 reasons, the utilization review organization must ensure that a physician of the utilization
7.27 review organization's choice in the same or a similar specialty as typically manages the
7.28 medical condition, procedure, or treatment under discussion is reasonably available to review
7.29 the case.

7.30 (h) If the ~~initial~~ adverse determination is not reversed on appeal, the utilization review
7.31 organization must include in its notification the right to submit the appeal to the external
7.32 review process described in section 62Q.73 and the procedure for initiating an appeal under
7.33 the external process.

8.7 requirements:

8.8 (1) written procedures and criteria used to determine whether care is appropriate,
8.9 reasonable, or medically necessary;

8.10 (2) a system for providing prompt notification of its determinations to enrollees and
8.11 providers and for notifying the provider, enrollee, or enrollee's designee of appeal procedures
8.12 under clause (4);

8.13 (3) compliance with section 62M.05, subdivisions 3a and 3b, regarding time frames for
8.14 ~~approving and disapproving~~ authorizing and making adverse determinations regarding prior
8.15 authorization requests;

8.16 (4) written procedures ~~for appeals of denials~~ to appeal adverse determinations of prior

8.29 Subd. 3. **Retrospective revocation or limitation of prior authorization.** No utilization
8.30 review organization, health plan company, or claims administrator may revoke, limit,

8.32 that the prior authorization was authorized based on fraud or misinformation or a previously

9.1 approved prior authorization conflicts with state or federal law. Application of a deductible,

9.22 manages the condition for which the health care service has been requested.

9.23 This paragraph does not apply to reviews conducted in connection with policies issued by

9.30 to evaluate the specific clinical issues presented in the review.

23.21 (5) a decision relating to a health care service made by a health plan company licensed

23.22 under chapter 60A that denies the service on the basis that the service was not medically

23.23 necessary; or

23.24 (6) the enrollee has met the requirements of subdivision 6, paragraph (e).

23.25 An adverse determination does not include complaints relating to fraudulent marketing

23.26 practices or agent misrepresentation.

23.27 **EFFECTIVE DATE.** This section is effective January 1, 2021, and applies to health
