1.26 Section 1. Laws 2022, chapter 42, section 2, is amended to read:

1.27 **Sec. 2. APPROPRIATION; ALS RESEARCH.**

1.28 (a) ~~\$20,000,000~~ \$396,000 in fiscal year 2023 is appropriated from the general fund to

1.29 the commissioner of the Office of Higher Education to award competitive grants to applicants

2.1 for research into amyotrophic lateral sclerosis (ALS). The commissioner may work with
2.2 the Minnesota Department of Health to administer the grant program, including identifying
2.3 clinical and translational research and innovations, developing outcomes and objectives
2.4 with the goal of bettering the lives of individuals with ALS and finding a cure for the disease,
2.5 and application review and grant recipient selection. Not more than ~~\$400,000~~ \$396,000
2.6 may be used by the commissioner to administer the grant program. This is a onetime
2.7 appropriation. Notwithstanding Minnesota Statutes, section 16A.28, unencumbered balances
2.8 under this section do not cancel until June 30, 2026.

2.9 (b) \$19,604,000 in fiscal year 2024 is appropriated from the general fund to the
2.10 commissioner of the Office of Higher Education to award competitive grants to applicants

2.12 the Minnesota Department of Health to administer the grant program, including identifying
2.13 clinical and translational research and innovations, developing outcomes and objectives
2.14 with the goal of bettering the lives of individuals with ALS and finding a cure for the disease,
2.15 and application review and grant recipient selection. Up to \$15,000,000 may be used by the
2.16 commissioner for grants to the Amyotrophic Lateral Sclerosis Association, Never Surrender,
2.17 or other similar organizations to award and administer competitive grants to applicants for
2.18 research into ALS under this section. This is a onetime appropriation. Notwithstanding
2.19 Minnesota Statutes, section 16A.28, unencumbered balances under this section do not cancel
2.20 until June 30, 2029. Notwithstanding Minnesota Statutes, section 16B.98, subdivision 14,
2.21 the commissioner, the Amyotrophic Lateral Sclerosis Association, Never Surrender, and
2.22 other similar organizations may use up to a total of five percent of this appropriation for
2.23 administrative costs.

2.24 ~~(b)~~ (c) Grants shall be awarded to support clinical and translational research related to
2.25 ALS. Research topics may include but are not limited to environmental factors, disease
2.26 mechanisms, disease models, biomarkers, drug development, clinical studies, precision
2.27 medicine, medical devices, assistive technology, and cognitive studies.

2.28 ~~(e)~~ (d) Eligible applicants for the grants are research facilities, universities, and health
2.29 systems located in Minnesota. Applicants must submit proposals to the commissioner in
2.30 the time, form, and manner established by the commissioner. Applicants may coordinate
2.31 research endeavors and submit a joint application. When reviewing the proposals, the
2.32 commissioner shall make an effort to avoid approving a grant for an applicant whose research
2.33 is duplicative of an existing grantee's research.

6.20 \$500,000 in fiscal year 2025 is appropriated from the general fund to the Board of
 6.21 Trustees of the Minnesota State Colleges and Universities to participate in the Kids on
 6.22 Campus initiative with the National Head Start Association and the Association of
 6.23 Community College Trustees. This appropriation may be used for a temporary statewide
 6.24 project coordinator, stipends to campuses and Head Start centers where letters of intent to
 6.25 officially form a partnership have been signed, engaging with local Head Start programs,
 6.26 and other costs associated with creating campus Head Start partnerships. Stipends shall be
 6.27 used to support the formation of parenting student advisory panels to gather perspective
 6.28 and feedback on proposed partnerships. The duties of the temporary statewide project
 6.29 coordinator include assessing the feasibility of partnerships between Minnesota State Colleges
 6.30 and Universities campuses and Head Start programs across the state, consulting with the
 6.31 Minnesota Head Start Association and existing Head Start partnership programs to develop
 6.32 best practices, working with campus-based navigators for parenting students to provide
 6.33 resources for financial aid and basic needs support to Head Start programs, and developing
 6.34 strategies to grow the early childhood care and education workforce through partnerships

7.4 **POLICY PROVISIONS**

7.5 **Section 1. [135A.062] CONSIDERATION OF CRIMINAL RECORDS LIMITED.**

7.6 Subdivision 1. **Applicability.** This section applies to postsecondary institutions under
7.7 section 136A.155, clause (1), except that the Board of Regents of the University of Minnesota
7.8 is requested to comply with this section.

7.9 Subd. 2. **Definition.** As used in this section, "a violent felony or sexual assault" includes
7.10 a felony-level violation or attempted violation of section 609.185; 609.19; 609.195; 609.20;
7.11 609.221; 609.2242, subdivision 4; 609.2247; 609.245, subdivision 1; 609.247, subdivision
7.12 2; 609.282; 609.322; 609.342; 609.343; 609.344; 609.345; 609.3451; 609.3458; 609.561,
7.13 subdivision 1 or 2; 609.582, subdivision 1; 609.66, subdivision 1e; or 609.749; or a statute
7.14 from another state, the United States, or a foreign jurisdiction, in conformity with any of
7.15 these sections.

7.16 Subd. 3. **Consideration of criminal records limited.** A postsecondary institution may
7.17 not inquire into, consider, or require disclosure of the criminal record or criminal history
7.18 of an applicant for admission. After a postsecondary institution has made an offer of
7.19 admission, the postsecondary institution may inquire into, consider, or require disclosure
7.20 of a conviction or delinquency adjudication that occurred within the previous five years for
7.21 a violent felony or sexual assault. The postsecondary institution must provide the applicant
7.22 with an opportunity to submit an explanatory statement, letters of recommendation, evidence
7.23 of rehabilitation, and any other supporting documents. The institution must provide clear
7.24 and detailed instructions and guidance to applicants related to what criminal history requires
7.25 disclosure. The institution must not require the applicant to provide official records of
7.26 criminal history. A postsecondary institution that rescinds an offer of admission must:

7.27 (1) provide an explanation of the basis for the decision to rescind the offer of admission;
7.28 and

7.29 (2) provide the applicant with an opportunity to appeal the decision to rescind.

7.30 Subd. 4. **Other information.** This section shall not prohibit or limit a postsecondary
7.31 institution from inquiring about student conduct records at the applicant's prior postsecondary
7.32 institution after making an offer of admission. This section shall not prohibit or limit a

8.1 postsecondary institution from inquiring about a student's ability to meet licensure
8.2 requirements in a professional program after making an offer of admission.

8.3 Subd. 5. **Limitation on admissibility.** (a) A postsecondary institution that complies
8.4 with this section is immune from liability in a civil action arising out of the institution's
8.5 decision to admit a student with a criminal history or the institution's failure to conduct a
8.6 criminal background check.

8.7 (b) Nothing in this section creates or establishes a legal duty upon a postsecondary
8.8 institution to inquire into or require disclosure of the criminal history or criminal convictions
8.9 of a student or an applicant for admission.

8.10 Sec. 2. Minnesota Statutes 2023 Supplement, section 135A.121, subdivision 2, is amended
8.11 to read:

8.12 Subd. 2. **Eligibility.** To be eligible each year for the program a student must:

8.13 (1) be enrolled in an undergraduate certificate, diploma, or degree program at the
8.14 University of Minnesota or a Minnesota state college or university;

8.15 (2) be either (i) a Minnesota resident for resident tuition purposes who is an enrolled

8.24 Sec. 3. [135A.144] TRANSCRIPT ACCESS.

8.25 Subdivision 1. **Definitions.** (a) The terms defined in this subdivision apply to this section.

8.26 (b) "Debt" means any money, obligation, claim, or sum, due or owed, or alleged to be
8.27 due or owed, from a student. Debt does not include the fee, if any, charged to all students
8.28 for the actual costs of providing the transcripts.

8.29 (c) "School" means a public institution governed by the Board of Trustees of the
8.30 Minnesota State Colleges and Universities, private postsecondary educational institution
8.31 as defined under section 136A.62 or 136A.821, or public or private entity that is responsible

9.1 for providing transcripts to current or former students of an educational institution.
9.2 Institutions governed by the Board of Regents of the University of Minnesota are requested
9.3 to comply with this section.

9.4 (d) "Transcript" means the statement of an individual's academic record, including
9.5 official transcripts or the certified statement of an individual's academic record provided
9.6 by a school, and unofficial transcripts or the uncertified statement of an individual's academic
9.7 record provided by a school.

9.8 Subd. 2. **Prohibited practices.** (a) A school must not refuse to provide a transcript for
9.9 a current or former student because the student owes a debt to the school if:

9.10 (1) the debt owed is less than \$1,000;

9.11 (2) the student has entered into and, as determined by the institution, is in compliance
9.12 with a payment plan with the school;

9.13 (3) the transcript request is made by a prospective employer for the student;

9.14 (4) the school has sent the debt for repayment to the Department of Revenue or to a
9.15 collection agency, as defined in section 332.31, subdivision 3, external to the institution
9.16 and the debt has not been returned to the institution unpaid; or

9.17 (5) the person is incarcerated at a Minnesota correctional facility.

9.18 (b) A school must not charge an additional or higher fee for obtaining a transcript or
9.19 provide less favorable treatment of a transcript request because a student owes a debt to the
9.20 originating school.

9.21 Subd. 3. **Institutional policy.** (a) A school that uses transcript issuance as a tool for debt
9.22 collection must have a policy accessible to students that outlines how the school collects
9.23 on debts owed to the school.

9.24 (b) A school shall seek to use transcript issuance as a tool for debt collection for the
9.25 fewest number of cases possible and in a manner that allows for the quickest possible
9.26 resolution of the debt benefitting the student's educational progress.

10.4 **POLICY.**

10.5 Subdivision 1. **Applicability; policy required.** (a) This section applies to the following
10.6 postsecondary institutions:

10.7 (1) institutions governed by the Board of Trustees of the Minnesota State Colleges and
10.8 Universities; and

10.9 (2) private postsecondary institutions that offer in-person courses on a campus located
10.10 in Minnesota and which are eligible institutions as defined in section 136A.103, ~~provided~~
10.11 ~~that a private postsecondary institution with a systemwide enrollment of fewer than 100~~
10.12 ~~students in the previous academic year is exempt from subdivisions 4 to 10 paragraph (a),~~
10.13 that are participating in the federal program under Title IV of the Higher Education Act of
10.14 1965, Public Law 89-329, as amended.

10.15 Institutions governed by the Board of Regents of the University of Minnesota are
10.16 requested to comply with this section.

10.17 (b) A postsecondary institution must adopt a clear, understandable written policy on
10.18 ~~sexual harassment and sexual violence~~ misconduct that informs victims of their rights under
10.19 the crime victims bill of rights, including the right to assistance from the Crime Victims
10.20 Reimbursement Board and the commissioner of public safety. The policy must apply to
10.21 students and employees and must provide information about their rights and duties. The
10.22 policy must apply to criminal incidents against a student or employee of a postsecondary
10.23 institution occurring on property owned or leased by the postsecondary system or institution
10.24 or at any activity, program, organization, or event sponsored by the system or institution,
10.25 ~~or by a fraternity and or sorority,~~ or any activity, program, organization, or event sponsored
10.26 by the system or institution, or by a fraternity or sorority, regardless of whether the activity,
10.27 program, organization, or event occurs on or off property owned or leased by the
10.28 postsecondary system or institution. It must include procedures for reporting incidents of
10.29 ~~sexual harassment or sexual violence~~ misconduct and for disciplinary actions against
10.30 violators. During student registration, a postsecondary institution shall provide each student
10.31 with information regarding its policy. A copy of the policy also shall be posted at appropriate
10.32 locations on campus at all times.

10.33 Subd. 1a. ~~Sexual assault definition~~ Definitions. (a) For the purposes of this section,
10.34 the following terms have the meanings given.

11.1 (b) "Advisor" means a person who is selected by a responding or reporting party to serve
11.2 as a support during a campus investigation and disciplinary process. This person may be
11.3 an attorney. An advisor serves as a support to a party by offering comfort or attending
11.4 meetings.

11.5 (c) "Domestic violence" has the meaning giving in section 518B.01, subdivision 2.

11.6 ~~(b)~~ (d) "Incident" means one report of sexual assault misconduct to a postsecondary
11.7 institution, regardless of the number of complainants included in the report, the number of
11.8 respondents included in the report, and whether or not the identity of any party is known
11.9 by the reporting postsecondary institution. Incident encompasses all nonconsensual events
11.10 included within one report if multiple events have been identified.

11.11 (e) "Intimate partner violence" means any physical or sexual harm or a pattern of any
11.12 other coercive behavior committed, enabled, or solicited to gain or maintain power and
11.13 control over a victim, including verbal, psychological, economic, or technological abuse
11.14 that may or may not constitute criminal behavior against an individual, that may be classified
11.15 as a sexual misconduct, dating violence, or domestic violence caused by:

11.16 (1) a current or former spouse of the individual; or

11.17 (2) a person in a sexual or romantic relationship with the individual.

11.18 (f) "Nonconsensual dissemination of sexual images" has the meaning given in section
11.19 617.261.

11.20 (g) "Reporting party" means the party in a disciplinary proceeding who has reported
11.21 being subjected to conduct or communication that could constitute sexual misconduct.

11.22 (h) "Responding party" means the party in a disciplinary proceeding who has been
11.23 reported to be the perpetrator of conduct or communication that could constitute sexual
11.24 misconduct.

11.25 ~~(e)~~ (i) "Sexual assault" means rape, sex offenses - fondling, sex offenses - incest, or sex
11.26 offenses - statutory rape as defined in Code of Federal Regulations, title 34, part 668, subpart
11.27 D, appendix A, as amended.

11.28 (j) "Sexual extortion" has the meaning given in section 609.3458.

11.29 (k) "Sex trafficking" has the meaning given in section 609.321, subdivision 7a.

11.30 (l) "Sexual harassment" has the meaning given in section 363A.03, subdivision 43.

11.31 (m) "Sexual misconduct" means an incident of sexual violence, intimate partner violence,
11.32 domestic violence, sexual assault, sexual harassment, nonconsensual distribution of sexual

12.1 images, sexual extortion, nonconsensual dissemination of a deepfake depicting intimate
 12.2 parts or sexual acts, sex trafficking, or stalking.

12.3 (n) "Stalking" has the meaning given in section 609.749.

12.4 Subd. 2. **Victims' rights.** (a) The policy required under subdivision 1 shall, at a minimum,
 12.5 require that students and employees be informed of the policy, and shall include provisions
 12.6 for:

12.7 (1) filing criminal charges with local law enforcement officials in ~~sexual assault~~ cases
 12.8 defined as sexual misconduct that may constitute criminal behavior;

12.9 (2) the prompt assistance of campus authorities, at the request of the victim, in notifying
 12.10 the appropriate law enforcement officials and disciplinary authorities of a sexual ~~assault~~
 12.11 misconduct incident;

12.12 (3) allowing sexual ~~assault~~ misconduct victims to decide whether to report a case to law
 12.13 enforcement or not report altogether; participate in a campus investigation, disciplinary
 12.14 proceeding, or nondisciplinary informal resolution; or not participate altogether;

12.15 (4) requiring campus authorities to treat sexual ~~assault~~ misconduct victims with dignity;

12.16 (5) requiring campus authorities to offer sexual ~~assault~~ misconduct victims fair and
 12.17 respectful health care, counseling services, or referrals to such services;

12.18 (6) preventing campus authorities from suggesting to a victim of sexual ~~assault~~
 12.19 misconduct that the victim is at fault for the crimes or violations that occurred;

12.20 (7) preventing campus authorities from suggesting to a victim of sexual ~~assault~~
 12.21 misconduct that the victim should have acted in a different manner to avoid such a crime;

12.22 (8) subject to ~~subdivision~~ subdivisions 2a and 10, protecting the privacy of sexual ~~assault~~
 12.23 misconduct victims by only disclosing data collected under this section to the victim, persons
 12.24 whose work assignments reasonably require access, and, at a sexual ~~assault~~ misconduct
 12.25 victim's request, police conducting a criminal investigation;

12.26 (9) an investigation and resolution of a sexual ~~assault~~ misconduct complaint by campus
 12.27 disciplinary authorities;

12.28 (10) a sexual ~~assault~~ misconduct victim's participation in and the presence of the victim's
 12.29 ~~attorney or other support person who is not a fact witness to the sexual assault~~ advisor at
 12.30 any meeting with campus officials concerning the victim's sexual ~~assault~~ misconduct
 12.31 complaint or campus disciplinary proceeding concerning a sexual ~~assault~~ misconduct
 12.32 complaint;

13.1 (11) ensuring that a sexual ~~assault~~ misconduct victim may decide when to repeat a
13.2 description of the incident of sexual ~~assault~~ misconduct;

13.3 (12) notice to a sexual ~~assault~~ misconduct victim of the availability of a campus or local
13.4 program providing ~~sexual assault~~ victim advocacy services and information on free legal
13.5 resources and services;

13.6 (13) notice to a sexual ~~assault~~ misconduct victim of the outcome of any campus
13.7 disciplinary proceeding concerning a sexual ~~assault~~ misconduct complaint, consistent with
13.8 laws relating to data practices;

13.9 (14) the complete and prompt assistance of campus authorities, at the direction of law
13.10 enforcement authorities, in obtaining, securing, and maintaining evidence in connection
13.11 with a sexual ~~assault~~ misconduct incident;

13.12 (15) the assistance of campus authorities, at the request of the sexual misconduct victim,
13.13 ~~in preserving for a sexual assault complainant or victim~~ materials relevant to a campus
13.14 disciplinary proceeding;

13.15 (16) during and after the process of investigating a complaint and conducting a campus
13.16 disciplinary procedure, the assistance of campus personnel, in cooperation with the
13.17 appropriate law enforcement authorities, at a sexual ~~assault~~ misconduct victim's request, in
13.18 shielding the victim from unwanted contact with the alleged assailant, including transfer of
13.19 the victim to alternative classes or to alternative college-owned housing, if alternative classes
13.20 or housing are available and feasible;

13.21 (17) forbidding retaliation, and establishing a process for investigating complaints of
13.22 retaliation, against sexual ~~assault~~ misconduct victims by campus authorities, the accused,
13.23 organizations affiliated with the accused, other students, and other employees;

13.24 (18) at the request of the victim, providing students who reported sexual ~~assaults~~
13.25 misconduct to the institution and subsequently choose to transfer to another postsecondary
13.26 institution with information about resources for victims of sexual ~~assault~~ misconduct at the

13.28 (19) consistent with laws governing access to student records, providing a student who
13.29 reported an incident of sexual ~~assault~~ misconduct with access to the student's description

13.32 (b) None of the rights given to a student by the policy required by subdivision 1 may be
13.33 made contingent upon the victim entering into a nondisclosure agreement or other contract

14.3 (c) A nondisclosure agreement or other contract restricting the victim's ability to discuss
14.4 information in connection with a sexual misconduct complaint, investigation, or hearing
14.5 may not be used as a condition of financial aid or remedial action.

14.6 **Subd. 2a. Campus investigation and disciplinary hearing procedures.** (a) A
14.7 postsecondary institution must provide a reporting party an opportunity for an impartial,
14.8 timely, and thorough investigation of a report of sexual misconduct against a student. If an
14.9 investigation reveals that sexual misconduct has occurred, the institution must take prompt
14.10 and effective steps reasonably calculated to end the sexual misconduct, prevent its recurrence,
14.11 and, as appropriate, remedy its effects.

14.12 (b) Throughout any investigation or disciplinary proceeding, a postsecondary institution
14.13 must treat the reporting parties, responding parties, witnesses, and other participants in the
14.14 proceeding with dignity and respect.

14.15 (c) If a postsecondary institution conducts a hearing, an advisor may provide opening
14.16 and closing remarks on behalf of a party or assist with formulating questions to the other
14.17 party or witnesses about related evidence or credibility.

14.18 **Subd. 3. Uniform amnesty.** The sexual ~~harassment and violence~~ misconduct policy
14.19 required by subdivision 1 must include a provision that a witness or victim of an incident
14.20 of sexual ~~assault~~ misconduct who reports the incident in good faith shall not be sanctioned
14.21 by the institution for admitting in the report to a violation of the institution's student conduct
14.22 policy on the personal use of drugs or alcohol.

14.23 **Subd. 4. Coordination with local law enforcement.** (a) A postsecondary institution
14.24 must enter into a memorandum of understanding with the primary local law enforcement

15.9 agencies establish a sexual ~~assault~~ misconduct protocol team to facilitate effective cooperation

15.11 Subd. 5. **Online reporting system.** (a) A postsecondary institution must provide an
15.12 online reporting system to receive complaints of sexual ~~harassment and sexual violence~~
15.13 misconduct from students and employees. The system must permit anonymous reports,
15.14 provided that the institution is not obligated to investigate an anonymous report unless a
15.15 formal report is submitted through the process established in the institution's sexual

15.17 (b) A postsecondary institution must provide students making reports under this

15.21 (c) Data collected under this subdivision is classified as private data on individuals as

15.25 Subd. 6. **Data collection and reporting.** (a) Postsecondary institutions must annually
15.26 report statistics on sexual ~~assault~~ misconduct. This report must be prepared in addition to
15.27 any federally required reporting on campus security, including reports required by the Jeanne
15.28 Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, United States
15.29 Code, title 20, section 1092(f). The report must include, but not be limited to, the number

- 16.6 (6) the number that resulted in any action by the institution greater than a warning issued
16.7 to the accused;
- 16.8 (7) the number that resulted in a disciplinary proceeding at the institution that closed
16.9 without resolution;
- 16.10 (8) the number that resulted in a disciplinary proceeding at the institution that closed
16.11 without resolution because the accused withdrew from the institution;
- 16.12 (9) the number that resulted in a disciplinary proceeding at the institution that closed
16.13 without resolution because the victim chose not to participate in the procedure; and
- 16.14 (10) the number of reports made through the online reporting system established in
16.15 subdivision 5, excluding reports submitted anonymously.
- 16.16 (b) If an institution previously submitted a report indicating that one or more disciplinary
16.17 proceedings was pending, but had not reached a final resolution, and one or more of those
16.18 disciplinary proceedings reached a final resolution within the previous calendar year, that
16.19 institution must submit updated totals from the previous year that reflect the outcome of
16.20 the pending case or cases.
- 16.21 (c) The reports required by this subdivision must be submitted to the Office of Higher
16.22 Education by October 1 of each year. Each report must contain the data required under
16.23 paragraphs (a) and (b) from the previous calendar year.
- 16.24 (d) The commissioner of the Office of Higher Education shall calculate statewide numbers
16.25 for each data item reported by an institution under this subdivision. The statewide numbers
16.26 must include data from postsecondary institutions that the commissioner could not publish
16.27 due to federal laws governing access to student records.
- 16.28 (e) The Office of Higher Education shall publish on its website:

17.8 **Subd. 7. Access to data; audit trail.** (a) Data on incidents of sexual ~~assault~~ misconduct
17.9 shared with campus security officers or campus administrators responsible for investigating
17.10 or adjudicating complaints of sexual ~~assault~~ misconduct are classified as private data on
17.11 individuals as defined by section 13.02, subdivision 12, for the purposes of postsecondary
17.12 institutions subject to the requirements of chapter 13. Postsecondary institutions not otherwise
17.13 subject to chapter 13 must limit access to the data to only the data subject and persons whose

17.15 (b) Only individuals with explicit authorization from an institution may enter, update,

17.17 created, or maintained under this section. The ability of authorized individuals to enter,
17.18 update, or access these data must be limited through the use of role-based access that
17.19 corresponds to the official duties or training level of the individual and the institutional

18.9 (2) students who are taking courses through the Postsecondary Enrollment Options Act;

18.11 (3) any other categories of students determined by the institution.

18.12 Students must complete such training no later than ten business days after the start of a
18.13 student's first semester of classes. Once a student completes the training, institutions must
18.14 document the student's completion of the training and provide proof of training completion
18.15 to a student at the student's request. Students enrolled at more than one institution within
18.16 the same system at the same time are only required to complete the training once.

18.17 The training shall include information about topics including but not limited to sexual
18.18 ~~assault~~ misconduct as defined in subdivision 1a; consent as defined in section 609.341,
18.19 subdivision 4; preventing and reducing the prevalence of sexual ~~assault~~ misconduct;

18.22 (c) A postsecondary institution shall annually train individuals responsible for responding
18.23 to reports of sexual ~~assault~~ misconduct. This training shall include information about best
18.24 practices for interacting with victims of sexual ~~assault~~ misconduct, including how to reduce
18.25 the emotional distress resulting from the reporting, investigatory, and disciplinary process.

18.26 (d) To the extent possible, trainings must be culturally responsive and address the unique
18.27 experiences and challenges faced by students based on race, ethnicity, color, national origin,
18.28 disability, socioeconomic status, religion, sex, gender identity, sexual orientation, and
18.29 pregnancy or parenting status.

18.30 Subd. 9. **Student health services.** (a) An institution's student health service providers
18.31 must screen students for incidents of sexual ~~violence and sexual harassment~~ misconduct.
18.32 Student health service providers shall offer students information on resources available to

19.1 victims and survivors of sexual ~~violence and sexual harassment~~ misconduct including
 19.2 counseling, mental health services, and procedures for reporting incidents to the institution.

19.3 (b) Each institution offering student health or counseling services must designate an
 19.4 existing staff member or existing staff members as confidential resources for victims of

 19.6 to meet with victims of sexual ~~violence and sexual harassment~~ misconduct. The confidential
 19.7 resource must provide victims with information about locally available resources for victims
 19.8 of sexual ~~violence and sexual harassment~~ misconduct including, but not limited to, mental
 19.9 health services and legal assistance. The confidential resource must provide victims with
 19.10 information about the process for reporting an incident of sexual ~~violence and sexual~~
 19.11 ~~harassment~~ misconduct to campus authorities or local law enforcement. The victim shall
 19.12 decide whether to report an incident of sexual ~~violence and sexual harassment~~ misconduct
 19.13 to campus authorities or local law enforcement. Confidential resources must be trained in
 19.14 all aspects of responding to incidents of sexual ~~violence and sexual harassment~~ misconduct
 19.15 including, but not limited to, best practices for interacting with victims of trauma, preserving
 19.16 evidence, campus disciplinary and local legal processes, and locally available resources for
 19.17 victims. Data shared with a confidential resource is classified as sexual assault
 19.18 communication data as defined by section 13.822, subdivision 1.

19.19 Subd. 10. **Applicability of other laws.** This section does not exempt mandatory reporters
 19.20 from the requirements of section 626.557 or chapter 260E governing the reporting of
 19.21 maltreatment of minors or vulnerable adults. Nothing in this section limits the authority of
 19.22 an institution to comply with other applicable state or federal laws related to investigations
 19.23 or reports of sexual ~~harassment, sexual violence, or sexual assault~~ misconduct.

19.24 **EFFECTIVE DATE.** This section is effective August 1, 2025.

19.25 Sec. 5. **[135A.1581] NAVIGATORS FOR PARENTING STUDENTS.**

19.26 **Subdivision 1. Applicability.** (a) This section applies to the following postsecondary
 19.27 institutions:

19.28 (1) institutions governed by the Board of Trustees of the Minnesota State Colleges and
 19.29 Universities; and

19.30 (2) private postsecondary institutions that offer in-person courses on a campus located
 19.31 in Minnesota and which are eligible institutions as defined in section 136A.103.

19.32 (b) Institutions governed by the Board of Regents of the University of Minnesota are
 19.33 requested to comply with this section.

20.1 Subd. 2. **Definitions.** (a) For purposes of this section, the following terms have the
20.2 meanings given.

20.3 (b) "Institutions of higher education" means an institution of higher education under
20.4 subdivision 1.

20.5 (c) "Parenting student" means a student enrolled at an institution of higher education
20.6 who is the parent or legal guardian of or can claim as a dependent a child under the age of
20.7 18.

20.8 Subd. 3. **Navigators.** An institution of higher education must designate at least one
20.9 employee of the institution to act as a college navigator for current or incoming students at
20.10 the institution who are parenting students. The navigator must provide to the students
20.11 information regarding support services and other resources available to the students at the
20.12 institution, including:

20.13 (1) medical and behavioral health coverage and services;

20.14 (2) public benefit programs, including programs related to food security, affordable
20.15 housing, and housing subsidies;

20.16 (3) parenting and child care resources;

20.17 (4) employment assistance;

20.18 (5) transportation assistance; and

20.19 (6) any other resources developed by the institution to assist the students, including
20.20 student academic success strategies.

20.21 Subd. 4. **Report.** (a) By June 30, 2026, an institution of higher education must establish
20.22 a process for collecting the parenting status of each enrolled student. By November 30,
20.23 2026, the Office of Higher Education shall establish a process for collecting this information
20.24 from institutions.

20.25 (b) Annually, beginning January 15, 2028, the Office of Higher Education must submit
20.26 a report to the chairs and ranking minority members of the legislative committees with
20.27 jurisdiction over higher education and children, youth, and families. The report must include
20.28 the following for parenting students:

20.29 (1) summary demographic data;

20.30 (2) enrollment patterns;

20.31 (3) retention rates;

21.1 (4) completion rates;

21.2 (5) average cumulative debt at exit or graduation as possible; and

21.4 Data must be disaggregated by institution, academic year, race and ethnicity, gender, and

21.6 Sec. 6. **[135A.1582] PROTECTIONS FOR PREGNANT AND PARENTING**

21.7 **STUDENTS.**

21.8 Subdivision 1. **Definition.** (a) For the purpose of this section, the following term has

21.9 the meaning given.

21.10 (b) "Parenting student" means a student enrolled at a public college or university who

21.11 is the parent or legal guardian of or can claim as a dependent a child under the age of 18.

21.12 Subd. 2. **Rights and protections.** (a) A Minnesota state college or university may not

21.13 require and the University of Minnesota is requested not to require a pregnant or parenting

21.14 student, solely because of the student's status as a pregnant or parenting student or due to

21.15 issues related to the student's pregnancy or parenting, to:

21.16 (1) take a leave of absence or withdraw from the student's degree or certificate program;

21.17 (2) limit the student's studies;

21.18 (3) participate in an alternative program;

21.19 (4) change the student's major, degree, or certificate program; or

21.20 (5) refrain from joining or cease participating in any course, activity, or program at the

21.21 college or university.

21.22 (b) A Minnesota state college or university shall provide and the University of Minnesota

21.23 is requested to provide reasonable modifications to a pregnant student, including

21.24 modifications that:

21.25 (1) would be provided to a student with a temporary medical condition; or

21.26 (2) are related to the health and safety of the student and the student's unborn child, such

21.27 as allowing the student to maintain a safe distance from substances, areas, and activities

21.28 known to be hazardous to pregnant women or unborn children.

22.1 (c) A Minnesota state college or university must and the University of Minnesota is
22.2 requested to, for reasons related to a student's pregnancy, childbirth, or any resulting medical
22.3 status or condition:

22.4 (1) excuse the student's absence;

22.5 (2) allow the student to make up missed assignments or assessments;

22.6 (3) allow the student additional time to complete assignments in the same manner as the
22.7 institution allows for a student with a temporary medical condition; and

22.8 (4) provide the student with access to instructional materials and video recordings of
22.9 lectures for classes for which the student has an excused absence under this section to the
22.10 same extent that instructional materials and video recordings of lectures are made available
22.11 to any other student with an excused absence.

22.12 (d) A Minnesota state college or university must and the University of Minnesota is
22.13 requested to allow a pregnant or parenting student to:

22.14 (1) take a leave of absence; and

22.15 (2) if in good academic standing at the time the student takes a leave of absence, return
22.16 to the student's degree or certificate program in good academic standing without being
22.17 required to reapply for admission.

22.18 (e) If a public college or university provides early registration for courses or programs
22.19 at the institution for any group of students, the Minnesota state college or university must
22.20 provide and the University of Minnesota is requested to provide early registration for those
22.21 courses or programs for pregnant or parenting students in the same manner.

22.22 Subd. 3. **Policy on discrimination.** Each Minnesota state college or university must
22.23 adopt and the University of Minnesota is requested to adopt a policy for students on
22.24 pregnancy and parenting discrimination. The policy must:

22.25 (1) include the contact information of the Title IX coordinator who is the designated
22.26 point of contact for a student requesting each protection or modification under this section.
22.27 Contact information must include the Title IX coordinator's name, phone number, email,
22.28 and office;

22.29 (2) be posted in an easily accessible, straightforward format on the college or university's
22.30 website; and

22.31 (3) be made available annually to faculty, staff, and employees of the college or
22.32 university.

23.1 Subd. 4. **Administration.** The commissioner of the Office of Higher Education must,
23.2 in consultation with the Board of Trustees of the Minnesota State Colleges and Universities
23.3 and the Board of Regents of the University of Minnesota, establish guidelines, as necessary,
23.4 to administer this section. The guidelines must establish minimum periods for which a

Subd. 2. **Content.** Each policy shall include a list of services each campus must make available to any student who, through a recent assessment, can document a disability. The following three services must be included in the policy:

(1) support, counseling, and information that may include support groups, individual counseling, career counseling and assessment, and referral services;

(2) academic assistance services that may include early registration services, early syllabus availability, course selection and program advising, coursework and testing assistance and modification, and tutoring; and

(3) advocacy services that may include a designated ombudsman serving as the primary contact and coordinator for students needing services, assistance in working individually with faculty and administrators, intervention procedures, and grievance procedures.

Subd. 3. **Availability.** The policy and related information must be readily available to enrolled students and applicants for admission. At a minimum, information on services, including a contact person and location, must be included in the campus catalog and in the schedule of course offerings each term.
