1.1 A bill for an act
1.2 relating to health occupations; increasing certain Board of Social Work fees;
1.3 amending Minnesota Statutes 2016, section 148E.180.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. Minnesota Statutes 2016, section 148E.180, is amended to read:

1.6 148E.180 FEE AMOUNTS.

1.7 Subdivision 1. Application fees. Nonrefundable application fees for licensure are as
1.8 follows may not exceed the following amounts but may be adjusted lower by board action:

- 1.9 (1) for a licensed social worker, \$45 \$75;
1.10 (2) for a licensed graduate social worker, \$45 \$75;
1.11 (3) for a licensed independent social worker, \$45 \$75;
1.12 (4) for a licensed independent clinical social worker, \$45 \$75;
1.13 (5) for a temporary license, \$50; and
1.14 (6) for a licensure by endorsement, \$85 \$115.

1.15 The fee for criminal background checks is the fee charged by the Bureau of Criminal
1.16 Apprehension. The criminal background check fee must be included with the application
1.17 fee as required according to section 148E.055.

1.18 Subd. 2. License fees. Nonrefundable license fees are as follows may not exceed the
1.19 following amounts but may be adjusted lower by board action:

- 1.20 (1) for a licensed social worker, \$81 \$115;

- 2.1 (2) for a licensed graduate social worker, ~~\$144~~ \$210;
- 2.2 (3) for a licensed independent social worker, ~~\$216~~ \$305;
- 2.3 (4) for a licensed independent clinical social worker, ~~\$238.50~~ \$335;
- 2.4 (5) for an emeritus inactive license, ~~\$43.20~~ \$65;
- 2.5 (6) for an emeritus active license, one-half of the renewal fee specified in subdivision
- 2.6 3; and
- 2.7 (7) for a temporary leave fee, the same as the renewal fee specified in subdivision 3.

2.8 If the licensee's initial license term is less or more than 24 months, the required license

2.9 fees must be prorated proportionately.

2.10 Subd. 3. **Renewal fees.** Nonrefundable renewal fees for licensure are as follows the

2.11 two-year renewal term may not exceed the following amounts but may be adjusted lower

2.12 by board action:

- 2.13 (1) for a licensed social worker, ~~\$81~~ \$115;
- 2.14 (2) for a licensed graduate social worker, ~~\$144~~ \$210;
- 2.15 (3) for a licensed independent social worker, ~~\$216~~ \$305; and
- 2.16 (4) for a licensed independent clinical social worker, ~~\$238.50~~ \$335.

2.17 Subd. 4. **Continuing education provider fees.** Continuing education provider fees are

2.18 as follows the following nonrefundable amounts:

- 2.19 (1) for a provider who offers programs totaling one to eight clock hours in a one-year
- 2.20 period according to section 148E.145, \$50;
- 2.21 (2) for a provider who offers programs totaling nine to 16 clock hours in a one-year
- 2.22 period according to section 148E.145, \$100;
- 2.23 (3) for a provider who offers programs totaling 17 to 32 clock hours in a one-year period
- 2.24 according to section 148E.145, \$200;
- 2.25 (4) for a provider who offers programs totaling 33 to 48 clock hours in a one-year period
- 2.26 according to section 148E.145, \$400; and
- 2.27 (5) for a provider who offers programs totaling 49 or more clock hours in a one-year
- 2.28 period according to section 148E.145, \$600.

2.29 Subd. 5. **Late fees.** Late fees are as follows the following nonrefundable amounts:

- 2.30 (1) renewal late fee, one-fourth of the renewal fee specified in subdivision 3;

3.1 (2) supervision plan late fee, \$40; and

3.2 (3) license late fee, \$100 plus the prorated share of the license fee specified in subdivision
3.3 2 for the number of months during which the individual practiced social work without a
3.4 license.

3.5 **Subd. 6. License cards and wall certificates.** (a) The fee for a license card as specified
3.6 in section 148E.095 is \$10.

3.7 (b) The fee for a license wall certificate as specified in section 148E.095 is \$30.

3.8 **Subd. 7. Reactivation fees.** Reactivation fees are ~~as follows~~ the following nonrefundable
3.9 amounts:

3.10 (1) reactivation from a temporary leave or emeritus status, the prorated share of the
3.11 renewal fee specified in subdivision 3; and

3.12 (2) reactivation of an expired license, 1-1/2 times the renewal fees specified in subdivision
