1.36 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

ARTICLE 1

ABSENTEE VOTING

Section 1. Minnesota Statutes 2012, section 5B.06, is amended to read:

5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.

A program participant who is otherwise eligible to vote may register with the secretary of state as ~~an ongoing~~ a permanent absentee voter. Notwithstanding section 203B.04, subdivision 5, the secretary of state is not required to send an absentee ballot application prior to each election to a program participant registered as a permanent absentee voter under this section. As soon as practicable before each election, the secretary of state shall determine the precinct in which the residential address of the program participant is located and shall request from and receive from the county auditor or other election official the ballot for that precinct and shall forward the absentee ballot to the program participant with the other materials for absentee balloting as required by Minnesota law. The program participant shall complete the ballot and return it to the secretary of state, who shall review the ballot in the manner provided by section 203B.24. If the ballot and ballot materials comply with the requirements of that section, the ballot must be certified by the secretary of state as the ballot of a program participant, and must be forwarded to the appropriate electoral jurisdiction for tabulation along with all other ballots. The name and address of a program participant must not be listed in the statewide voter registration system.

Sec. 2. Minnesota Statutes 2012, section 203B.02, subdivision 1, is amended to read:

Subdivision 1. ~~Unable to go to polling place~~ Absentee voting; eligibility. (a) Any eligible voter ~~who reasonably expects to be unable to go to the polling place on election day in the precinct where the individual maintains residence because of absence from the precinct; illness, including isolation or quarantine under sections 144.419 to 144.4196 or United States Code, title 42, sections 264 to 272; disability; religious discipline; observance of a religious holiday; or service as an election judge in another precinct~~ may vote by absentee ballot as provided in sections 203B.04 to 203B.15.

~~(b) If the governor has declared an emergency and filed the declaration with the secretary of state under section 12.31, and the declaration states that the emergency has made it difficult for voters to go to the polling place on election day, any voter in a precinct covered by the declaration may vote by absentee ballot as provided in sections 203B.04 to 203B.15.~~

Sec. 3. Minnesota Statutes 2012, section 203B.04, subdivision 1, is amended to read:

3.1 Subdivision 1. **Application procedures.** (a) Except as otherwise allowed by
3.2 subdivision 2 or by section 203B.11, subdivision 4, an application for absentee ballots for
3.3 any election may be submitted at any time not less than one day before the day of that
3.4 election. The county auditor shall prepare absentee ballot application forms in the format
3.5 provided by the secretary of state and shall furnish them to any person on request. By
3.6 January 1 of each even-numbered year, the secretary of state shall make the forms to be
3.7 used available to auditors through electronic means. An application submitted pursuant to
3.8 this subdivision shall be in writing and shall be submitted to:

3.9 (1) the county auditor of the county where the applicant maintains residence; or

3.10 (2) the municipal clerk of the municipality, or school district if applicable, where
3.11 the applicant maintains residence.

3.12 (b) An application shall be approved if it is timely received, signed and dated by
3.13 the applicant, contains the applicant's name and residence and mailing addresses, date
3.14 of birth, and at least one of the following:

3.15 (1) the applicant's Minnesota driver's license number;

3.16 (2) Minnesota state identification card number;

3.17 (3) the last four digits of the applicant's Social Security number; or

3.18 (4) a statement that the applicant does not have any of these numbers.

3.19 (c) To be approved, the application ~~must state that the applicant is eligible to vote by~~
3.20 ~~absentee ballot for one of the reasons specified in section 203B.02,~~ and must contain an oath
3.21 that the information contained on the form is accurate, that the applicant is applying on the
3.22 applicant's own behalf, and that the applicant is signing the form under penalty of perjury.

3.23 (d) An applicant's full date of birth, Minnesota driver's license or state identification
3.24 number, and the last four digits of the applicant's Social Security number must not be
3.25 made available for public inspection. An application may be submitted to the county
3.26 auditor or municipal clerk by an electronic facsimile device. An application mailed or
3.27 returned in person to the county auditor or municipal clerk on behalf of a voter by a
3.28 person other than the voter must be deposited in the mail or returned in person to the
3.29 county auditor or municipal clerk within ten days after it has been dated by the voter and
3.30 no later than six days before the election. The absentee ballot applications or a list of
3.31 persons applying for an absentee ballot may not be made available for public inspection
3.32 until the close of voting on election day.

3.33 (e) An application under this subdivision may contain an application under
3.34 subdivision 5 to automatically receive an absentee ballot application.

3.35 Sec. 4. Minnesota Statutes 2012, section 203B.04, subdivision 5, is amended to read:

4.1 Subd. 5. **Permanent illness or disability absentee voter status.** (a) An eligible
 4.2 voter ~~who reasonably expects to be permanently unable to go to the polling place on~~
 4.3 ~~election day because of illness or disability~~ may apply to a county auditor or municipal
 4.4 clerk ~~under this section~~ to automatically receive an absentee ballot application before each
 4.5 election, other than an election by mail conducted under section 204B.45, and to have
 4.6 the status as a permanent absentee voter indicated on the voter's registration record. An
 4.7 eligible voter listed as an ongoing absentee voter as of July 31, 2013, pursuant to laws
 4.8 in effect on that date, shall be treated as if the voter applied for status as a permanent
 4.9 absentee voter pursuant to this subdivision.

4.10 (b) A voter who applies under paragraph (a) must automatically be provided an
 4.11 absentee ballot application for each eligible election. A voter's permanent absentee status
 4.12 ends and automatic ballot application delivery must be terminated on:

4.13 (1) the voter's written request;

4.14 (2) the voter's death;

4.15 (3) return of an absentee ballot as undeliverable; or

4.16 (4) a change in the voter's status to "challenged" or "inactive" in the statewide voter
 4.17 registration system.

4.18 ~~(b)~~ (c) The secretary of state shall adopt rules governing procedures under this
 4.19 subdivision.

4.20 Sec. 5. Minnesota Statutes 2012, section 203B.06, subdivision 1, is amended to read:

4.21 Subdivision 1. **Printing and delivery of forms.** Each county auditor and municipal
 4.22 clerk shall prepare and print a sufficient number of blank application forms for absentee
 4.23 ballots. The county auditor or municipal clerk shall deliver a blank application form to
 4.24 any voter who requests one pursuant to section 203B.04. Blank application forms must be
 4.25 mailed to eligible voters who have requested an application pursuant to section 203B.04,
 4.26 subdivision 5 ~~or 6~~, at least 60 days before:

4.27 (1) each regularly scheduled primary for federal, state, county, city, or school board
 4.28 office;

4.29 (2) each regularly scheduled general election for city or school board office for
 4.30 which a primary is not held; and

4.31 (3) a special primary to fill a federal or county office vacancy or special election to
 4.32 fill a federal or county office vacancy, if a primary is not required to be held pursuant to

5.1 Sec. 6. Minnesota Statutes 2012, section 203B.121, subdivision 2, is amended to read:

5.2 Subd. 2. **Duties of ballot board; absentee ballots.** (a) The members of the ballot
5.3 board shall take possession of all return envelopes delivered to them in accordance with
5.4 section 203B.08. Upon receipt from the county auditor, municipal clerk, or school district
5.5 clerk, two or more members of the ballot board shall examine each return envelope and
5.6 shall mark it accepted or rejected in the manner provided in this subdivision. Election
5.7 judges performing the duties in this section must be of different major political parties,
5.8 unless they are exempt from that requirement under section 205.075, subdivision 4, or
5.9 section 205A.10, subdivision 2.

5.10 (b) The members of the ballot board shall mark the return envelope "Accepted" and
5.11 initial or sign the return envelope below the word "Accepted" if a majority of the members
5.12 of the ballot board examining the envelope are satisfied that:

5.13 (1) the voter's name and address on the return envelope are the same as the
5.14 information provided on the absentee ballot application;

5.15 (2) the voter signed the certification on the envelope;

5.16 (3) the voter's Minnesota driver's license, state identification number, or the last four
5.17 digits of the voter's Social Security number are the same as the number provided on the
5.18 voter's application for ballots. If the number does not match the number as submitted on
5.19 the application, or if a number was not submitted on the application, the election judges
5.20 must compare the signature provided by the applicant to determine whether the ballots
5.21 were returned by the same person to whom they were transmitted;

5.22 (4) the voter is registered and eligible to vote in the precinct or has included a
5.23 properly completed voter registration application in the return envelope;

5.24 (5) the certificate has been completed as prescribed in the directions for casting an
5.25 absentee ballot; and

5.26 (6) the voter has not already voted at that election, either in person or, if it is after the
5.27 close of business on the ~~fourth~~ seventh day before the election, by absentee ballot.

5.28 The return envelope from accepted ballots must be preserved and returned to the
5.29 county auditor.

5.30 (c)(1) If a majority of the members of the ballot board examining a return envelope
5.31 find that an absentee voter has failed to meet one of the requirements provided in
5.32 paragraph (b), they shall mark the return envelope "Rejected," initial or sign it below the
5.33 word "Rejected," list the reason for the rejection on the envelope, and return it to the
5.34 county auditor. There is no other reason for rejecting an absentee ballot beyond those
5.35 permitted by this section. Failure to place the ballot within the security envelope before
5.36 placing it in the outer white envelope is not a reason to reject an absentee ballot.

6.1 (2) If an envelope has been rejected at least five days before the election, the
6.2 envelope must remain sealed and the official in charge of the ballot board shall provide the
6.3 voter with a replacement absentee ballot and return envelope in place of the rejected ballot.

6.4 (3) If an envelope is rejected within five days of the election, the envelope must
6.5 remain sealed and the official in charge of the ballot board must attempt to contact the
6.6 voter by telephone or e-mail to notify the voter that the voter's ballot has been rejected.
6.7 The official must document the attempts made to contact the voter.

6.8 (d) The official in charge of the absentee ballot board must mail the voter a written
6.9 notice of absentee ballot rejection between six and ten weeks following the election. If the
6.10 official determines that the voter has otherwise cast a ballot in the election, no notice is
6.11 required. If an absentee ballot arrives after the deadline for submission provided by this
6.12 chapter, the notice must be provided between six to ten weeks after receipt of the ballot. A
6.13 notice of absentee ballot rejection must contain the following information:

6.14 (1) the date on which the absentee ballot was rejected or, if the ballot was received
6.15 after the required deadline for submission, the date on which the ballot was received;

6.16 (2) the reason for rejection; and

6.17 (3) the name of the appropriate election official to whom the voter may direct further
6.18 questions, along with appropriate contact information.

6.19 (e) An absentee ballot return envelope marked "Rejected" may not be opened or
6.20 subject to further review except in an election contest filed pursuant to chapter 209.

6.21 Sec. 7. Minnesota Statutes 2012, section 203B.121, subdivision 3, is amended to read:

6.22 Subd. 3. **Record of voting.** (a) When applicable, the county auditor or municipal
6.23 clerk must immediately record that a voter's absentee ballot has been accepted. After the
6.24 close of business on the ~~fourth~~ seventh day before the election, a voter whose record
6.25 indicates that an absentee ballot has been accepted must not be permitted to cast another
6.26 ballot at that election. In a state primary, general, or state special election for federal or
6.27 state office, the auditor or clerk must also record this information in the statewide voter
6.28 registration system.

6.29 (b) The roster must be marked, and a supplemental report of absentee voters who
6.30 submitted a voter registration application with their ballot must be created, no later than
6.31 the start of voting on election day to indicate the voters that have already cast a ballot at
6.32 the election. The roster may be marked either:

6.33 (1) by the county auditor or municipal clerk before election day;

6.34 (2) by the ballot board before election day; or

6.35 (3) by the election judges at the polling place on election day.

7.1 The record of a voter whose absentee ballot was received after the close of business
7.2 on the ~~fourth~~ seventh day before the election is not required to be marked on the roster or
7.3 contained in a supplemental report as required by this paragraph.

7.4 Sec. 8. Minnesota Statutes 2012, section 203B.121, subdivision 4, is amended to read:

7.5 Subd. 4. **Opening of envelopes.** After the close of business on the ~~fourth~~ seventh
7.6 day before the election, the ballots from return envelopes marked "Accepted" may be
7.7 opened, duplicated as needed in the manner provided in section 206.86, subdivision 5,
7.8 initialed by the members of the ballot board, and deposited in the appropriate ballot box. If
7.9 more than one ballot is enclosed in the ballot envelope, the ballots must be returned in the
7.10 manner provided by section 204C.25 for return of spoiled ballots, and may not be counted.

7.11 Sec. 9. **REPEALER.**

7.12 Minnesota Statutes 2012, section 203B.04, subdivision 6, is repealed.

7.13 Sec. 10. **EFFECTIVE DATE; APPLICABILITY.**

7.14 This article is effective January 1, 2014, and applies to voting at elections conducted

7.21 No. A11-152 (February 21, 2012).

7.22 Subd. 2. **House of representatives districts.** Notwithstanding the order of the
7.23 Minnesota Special Redistricting Panel in Hippert v. Ritchie, No. A11-152 (February
7.24 21, 2012), Senate District 39, as described in that order, is divided into two house of
7.25 representatives districts as follows:

7.26 (a) House of Representatives District 39A consists of the district as described in
7.27 that order, with the modification contained in file L39A-1, on file with the Geographic
7.28 Information Systems Office of the Legislative Coordinating Commission and published on
7.29 its Web site on March 9, 2012.

7.30 (b) House of Representatives District 39B consists of that district as described in
7.31 that order, with the modification contained in file L39B-1, on file with the Geographic

8.2 its Web site on March 9, 2012.

8.3 **EFFECTIVE DATE.** This section is effective for the state primary and state general

8.7 Subdivision 1. **Senate district.** Senate District 49 consists of that district as
8.8 described in the order of the Minnesota Special Redistricting Panel in Hippert v. Ritchie,
8.9 No. A11-152 (February 21, 2012).

8.10 Subd. 2. **House of representatives districts.** Notwithstanding the order of the
8.11 Minnesota Special Redistricting Panel in Hippert v. Ritchie, No. A11-152 (February 21,
8.12 2012), Senate District 49 is divided into two house of representatives districts as follows:

8.13 (a) House of Representatives District 49A consists of the district as described in
8.14 that order, with the modification contained in file L49A-2, on file with the Geographic
8.15 Information Systems Office of the Legislative Coordinating Commission and published on
8.16 its Web site on March 28, 2012.

8.17 (b) House of Representatives District 49B consists of the district as described in
8.18 that order, with the modification contained in file L49B-2, on file with the Geographic
8.19 Information Systems Office of the Legislative Coordinating Commission and published on
8.20 its Web site on March 28, 2012.

8.21 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.22 Sec. 3. Minnesota Statutes 2012, section 103C.225, subdivision 3, is amended to read:

8.23 Subd. 3. **Referendum.** (a) ~~Within 60 days after the petition is received by the state~~
8.24 ~~board, it shall give due notice of the holding of a referendum, schedule the referendum at~~
8.25 ~~the next general election, and cooperate with county election officials to accomplish the~~
8.26 ~~election in the most expedient manner. Upon receipt of a petition, the state board shall~~
8.27 ~~provide written notice to the secretary of state and the county auditor of each county in~~
8.28 ~~which the district is located no later than 74 days before the state general election. The~~

 9.4 ~~the existence of the (name of the soil and water conservation district to be here~~
 9.5 ~~inserted)" shall be printed, with a square before each proposition and a direction to insert~~
 9.6 ~~an X mark in the square before one or the other~~ be terminated?".

9.7 (c) Only eligible voters in the district may vote in the referendum.

9.8 (d) Informalities in the conduct of the referendum or matters relating to the
 9.9 referendum do not invalidate the referendum, or result of the referendum, if due notice has
 9.10 been given and the referendum has been fairly conducted.

9.11 (e) The state board shall publish the result of the referendum.

9.12 Sec. 4. Minnesota Statutes 2012, section 103C.305, subdivision 3, is amended to read:

9.13 Subd. 3. **Ballots.** Ballots shall be prepared by the county auditor. The names of
 9.14 candidates shall be placed on the ~~"canary ballot" described in section 204D.11, subdivision~~
 9.15 ~~3~~ state general election ballot. The office title printed on the ballot must be either "Soil
 9.16 and Water Conservation District Supervisor" or "Conservation District Supervisor," based
 9.17 upon the district from which the supervisor is to be elected.

9.18 Sec. 5. Minnesota Statutes 2012, section 103C.311, subdivision 2, is amended to read:

9.19 Subd. 2. **Supervisors elected by districts.** (a) The district board, with the approval
 9.20 of the state board, may by resolution provide that supervisors will be elected by supervisor
 9.21 districts as provided in this subdivision.

9.22 (b) The supervisor districts must be composed of precincts established by county and
 9.23 municipal governing bodies under section 204B.14. The districts must be compact, include
 9.24 only contiguous territory, and be substantially equal in population. The districts must be
 9.25 numbered in a regular series. The districts must be drawn by the county board of the county
 9.26 containing the largest area of the soil and water conservation district, in consultation with
 9.27 the district board and with the approval of the state board. The boundaries of the districts
 9.28 must be redrawn after each decennial federal census as provided in section 204B.135. A
 9.29 certified copy of the resolution establishing supervisor districts must be filed by the chair
 9.30 of the district board with the county auditor of the counties where the soil and water
 9.31 conservation district is located, with the state board, and with the secretary of state ~~at least~~
 9.32 ~~30 days before the first date candidates may file for the office of supervisor, and the filings~~
 9.33 must occur within 80 days of the time when the legislature has been redistricted or at least
 9.34 15 weeks before the state primary election in a year ending in two, whichever comes first.

10.1 (c) Each supervisor district is entitled to elect one supervisor. A supervisor must be a
 10.2 resident of the district from which elected.

10.3 (d) The district board shall provide staggered terms for supervisors elected by
 10.4 district. After each redistricting, there shall be a new election of supervisors in all the
 10.5 districts at the next general election, except that if the change made in the boundaries of a
 10.6 district is less than five percent of the average population of all the districts, the supervisor
 10.7 in office at the time of the redistricting shall serve for the full term for which elected. The
 10.8 district board shall determine by lot the seats to be filled for a two-year term, a four-year
 10.9 term, and a six-year term.

10.10 Sec. 6. Minnesota Statutes 2012, section 123A.48, subdivision 14, is amended to read:

10.11 Subd. 14. **Election.** The board shall determine the date of the election, the number
 10.12 of boundaries of voting precincts, and the location of the polling places where voting shall
 10.13 be conducted, and the hours the polls will be open. The board shall also provide official
 10.14 ballots which must be used exclusively and shall be in the following form: "Shall the
 10.15 (name of school district) and the (name of school district) be consolidated as proposed?
 10.16 Yes No"

10.19 The board must appoint election judges who shall act as clerks of election. The
 10.20 ballots and results must be certified to the board who shall canvass and tabulate the total

Subdivision 1. **Authorization to make office appointive.** Notwithstanding Minnesota Statutes, section 382.01, upon adoption of a resolution by the Kandiyohi County Board of Commissioners, the offices of county auditor-treasurer and county recorder are not elective but must be filled by appointment by the county board as provided in the resolution.

Subd. 2. **Board controls; may change as long as duties done.** Upon adoption of a resolution by the county board of commissioners and subject to subdivisions 3 and 4, the duties of an elected official required by statute whose office is made appointive as authorized by this section must be discharged by the county board of commissioners acting through a department head appointed by the board for that purpose. Reorganization, reallocation, delegation, or other administrative change or transfer does not diminish, prohibit, or avoid the discharge of duties required by statute.

Subd. 3. **Incumbents to complete term.** The person elected at the last general election to an office made appointive under this section must serve in that capacity and perform the duties, functions, and responsibilities required by statute until the completion of the term of office to which the person was elected or until a vacancy occurs in the office, whichever occurs earlier.

Subd. 4. **Publishing resolution; petition; referendum.** (a) Before the adoption of a resolution to provide for the appointment of the county auditor-treasurer and the county recorder, the county board must publish a proposed resolution notifying the public of its intent to consider the issue once each week for two consecutive weeks in the official publication of the county. Following publication and prior to formally adopting the resolution, the county board shall provide an opportunity at its next regular meeting for public comment relating to the issue. After the public comment opportunity, at the same meeting or a subsequent meeting, the county board of commissioners may adopt a resolution that provides for the appointment of the county auditor-treasurer and the county recorder as permitted in this section. The resolution must be approved by at least 80 percent of the members of the county board. The resolution may take effect 60 days after it is adopted, or at a later date stated in the resolution, unless a petition is filed as provided in paragraph (b).

60.1 (b) Within 60 days after the county board adopts the resolution, a petition requesting
 60.2 a referendum may be filed with the county auditor-treasurer. The petition must be signed
 60.3 by at least ten percent of the registered voters of the county. The petition must meet

2.484 FORTY-FIFTH DISTRICT.

Subdivision 1. **Senate district.** Senate District 45 consists of that district as described in the order of the Minnesota Special Redistricting Panel in *Zachman v. Kiffmeyer*, No. C0-01-160 (March 19, 2002).

Subd. 2. **House of representatives districts.** Notwithstanding the order of the Minnesota Special Redistricting Panel in *Zachman v. Kiffmeyer*, No. C0-01-160 (March 19, 2002), Senate District 45, as described in that order, is divided into two house of representatives districts as follows:

(a) House of Representatives District 45A consists of House of Representatives District 45A as described in that order, except for the portion of that House of Representatives District 45A described as follows:

Beginning at the intersection of the center lines of 35th Avenue North and Nevada Avenue North, then south along the center line of Nevada Avenue North to the center line of 34th Avenue North, then west along the center line of 34th Avenue North to the center line of Winpark Drive, then north along the center line of Winpark Drive to the center line of 35th Avenue North, then west along the center line of 35th Avenue North to the center line of Winnetka Avenue North, then north along the center line of Winnetka Avenue North to the north municipal boundary line of Crystal, then west along that municipal boundary line to the west municipal boundary line of Crystal, then south along that municipal boundary line to the center line of 33rd Avenue North, then east along the center line of 33rd Avenue North to the center line of Wisconsin Avenue North, then north along the center line of Wisconsin Avenue North to the center line of 35th Avenue North, then east along the center line of 35th Avenue North to the center line of Utah Avenue North, then south along the center line of Utah Avenue North to the center line of 33rd Place North, then east along the center line of 33rd Place North to the center line of Winnetka Avenue North, then south along the center line of Winnetka Avenue North to the center line of 32nd Avenue North, then east along the center line of 32nd Avenue North to the center line of Nevada Avenue, then north along the center line of Nevada Avenue to the center line of Valley Place, then east along the center line of Valley Place to the center line of Louisiana Avenue North, then north along the center line of Louisiana Avenue North to the center line of 35th Avenue North, then west along the center line of 35th Avenue North to the center line of Nevada Avenue North, which was the place of beginning.

203B.04 APPLICATION FOR BALLOTS.

Subd. 6. **Ongoing absentee status; termination.** (a) An eligible voter may apply to a county auditor or municipal clerk for status as an ongoing absentee voter who reasonably expects to meet the requirements of section 203B.02, subdivision 1. Each applicant must automatically be provided with an absentee ballot application for each ensuing election other than an election by mail conducted under section 204B.45, and must have the status of ongoing absentee voter indicated on the voter's registration record.

(b) Ongoing absentee voter status ends on:

- (1) the voter's written request;
- (2) the voter's death;
- (3) return of an ongoing absentee ballot as undeliverable;
- (4) a change in the voter's status so that the voter is not eligible to vote under section 201.15 or 201.155; or
- (5) placement of the voter's registration on inactive status under section 201.171.

204B.12 WITHDRAWAL OF CANDIDATES.

Subd. 2a. **After primary; candidates for constitutional office.** (a) A candidate for a constitutional office may withdraw from the general election ballot by filing an affidavit of withdrawal with the same official who received the affidavit of candidacy. The affidavit must request that official to withdraw that candidate's name from the ballot and must be filed no later than 16 days before the general election.

(b) A candidate for a constitutional office may withdraw after the deadline in paragraph (a) if:

- (1) the candidate withdraws because of a catastrophic illness that was diagnosed after the deadline for withdrawal;

(2) the candidate's illness will permanently and continuously incapacitate the candidate and prevent the candidate from performing the duties of the office sought; and

(3) the candidate or the candidate's legal guardian files with the affidavit of withdrawal a certificate verifying that the candidate's illness meets the requirements of clauses (1) and (2), signed by at least two licensed physicians.

204B.13 VACANCY IN NOMINATION.

Subd. 4. **Nonpartisan office; filling vacancy.** A vacancy in nomination in a nonpartisan office may be filled by filing an affidavit of candidacy and paying a filing fee or by filing an affidavit of candidacy and filing a petition in place of a filing fee in the manner provided in sections 204B.06, 204B.09, and 204B.11. All documents and fees required by this subdivision must be filed within five days after the vacancy in nomination occurs. There must be a two-day period for withdrawal of candidates after the last day for filing.

If the vacancy in nomination resulted from a withdrawal during the withdrawal period held on the 68th to 69th day before the primary, and if, at the end of the withdrawal period to fill the vacancy in nomination, there are more than two candidates, the candidates' names must appear on the primary ballot.

In all other cases, the candidates' names must appear on the general election ballot.

Subd. 6. **Vacancy after deadline.** If a candidate withdraws after the 16th day before the general election but before four days before the general election, the secretary of state shall instruct the election judges to strike the name of the withdrawn candidate from the general election ballot and shall substitute no other candidate's name. Filing officers may not accept a nomination certificate for filing to fill a vacancy in nomination resulting from the filing of an affidavit of withdrawal by a candidate after the 14th day before the general election.

204B.22 ELECTION JUDGES; NUMBER REQUIRED.

Subd. 2. **Exception.** A minimum of three election judges shall be appointed in precincts not using electronic voting equipment. One additional election judge shall be appointed for each 150 votes cast in that precinct at the last similar election.

204B.42 PAPER COLOR FOR SAMPLE BALLOTS; PENALTY.

No sample ballot shall be printed on paper of the same color as any official ballots except when printed in black ink on white paper and appearing in a newspaper as news matter. A violation of this section is a misdemeanor.

204D.11 STATE GENERAL ELECTION BALLOTS; CANDIDATES; OFFICIAL IN CHARGE; RULES; REIMBURSEMENT.

Subd. 2. **Pink ballots.** Amendments to the state Constitution shall be placed on a ballot printed on pink paper which shall be known as the "pink ballot." The pink ballot shall be prepared by the county auditor, in the manner provided in the rules of the secretary of state.

Subd. 3. **Canary ballot.** All questions and the names of all candidates for offices to be voted on at the state general election which are not placed on the white ballot shall be placed on a single ballot printed on canary paper which shall be known as the "canary ballot." The canary ballot shall be prepared by the county auditor in the manner provided in the rules of the secretary of state.

205.17 BALLOTS.

Subd. 2. **First class cities.** In all cities of the first class, for the municipal general election, the city clerk shall have printed in blocks of 50 a partisan ballot upon which the names of all candidates for the office of mayor and for the city council are printed, and a nonpartisan ballot upon which the names of all candidates for all other city offices are printed. The partisan ballot shall be printed on light orange paper and shall be headed "City Partisan General Ballot." The nonpartisan ballot shall be printed on light green paper and shall be headed "City Nonpartisan General Ballot." Both ballots shall state the name of the city and the date of the election and conform in all other respects to the white ballot used at the state general election. The names of the candidates on the nonpartisan ballot shall be rotated in the manner prescribed for the rotation of names on nonpartisan ballots in state general elections.

APPENDIX

Repealed Minnesota Statutes: H0894-5

On the partisan ballot the names of the candidates for mayor shall be placed first. The order of the names of the candidates shall be in the manner prescribed for state general elections in section 204D.13.

Subd. 4. **Blue ballots; questions.** All questions relating to the adoption of a city charter or charter amendments, a proposition for the issuance of bonds, and all other questions relating to city or town affairs submitted at an election to the voters of the municipality shall be printed on one separate blue ballot and shall be prepared, printed, and distributed under the direction of the municipal clerk at the same time and in the same manner as other municipal ballots. The ballots, when voted, shall be deposited in a separate blue ballot box provided by the local authorities for each voting precinct. The ballots shall be canvassed, counted, and returned in the same manner as other municipal ballots. The returns shall provide appropriate blank spaces for the counting, canvassing, and returning of the results of the questions submitted on the blue ballot.

205A.08 BALLOTS.

Subd. 4. **Goldenrod ballots; questions.** All questions relating to a proposition for the issuance of bonds, and all other questions relating to school district affairs submitted at an election to the voters of the school district, shall be printed on one separate goldenrod ballot and shall be prepared, printed, and distributed under the direction of the school district clerk at the same time and in the same manner as other school district ballots. The ballots, when voted, shall be deposited in a separate goldenrod ballot box provided by the local authorities for each voting precinct. The ballots shall be canvassed, counted, and returned in the same manner as other school district ballots. The returns shall provide appropriate blank spaces for the counting, canvassing, and return of the results of the questions submitted on the goldenrod ballot.
