1.2 relating to labor and industry; modifying construction codes and licensing;
1.3 requiring rulemaking; amending Minnesota Statutes 2008, sections 326B.082,
1.4 subdivision 12; 326B.084; 326B.43, subdivision 1; 326B.435, subdivision 2;
1.5 326B.475, subdivision 6; 326B.52; 326B.53; 326B.55; 326B.57; 326B.58;
1.6 326B.59; 326B.801; 326B.84; 326B.921, subdivision 1; proposing coding for
1.7 new law in Minnesota Statutes, chapter 326B; repealing Minnesota Statutes
1.8 2008, section 326B.43, subdivision 5.

1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 Section 1. Minnesota Statutes 2008, section 326B.082, subdivision 12, is amended to
1.11 read:

1.12 Subd. 12. **Issuance of licensing orders; hearings related to licensing orders.**

1.13 (a) If the commissioner determines that a permit, license, registration, or certificate
1.14 should be conditioned, limited, suspended, revoked, or denied under subdivision 11,
1.15 or that the permit holder, licensee, registrant, or certificate holder should be censured
1.16 under subdivision 11, then the commissioner shall issue to the person an order denying,
1.17 conditioning, limiting, suspending, or revoking the person's permit, license, registration,
1.18 or certificate, or censuring the permit holder, licensee, registrant, or certificate holder.

1.19 (b) Any order issued under paragraph (a) may include an assessment of monetary
1.20 penalties and may require the person to cease and desist from committing the violation
1.21 or committing the act, conduct, or practice set out in subdivision 11, paragraph (b). The
1.22 monetary penalty may be up to \$10,000 for each violation or act, conduct, or practice
1.23 committed by the person. The procedures in section 326B.083 must be followed when
1.24 issuing orders under paragraph (a).

1.25 (c) The permit holder, licensee, registrant, certificate holder, or applicant to whom
1.26 the commissioner issues an order under paragraph (a) shall have 30 days after ~~service~~

2.1 issuance of the order to request a hearing. The request for hearing must be in writing and
2.2 must be served on or faxed to the commissioner at the address or fax number specified
2.3 in the order by the 30th day after ~~service~~ issuance of the order. If the person does not
2.4 request a hearing or if the person's written request for hearing is not served on or faxed
2.5 to the commissioner by the 30th day after ~~service~~ issuance of the order, the order shall
2.6 become a final order of the commissioner and will not be subject to review by any court or
2.7 agency. The date on which a request for hearing is served by mail shall be the postmark
2.8 date on the envelope in which the request for hearing is mailed. If the person submits to
2.9 the commissioner a timely request for hearing, the order is stayed unless the commissioner
2.10 summarily suspends the license, registration, certificate, or permit under subdivision 13,
2.11 and a contested case hearing shall be held in accordance with chapter 14.

2.14 Subdivision 1. False information. A person subject to any of the requirements in
2.15 the applicable law may not make a false material statement, representation, or certification
2.16 in; omit material information from; or alter, conceal, or fail to file or maintain a notice,
2.17 application, record, report, plan, or other document required under the applicable law.

2.18 Subd. 2. Unlicensed advertising. No person shall offer to perform services for
2.19 which a license issued by the commissioner is required unless the person holds an active
2.20 license to perform those services. Nothing herein shall prohibit an offer to sell, repair, or
2.21 perform services provided those services are performed by a licensed person.

2.23 Subdivision 1. **Rules.** The Plumbing Board may, by rule, prescribe minimum
2.24 standards which shall be uniform and which shall be effective for all new plumbing
2.25 installations performed anywhere in the state, including additions, extensions, alterations,
2.26 and replacements ~~connected with any water or sewage disposal system owned or operated~~
2.27 ~~by or for any municipality, institution, factory, office building, hotel, apartment building,~~

2.29 ~~which the installation is to be located.~~ Notwithstanding the provisions of Minnesota Rules,

3.20 plumbers, restricted master plumbers, ~~and~~ restricted journeymen, water conditioning
3.21 contractors, and water conditioning installers, and other persons engaged in the design,
3.22 installation, and alteration of plumbing systems or engaged in or working at the business
3.23 of water conditioning installation or service, except for those individuals licensed under
3.24 section 326.02, subdivisions 2 and 3. The board shall adopt these rules pursuant to chapter
3.25 14 and as provided in subdivision 6, paragraphs (e) and (f);

3.26 (6) advise the commissioner regarding educational requirements for plumbing
3.27 inspectors;

3.28 (7) refer complaints or other communications to the commissioner, whether oral or
3.29 written, as provided in subdivision 8, that allege or imply a violation of a statute, rule, or
3.30 order that the commissioner has the authority to enforce pertaining to code compliance,
3.31 licensure, or an offering to perform or performance of unlicensed plumbing services;

3.32 (8) approve per diem and expenses deemed necessary for its members as provided in
3.33 subdivision 3;

3.34 (9) approve license reciprocity agreements;

4.1 (10) select from its members individuals to serve on any other state advisory council,
4.2 board, or committee; and

4.3 (11) recommend the fees for licenses and certifications.

4.4 Except for the powers granted to the Plumbing Board, the Board of Electricity, and the
4.5 Board of High Pressure Piping Systems, the commissioner of labor and industry shall
4.6 administer and enforce the provisions of this chapter and any rules promulgated pursuant

5.27 issued to an individual other than a water conditioning contractor who has demonstrated
5.28 practical knowledge of water conditioning installation, and has successfully passed
5.29 the examination for water conditioning installers. A water conditioning installer must
5.30 successfully pass the examination for water conditioning contractors before being licensed
5.31 as a water conditioning contractor.

5.32 Subd. 3. **Rules Commissioner.** The commissioner shall:

5.33 (1) ~~prescribe rules, not inconsistent herewith, for the licensing of water conditioning~~
5.34 ~~contractors and installers;~~

5.35 ~~(2)~~ license water conditioning contractors and installers; and

6.14 licensed plumber which may be performed by a person licensed hereunder, ~~and~~. The
6.15 commissioner may by rule in appropriate instances require filing of plans, blueprints and
6.16 specifications prior to commencement of installation. The installation of water heaters
6.17 shall not constitute water conditioning installation and consequently such work shall be
6.18 accomplished in accordance with the provisions of sections 326B.42 to 326B.49.

6.21 Examination fees for both water conditioning contractors and water conditioning
6.22 installers shall be \$50 for each examination. Each water conditioning contractor and
6.23 installer license shall expire on December 31 of the year for which it was issued. The
6.24 license fee for each initial water conditioning contractor's license shall be \$70, except that
6.25 the license fee shall be \$35 if the application is submitted during the last three months
6.26 of the calendar year. The license fee for each renewal water conditioning contractor's
6.27 license shall be \$70. The license fee for each initial water conditioning installer license
6.28 shall be \$35, except that the license fee shall be \$17.50 if the application is submitted
6.29 during the last three months of the calendar year. The license fee for each renewal water

7.18 Except as otherwise provided by law, ~~the provisions of~~ sections 326B.801 to

7.20 roofers, and manufactured home installers.

7.22 **326B.84 GROUNDS FOR LICENSE SANCTIONS.**

7.23 In addition to the grounds set forth in section 326B.082, subdivision 11, the
7.24 commissioner may deny, suspend, limit, place conditions on, or revoke a license or
7.25 certificate of exemption, or may censure the person holding the license or certificate of
7.26 exemption, if the applicant, licensee, certificate of exemption holder, qualifying person,
7.27 owner, officer, or affiliate of an applicant, licensee, or certificate of exemption holder, or
7.28 other agent owner:

7.29 (1) has filed an application for licensure or a certificate of exemption which is
7.30 incomplete in any material respect or contains any statement which, in light of the
7.31 circumstances under which it is made, is false or misleading with respect to any material
7.32 fact;

8.1 (2) has engaged in a fraudulent, deceptive, or dishonest practice;

8.2 (3) is permanently or temporarily enjoined by any court of competent jurisdiction
8.3 from engaging in or continuing any conduct or practice involving any aspect of the
8.4 business;

8.5 (4) has failed to reasonably supervise employees, agents, subcontractors, or
8.6 salespersons, or has performed negligently or in breach of contract, so as to cause injury
8.7 or harm to the public;

8.8 (5) has violated or failed to comply with any provision of sections 326B.802 to
8.9 326B.885, any rule or order under sections 326B.802 to 326B.885, or any other law, rule,
8.10 or order related to the duties and responsibilities entrusted to the commissioner;

8.11 (6) has been convicted of a violation of the State Building Code or has refused to
8.12 comply with a notice of violation or stop order issued by a certified building official, or in
8.13 local jurisdictions that have not adopted the State Building Code has refused to correct a
8.14 violation of the State Building Code when the violation has been documented or a notice
8.15 of violation or stop order issued by a certified building official has been received;

8.17 construction of, or any improvement to, residential real estate, as defined in section

8.20 performed, or skill, material, or machinery furnished for the improvement remains unpaid;

8.22 any unpaid labor performed, or skill, material, or machinery furnished for an improvement,
8.23 or a payment bond in the basic amount of the contract price for the improvement
8.24 conditioned for the prompt payment to any person or persons entitled to payment;

8.25 (9) has engaged in an act or practice that results in compensation to an aggrieved
8.26 owner or lessee from the contractor recovery fund pursuant to section 326B.89, unless:

8.27 (i) the applicant or licensee has repaid the fund twice the amount paid from the fund,
8.28 plus interest at the rate of 12 percent per year; and

8.29 (ii) the applicant or licensee has obtained a surety bond in the amount of at least
8.30 \$40,000, issued by an insurer authorized to transact business in this state;

8.31 (10) has engaged in bad faith, unreasonable delays, or frivolous claims in defense
8.32 of a civil lawsuit or arbitration arising out of their activities as a licensee or certificate
8.33 of exemption holder under this chapter;

8.34 (11) has had a judgment entered against them for failure to make payments to
8.35 employees, subcontractors, or suppliers, that the licensee has failed to satisfy and all
8.36 appeals of the judgment have been exhausted or the period for appeal has expired;

9.1 (12) if unlicensed, has obtained a building permit by the fraudulent use of a fictitious
9.2 license number or the license number of another, or, if licensed, has knowingly allowed
9.3 an unlicensed person to use the licensee's license number for the purpose of fraudulently
9.4 obtaining a building permit; or has applied for or obtained a building permit for an
9.5 unlicensed person;

9.6 (13) has made use of a forged mechanic's lien waiver under chapter 514;

9.7 (14) has provided false, misleading, or incomplete information to the commissioner
9.8 or has refused to allow a reasonable inspection of records or premises;

9.9 (15) has engaged in an act or practice whether or not the act or practice directly
9.10 involves the business for which the person is licensed, that demonstrates that the applicant
9.11 or licensee is untrustworthy, financially irresponsible, or otherwise incompetent or
9.12 unqualified to act under the license granted by the commissioner; or

9.13 (16) has failed to comply with requests for information, documents, or other requests
9.14 from the department within the time specified in the request or, if no time is specified,

9.17 Subdivision 1. **License required; rules; time credit.** No individual shall engage in
9.18 or work at the business of a contracting high pressure pipefitter unless issued a contracting
9.19 high pressure pipefitter license to do so by the department under rules adopted by the
9.20 board. No license shall be required for repairs on existing installations. No individual shall
9.21 engage in or work at the business of journeyman high pressure pipefitter unless issued a
9.22 journeyman high pressure pipefitter competency license to do so by the department under
9.23 rules adopted by the board. An individual possessing a contracting high pressure pipefitter
9.24 competency license may also work as a journeyman high pressure pipefitter.

10.6 Subdivision 1. **Triennial audits; assignment; qualifications.** The chief boiler
10.7 inspector shall assign a qualified ASME designee or team leader to perform triennial
10.8 audits on ASME Code and national board stamp holders at the request of the stamp holder.
10.9 The department shall maintain qualifications for ASME designees and national board team
10.10 leaders in accordance with ASME and national board requirements.

10.11 Subd. 2. **Fees.** The fee for performing ASME and national board triennial audits
10.12 shall be the hourly rate pursuant to section 326B.986, subdivision 4.

10.14 Notwithstanding the lapse of the time limit to adopt rules under Minnesota Statutes,
10.15 section 14.125, the commissioner of labor and industry's authority to adopt rules under
10.16 Minnesota Statutes, section 326B.978, subdivisions 4 and 18, is extended by 18 months
10.17 following the effective date of this section.

10.18 Sec. 17. **RULE CHANGE.**

10.19 The Plumbing Board shall amend Minnesota Rules, part 4715.0320, subpart 1, so
10.20 that it conforms with Minnesota Statutes, sections 326B.43 and 326B.52, as amended
10.21 by this act. The Plumbing Board may use the good cause exemption under Minnesota
10.22 Statutes, section 14.388, subdivision 1, clause (3), in adopting the amendment, and
10.23 Minnesota Statutes, section 14.386, does not apply.
