1.5	Section 1. U.S. HIGHWAY 169 INTERCHANGE AT MARKED TRUNK HIGHWAY
1.6	282 AND COUNTY STATE-AID HIGHWAY 9.
1.7	Subdivision 1. Appropriation; general obligation bonds. \$4,900,000 is appropriated
1.8	from the bond proceeds account in the state transportation fund to the commissioner of
1.9	transportation for a grant to Scott County to design and construct local road improvements
1.10	associated with an interchange at U.S. Highway 169, marked Trunk Highway 282, and
1.11	County State-Aid Highway 9 in the city of Jordan. The improvements include
1.12	accommodations for bicycles and pedestrians, rail grade separation, road work, and public
1.13	utility relocations.
1.14	Subd. 2. Appropriation; trunk highway bonds. \$4,200,000 is appropriated from the
1.15	bond proceeds account in the trunk highway fund to the commissioner of transportation for
1.16	a grant to Scott County to design and construct trunk highway improvements associated
1.17	with an interchange at U.S. Highway 169, marked Trunk Highway 282, and County State-Aid
1.18	Highway 9 in the city of Jordan, including accommodations for bicycles and pedestrians
1.19	and for bridge and road construction.
1.20	Subd. 3. Bond sale; general obligation bonds. To provide the money appropriated in
1.21	this section from the bond proceeds fund, the commissioner of management and budget

- 3.4 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
- 3.5 <u>Constitution, article XI, sections 4 to 7.</u>
- 3.6 Sec. 4. EFFECTIVE DATE.
- 3.7 This act is effective the day following final enactment.
