 1.2 relating to retirement; volunteer firefighter relief associations; implementing
 1.3 the recommendations of the state auditor's volunteer firefighter working group;
 1.4 addressing various disbursement and accounting issues; addressing various
 1.5 benefit issues; updating volunteer fire state aid references; addressing various
 1.6 relief association establishment and membership issues; amending Minnesota
 1.7 Statutes 2014, sections 69.051, subdivision 1a; 69.80; 424A.001, by adding
 1.8 a subdivision; 424A.002, subdivision 1; 424A.016, subdivision 4; 424A.02,
 1.9 subdivisions 3, 3a, 9a; 424A.05, subdivisions 2, 3; 424A.092, subdivisions 3, 6;
 1.10 424A.093, subdivisions 5, 6.

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 **ARTICLE 1**

1.13 **DISBURSEMENT AND ACCOUNTING ISSUES**

1.14 Section 1. Minnesota Statutes 2014, section 69.051, subdivision 1a, is amended to read:

1.15 Subd. 1a. **Financial statement.** (a) The board of each volunteer firefighters relief
 1.16 association, as defined in section 424A.001, subdivision 4, that is not required to file a
 1.17 financial report and audit under subdivision 1 must prepare a detailed statement of the
 1.18 financial affairs for the preceding fiscal year of the relief association's special and general
 1.19 funds in the style and form prescribed by the state auditor. The detailed statement must
 1.20 show:

- 1.21 (1) the sources and amounts of all money received;
 1.22 (2) all disbursements, accounts payable and accounts receivable;
 1.23 (3) the amount of money remaining in the treasury;
 1.24 (4) total assets, including a listing of all investments;
 1.25 (5) the accrued liabilities; and

2.1 (6) all other items necessary to show accurately the revenues and expenditures and
2.2 financial position of the relief association.

2.3 (b) The detailed financial statement of the special and general funds required under
2.4 paragraph (a) must be certified by a certified public accountant or by the state auditor. ~~In~~
2.5 ~~addition to certifying the financial condition of the special and general funds of the relief~~
2.6 ~~association, the accountant or auditor conducting the examination shall give an opinion~~
2.7 ~~as to the condition of the special and general funds of the relief association, and shall~~
2.8 ~~comment upon any exceptions to the report in accordance with agreed-upon procedures~~
2.9 ~~and forms prescribed by the state auditor.~~ The accountant must have at least five years of
2.10 public accounting, auditing, or similar experience, and must not be an active, inactive, or
2.11 retired member of the relief association or the fire department.

2.12 (c) The detailed financial statement required under paragraph (a) must be
2.13 countersigned by:

2.14 (1) the municipal clerk or clerk-treasurer of the municipality; or

2.15 (2) where applicable, by the municipal clerk or clerk-treasurer of the largest
2.16 municipality in population which contracts with the independent nonprofit firefighting
2.17 corporation if the relief association is a subsidiary of an independent nonprofit firefighting
2.18 corporation and by the secretary of the independent nonprofit firefighting corporation; or

2.19 (3) by the chief financial official of the county in which the volunteer firefighter
2.20 relief association is located or primarily located if the relief association is associated with
2.21 a fire department that is not located in or associated with an organized municipality.

2.22 (d) The volunteer firefighters' relief association board must file the detailed financial
2.23 statement required under paragraph (a) in the relief association office for public inspection
2.24 and present it to the governing body of the municipality within 45 days after the close of
2.25 the fiscal year, and must submit a copy of the certified detailed financial statement to the
2.26 state auditor within 90 days of the close of the fiscal year.

2.27 (e) A certified public accountant or auditor who performs the agreed-upon
2.28 procedures under paragraph (b) is subject to the reporting requirements of section 6.67.

2.29 **EFFECTIVE DATE.** This section is effective July 1, 2015, and applies to financial
2.30 statements prepared for calendar year 2015 and thereafter.

2.31 Sec. 2. Minnesota Statutes 2014, section 69.80, is amended to read:

2.32 **69.80 AUTHORIZED ADMINISTRATIVE EXPENSES.**

2.33 (a) Notwithstanding any provision of law to the contrary, the payment of the
2.34 following necessary, reasonable and direct expenses of maintaining, protecting and

3.1 administering the special fund, when provided for in the bylaws of the association and
 3.2 approved by the board of trustees, constitutes authorized administrative expenses of a
 3.3 volunteer firefighters' relief association organized under any law of this state or the
 3.4 Bloomington Fire Department Relief Association:

3.5 (1) office expense, including, but not limited to, rent, utilities, equipment, supplies,
 3.6 postage, periodical subscriptions, furniture, fixtures, and salaries of administrative
 3.7 personnel;

3.8 (2) salaries of the officers of the association, or their designees, and salaries of the
 3.9 members of the board of trustees of the association if the salary amounts are approved by
 3.10 the governing body of the entity that is responsible for meeting any minimum obligation
 3.11 under section 424A.092 or 424A.093, or Laws 2013, chapter 111, article 5, sections 31 to
 3.12 42, and the itemized expenses of relief association officers and board members that are
 3.13 incurred as a result of fulfilling their responsibilities as administrators of the special fund;

3.14 (3) tuition, registration fees, organizational dues, and other authorized expenses
 3.15 of the officers or members of the board of trustees incurred in attending educational
 3.16 conferences, seminars, or classes relating to the administration of the relief association;

3.17 (4) audit, and audit-related services, and accounting and accounting-related services,
 3.18 actuarial, medical, legal, and investment and performance evaluation expenses;

3.19 (5) filing and application fees payable by the relief association to federal or other
 3.20 governmental entities;

3.21 (6) reimbursement to the officers and members of the board of trustees, or their
 3.22 designees, for reasonable and necessary expenses actually paid and incurred in the
 3.23 performance of their duties as officers or members of the board; and

3.24 (7) premiums on fiduciary liability insurance and official bonds for the officers,
 3.25 members of the board of trustees, and employees of the relief association.

3.26 (b) Any other expenses of the relief association must be paid from the general fund
 3.27 of the association, if one exists. If a relief association has only one fund, that fund is the
 3.28 special fund for purposes of this section. If a relief association has a special fund and
 3.29 a general fund, and any expense of the relief association that is directly related to the
 3.30 purposes for which both funds were established, the payment of that expense must be
 3.31 apportioned between the two funds on the basis of the benefits derived by each fund.

3.32 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.33 Sec. 3. Minnesota Statutes 2014, section 424A.05, subdivision 3, is amended to read:

3.34 Subd. 3. **Authorized disbursements from special fund.** (a) Disbursements from
 3.35 the special fund may not be made for any purpose other than one of the following:

4.1 (1) for the payment of service pensions to retired members of the relief association if
4.2 authorized and paid under law and the bylaws governing the relief association;

4.3 (2) for the purchase of an annuity for the applicable person under section 424A.015,
4.4 subdivision 3, for the transfer of service pension or benefit amounts to the applicable
4.5 person's individual retirement account under section 424A.015, subdivision 4, or to the
4.6 applicable person's account in the Minnesota deferred compensation plan under section
4.7 424A.015, subdivision 5;

4.8 (3) for the payment of temporary or permanent disability benefits to disabled
4.9 members of the relief association if authorized and paid under law and specified in amount
4.10 in the bylaws governing the relief association;

4.11 (4) for the payment of survivor benefits or for the payment of a death benefit to the
4.12 estate of the deceased active or deferred firefighter, if authorized and paid under law and
4.13 specified in amount in the bylaws governing the relief association;

4.14 (5) for the payment of the fees, dues and assessments to the Minnesota State Fire
4.15 Department Association and to the Minnesota State Fire Chiefs Association in order to
4.16 entitle relief association members to membership in and the benefits of these associations
4.17 or organizations;

4.18 (6) for the payment of insurance premiums to the state Volunteer Firefighters Benefit
4.19 Association, or an insurance company licensed by the state of Minnesota offering casualty
4.20 insurance, in order to entitle relief association members to membership in and the benefits
4.21 of the association or organization; and

4.22 (7) for the payment of administrative expenses of the relief association as authorized
4.23 under section 69.80.

4.24 (b) Checks or authorizations for electronic fund transfers for disbursements
4.25 authorized by this section must be signed by the relief association treasurer and at least one
4.26 other elected trustee who has been designated by the board of trustees to sign the checks or
4.27 authorizations. A relief association may make disbursements authorized by this subdivision
4.28 by electronic funds transfers only if the specific method of payment and internal control
4.29 policies and procedures regarding the method are approved by the board of trustees.

4.30 **EFFECTIVE DATE.** This section is effective July 1, 2015.

4.32 **BENEFIT ISSUES**

4.33 Section 1. Minnesota Statutes 2014, section 424A.02, subdivision 3a, is amended to
4.34 read:

5.1 Subd. 3a. **Penalty for paying pension greater than applicable maximum.** (a)
5.2 If a defined benefit relief association pays a service pension greater than the maximum
5.3 service pension associated with the applicable average amount of available financing per
5.4 active covered firefighter under the table in subdivision 3, paragraph (c) or (d), whichever
5.5 applies, the maximum service pension under subdivision 3, paragraph (f), or the applicable
5.6 maximum service pension amount specified in subdivision 3, paragraph (g), whichever is
5.7 less, the state auditor shall:

5.8 (1) disqualify the municipality or the nonprofit firefighting corporation associated
5.9 with the relief association from receiving fire state aid by making the appropriate
5.10 notification to the municipality and the commissioner of revenue, with the disqualification
5.11 applicable for the next apportionment and payment of fire state aid; and

5.12 (2) order the treasurer of the applicable relief association to recover the amount of
5.13 the overpaid service pension or pensions from any retired firefighter who received an
5.14 overpayment.

5.15 (b) Fire state aid amounts from disqualified municipalities for the period of
5.16 disqualifications under paragraph (a), clause (1), must be credited to the amount of
5.17 fire insurance premium tax proceeds available for the next subsequent fire state aid
5.18 apportionment.

5.19 (c) The amount of any overpaid service pension recovered under paragraph (a),
5.20 clause (2), must be credited to the amount of fire insurance premium tax proceeds
5.21 available for the next subsequent fire state aid apportionment.

5.22 (d) The determination of the state auditor that a relief association has paid a service
5.23 pension greater than the applicable maximum must be made on the basis of the information
5.24 filed by the relief association and the municipality with the state auditor under sections
5.25 69.011, subdivision 2, and 69.051, subdivision 1 or 1a, whichever applies, and any other
5.26 relevant information that comes to the attention of the state auditor. The determination
5.27 of the state auditor is final. An aggrieved municipality, relief association, or person may
5.28 appeal the determination under section 480A.06.

5.29 (e) The state auditor may certify, upon learning that a relief association overpaid
5.30 a service pension based on an error in the maximum service pension calculation, the
5.31 municipality or nonprofit firefighting corporation associated with the relief association
5.32 for fire state aid if (1) there is evidence that the error occurred in good faith, and (2) the
5.33 relief association has initiated recovery of any overpayment amount. Notwithstanding
5.34 paragraph (c), all overpayments recovered under this paragraph must be credited to the
5.35 relief association's special fund.

5.36 **EFFECTIVE DATE.** This section is effective the day following final enactment.

6.1 Sec. 2. Minnesota Statutes 2014, section 424A.02, subdivision 9a, is amended to read:

6.2 Subd. 9a. **Postretirement increases.** Notwithstanding any provision of general or
 6.3 special law to the contrary, a defined benefit relief association paying a monthly service
 6.4 pension may provide a postretirement increase to retired members and ancillary benefit
 6.5 recipients of the relief association if (1) the relief association adopts an appropriate
 6.6 bylaw amendment; and (2) the bylaw amendment is approved by the municipality
 6.7 pursuant to subdivision 10 and section 424A.093, subdivision 6. The postretirement
 6.8 increase is applicable only to retired members and ancillary benefit recipients receiving a
 6.9 monthly service pension or monthly ancillary benefit as of the effective date of the bylaw
 6.10 amendment. The authority to provide a postretirement increase to retired members and
 6.11 ancillary benefit recipients of a relief association contained in this subdivision supersedes
 6.12 any prior special law authorization relating to the provision of postretirement increases.

6.13 **EFFECTIVE DATE.** This section is effective the day following final enactment.

6.14 **ARTICLE 3**

6.15 **STATE AID REFERENCES**

6.16 Section 1. Minnesota Statutes 2014, section 424A.016, subdivision 4, is amended to
 6.17 read:

6.18 Subd. 4. **Individual accounts.** (a) An individual account must be established for
 6.19 each firefighter who is a member of the relief association.

6.20 (b) To each individual active member account must be credited an equal share of:

6.21 (1) any amounts of fire state aid and police and firefighter retirement supplemental
 6.22 state aid received by the relief association;

6.23 (2) any amounts of municipal contributions to the relief association raised from
 6.24 levies on real estate or from other available municipal revenue sources exclusive of fire
 6.25 state aid; and

6.26 (3) any amounts equal to the share of the assets of the special fund to the credit of:

6.27 (i) any former member who terminated active service with the fire department to
 6.28 which the relief association is associated before meeting the minimum service requirement
 6.29 provided for in subdivision 2, paragraph (b), and has not returned to active service with
 6.30 the fire department for a period no shorter than five years; or

6.31 (ii) any retired member who retired before obtaining a full nonforfeitable interest in
 6.32 the amounts credited to the individual member account under subdivision 2, paragraph
 6.33 (b), and any applicable provision of the bylaws of the relief association. In addition, any
 6.34 investment return on the assets of the special fund must be credited in proportion to the

7.1 share of the assets of the special fund to the credit of each individual active member
7.2 account. Administrative expenses of the relief association payable from the special
7.3 fund may be deducted from individual accounts in a manner specified in the bylaws of
7.4 the relief association.

7.5 (c) If the bylaws so permit and as the bylaws define, the relief association may credit
7.6 any investment return on the assets of the special fund to the accounts of inactive members.

7.7 (d) Amounts to be credited to individual accounts must be allocated uniformly
7.8 for all years of active service and allocations must be made for all years of service,
7.9 except for caps on service credit if so provided in the bylaws of the relief association.
7.10 Amounts forfeited under paragraph (b), clause (3), before a resumption of active service
7.11 and membership under section 424A.01, subdivision 6, remain forfeited and may not be
7.12 reinstated upon the resumption of active service and membership. The allocation method
7.13 may utilize monthly proration for fractional years of service, as the bylaws or articles of
7.14 incorporation of the relief association so provide. The bylaws or articles of incorporation
7.15 may define a "month," but the definition must require a calendar month to have at least 16
7.16 days of active service. If the bylaws or articles of incorporation do not define a "month," a
7.17 "month" is a completed calendar month of active service measured from the member's
7.18 date of entry to the same date in the subsequent month.

7.19 (e) At the time of retirement under subdivision 2 and any applicable provision of the
7.20 bylaws of the relief association, a retiring member is entitled to that portion of the assets
7.21 of the special fund to the credit of the member in the individual member account which is
7.22 nonforfeitable under subdivision 3 and any applicable provision of the bylaws of the relief
7.23 association based on the number of years of service to the credit of the retiring member.

7.24 (f) Annually, the secretary of the relief association shall certify the individual
7.25 account allocations to the state auditor at the same time that the annual financial statement
7.26 or financial report and audit of the relief association, whichever applies, is due under
7.27 section 69.051.

7.28 Sec. 2. Minnesota Statutes 2014, section 424A.02, subdivision 3, is amended to read:

7.29 Subd. 3. **Flexible service pension maximums.** (a) Annually on or before August
7.30 1 as part of the certification of the financial requirements and minimum municipal
7.31 obligation determined under section 424A.092, subdivision 4, or 424A.093, subdivision 5,
7.32 as applicable, the secretary or some other official of the relief association designated in the
7.33 bylaws of each defined benefit relief association shall calculate and certify to the governing
7.34 body of the applicable municipality the average amount of available financing per active
7.35 covered firefighter for the most recent three-year period. The amount of available financing

8.1 includes any amounts of fire state aid and police and firefighter retirement supplemental
 8.2 state aid received or receivable by the relief association, any amounts of municipal
 8.3 contributions to the relief association raised from levies on real estate or from other
 8.4 available revenue sources exclusive of fire state aid, and one-tenth of the amount of assets in
 8.5 excess of the accrued liabilities of the relief association calculated under section 424A.092,
 8.6 subdivision 2; 424A.093, subdivisions 2 and 4; or 424A.094, subdivision 2, if any.

8.7 (b) The maximum service pension which the defined benefit relief association has
 8.8 authority to provide for in its bylaws for payment to a member retiring after the calculation
 8.9 date when the minimum age and service requirements specified in subdivision 1 are met
 8.10 must be determined using the table in paragraph (c) or (d), whichever applies.

8.11 (c) For a defined benefit relief association where the governing bylaws provide for
 8.12 a monthly service pension to a retiring member, the maximum monthly service pension
 8.13 amount per month for each year of service credited that may be provided for in the bylaws
 8.14 is the greater of the service pension amount provided for in the bylaws on the date of the
 8.15 calculation of the average amount of the available financing per active covered firefighter
 8.16 or the maximum service pension figure corresponding to the average amount of available
 8.17 financing per active covered firefighter:

14.11 (e) For a defined benefit relief association in which the governing bylaws provide
 14.12 for a monthly benefit service pension as an alternative form of service pension payment
 14.13 to a lump-sum service pension, the maximum service pension amount for each pension
 14.14 payment type must be determined using the applicable table contained in this subdivision.

14.15 (f) If a defined benefit relief association establishes a service pension in compliance
 14.16 with the applicable maximum contained in paragraph (c) or (d) and the minimum average
 14.17 amount of available financing per active covered firefighter is subsequently reduced
 14.18 because of a reduction in fire state aid or because of an increase in the number of active
 14.19 firefighters, the relief association may continue to provide the prior service pension
