- 1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.9 Section 1. Minnesota Statutes 2020, section 245A.05, is amended to read:
- 1.10 **245A.05 DENIAL OF APPLICATION.**
- 1.11 (a) The commissioner may deny a license if an applicant or controlling individual:
- 1.12 (1) fails to submit a substantially complete application after receiving notice from the
- 1.13 commissioner under section 245A.04, subdivision 1;
- 1.14 (2) fails to comply with applicable laws or rules;
- 1.15 (3) knowingly withholds relevant information from or gives false or misleading
- 1.16 information to the commissioner in connection with an application for a license or during
- 1.17 an investigation;
- 1.18 (4) has a disqualification that has not been set aside under section 245C.22 and no
- 1.19 variance has been granted;
- 1.20 (5) has an individual living in the household who received a background study under
- 1.21 section 245C.03, subdivision 1, paragraph (a), clause (2), who has a disqualification that
- 1.22 has not been set aside under section 245C.22, and no variance has been granted;

2.1 (6) is associated with an individual who received a background study under section
2.2 245C.03, subdivision 1, paragraph (a), clause (6), who may have unsupervised access to
2.3 children or vulnerable adults, and who has a disqualification that has not been set aside
2.4 under section 245C.22, and no variance has been granted;

2.5 (7) fails to comply with section 245A.04, subdivision 1, paragraph (f) or (g);

2.6 (8) fails to demonstrate competent knowledge as required by section 245A.04, subdivision
2.7 6;

2.8 (9) has a history of noncompliance as a license holder or controlling individual with
2.9 applicable laws or rules, including but not limited to this chapter and chapters 119B and
2.10 245C; ~~or~~

2.11 (10) is prohibited from holding a license according to section 245.095; or

2.12 (11) for a family foster setting, has nondisqualifying background study information, as
2.13 described in section 245C.05, subdivision 4, that reflects on the individual's ability to safely
2.14 provide care to foster children.

2.15 (b) An applicant whose application has been denied by the commissioner must be given
2.16 notice of the denial, which must state the reasons for the denial in plain language. Notice
2.17 must be given by certified mail or personal service. The notice must state the reasons the
2.18 application was denied and must inform the applicant of the right to a contested case hearing
2.19 under chapter 14 and Minnesota Rules, parts 1400.8505 to 1400.8612. The applicant may
2.20 appeal the denial by notifying the commissioner in writing by certified mail or personal
2.21 service. If mailed, the appeal must be postmarked and sent to the commissioner within 20
2.22 calendar days after the applicant received the notice of denial. If an appeal request is made
2.23 by personal service, it must be received by the commissioner within 20 calendar days after
2.24 the applicant received the notice of denial. Section 245A.08 applies to hearings held to
2.25 appeal the commissioner's denial of an application.

2.26 **EFFECTIVE DATE.** This section is effective July 1, 2022.

2.27 Sec. 2. Minnesota Statutes 2020, section 245A.07, subdivision 1, is amended to read:

2.28 Subdivision 1. **Sanctions; appeals; license.** (a) In addition to making a license conditional
2.29 under section 245A.06, the commissioner may suspend or revoke the license, impose a fine,
2.30 or secure an injunction against the continuing operation of the program of a license holder
2.31 who does not comply with applicable law or rule, or who has nondisqualifying background
2.32 study information, as described in section 245C.05, subdivision 4, that reflects on the license
2.33 holder's ability to safely provide care to foster children. When applying sanctions authorized

3.1 under this section, the commissioner shall consider the nature, chronicity, or severity of the
 3.2 violation of law or rule and the effect of the violation on the health, safety, or rights of
 3.3 persons served by the program.

3.4 (b) If a license holder appeals the suspension or revocation of a license and the license
 3.5 holder continues to operate the program pending a final order on the appeal, the commissioner
 3.6 shall issue the license holder a temporary provisional license. Unless otherwise specified
 3.7 by the commissioner, variances in effect on the date of the license sanction under appeal
 3.8 continue under the temporary provisional license. If a license holder fails to comply with
 3.9 applicable law or rule while operating under a temporary provisional license, the
 3.10 commissioner may impose additional sanctions under this section and section 245A.06, and
 3.11 may terminate any prior variance. If a temporary provisional license is set to expire, a new
 3.12 temporary provisional license shall be issued to the license holder upon payment of any fee
 3.13 required under section 245A.10. The temporary provisional license shall expire on the date
 3.14 the final order is issued. If the license holder prevails on the appeal, a new nonprovisional
 3.15 license shall be issued for the remainder of the current license period.

3.16 (c) If a license holder is under investigation and the license issued under this chapter is
 3.17 due to expire before completion of the investigation, the program shall be issued a new
 3.18 license upon completion of the reapplication requirements and payment of any applicable
 3.19 license fee. Upon completion of the investigation, a licensing sanction may be imposed
 3.20 against the new license under this section, section 245A.06, or 245A.08.

3.21 (d) Failure to reapply or closure of a license issued under this chapter by the license
 3.22 holder prior to the completion of any investigation shall not preclude the commissioner
 3.23 from issuing a licensing sanction under this section or section 245A.06 at the conclusion
 3.24 of the investigation.

3.28 **Subd. 9. Licensed family foster settings.** (a) Before recommending to grant a license,
 3.29 deny a license under section 245A.05, or revoke a license under section 245A.07 for
 3.30 nondisqualifying background study information received under section 245C.05, subdivision
 3.31 4, paragraph (a), clause (3), for a licensed family foster setting, a county agency or private
 3.32 agency that has been designated or licensed by the commissioner must review the following:

3.33 (1) the type of offenses;

- 4.1 (2) the number of offenses;
- 4.2 (3) the nature of the offenses;
- 4.3 (4) the age of the individual at the time of the offenses;
- 4.4 (5) the length of time that has elapsed since the last offense;
- 4.5 (6) the relationship of the offenses and the capacity to care for a child;
- 4.6 (7) evidence of rehabilitation;
- 4.7 (8) information or knowledge from community members regarding the individual's
4.8 capacity to provide foster care;
- 4.9 (9) any available information regarding child maltreatment reports or child in need of
4.10 protection or services petitions, or related cases, in which the individual has been involved
4.11 or implicated, and documentation that the individual has remedied issues or conditions
4.12 identified in child protection or court records that are relevant to safely caring for a child;
- 4.13 (10) a statement from the study subject;
- 4.14 (11) a statement from the license holder; and
- 4.15 (12) other aggravating and mitigating factors.
- 4.16 (b) For purposes of this section, "evidence of rehabilitation" includes but is not limited
4.17 to the following:
- 4.18 (1) maintaining a safe and stable residence;
- 4.19 (2) continuous, regular, or stable employment;
- 4.20 (3) successful participation in an education or job training program;
- 4.21 (4) positive involvement with the community or extended family;
- 4.22 (5) compliance with the terms and conditions of probation or parole following the
4.23 individual's most recent conviction;
- 4.24 (6) if the individual has had a substance use disorder, successful completion of a substance
4.25 use disorder assessment, substance use disorder treatment, and recommended continuing
4.26 care, if applicable, demonstrated abstinence from controlled substances, as defined in section
4.27 152.01, subdivision 4, or the establishment of a sober network;
- 4.28 (7) if the individual has had a mental illness or documented mental health issues,
4.29 demonstrated completion of a mental health evaluation, participation in therapy or other
4.30 recommended mental health treatment, or appropriate medication management, if applicable;

5.1 (8) if the individual's offense or conduct involved domestic violence, demonstrated
5.2 completion of a domestic violence or anger management program, and the absence of any
5.3 orders for protection or harassment restraining orders against the individual since the previous
5.4 offense or conduct;

5.5 (9) written letters of support from individuals of good repute, including but not limited
5.6 to employers, members of the clergy, probation or parole officers, volunteer supervisors,
5.7 or social services workers;

5.8 (10) demonstrated remorse for convictions or conduct, or demonstrated positive behavior
5.9 changes; and

5.10 (11) absence of convictions or arrests since the previous offense or conduct, including
5.11 any convictions that were expunged or pardoned.

5.12 (c) An applicant for a family foster setting license must sign all releases of information
5.13 requested by the county or private licensing agency.

5.14 (d) When licensing a relative for a family foster setting, the commissioner shall also
5.15 consider the importance of maintaining the child's relationship with relatives as an additional
5.16 significant factor in determining whether an application will be denied.

5.17 (e) When recommending that the commissioner deny or revoke a license, the county or
5.18 private licensing agency must send a summary of the review completed according to
5.19 paragraph (a), on a form developed by the commissioner, to the commissioner and include
5.20 any recommendation for licensing action.

5.23 Subd. 2c. **Privacy notice to background study subject.** (a) Prior to initiating each
5.24 background study, the entity initiating the study must provide the commissioner's privacy
5.25 notice to the background study subject required under section 13.04, subdivision 2. The
5.26 notice must be available through the commissioner's electronic NETStudy and NETStudy
5.27 2.0 systems and shall include the information in paragraphs (b) and (c).

5.28 (b) The background study subject shall be informed that any previous background studies
5.29 that received a set-aside will be reviewed, and without further contact with the background
5.30 study subject, the commissioner may notify the agency that initiated the subsequent
5.31 background study:

6.1 (1) that the individual has a disqualification that has been set aside for the program or
6.2 agency that initiated the study;

6.3 (2) the reason for the disqualification; and

6.4 (3) that information about the decision to set aside the disqualification will be available
6.5 to the license holder upon request without the consent of the background study subject.

6.6 (c) The background study subject must also be informed that:

6.7 (1) the subject's fingerprints collected for purposes of completing the background study
6.8 under this chapter must not be retained by the Department of Public Safety, Bureau of
6.9 Criminal Apprehension, or by the commissioner. The Federal Bureau of Investigation will
6.10 ~~only retain fingerprints of subjects with a criminal history~~ not retain background study
6.11 subjects' fingerprints;

6.12 (2) effective upon implementation of NETStudy 2.0, the subject's photographic image
6.13 will be retained by the commissioner, and if the subject has provided the subject's Social
6.14 Security number for purposes of the background study, the photographic image will be
6.15 available to prospective employers and agencies initiating background studies under this
6.16 chapter to verify the identity of the subject of the background study;

6.17 (3) the commissioner's authorized fingerprint collection vendor shall, for purposes of
6.18 verifying the identity of the background study subject, be able to view the identifying
6.19 information entered into NETStudy 2.0 by the entity that initiated the background study,
6.20 but shall not retain the subject's fingerprints, photograph, or information from NETStudy
6.21 2.0. The authorized fingerprint collection vendor shall retain no more than the subject's
6.22 name and the date and time the subject's fingerprints were recorded and sent, only as
6.23 necessary for auditing and billing activities;

6.24 (4) the commissioner shall provide the subject notice, as required in section 245C.17,
6.25 subdivision 1, paragraph (a), when an entity initiates a background study on the individual;

6.28 (b);

6.29 (6) the subject may request in writing that information used to complete the individual's
6.30 background study in NETStudy 2.0 be destroyed if the requirements of section 245C.051,

6.32 (7) notwithstanding clause (6), the commissioner shall destroy:

7.1 (i) the subject's photograph after a period of two years when the requirements of section
7.2 245C.051, paragraph (c), are met; and

7.9 retain fingerprint data after a background study is completed, and that the Federal Bureau
7.10 of Investigation ~~only retains the fingerprints of subjects who have a criminal history~~ does

7.13 Subd. 4. **Electronic transmission.** (a) For background studies conducted by the
7.14 Department of Human Services, the commissioner shall implement a secure system for the
7.15 electronic transmission of:

7.16 (1) background study information to the commissioner;

7.17 (2) background study results to the license holder;

7.18 (3) background study results to counties for background studies conducted by the
7.19 commissioner for child foster care, including a summary of nondisqualifying results, except
7.20 as prohibited by law; and

7.21 (4) background study results to county agencies for background studies conducted by
7.22 the commissioner for adult foster care and family adult day services and, upon
