2.1 (10) to clean up, remove, dispose of, and make repairs related to storing heating fuel
2.2 or transportation fuels such as alcohol, gasoline, fuel oil, and special fuel, as defined
2.3 in section 296A.01;

2.4 (11) for energy audits for school buildings and to modify buildings if the audit
2.5 indicates the cost of the modification can be recovered within ten years;
