1.7	Section 1. Minnesota Statutes 2011 Supplement, section 84D.10, subdivision 4, is
1.8	amended to read:
1.9	Subd. 4. Persons transporting water-related equipment. (a) When leaving waters
1.10	of the state a person must drain water-related equipment holding water and live wells and
1.11	bilges by removing the drain plug before transporting the water-related equipment off
1.12	the water access site or riparian property.
1.13	(b) Drain plugs, bailers, valves, or other devices used to control the draining of water
1.14	from ballast tanks, bilges, and live wells must be removed or opened while transporting
1.15	water-related equipment.

(c) Emergency response vehicles and equipment may be transported on a public road

(d) Portable bait containers used by licensed aquatic farms, portable bait containers

with the drain plug or other similar device replaced only after all water has been drained

when fishing through the ice except on waters designated infested for viral hemorrhagic

(f) A boat lift, dock, swim raft, or associated equipment that has been removed

from any water body may not be placed in another water body until a minimum of 21

(e) A person must not dispose of bait in waters of the state.

Sec. 2. Minnesota Statutes 2011 Supplement, section 84D.105, subdivision 2, is amended to read:

- Subd. 2. **Inspector authority.** (a) The commissioner shall train and authorize individuals to inspect water-related equipment for aquatic macrophytes, aquatic invasive species, and water. The commissioner may delegate inspection authority as provided under paragraphs (b), (g), and (h) to tribal and local governments that assume all legal, financial, and administrative responsibilities for inspection programs on public waters within their jurisdiction.
- (b) Inspectors may visually and tactilely inspect watercraft and water-related equipment to determine whether aquatic invasive species, aquatic macrophytes, or water is present. If a person transporting watercraft or water-related equipment refuses to take required corrective actions or fails to comply with an order under section 84D.10, subdivision 3, an inspector who is not a licensed peace officer shall refer the violation to a conservation officer or other licensed peace officer.
- (c) In addition to paragraph (b), a conservation officer or other licensed peace officer may inspect any watercraft or water-related equipment that is stopped at a water access site, any other public location in the state, or a private location where the watercraft or water-related equipment is in plain view, if the officer determines there is reason to believe that aquatic invasive species, aquatic macrophytes, or water is present on the watercraft or water-related equipment.
- (d) Conservation officers or other licensed peace officers may utilize check stations in locations, or in proximity to locations, where watercraft or other water-related equipment is placed into or removed from waters of the state. Any check stations shall be operated in a manner that minimizes delays to vehicles, equipment, and their occupants.
- (e) Conservation officers or other licensed peace officers may order water-related equipment to be removed from a water body if the commissioner determines such action is needed to implement aquatic invasive species control measures.
- (f) The commissioner may require mandatory inspections of water-related equipment before a person places the water-related equipment into a water body. Inspection stations may be located at or near public water accesses or in locations that allow for servicing multiple water bodies. The commissioner shall ensure that inspection stations:
 - (1) have adequate staffing to minimize delays to vehicles and their occupants;
- (2) allow for reasonable travel times between public accesses and inspection stations if inspection is required before placing water-related equipment into a water body;
 - (3) are located so as not to create traffic delays or public safety issues;

4.20	(b) A civil citation that is issued to a person who has one or more prior convictions
4.21	or final orders for violations of this chapter is subject to twice the penalty amounts listed

4.24	Subdivision 1. Establishment. The commissioner shall establish a statewide course
4.25	in preventing the spread of aquatic invasive species. The commissioner must develop an
4.26	educational course and testing program that address identification of aquatic invasive
4.27	species and best practices to prevent the spread of aquatic invasive species when moving
4.28	water-related equipment, as defined under section 84D.01, subdivision 18a.

5.3	(a) A person may not transport watercraft or water-related equipment, as defined
5.4	under section 84D.01, subdivision 18a, with a trailer unless the person has an aquatic
5.5	invasive species trailer decal issued under section 86B.13.
5.6	(b) Aquatic invasive species trailer decals are valid for three years.
5.7	EFFECTIVE DATE. This section is effective July 1, 2015.
5.8	Sec. 6. Minnesota Statutes 2011 Supplement, section 97C.341, is amended to read:
5.9	97C.341 CERTAIN AQUATIC LIFE PROHIBITED FOR BAIT.
5.10	(a) A person may not use live minnows imported from outside of the state, game
5.11	fish, goldfish, or carp for bait. The commissioner may, by written order published in
5.12	the State Register, authorize use of game fish eggs as bait and prescribe restrictions on
5.13	their use. The order is exempt from the rulemaking provisions of chapter 14 and section
5.14	14.386 does not apply.
5.15	(b) A person may not import or possess live, frozen, or processed bait from known
5.16	waters where viral hemorrhagic septicemia has been identified as being present; (1)
5.17	unless the bait has been processed to inactivate viral hemorrhagic septicemia in a manner
5.18	prescribed by rules adopted by the commissioner; or (2) except as provided in paragraph
5.19	(c). For purposes of this paragraph, "bait" includes fish, aquatic worms, amphibians,
5.20	invertebrates, and insects used for taking wild animals in waters of the state.
5.21	(c) Cisco and rainbow smelt taken under rules adopted by the commissioner may
5.22	be used as:
5.23	(1) fresh or frozen bait only on Lake Superior; or
5.24	(2) bait that has been processed to inactivate viral hemorrhagic septicemia in a
5.25	manner prescribed by rules adopted by the commissioner.
5.26	(d) To ensure that frozen or dead fish being brought into the state are not in violation
5.27	of paragraph (b), the following paperwork must accompany the shipment. Documents
5.28	must be open for inspection by the commissioner at any reasonable time. All documents
5.29	must be available to purchasers of these bait items. Each container or package of frozen or
5.30	dead fish must have the following information:
5.31	(1) water body source;
5.32	(2) lot number;
5.33	(3) company contact including name, phone, and address;
5.34	(4) date of packaging and labeling; and
