 1.2 board to request reconciliation information; authorizing certain fees; authorizing
 1.3 the board to establish a system to store electronic records online; modifying
 1.4 certain definitions and fee amounts; imposing penalties; amending Minnesota

1.13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.14 Section 1. Minnesota Statutes 2012, section 10A.01, subdivision 5, is amended to read:

1.15 Subd. 5. **Associated business.** "Associated business" means an association,
 1.16 corporation, partnership, limited liability company, limited liability partnership, or other
 1.17 organized legal entity from which the individual receives compensation in excess of \$50,
 1.18 except for actual and reasonable expenses, in any month as a director, officer, owner,
 1.19 member, partner, employer or employee, or whose securities the individual holds worth
 1.20 more than \$2,500 ~~or more~~ at fair market value.

1.21 Sec. 2. Minnesota Statutes 2013 Supplement, section 10A.01, subdivision 10, is
 1.22 amended to read:

1.23 Subd. 10. **Candidate.** "Candidate" means an individual who seeks nomination or
 1.24 election as a state constitutional officer, legislator, or judge. An individual is deemed
 1.25 to seek nomination or election if the individual has taken the action necessary under
 1.26 the law of this state to qualify for nomination or election, has received contributions or

2.1 made expenditures in excess of ~~\$100~~ \$750, or has given implicit or explicit consent for
2.2 any other person to receive contributions or make expenditures in excess of ~~\$100~~ \$750,
2.3 for the purpose of bringing about the individual's nomination or election. A candidate
2.4 remains a candidate until the candidate's principal campaign committee is dissolved as
2.5 provided in section 10A.243.

2.6 Sec. 3. Minnesota Statutes 2013 Supplement, section 10A.02, subdivision 11, is
2.7 amended to read:

2.8 Subd. 11. **Violations; enforcement.** (a) The board may investigate any alleged
2.9 violation of this chapter. The board may also investigate an alleged violation of section
2.10 211B.04, 211B.12, or 211B.15 by or related to a candidate, treasurer, principal campaign
2.11 committee, political committee, political fund, or party unit, as those terms are defined in
2.12 this chapter. The board must investigate any violation that is alleged in a written complaint
2.13 filed with the board and must within 30 days after the filing of the complaint make findings
2.14 and conclusions as to whether a violation has occurred and must issue an order, except that
2.15 if the complaint alleges a violation of section 10A.25 or 10A.27, the board must either enter
2.16 a conciliation agreement or make public findings and conclusions as to whether a violation
2.17 has occurred and must issue an order within 60 days after the filing of the complaint. The
2.18 deadline for action on a written complaint may be extended by majority vote of the board.

2.19 (b) The board may bring legal actions or negotiate settlements in its own name to
2.20 recover money raised from contributions subject to the conditions in this paragraph.

2.21 (1) No action may be commenced unless the board has made a formal determination,
2.22 after an investigation, that the money was raised for political purposes as defined in
2.23 section 211B.01, subdivision 6, and that the money was used for purposes not permitted
2.24 under this chapter or under section 211B.12.

2.25 (2) Prior to commencing an action, the board must give the association whose money
2.26 was misused written notice by certified mail of its intent to take action under this subdivision
2.27 and must give the association a reasonable opportunity, for a period of not less than 90
2.28 days, to recover the money without board intervention. This period must be extended
2.29 for at least an additional 90 days for good cause if the association is actively pursuing
2.30 recovery of the money. The board may not commence a legal action under this subdivision
2.31 if the association has commenced a legal action for the recovery of the same money.

2.32 (3) Any funds recovered under this subdivision must be deposited in a campaign
2.33 finance recovery account in the special revenue fund and are appropriated as follows:

3.1 (i) an amount equal to the board's actual costs and disbursements in the action,
3.2 including court reporter fees for depositions taken in the course of an investigation, is
3.3 appropriated to the board for its operations;

3.4 (ii) an amount equal to the reasonable value of legal services provided by the Office
3.5 of the Attorney General in the recovery matter, calculated on the same basis as is used
3.6 for charging legal fees to state agencies, is appropriated to the attorney general for the
3.7 attorney general's operations; and

3.8 (iii) any remaining balance is appropriated to the board for distribution to the
3.9 association to which the money was originally contributed.

3.10 (4) Notwithstanding clause (3), item (iii), if the candidate of a principal campaign
3.11 committee is the person who used the association's money for illegal purposes, or if the
3.12 association or political fund whose money was misused is no longer registered with the
3.13 board, any money remaining after the payments specified in clause (3), items (i) and (ii),
3.14 must be transferred to the general account of the state elections campaign account.

3.15 (5) Any action by the board under this paragraph must be commenced not later than
3.16 four years after the improper use of money is shown on a report filed with the board or the
3.17 board has actual knowledge of improper use. No action may be commenced under this
3.18 paragraph for improper uses disclosed on reports for calendar years prior to 2011.

3.19 (6) If the board prevails in an action brought under this subdivision and the court
3.20 makes a finding that the misuse of funds was willful, the court may enter judgment in favor
3.21 of the board and against the person misusing the funds in the amount of the misused funds.

3.22 (c) Within a reasonable time after beginning an investigation of an individual
3.23 or association, the board must notify the individual or association of the fact of the
3.24 investigation. The board must not make a finding of whether there is probable cause to
3.25 believe that a violation has occurred without notifying the individual or association of the
3.26 nature of the allegations and affording an opportunity to answer those allegations.

3.27 (d) A hearing before the board or action of the board concerning a complaint or
3.28 investigation other than a ~~finding concerning probable cause~~ findings, conclusions, and
3.29 orders or a conciliation agreement is confidential. Until the board makes a public finding
3.30 ~~concerning probable cause~~ or enters a conciliation agreement:

3.31 (1) a member, employee, or agent of the board must not disclose to an individual
3.32 information obtained by that member, employee, or agent concerning a complaint or
3.33 investigation except as required to carry out the investigation or take action in the matter
3.34 as authorized by this chapter; and

3.35 (2) an individual who discloses information contrary to this subdivision is subject
3.36 to a civil penalty imposed by the board of up to \$1,000.

4.1 (e) A matter that is under the board's jurisdiction pursuant to this section and that
 4.2 may result in a criminal offense must be finally disposed of by the board before the alleged
 4.3 violation may be prosecuted by a city or county attorney.

4.5 Subd. 11a. **Data privacy.** If, after making a public finding ~~concerning probable~~
 4.6 ~~cause~~ or entering a conciliation agreement, the board determines that the record of the
 4.7 investigation contains statements, documents, or other matter that, if disclosed, would
 4.8 unfairly injure the reputation of an innocent individual, the board may:

4.9 (1) retain the statement, document, or other matter as a private record, as defined in
 4.10 section 13.02, subdivision 12, for a period of one year, after which it must be destroyed; or

4.11 (2) return the statement, document, or other matter to the individual who supplied
 4.12 it to the board.

 4.16 develop and maintain systems to enable treasurers to enter and store electronic records

 4.18 by treasurers or their authorized agents is not government data under chapter 13 and
 4.19 may not be accessed or used by the board for any purpose without the treasurer's written
 4.20 consent. Data from such systems that has been submitted to the board as a filed report is
 4.21 government data under chapter 13.

4.24 Subd. 4. **Changes and corrections.** Material changes in information previously

 4.27 which the person filing became aware of the inaccuracy. The change or correction must
 4.28 identify the form and the paragraph containing the information to be changed or corrected.

4.29 A person who willfully fails to report a material change or correction is subject to a
 4.30 civil penalty imposed by the board of up to \$3,000. A willful violation of this subdivision
 4.31 is a gross misdemeanor.

 5.16 or association fails to provide the requested information within ten business days after the

 5.19 not timely responded to the board's written request for reconciliation information. The
 5.20 certified notice must state that if the individual or association does not respond to the

 5.23 information to the board. An individual or association that does not provide the requested
 5.24 information within ten business days after the certified notice was sent is subject to a civil
 5.25 penalty imposed by the board of up to \$1,000.

 5.27 discrepancy is subject to a civil penalty imposed by the board of up to \$3,000.

 5.32 a metropolitan governmental unit;

5.33 (2) within 60 days of assuming office as a district court judge, appeals court judge,
 5.34 supreme court justice, or county commissioner;

 7.9 dues, membership fees, and contributions deposited in the political fund together exceed

 10.13 available, of the person responsible for filing the report;
- 10.14 (3) the total cash on hand designated to be used for political purposes;

10A.09 STATEMENTS OF ECONOMIC INTEREST.

Subd. 8. **Failure to file; suspension.** A public official, except a member of the legislature or a constitutional officer, who is required to file a statement of economic interest and fails to do so by the prescribed deadline must be suspended without pay by the board in the manner prescribed in the contested case procedures in chapter 14.
