(b) A candidate's committee may not claim the following expenses as noncampaign 4.1 disbursements for expenses for serving in public office under section 10A.01, subdivision 4.2 26, paragraph (a), clause (10): 4.3 (1) the cost of membership fees and dues necessary to belong to organizations located 4.4 in the office holder's district; 4.5 (2) costs incurred for transportation, lodging, and other expenses for trips taken outside 4.6 of the office holder's district for the purpose of relationship building; and 4.7 (3) costs incurred for transportation, lodging, and other expenses by an individual 4.8 accompanying an office holder on a trip unless the office holder is a person with a disability, 4.9 as defined in section 363A.03, subdivision 12, and the accompanying individual is providing 4.10 services that are made necessary by the disability. 4.11 Clause (3) does not require a committee to allocate a travel expense between an office holder 4.12 and an individual accompanying the office holder on a trip when the presence of the 4.13 accompanying individual does not increase the amount of the expense. 4.14 Sec. 3.
