2.19 Section 1. Minnesota Statutes 2020, section 116J.8737, subdivision 5, is amended to read:

2.20 Subd. 5. **Credit allowed.** (a) A qualified investor or qualified fund is eligible for a credit
 2.21 equal to 25 percent of the qualified investment in a qualified small business. Investments
 2.22 made by a pass-through entity qualify for a credit only if the entity is a qualified fund. The
 2.23 commissioner must not allocate ~~more than \$10,000,000 in credits~~ to qualified investors or
 2.24 qualified funds more than the dollar amount in credits allowed for the taxable years listed
 2.25 in paragraph (i). For each taxable year, 50 percent must be allocated to credits for qualified
 2.26 investments in qualified greater Minnesota businesses and minority-owned, women-owned,
 2.27 or veteran-owned qualified small businesses in Minnesota. Any portion of a taxable year's
 2.28 credits that is reserved for qualified investments in greater Minnesota businesses and
 2.29 minority-owned, women-owned, or veteran-owned qualified small businesses in Minnesota
 2.30 that is not allocated by September 30 of the taxable year is available for allocation to other
 2.31 credit applications beginning on October 1. Any portion of a taxable year's credits that is
 2.32 not allocated by the commissioner does not cancel and may be carried forward to subsequent
 2.33 taxable years until all credits have been allocated.

2.34 (b) The commissioner may not allocate more than a total maximum amount in credits
 2.35 for a taxable year to a qualified investor for the investor's cumulative qualified investments
 2.36 as an individual qualified investor and as an investor in a qualified fund; for married couples
 2.37 filing joint returns the maximum is \$250,000, and for all other filers the maximum is
 2.38 \$125,000. The commissioner may not allocate more than a total of \$1,000,000 in credits
 2.39 over all taxable years for qualified investments in any one qualified small business.

3.1 (c) The commissioner may not allocate a credit to a qualified investor either as an
3.2 individual qualified investor or as an investor in a qualified fund if, at the time the investment
3.3 is proposed:

3.4 (1) the investor is an officer or principal of the qualified small business; or

3.5 (2) the investor, either individually or in combination with one or more members of the
3.6 investor's family, owns, controls, or holds the power to vote 20 percent or more of the
3.7 outstanding securities of the qualified small business.

3.8 A member of the family of an individual disqualified by this paragraph is not eligible for a
3.9 credit under this section. For a married couple filing a joint return, the limitations in this
3.10 paragraph apply collectively to the investor and spouse. For purposes of determining the
3.11 ownership interest of an investor under this paragraph, the rules under section 267(c) and
3.12 267(e) of the Internal Revenue Code apply.

3.13 (d) Applications for tax credits ~~for 2010~~ must be made available on the department's
3.14 website ~~by September 1, 2010, and the department must begin accepting applications by~~
3.15 ~~September 1, 2010. Applications for subsequent years must be made available~~ by November
3.16 1 of the preceding year.

3.17 (e) Qualified investors and qualified funds must apply to the commissioner for tax credits.
3.18 Tax credits must be allocated to qualified investors or qualified funds in the order that the
3.19 tax credit request applications are filed with the department. The commissioner must approve
3.20 or reject tax credit request applications within 15 days of receiving the application. The
3.21 investment specified in the application must be made within 60 days of the allocation of
3.22 the credits. If the investment is not made within 60 days, the credit allocation is canceled
3.23 and available for reallocation. A qualified investor or qualified fund that fails to invest as
3.24 specified in the application, within 60 days of allocation of the credits, must notify the
3.25 commissioner of the failure to invest within five business days of the expiration of the
3.26 60-day investment period.

3.27 (f) All tax credit request applications filed with the department on the same day must
3.28 be treated as having been filed contemporaneously. If two or more qualified investors or
3.29 qualified funds file tax credit request applications on the same day, and the aggregate amount
3.30 of credit allocation claims exceeds the aggregate limit of credits under this section or the
3.31 lesser amount of credits that remain unallocated on that day, then the credits must be allocated
3.32 among the qualified investors or qualified funds who filed on that day on a pro rata basis
3.33 with respect to the amounts claimed. The pro rata allocation for any one qualified investor
3.34 or qualified fund is the product obtained by multiplying a fraction, the numerator of which

4.1 is the amount of the credit allocation claim filed on behalf of a qualified investor and the
 4.2 denominator of which is the total of all credit allocation claims filed on behalf of all
 4.3 applicants on that day, by the amount of credits that remain unallocated on that day for the
 4.4 taxable year.

4.5 (g) A qualified investor or qualified fund, or a qualified small business acting on their
 4.6 behalf, must notify the commissioner when an investment for which credits were allocated
 4.7 has been made, and the taxable year in which the investment was made. A qualified fund
 4.8 must also provide the commissioner with a statement indicating the amount invested by
 4.9 each investor in the qualified fund based on each investor's share of the assets of the qualified
 4.10 fund at the time of the qualified investment. After receiving notification that the investment
 4.11 was made, the commissioner must issue credit certificates for the taxable year in which the
 4.12 investment was made to the qualified investor or, for an investment made by a qualified
 4.13 fund, to each qualified investor who is an investor in the fund. The certificate must state
 4.14 that the credit is subject to revocation if the qualified investor or qualified fund does not
 4.15 hold the investment in the qualified small business for at least three years, consisting of the
 4.16 calendar year in which the investment was made and the two following years. The three-year
 4.17 holding period does not apply if:

4.18 (1) the investment by the qualified investor or qualified fund becomes worthless before
 4.19 the end of the three-year period;

4.20 (2) 80 percent or more of the assets of the qualified small business is sold before the end
 4.21 of the three-year period;

4.22 (3) the qualified small business is sold before the end of the three-year period;

4.23 (4) the qualified small business's common stock begins trading on a public exchange
 4.24 before the end of the three-year period; or

4.25 (5) the qualified investor dies before the end of the three-year period.

4.26 (h) The commissioner must notify the commissioner of revenue of credit certificates
 4.27 issued under this section.

4.28 (i) The credit allowed under this subdivision is effective ~~for each of the following taxable~~
 4.29 ~~years~~ as follows:

4.30 ~~(1) taxable years beginning after December 31, 2018, and before January 1, 2020; and~~

4.31 ~~(2)~~ (1) \$10,000,000 for taxable years beginning after December 31, 2020, and before

5.4 Sec. 2. **[116U.27] FILM PRODUCTION CREDIT.**

5.5 Subdivision 1. **Definitions.** (a) For purposes of this section, the following terms have
5.6 the meanings given.

5.7 (b) "Allocation certificate" means a certificate issued by the commissioner to a taxpayer
5.8 upon receipt of an initial application for a credit for a project that has not yet been completed.

5.9 (c) "Application" means the application for a credit under subdivision 4.

5.10 (d) "Commissioner" means the commissioner of employment and economic development.

5.11 (e) "Credit certificate" means a certificate issued by the commissioner upon submission
5.12 of the cost verification report in subdivision 4, paragraph (e).

5.13 (f) "Eligible production costs" means eligible production costs as defined in section
5.14 116U.26, paragraph (b), clause (1), incurred in Minnesota that are directly attributable to
5.15 the production of a film project in Minnesota.

5.16 (g) "Film" has the meaning given in section 116U.26, paragraph (b), clause (2).

5.17 (h) "Project" means a film:

5.18 (1) that includes the promotion of Minnesota;

5.19 (2) for which the taxpayer has expended at least \$1,000,000 in the taxable year for
5.20 eligible production costs; and

5.21 (3) to the extent practicable, that employs Minnesota residents.

5.22 (i) "Promotion of Minnesota" or "promotion" means visible display of a static or animated
5.23 logo, approved by the commissioner and lasting approximately five seconds, that promotes
5.24 Minnesota within its presentation and all promotional trailers worldwide in the end credits
5.25 before the below-the-line crew crawl for the life of the project.

5.26 Subd. 2. **Credit allowed.** A taxpayer is eligible for a credit up to 25 percent of eligible
5.27 production costs paid in a taxable year. A taxpayer may only claim a credit if the taxpayer
5.28 was issued a credit certificate under subdivision 4.

5.29 Subd. 3. **Credit assignable.** The recipient of a credit certificate may assign the certificate
5.30 to another taxpayer before any amount of the credit is claimed. The assignee is allowed the

6.1 credit under sections 290.06, subdivision 39, and 297I.20, subdivision 4. An assignment is
6.2 not valid unless the assignee notifies the commissioner of revenue within 30 days of the
6.3 date that the assignment is made. The commissioner of revenue shall prescribe the forms
6.4 necessary for notifying the commissioner of revenue of the assignment of a credit certificate
6.5 and for claiming a credit by assignment.

6.6 Subd. 4. **Applications; allocations.** (a) To qualify for a credit under this section, a
6.7 taxpayer must submit to the commissioner an application for a credit in the form prescribed
6.8 by the commissioner, in consultation with the commissioner of revenue.

6.9 (b) Upon approving an application for a credit that meets the requirements of this section,
6.10 the commissioner shall issue allocation certificates that:

6.11 (1) verify eligibility for the credit;

6.12 (2) state the amount of credit anticipated for the eligible project, with the credit amount
6.13 up to 25 percent of eligible project costs; and

6.14 (3) state the taxable year in which the credit is allocated.

6.15 The commissioner must consult with Minnesota Film and TV Board prior to issuing an
6.16 allocation certificate.

6.17 (c) The commissioner must not issue allocation certificates for more than \$4,950,000
6.18 of credits each year. If the entire amount is not allocated in that taxable year, any remaining
6.19 amount is available for allocation for the four following taxable years until the entire
6.20 allocation has been made. The commissioner must not award any credits for taxable years
6.21 beginning after December 31, 2024, and any unallocated amounts cancel on that date.

6.22 (d) The commissioner must allocate credits on a first-come, first-served basis.

6.23 (e) Upon completion of a project, the taxpayer shall submit to the commissioner a report
6.24 prepared by an independent certified public accountant licensed in the state of Minnesota
6.25 to verify the amount of eligible production costs related to the project. The report must be
6.26 prepared in accordance with generally accepted accounting principles. Upon receipt and
6.27 review of the cost verification report, the commissioner shall determine the final amount
6.28 of eligible production costs and issue a credit certificate to the taxpayer. The credit may not
6.29 exceed the anticipated credit amount on the allocation certificate. If the credit is less than
6.30 the anticipated amount on the allocation credit, the difference is returned to the amount
6.31 available for allocation under paragraph (c). To claim the credit under section 290.06,
6.32 subdivision 39, or 297I.20, subdivision 4, a taxpayer must include a copy of the credit
6.33 certificate as part of the taxpayer's return.

7.1 Subd. 5. **Report required.** By January 15, 2025, the commissioner of revenue, in
7.2 consultation with the commissioner, must provide a report to the chairs and ranking minority
7.3 members of the legislative committees with jurisdiction over economic development and
7.4 taxes. The report must comply with sections 3.195 and 3.197, and must detail the following:

7.5 (1) the amount of credit certifications issued annually;

7.6 (2) the number of applications submitted, the number of allocation certificates issued,
7.7 the amount of allocation certificates issued, the number of reports submitted upon completion
7.8 of a project, and the number of credit certificates issued;

7.9 (3) the types of projects eligible for the credit;

7.10 (4) the total economic impact of the credit in Minnesota, including the calendar year
7.11 over calendar year percentage changes in the number of jobs held by Minnesota residents
7.12 in businesses having a primary North American Industry Classification System code of
7.13 512110 as reported to the commissioner, for calendar years 2019 through 2023;

7.14 (5) the number of taxpayers per tax type which are assignees of credit certificates under
7.15 subdivision 3;

7.16 (6) annual Minnesota taxes paid by businesses having a primary North American Industry
7.17 Classification System code of 512110, for taxable years beginning after December 31, 2018,
7.18 and before January 1, 2024; and

7.19 (7) any other information the commissioner of revenue, in consultation with the
7.20 commissioner, deems necessary for purposes of claiming and administering the credit.

7.21 Subd. 6. **Appropriation.** Beginning in fiscal year 2022, \$50,000 is annually appropriated
7.22 from the general fund to the commissioner of revenue for a transfer to the Department of
7.23 Employment and Economic Development for costs associated with personnel and
7.24 administrative expenses related to administering the credit. This subdivision expires on June
7.25 30, 2025.

7.26 Subd. 7. **Expiration.** Subdivisions 1 to 5 expire January 1, 2025, for taxable years
7.27 beginning after December 31, 2024.

7.28 **EFFECTIVE DATE.** This section is effective for taxable years beginning after December
7.29 31, 2020, and before January 1, 2025, except that the requirement to provide the report
7.30 required in subdivision 5 expires July 1, 2025.

8.2 Subd. 19. **Net income.** (a) For a trust or estate taxable under section 290.03, and a
8.3 corporation taxable under section 290.02, the term "net income" means the federal taxable
8.4 income, as defined in section 63 of the Internal Revenue Code of 1986, as amended through
8.5 the date named in this subdivision, incorporating the federal effective dates of changes to
8.6 the Internal Revenue Code and any elections made by the taxpayer in accordance with the

8.15 (1) the exclusion of net capital gain provided in section 852(b)(2)(A) of the Internal
8.16 Revenue Code does not apply;

8.28 Internal Revenue Code means the gross income as defined in section 468B(b) of the Internal
8.29 Revenue Code.

8.30 (f) The Internal Revenue Code of 1986, as amended through December 31, 2018, ~~shall~~

(2) "qualifying entity" means a partnership, limited liability company, or S corporation including a qualified subchapter S subsidiary organized under section 1361(b)(3)(B) of the Internal Revenue Code. Qualifying entity does not include a partnership, limited liability company, or corporation that has a partnership, limited liability company other than a disregarded entity, or corporation as a partner, member, or shareholder; and

(3) "qualifying owner" means:

(i) a resident or nonresident individual or estate that is a partner, member, or shareholder of a qualifying entity; or

(ii) a resident or nonresident trust that is a shareholder of a qualifying entity that is an S corporation.

(b) For taxable years beginning after December 31, 2020, in which the taxes of a qualifying owner are limited under section 164(b)(6)(B) of the Internal Revenue Code, a qualifying entity may elect to file a return and pay the pass-through entity tax imposed under paragraph (c). The election:

(1) must be made on or before the due date or extended due date of the qualifying entity's pass-through entity tax return;

(2) may only be made by qualifying owners who collectively hold more than a 50 percent ownership interest in the qualifying entity;

41.1 (3) is binding on all qualifying owners who have an ownership interest in the qualifying
41.2 entity; and

41.3 (4) once made is irrevocable for the taxable year.

41.4 (c) Subject to the election in paragraph (b), a pass-through entity tax is imposed on a

270C.17 COMMISSIONER TO COLLECT CERTAIN LOCAL TAXES.

Subd. 2. **Development costs.** If the commissioner determines that a new computer system will be required to collect the local taxes, the costs of development of the system will be charged to the first local units of government to be included in the system. Any additional local units of government that by agreement are added to the system will be charged for a share of the development costs. The charge will be determined by the commissioner who shall then refund to the original local units of government their portion of the development costs recovered from the additional users.

469.055 POWERS AND DUTIES.

Subd. 7. **Sale of realty.** The authority may sell, convey, and exchange any real or personal property owned or held by it in any manner and on any terms it wishes. Real property owned by the authority must not be sold, be exchanged, or have its title transferred without approval of two-thirds of the commissioners. All commissioners must have ten days' written notice of a regular or special meeting at which a sale, conveyance, exchange, or transfer of property is to be voted on. The notice must contain a complete description of the affected real estate. The resolution authorizing the real estate transaction is not effective unless a quorum is present.
