- 1.1 A bill for an act
- 1.2 relating to local government aids; appropriating onetime supplemental aid to
- 1.3 Windom school district; appropriating money to the city of Windom.
- 1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.5 Section 1. **APPROPRIATION; CITY OF WINDOM.**
- 1.6 (a) \$13,000,000 in fiscal year 2023 is appropriated from the general fund to the
- 1.7 commissioner of revenue for a grant to the city of Windom to be allocated as provided under
- 1.8 paragraph (b). This appropriation is onetime and is available until June 30, 2025.
- 1.9 (b) Of the amount appropriated under paragraph (a):
- 1.10 (1) \$10,000,000 must be used by the city to facilitate completion of the Windom HyLife
- 1.11 Affordable Housing Development;
- 1.12 (2) \$2,000,000 must be used by the city for repayment of loans issued to the city from
- 1.13 the Public Facilities Authority for wastewater improvements related to the HyLife Foods
- 1.14 Windom processing plant; and
- 1.15 (3) \$1,000,000 must be used by the city for recruitment efforts including locating and
- 1.16 securing a purchaser of the HyLife Foods Windom processing plant.
- 1.17 (c) The appropriations under paragraph (b), clauses (1) and (2), are contingent upon
- 1.18 certification from the city that Hylife Foods has not entered into a contract to transfer
- 1.19 ownership of the Hylife Foods Windom processing plant. Certification from the city to the
- 1.20 commissioner of revenue must be made on or before July 1, 2023.
- 1.21 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.1 Sec. 2. **APPROPRIATION; WINDOM SCHOOL DISTRICT.**

2.2 **Subdivision 1. Department of Education.** The sum indicated in this section is
2.3 appropriated from the general fund to the Department of Education for the fiscal year
2.4 designated.

2.5 **Subd. 2. Windom School District onetime supplemental aid.** (a) For aid to Independent
2.6 School District No. 177, Windom:

2.7 \$ 1,000,000 2024

2.8 **(b) For fiscal year 2024 only, Windom School District's onetime supplemental aid equals**
2.9 **the greater of zero or the product of: (1) \$10,000, and (2) the difference between the October**
2.10 **1, 2022, pupil enrollment count and the October 1, 2023, pupil enrollment count.**

2.11 **(c) 100 percent of the aid must be paid in the current year.**

2.12 **(d) This is a onetime appropriation.**

2.13 **EFFECTIVE DATE.** This section is effective the day following final enactment.
