| 1.12 | of vehicles the applicant is authorized to drive as applied for. This license must bear a |
| 1.13 | distinguishing number assigned to the licensee; the licensee's full name and date of birth; |

| 1.15 | 5B.05; a description of the licensee in a manner as the commissioner deems necessary; |

The notice may not name a spouse of the notifying person. Upon receiving the notice the commissioner shall not issue any license or identification card under this chapter, or
