1.16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.17 Section 1. Minnesota Statutes 2017 Supplement, section 84.01, subdivision 6, is amended

1.18 to read:

1.19 Subd. 6. **Legal counsel.** The commissioner of natural resources may appoint attorneys

1.20 or outside counsel to render title opinions, represent the department in severed mineral

1.21 interest forfeiture actions brought pursuant to section 93.55, and, notwithstanding any statute

1.22 to the contrary, represent the state in quiet title or title registration actions affecting land or

1.23 interests in land administered by the commissioner and in all proceedings relating to road

1.24 vacations.

2.1 Sec. 2. Minnesota Statutes 2017 Supplement, section 84D.03, subdivision 3, is amended  
2.2 to read:

2.3 Subd. 3. **Bait harvest from infested waters.** (a) Taking wild animals from infested  
2.4 waters for bait or aquatic farm purposes is prohibited except as provided in paragraph (b),  
2.5 (c), or (d) and section 97C.341.

2.6 (b) In waters that are listed as infested waters, except those listed as infested with  
2.7 prohibited invasive species of fish or certifiable diseases of fish, as defined under section  
2.8 17.4982, subdivision 6, taking wild animals may be permitted for:

2.9 (1) commercial taking of wild animals for bait and aquatic farm purposes as provided  
2.10 in a permit issued under section 84D.11, subject to rules adopted by the commissioner; and

2.11 (2) bait purposes for noncommercial personal use in waters that contain Eurasian  
2.12 watermilfoil, when the infested waters are listed solely because they contain Eurasian  
2.13 watermilfoil and if the equipment for taking is limited to cylindrical minnow traps not  
2.14 exceeding 16 inches in diameter and 32 inches in length.

2.15 (c) In streams or rivers that are listed as infested waters, except those listed as infested  
2.16 with certifiable diseases of fish, as defined under section 17.4982, subdivision 6, the harvest  
2.17 of bullheads, goldeyes, mooneyes, sheepshead (freshwater drum), and suckers for bait by  
2.18 hook and line for noncommercial personal use is allowed as follows:

2.19 (1) fish taken under this paragraph must be used on the same body of water where caught  
2.20 and while still on that water body. Where the river or stream is divided by barriers such as  
2.21 dams, the fish must be caught and used on the same section of the river or stream;

2.22 (2) fish taken under this paragraph may not be transported live from or off the water  
2.23 body;

2.24 (3) fish harvested under this paragraph may only be used in accordance with this section;

2.25 (4) any other use of wild animals used for bait from infested waters is prohibited;

2.26 (5) fish taken under this paragraph must meet all other size restrictions and requirements  
2.27 as established in rules; and

2.28 (6) all species listed under this paragraph shall be included in the person's daily limit as  
2.29 established in rules, if applicable.

2.30 (d) In the Minnesota River downstream of Granite Falls, the Mississippi River  
2.31 downstream of St. Anthony Falls, and the St. Croix River downstream of the dam at Taylors  
2.32 Falls, including portions described as Minnesota-Wisconsin boundary waters in Minnesota

3.1 Rules, part 6266.0500, subpart 1, items A and B, the harvest of gizzard shad by cast net for  
3.2 noncommercial personal use as bait for angling, as provided in a permit issued under section  
3.3 84D.11, is allowed as follows:

3.4 (1) nontarget species must immediately be returned to the water;

3.5 (2) gizzard shad taken under this paragraph must be used on the same body of water  
3.6 where caught and while still on that water body. Where the river is divided by barriers such  
3.7 as dams, the gizzard shad must be caught and used on the same section of the river;

3.8 (3) gizzard shad taken under this paragraph may not be transported off the water body;  
3.9 and

3.10 (4) gizzard shad harvested under this paragraph may only be used in accordance with  
3.11 this section.

3.12 ~~This paragraph expires December 1, 2017.~~

3.13 (e) Equipment authorized for minnow harvest in a listed infested water by permit issued  
3.14 under paragraph (b) may not be transported to, or used in, any waters other than waters  
3.15 specified in the permit.

3.16 (f) Bait intended for sale may not be held in infested water after taking and before sale,  
3.17 unless authorized under a license or permit according to Minnesota Rules, part 6216.0500.

3.18 **EFFECTIVE DATE.** This section is effective retroactively from December 1, 2017.

3.19 Sec. 3. Minnesota Statutes 2017 Supplement, section 84D.03, subdivision 4, is amended  
3.20 to read:

3.21 Subd. 4. **Restrictions in infested and noninfested waters; commercial fishing and**  
3.22 **turtle, frog, and crayfish harvesting.** (a) All nets, traps, buoys, anchors, stakes, and lines  
3.23 used for commercial fishing or turtle, frog, or crayfish harvesting in an infested water that  
3.24 is listed because it contains invasive fish, invertebrates, aquatic plants or aquatic macrophytes  
3.25 other than Eurasian watermilfoil, or certifiable diseases, as defined in section 17.4982, must  
3.26 be tagged with tags provided by the commissioner, as specified in the commercial licensee's  
3.27 license or permit. Tagged gear must not be used in water bodies other than those specified  
3.28 in the license or permit. The license or permit may authorize department staff to remove  
3.29 tags after the from gear is that has been decontaminated according to a protocol specified  
3.30 by the commissioner if removing tags from the gear would not pose an unreasonable risk  
3.31 of harm to natural resources or the use of natural resources in the state. This tagging  
3.32 requirement does not apply to commercial fishing equipment used in Lake Superior.

4.1 (b) All nets, traps, buoys, anchors, stakes, and lines used for commercial fishing or turtle,  
 4.2 frog, or crayfish harvesting in an infested water that is listed solely because it contains  
 4.3 Eurasian watermilfoil must be dried for a minimum of ten days or frozen for a minimum  
 4.4 of two days before they are used in any other waters, except as provided in this paragraph.  
 4.5 Commercial licensees must notify the department's regional or area fisheries office or a  
 4.6 conservation officer before removing nets or equipment from an infested water listed solely  
 4.7 because it contains Eurasian watermilfoil and before resetting those nets or equipment in  
 4.8 any other waters. Upon notification, the commissioner may authorize a commercial licensee  
 4.9 to move nets or equipment to another water without freezing or drying, if that water is listed  
 4.10 as infested solely because it contains Eurasian watermilfoil.

4.11 (c) A commercial licensee must remove all aquatic macrophytes from nets and other  
 4.12 equipment before placing the equipment into waters of the state.

4.13 (d) The commissioner shall provide a commercial licensee with a current listing of listed  
 4.14 infested waters at the time that a license or permit is issued.

4.15 Sec. 4. Minnesota Statutes 2016, section 88.10, is amended by adding a subdivision to  
 4.16 read:

4.17 Subd. 3. **Wildland firefighters; training and licensing.** Forest officers and all  
 4.18 individuals employed as wildland firefighters under this chapter are not subject to the  
 4.19 requirements of chapter 299N.

4.20 Sec. 5. Minnesota Statutes 2016, section 88.75, subdivision 1, is amended to read:

4.21 Subdivision 1. **Misdemeanor offenses; damages; injunctive relief.** (a) Any person  
 4.22 who violates any of the provisions of sections 88.03 to 88.22 for which no specific penalty  
 4.23 is therein prescribed shall be guilty of a misdemeanor and be punished accordingly.

4.24 (b) Failure by any person to comply with any provision or requirement of sections 88.03  
 4.25 to 88.22 to which such person is subject shall be deemed a violation thereof.

4.26 (c) Any person who violates ~~any provisions of~~ sections 88.03 to 88.22, in addition to  
 4.27 any penalties therein prescribed, or hereinbefore in this section prescribed, for such violation,  
 4.28 shall also be liable in full damages to any and every person suffering loss or injury by reason  
 4.29 of such violation, including liability to the state, and any of its political subdivisions, for  
 4.30 all expenses incurred in fighting or preventing the spread of, or extinguishing, any fire  
 4.31 caused by, or resulting from, any violation of these sections. Notwithstanding any statute  
 4.32 to the contrary, an attorney who is licensed to practice law in Minnesota and is an employee

5.1 of the Department of Natural Resources may represent the commissioner in proceedings  
5.2 under this subdivision that are removed to district court from conciliation court. All expenses  
5.3 so collected by the state shall be deposited in the general fund. When a fire set by any person  
5.4 spreads to and damages or destroys property belonging to another, the setting of the fire  
5.5 shall be prima facie evidence of negligence in setting and allowing the same to spread.

5.6 (d) At any time the state, or any political subdivision thereof, either of its own motion,  
5.7 or at the suggestion or request of the director, may bring an action in any court of competent  
5.8 jurisdiction to restrain, enjoin, or otherwise prohibit any violation of sections 88.03 to 88.22,  
5.9 whether therein described as a crime or not, and likewise to restrain, enjoin, or prohibit any  
5.10 person from proceeding further in, with, or at any timber cutting or other operations without  
5.11 complying with the provisions of those sections, or the requirements of the director pursuant  
5.12 thereto; and the court may grant such relief, or any other appropriate relief, whenever it  
5.13 shall appear that the same may prevent loss of life or property by fire, or may otherwise aid  
5.14 in accomplishing the purposes of sections 88.03 to 88.22.

5.15 Sec. 6. Minnesota Statutes 2017 Supplement, section 89.17, is amended to read:

5.16 **89.17 LEASES AND PERMITS.**

5.17 (a) Notwithstanding the permit procedures of chapter 90, the commissioner may grant  
5.18 and execute, in the name of the state, leases and permits for the use of any forest lands under  
5.19 the authority of the commissioner for any purpose that in the commissioner's opinion is not  
5.20 inconsistent with the maintenance and management of the forest lands, on forestry principles  
5.21 for timber production. Every such lease or permit is revocable at the discretion of the  
5.22 commissioner at any time subject to such conditions as may be agreed on in the lease. The  
5.23 approval of the commissioner of administration is not required upon any such lease or  
5.24 permit. No such lease or permit for a period exceeding 21 years shall be granted except with  
5.25 the approval of the Executive Council.

5.26 (b) Public access to the leased land for outdoor recreation is the same as access would  
5.27 be under state management.

5.28 (c) Notwithstanding section 16A.125, subdivision 5, after deducting the reasonable costs  
5.29 incurred for preparing and issuing the lease, all remaining proceeds from leasing school  
5.30 trust land and university land for roads on forest lands must be deposited into the respective  
5.31 permanent fund for the lands.

6.1 (d) The commissioner may require a performance bond, security deposit, or other form  
6.2 of security for removing any improvements or personal property left on the leased premises  
6.3 by the lessee upon termination or cancellation of the lease.

6.4 Sec. 7. Minnesota Statutes 2016, section 89.551, is amended to read:

6.5 **89.551 APPROVED FIREWOOD REQUIRED.**

6.6 (a) After the commissioner issues an order under paragraph (b), a person may not possess  
6.7 firewood on land administered by the commissioner of natural resources unless the firewood:

6.8 (1) was obtained from a firewood distribution facility located on land administered by  
6.9 the commissioner;

6.10 (2) was obtained from a firewood dealer who is selling firewood that is approved by the  
6.11 commissioner under paragraph (b); or

6.12 (3) has been approved by the commissioner of natural resources under paragraph (b).

6.13 (b) The commissioner of natural resources shall, by written order published in the State  
6.14 Register, approve firewood for possession on lands administered by the commissioner. The  
6.15 order is not subject to the rulemaking provisions of chapter 14, and section 14.386 does not  
6.16 apply.

6.17 (c) A violation under this section is subject to confiscation of firewood ~~and after May~~  
6.18 ~~1, 2008, confiscation~~ and a \$100 penalty. ~~A firewood dealer shall be subject to confiscation~~  
6.19 ~~and assessed a \$100 penalty for each sale of firewood not approved under the provisions~~  
6.20 ~~of this section and sold for use on land administered by the commissioner.~~

6.21 (d) For the purposes of this section, "firewood" means any wood that is intended for use  
6.22 in a campfire, as defined in section 88.01, subdivision 25.

6.23 Sec. 8. Minnesota Statutes 2016, section 92.50, is amended by adding a subdivision to  
6.24 read:

6.25 Subd. 3. Security requirement. The commissioner may require a performance bond,  
6.26 security deposit, or other form of security for removing any improvements or personal  
6.27 property left on the leased premises by the lessee upon termination or cancellation of the  
6.28 lease.

7.1 Sec. 9. Minnesota Statutes 2016, section 94.10, subdivision 2, is amended to read:

7.2 Subd. 2. **Public sale requirements.** (a) After complying with subdivision 1 and before  
7.3 any public sale of surplus state-owned land is made and at least 30 days before the sale, the  
7.4 commissioner of natural resources shall publish a notice of the sale in a newspaper of general  
7.5 distribution in the county in which the real property to be sold is situated. The notice shall  
7.6 specify the time and place at which the sale will commence, a general description of the  
7.7 lots or tracts to be offered, and a general statement of the terms of sale. The commissioner  
7.8 shall also provide electronic notice of sale.

7.9 (b) The minimum bid for a parcel of land must include the estimated value or appraised  
7.10 value of the land and any improvements and, if any of the land is valuable for merchantable  
7.11 timber, the value of the merchantable timber. The minimum bid may include expenses  
7.12 incurred by the commissioner in rendering the property salable, including survey, appraisal,  
7.13 legal, advertising, and other expenses.

7.14 (c) The purchaser of state land must pay recording fees and the state deed tax.

7.15 (d) Except as provided under paragraph (e), parcels remaining unsold after the offering  
7.16 may be sold to anyone agreeing to pay at least 75 percent of the appraised value. The sale  
7.17 shall continue until all parcels are sold or until the commissioner orders a reappraisal or  
7.18 withdraws the remaining parcels from sale.

7.19 (e) The commissioner may retain the services of a licensed real estate broker to find a  
7.20 buyer for parcels remaining unsold after the offering. The sale price may be negotiated by  
7.21 the broker, but must not be less than 90 percent of the appraised value as determined by the  
7.22 commissioner. The broker's fee must be established by prior agreement between the  
7.23 commissioner and the broker and must not exceed ten percent of the sale price for sales of  
7.24 \$10,000 or more. The broker's fee must be paid to the broker from the proceeds of the sale.

7.25 (f) Public sales of surplus state-owned land may be conducted through online auctions.

7.26 Sec. 10. Minnesota Statutes 2016, section 97A.051, subdivision 2, is amended to read:

7.27 Subd. 2. **Summary of fish and game laws.** (a) The commissioner shall prepare a  
7.28 summary of the hunting and fishing laws and rules and deliver a sufficient supply to license  
7.29 vendors to furnish one copy to each person obtaining a hunting, fishing, or trapping license.

7.30 (b) At the beginning of the summary, under the heading "Trespass," the commissioner  
7.31 shall summarize the trespass provisions under sections 97B.001 to 97B.945, state that  
7.32 conservation officers and peace officers must enforce the trespass laws, and state the penalties  
7.33 for trespassing.

8.1 (c) In the summary the commissioner shall, under the heading "Duty to Render Aid,"  
8.2 summarize the requirements under section 609.662 and state the penalties for failure to  
8.3 render aid to a person injured by gunshot.

8.4 Sec. 11. Minnesota Statutes 2016, section 97A.433, subdivision 4, is amended to read:

8.5 Subd. 4. **Discretionary separate selection; eligibility.** (a) The commissioner may  
8.6 conduct a separate selection for up to 20 percent of the elk licenses to be issued for an area.  
8.7 Only owners of, and tenants living on, at least 160 acres of agricultural or grazing land in  
8.8 the area, and their family members, are eligible for the separate selection. Persons that are  
8.9 unsuccessful in a separate selection must be included in the selection for the remaining  
8.10 licenses. Persons who obtain an elk license in a separate selection ~~must allow public elk~~  
8.11 ~~hunting on their land during the elk season for which the license is valid~~ may sell the license  
8.12 to any Minnesota resident eligible to hunt big game for no more than the original cost of  
8.13 the license.

8.14 (b) The commissioner may by rule establish criteria for determining eligible family  
8.15 members under this subdivision.

8.17 Subd. 5. **Mandatory separate selection.** The commissioner must conduct a separate  
8.18 selection for 20 percent of the elk licenses to be issued each year. Only individuals who  
8.19 have applied at least ten times for an elk license and who have never received a license are  
8.20 eligible for this separate selection. A person who is unsuccessful in a separate selection  
8.21 under this subdivision must be included in the selection for the remaining licenses.

8.22 Sec. 13. **[97B.427] FEEDING BEARS.**

8.23 Feeding a bear by hand or other physical contact is prohibited. A person violating this  
8.24 section is guilty of a misdemeanor.

8.25 Sec. 14. Minnesota Statutes 2016, section 97C.345, subdivision 3a, is amended to read:

8.26 Subd. 3a. **Cast nets for gizzard shad.** (a) Cast nets may be used only to take gizzard  
8.27 shad for use as bait for angling:

8.28 (1) from July 1 to November 30; and

8.29 (2) from the Minnesota River downstream of Granite Falls, Mississippi River downstream  
8.30 of St. Anthony Falls<sub>2</sub> and the St. Croix River downstream of the dam at Taylors Falls,



9.1 including portions described as Minnesota-Wisconsin boundary waters in Minnesota Rules,  
 9.2 part 6266.0500, subpart 1, items A and B, that are listed as infested waters as allowed under

9.4 (b) Cast nets used under this subdivision must be monofilament and may not exceed  
 9.5 ~~seven~~ five feet in ~~diameter~~ radius, and mesh size must be from three-eighths to five-eighths  
 9.6 inch bar measure. No more than two cast nets may be used at one time.

9.7 ~~(c) This subdivision expires December 1, 2017. The commissioner must report to the~~

9.14 Subdivision 1. [85.012] [Subd. 21.] Frontenac State Park, Goodhue County. The  
 9.15 following area is added to Frontenac State Park, Goodhue County:

9.16 That part of the Northeast Quarter of Section 10, that part of the Southeast Quarter of  
 9.17 Section 10, that part of the Northwest Quarter of Section 11, and that part of the Southwest  
 9.18 Quarter of Section 11, all in Township 112 North, Range 13 West, Goodhue County,  
 9.19 Minnesota, described as follows:

9.20 Commencing at the east quarter corner of said Section 10; thence on an assumed bearing  
 9.21 South 00 degrees 25 minutes 27 seconds East, along the east line of the Southeast Quarter  
 9.22 of said Section 10, a distance of 1,654.63 feet; thence South 89 degrees 34 minutes 33  
 9.23 seconds West, a distance of 2,219.43 feet to the point of beginning of the land to be described;  
 9.24 thence North 19 degrees 04 minutes 33 seconds East, a distance of 3,905.90 feet to the  
 9.25 centerline of Hill Avenue; thence southeasterly, along said centerline, to the northwesterly  
 9.26 right-of-way boundary of County Road Number 2, as designated on Goodhue County  
 9.27 Highway Right-Of-Way Plat No. 25, as recorded in the Goodhue County Recorder's Office;  
 9.28 thence southwesterly along said northwesterly right-of-way boundary and along the  
 9.29 northwesterly right-of-way boundary of County Road Number 2, as designated in Goodhue  
 9.30 County Highway Right-Of-Way Plat No. 24, and along the northwesterly right-of-way  
 9.31 boundary of County Road Number 2, as designated in Goodhue County Highway  
 9.32 Right-of-Way Plat No. 23, to the intersection with a line bearing South 76 degrees 25 minutes

10.1 27 seconds East from the point of beginning; thence North 76 degrees 25 minutes 27 seconds  
10.2 West, a distance of 907.89 feet to the point of beginning.

10.8 southerly on an assumed azimuth from North of 179 degrees 34 minutes 33 seconds, along

10.11 of beginning of the land to be described; thence northerly 340 degrees 42 minutes 19 seconds  
10.12 azimuth, a distance of 300.00 feet; thence easterly 100 degrees 22 minutes 46 seconds  
10.13 azimuth, a distance of 286.97 feet to the centerline of County Road Number 2, as now  
10.14 located and established; thence southerly and southwesterly, along said centerline, to the  
10.15 intersection with a line drawn southerly 160 degrees 42 minutes 19 seconds azimuth from
