1.6	Section 1. [152.138] PRESCRIBING AND DISPENSING DRUGS FOR OFF-LABEL

1.8	Subdivision 1. Definitions. (a) For purposes of this section, the following terms have

1.10	(b) "COVID-19" means the disease caused by the coronavirus identified as SARS-CoV-2.
1.11	(c) "Disciplinary action" means any action taken by a health-related licensing board
1.12	against a licensee, including but not limited to revocation, limitation, suspension, or denial

2.4	Subd. 2. General provision. (a) Notwithstanding any other law to the contrary, a
2.5	prescriber may prescribe and a pharmacist must dispense in accordance with a valid
2.6	prescription order a prescription drug approved by the United States Food and Drug
2.7	Administration, including but not limited to hydroxychloroquine sulfate and ivermectin,
2.8	for off-label use to prevent or treat COVID-19, even if the patient has not been exposed to
2.9	or tested positive for COVID-19.
2.10	(b) This subdivision does not apply to a controlled substance.
2.11	Subd. 3. Immunity from civil liability. Notwithstanding any law to the contrary, a
2.12	prescriber or pharmacist is immune from civil liability for damages, administrative fines,
2.13	or penalties for acts, omissions, health care decisions, or the rendering of or the failure to
2.14	render health care services if the prescriber or pharmacist is acting pursuant to this section.
2.15	Subd. 4. Professional conduct. (a) Any recommendation, prescription, use, or opinion
2.16	of a prescriber or pharmacist related to a treatment for COVID-19, including a treatment
2.17	that is not recommended or regulated by a health-related licensing board, the Minnesota
2.18	Department of Health, a professional association, or the United States Food and Drug
2.19	Administration, must not be considered unprofessional conduct.

2.27	(a) Any health-related licensing board that regulates prescribers or pharmacists shall
2.28	independently review all complaints and disciplinary action for acts occurring on or after
2.29	March 12, 2020, through the effective date of Minnesota Statutes, section 152.138. If any
2.30	health-related licensing board took disciplinary action based on conduct described in
2.31	Minnesota Statutes, section 152.138, in whole or in part, the board shall reconsider such
2.32	action and rescind any disciplinary action taken against the licensee if prohibited under
2.33	Minnesota Statutes, section 151.138.
