1.1 A bill for an act

1.2 relating to capital investment; appropriating money for a fire station and emergency

1.3 operations center in the city of Brooklyn Park; authorizing the sale and issuance

1.4 of state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **BROOKLYN PARK; FIRE STATION AND EMERGENCY OPERATIONS**

1.7 **CENTER.**

1.8 Subdivision 1. **Appropriation.** \$20,000,000 is appropriated from the bond proceeds

1.9 fund to the commissioner of public safety for a grant to the city of Brooklyn Park to acquire

1.10 and improve property, predesign, design, construct, engineer, furnish, and equip a new fire

1.11 station with space for a multiagency emergency operations center, regional training

1.12 opportunities, and other associated site improvements. This appropriation does not require

1.13 a nonstate contribution.

1.14 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond

1.15 proceeds fund, the commissioner of management and budget shall sell and issue bonds of

1.16 the state in an amount up to \$20,000,000 in the manner, upon the terms, and with the effect

1.17 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota

1.18 Constitution, article XI, sections 4 to 7.

1.19 **EFFECTIVE DATE.** This section is effective the day following final enactment.
