1.14 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.15 Section 1. 122A.051] CODE OF ETHICS.

1.16 Subdivision 1. Scope. Each teacher, upon entering the teaching profession, assumes a
1.17 number of obligations, one of which is to adhere to a set of principles that defines professional
1.18 conduct. These principles are reflected in the code of ethics, which sets forth to the education
1.19 profession and the public it serves standards of professional conduct. This code applies to
1.20 all persons licensed according to rules established by the Professional Educator Licensing
1.21 and Standards Board.

1.22 Subd. 2. Standards of professional conduct. (a) A teacher must provide professional
1.23 education services in a nondiscriminatory manner.

1.24 (b) A teacher must make reasonable effort to protect students from conditions harmful
1.25 to health and safety.

2.1 (c) In accordance with state and federal laws, a teacher must disclose confidential
2.2 information about individuals only when a compelling professional purpose is served or
2.3 when required by law.

2.4 (d) A teacher must take reasonable disciplinary action in exercising the authority to
2.5 provide an atmosphere conducive to learning.

2.6 (e) A teacher must not use professional relationships with students, parents, and
2.7 colleagues to personal advantage.

2.8 (f) A teacher must delegate authority for teaching responsibilities only to licensed
2.9 personnel or as otherwise provided by law.

2.10 (g) A teacher must not deliberately suppress or distort subject matter.

2.11 (h) A teacher must not knowingly falsify or misrepresent records or facts relating to that
2.12 teacher's own qualifications or to other teachers' qualifications.

2.13 (i) A teacher must not knowingly make false or malicious statements about students or
2.14 colleagues.

2.15 (j) A teacher must accept a contract for a teaching position that requires licensing only
2.16 if properly or provisionally licensed for that position.

2.17 (k) A teacher must not engage in any sexual contact with a student.

2.18 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.21 Subd. 2. **Advise members of profession.** The Professional Educator Licensing and
2.22 Standards Board must act in an advisory capacity to members of the profession in matters

2.24 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.26 subdivision to read:

2.27 Subd. 7. **Background check.** The Professional Educator Licensing and Standards Board
2.28 must request a criminal history background check from the superintendent of the Bureau
2.29 of Criminal Apprehension on a licensed teacher applying for a renewal license who has not

3.1 had a background check consistent with section 122A.18, subdivision 8, within the preceding
 3.2 five years.

3.6 Subdivision 1. **Grounds for revocation, suspension, or denial.** (a) The Professional
 3.7 Educator Licensing and Standards Board or Board of School Administrators, whichever
 3.8 has jurisdiction over a teacher's licensure, may, on the written complaint of the school board
 3.9 employing a teacher, a teacher organization, or any other interested person, refuse to issue,
 3.10 refuse to renew, suspend, or revoke a teacher's license to teach for any of the following
 3.11 causes:

3.12 (1) immoral character or conduct;

3.13 (2) failure, without justifiable cause, to teach for the term of the teacher's contract;

3.14 (3) gross inefficiency or willful neglect of duty;

3.15 (4) failure to meet licensure requirements; or

3.16 (5) fraud or misrepresentation in obtaining a license.

3.17 The written complaint must specify the nature and character of the charges.

3.18 (b) The Professional Educator Licensing and Standards Board or Board of School

 3.20 issue, refuse to renew, or automatically revoke a teacher's license to teach without the right

4.5 (9) embezzlement of public funds under section 609.54;

4.6 (10) interference with privacy under section 609.746 or stalking under section 609.749
4.7 and the victim was a minor₂;

4.8 (11) using minors in a sexual performance under section 617.246₂;

4.9 (12) possessing pornographic works involving a minor under section 617.247₂; or

4.10 (13) any other offense not listed in this paragraph that requires the person to register as
4.11 a predatory offender under section 243.166, or a crime under a similar law of another state
4.12 or the United States.

4.13 The board ~~shall~~ must send notice of this licensing action to the district in which the teacher
4.14 is currently employed.

4.15 (c) A person whose license to teach has been revoked, not issued, or not renewed under
4.16 paragraph (b), may petition the board to reconsider the licensing action if the person's
4.17 conviction for child abuse or sexual abuse is reversed by a final decision of the Court of
4.18 Appeals or the Supreme Court or if the person has received a pardon for the offense. The
4.19 petitioner ~~shall~~ must attach a certified copy of the appellate court's final decision or the
4.20 pardon to the petition. Upon receiving the petition and its attachment, the board ~~shall~~ must
4.21 schedule and hold a disciplinary hearing on the matter under section 214.10, subdivision 2,
4.22 unless the petitioner waives the right to a hearing. If the board finds that, notwithstanding
4.23 the reversal of the petitioner's criminal conviction or the issuance of a pardon, the petitioner

5.17 over the teacher's or administrator's license, when its teacher or administrator is discharged
5.18 or resigns from employment after a charge is filed with the school board under section
5.19 122A.41, subdivisions 6, clauses (1), (2), and (3), and 7, or after charges are filed that are
5.20 grounds for discharge under section 122A.40, subdivision 13, paragraph (a), clauses (1) to
5.21 (5), or when a teacher or administrator is suspended or resigns while an investigation is
5.22 pending under section 122A.40, subdivision 13, paragraph (a), clauses (1) to (5); 122A.41,
5.23 subdivisions 6, clauses (1), (2), and (3), and 7; or 626.556, or when a teacher or administrator

5.25 clauses (1), (2), and (3), and 7; or 626.556. The report must be made to the appropriate
5.26 licensing board within ten days after the discharge, suspension, or resignation has occurred.
5.27 The licensing board to which the report is made must investigate the report for violation of
5.28 subdivision 1 and the reporting board must cooperate in the investigation. Notwithstanding
5.29 any provision in chapter 13 or any law to the contrary, upon written request from the licensing
5.30 board having jurisdiction over the license, a board or school superintendent ~~shall~~ must
5.31 provide the licensing board with information about the teacher or administrator from the
5.32 district's files, any termination or disciplinary proceeding, any settlement or compromise,
5.33 or any investigative file. Upon written request from the appropriate licensing board, a board
5.34 or school superintendent may, at the discretion of the board or school superintendent, solicit

6.1 the written consent of a student and the student's parent to provide the licensing board with
6.2 information that may aid the licensing board in its investigation and license proceedings.
6.3 The licensing board's request need not identify a student or parent by name. The consent
6.4 of the student and the student's parent must meet the requirements of chapter 13 and Code
6.5 of Federal Regulations, title 34, section 99.30. The licensing board may provide a consent
6.6 form to the district. Any data transmitted to any board under this section is private data
6.7 under section 13.02, subdivision 12, notwithstanding any other classification of the data
6.8 when it was in the possession of any other agency.

6.9 (b) The licensing board to which a report is made must transmit to the Attorney General's
6.10 Office any record or data it receives under this subdivision for the sole purpose of having
6.11 the Attorney General's Office assist that board in its investigation. When the Attorney
6.12 General's Office has informed an employee of the appropriate licensing board in writing
6.13 that grounds exist to suspend or revoke a teacher's license to teach, that licensing board
6.14 must consider suspending or revoking or decline to suspend or revoke the teacher's or
6.15 administrator's license within 45 days of receiving a stipulation executed by the teacher or
6.16 administrator under investigation or a recommendation from an administrative law judge
6.17 that disciplinary action be taken.

6.18 (c) The Professional Educator Licensing and Standards Board and Board of School
6.19 Administrators must report to the appropriate law enforcement authorities a revocation,
6.20 suspension, or agreement involving a loss of license, relating to a teacher or administrator's
6.21 inappropriate sexual conduct with a minor. For purposes of this section, "law enforcement
6.22 authority" means a police department, county sheriff, or tribal police department. A report
6.23 by the Professional Educator Licensing and Standards Board or the Board of School
6.24 Administrators to appropriate law enforcement authorities does not diminish, modify, or
6.25 otherwise affect the responsibilities of a licensing board, school board, or any person
6.26 mandated to report abuse under section 626.556.

6.27 (d) The Professional Educator Licensing and Standards Board and Board of School
6.28 Administrators must, immediately upon receiving information that gives the board reason
6.29 to believe a child has at any time been neglected or physically or sexually abused, as defined
6.30 in section 626.556, subdivision 2, report the information to:

6.31 (1) the local welfare agency, agency responsible for assessing or investigating the report,
6.32 or tribal social services agency; and

6.33 (2) the police department, county sheriff, or tribal police department.

7.1 A report under this paragraph does not diminish, modify, or otherwise affect the
7.2 responsibilities of a licensing board under section 626.556.

7.5 to read:

7.6 Subd. 13. **Immediate discharge.** (a) Except as otherwise provided in paragraph (b), a
7.7 board may discharge a continuing-contract teacher, effective immediately, upon any of the
7.8 following grounds:

7.9 (1) immoral conduct, insubordination, or conviction of a felony;

7.10 (2) conduct unbecoming a teacher which requires the immediate removal of the teacher
7.11 from classroom or other duties;

7.12 (3) failure without justifiable cause to teach without first securing the written release of
7.13 the school board;

7.14 (4) gross inefficiency which the teacher has failed to correct after reasonable written
7.15 notice;

7.16 (5) willful neglect of duty; or

7.17 (6) continuing physical or mental disability subsequent to a 12 months leave of absence
7.18 and inability to qualify for reinstatement in accordance with subdivision 12.

7.19 For purposes of this paragraph, conduct unbecoming a teacher includes an unfair

7.21 Prior to discharging a teacher under this paragraph, the board must notify the teacher in
7.22 writing and state its ground for the proposed discharge in reasonable detail. Within ten days
7.23 after receipt of this notification the teacher may make a written request for a hearing before
7.24 the board and it ~~shall~~ must be granted before final action is taken. The board may suspend
7.25 a teacher with pay pending the conclusion of the hearing and determination of the issues
7.26 raised in the hearing after charges have been filed which constitute ground for discharge.
7.27 If a teacher has been charged with a felony and the underlying conduct that is the subject
7.28 of the felony charge is a ground for a proposed immediate discharge, the suspension pending

11.13 Subdivision 1. **Background check required.** (a) A school hiring authority ~~shall~~ must
11.14 request a criminal history background check from the superintendent of the Bureau of
11.15 Criminal Apprehension on all individuals who are offered employment in a school and on
11.16 all individuals, except enrolled student volunteers, who are offered the opportunity to provide
11.17 athletic coaching services or other extracurricular academic coaching services to a school,
11.18 regardless of whether any compensation is paid. In order for an individual to be eligible for
11.19 employment or to provide the services, the individual must provide an executed criminal
11.20 history consent form and a money order or check payable to either the Bureau of Criminal
11.21 Apprehension or the school hiring authority, at the discretion of the school hiring authority,
11.22 in an amount equal to the actual cost to the Bureau of Criminal Apprehension and the school
11.23 district of conducting the criminal history background check. A school hiring authority
11.24 deciding to receive payment may, at its discretion, accept payment in the form of a negotiable
11.25 instrument other than a money order or check and shall pay the superintendent of the Bureau
11.26 of Criminal Apprehension directly to conduct the background check. The superintendent
11.27 of the Bureau of Criminal Apprehension shall conduct the background check by retrieving
11.28 criminal history data as defined in section 13.87. A school hiring authority, at its discretion,
11.29 may decide not to request a criminal history background check on an individual who holds
11.30 an initial entrance license issued by the Professional Educator Licensing and Standards
11.31 Board or the commissioner of education within the 12 months preceding an offer of
11.32 employment.

11.33 (b) A school hiring authority may use the results of a criminal background check
11.34 conducted at the request of another school hiring authority if:

122A.09 DUTIES.

Subdivision 1. **Code of ethics.** The Professional Educator Licensing and Standards Board must develop by rule a code of ethics covering standards of professional teaching practices, including areas of ethical conduct and professional performance and methods of enforcement.

8710.2100 CODE OF ETHICS FOR MINNESOTA TEACHERS.

Subpart 1. **Scope.** Each teacher, upon entering the teaching profession, assumes a number of obligations, one of which is to adhere to a set of principles which defines professional conduct. These principles are reflected in the following code of ethics, which sets forth to the education profession and the public it serves standards of professional conduct and procedures for implementation.

This code shall apply to all persons licensed according to rules established by the Professional Educator Licensing and Standards Board.

Subp. 2. **Standards of professional conduct.** The standards of professional conduct are as follows:

A. A teacher shall provide professional education services in a nondiscriminatory manner.

B. A teacher shall make reasonable effort to protect the student from conditions harmful to health and safety.

C. In accordance with state and federal laws, a teacher shall disclose confidential information about individuals only when a compelling professional purpose is served or when required by law.

D. A teacher shall take reasonable disciplinary action in exercising the authority to provide an atmosphere conducive to learning.

E. A teacher shall not use professional relationships with students, parents, and colleagues to private advantage.

F. A teacher shall delegate authority for teaching responsibilities only to licensed personnel.

G. A teacher shall not deliberately suppress or distort subject matter.

H. A teacher shall not knowingly falsify or misrepresent records or facts relating to that teacher's own qualifications or to other teachers' qualifications.

I. A teacher shall not knowingly make false or malicious statements about students or colleagues.

J. A teacher shall accept a contract for a teaching position that requires licensing only if properly or provisionally licensed for that position.
