1.3 Statutes 2022, section 177.24, subdivision 1.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. Minnesota Statutes 2022, section 177.24, subdivision 1, is amended to read:

1.6 Subdivision 1. **Amount.** ~~(a) For purposes of this subdivision, the terms defined in this~~

1.16 ~~(b)~~ (a) Except as otherwise provided in sections 177.21 to 177.35<sup>2</sup>,

3.13 ~~(f)~~ (c) No later than August 31 of each year, beginning in ~~2017~~ 2029, the commissioner  
 3.14 shall determine the percentage increase in the rate of inflation, as measured by the implicit  
 3.15 price deflator, national data for personal consumption expenditures as determined by the  
 3.16 United States Department of Commerce, Bureau of Economic Analysis during the 12-month  
 3.17 period immediately preceding that August or, if that data is unavailable, during the most  
 3.18 recent 12-month period for which data is available. The minimum wage rates in paragraphs  
 3.19 (a) and (b), ~~(c), (d), and (e)~~ are increased by the lesser of: ~~(1) 2.5 percent, rounded to the~~  
 3.20 ~~nearest cent; or (2) the percentage calculated by the commissioner, shall be rounded to the~~  
 3.21 nearest cent. A minimum wage rate shall not be reduced under this paragraph. The new  
 3.22 minimum wage rates determined under this paragraph take effect on the next January 1.

3.23 ~~(g)(1)~~ (d)(1) No later than September 30 of each year, beginning in ~~2017~~ 2029, the  
 3.24 commissioner may issue an order that an increase calculated under paragraph ~~(f)~~ (c) not  
 3.25 take effect. The commissioner may issue the order only if the commissioner, after  
 3.26 consultation with the commissioner of management and budget, finds that leading economic  
 3.27 indicators, including but not limited to projections of gross domestic product calculated by  
 3.28 the United States Department of Commerce, Bureau of Economic Analysis; the Consumer  
 3.29 Confidence Index issued by the Conference Board; and seasonally adjusted Minnesota  
 3.30 unemployment rates, indicate the potential for a substantial downturn in the state's economy.  
 3.31 Prior to issuing an order, the commissioner shall also calculate and consider the ratio of the  
 3.32 rate of the calculated change in the minimum wage rate to the rate of change in state median  
 3.33 income over the same time period used to calculate the change in wage rate. Prior to issuing

4.1 the order, the commissioner shall hold a public hearing, notice of which must be published  
4.2 in the State Register, on the department's website, in newspapers of general circulation, and  
4.3 by other means likely to inform interested persons of the hearing, at least ten days prior to  
4.4 the hearing. The commissioner must allow interested persons to submit written comments  
4.5 to the commissioner before the public hearing and for 20 days after the public hearing.

4.6 (2) The commissioner may in a year subsequent to issuing an order under clause (1),  
4.7 make a supplemental increase in the minimum wage rate in addition to the increase for a  
4.8 year calculated under paragraph ~~(f)~~ (c). The supplemental increase may be in an amount up  
4.9 to the full amount of the increase not put into effect because of the order. If the supplemental  
4.10 increase is not the full amount, the commissioner may make a supplemental increase of the  
4.11 difference, or any part of a difference, in a subsequent year until the full amount of the  
4.12 increase ordered not to take effect has been included in a supplemental increase. In making  
4.13 a determination to award a supplemental increase under this clause, the commissioner shall  
4.14 use the same considerations and use the same process as for an order under clause (1). A  
4.15 supplemental wage increase is not subject to and shall not be considered in determining  
4.16 whether a wage rate increase exceeds the limits for annual wage rate increases allowed  
4.17 under paragraph ~~(f)~~ (c).

4.18 **EFFECTIVE DATE.** This section is effective the day following final enactment.
