BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

## Section 1. FEDERAL FUNDS REPLACEMENT OF STATE APPROPRIATION.

Subdivision 1. Suspension of statutory appropriation. The requirements for the use of the appropriation in Minnesota Statutes, section 4.07, subdivision 3, do not apply to any federal funds for COVID-19 received by the state of Minnesota between January 1, 2021, and June 30, 2021, for which a state general fund appropriation or transfer in this act is an eligible expenditure. Federal funding for COVID-19 to which this section applies shall not be used for any other purpose.

Subd. 2. Cancellation. If the state of Minnesota receives federal funds for COVID-19 between January 1, 2021, and June 30, 2021, for which any state general fund appropriation or transfer enacted in this act is an eligible expenditure, the commissioner of human services must cancel the state general fund appropriation or transfer in this act in an amount up to, but not greater than, the amount appropriated or transferred in this act. The commissioner of human services may designate a portion of a state appropriation or transfer for cancellation if the federal funds are not sufficient to replace the entire state general fund appropriation or transfer.

Subd. 3. Appropriation and transfer. Each amount canceled under subdivision 2 is 1.22 appropriated from the federal fund for the original purposes of the state general fund 1.23
