1.1 A bill for an act
 1.2 relating to education finance; increasing funding for extended time and area
 1.3 learning center programs; amending Minnesota Statutes 2012, sections 126C.05,
 1.4 subdivision 8; 126C.10, subdivision 2a.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2012, section 126C.05, subdivision 8, is amended to read:

1.7 Subd. 8. **Average daily membership.** (a) Membership for pupils in grades
 1.8 kindergarten through 12 and for prekindergarten pupils with disabilities shall mean the
 1.9 number of pupils on the current roll of the school, counted from the date of entry until
 1.10 withdrawal. The date of withdrawal shall mean the day the pupil permanently leaves
 1.11 the school or the date it is officially known that the pupil has left or has been legally
 1.12 excused. However, a pupil, regardless of age, who has been absent from school for 15
 1.13 consecutive school days during the regular school year or for five consecutive school days
 1.14 during summer school or intersession classes of flexible school year programs without
 1.15 receiving instruction in the home or hospital shall be dropped from the roll and classified
 1.16 as withdrawn. Nothing in this section shall be construed as waiving the compulsory
 1.17 attendance provisions cited in section 120A.22. Average daily membership equals the
 1.18 sum for all pupils of the number of days of the school year each pupil is enrolled in the
 1.19 district's schools divided by the number of days the schools are in session. Days of
 1.20 summer school or intersession classes of flexible school year programs are only included
 1.21 in the computation of membership for pupils with a disability not appropriately served
 1.22 primarily in the regular classroom. A student must not be counted as more than ~~1.2~~ 1.5
 1.23 pupils in average daily membership under this section. When the initial total average daily

2.1 membership exceeds ~~1.2~~ 1.5 for a pupil enrolled in more than one school district during
2.2 the fiscal year, each district's average daily membership must be reduced proportionately.

2.3 (b) A student must not be counted as more than one pupil in average daily
2.4 membership except for purposes of section 126C.10, subdivision 2a.

2.5 **EFFECTIVE DATE.** This section is effective for revenue for fiscal year 2014
2.6 and later.

2.7 Sec. 2. Minnesota Statutes 2012, section 126C.10, subdivision 2a, is amended to read:

2.8 Subd. 2a. **Extended time revenue.** (a) A school district's extended time revenue is
2.9 equal to the product of ~~\$4,601~~ the basic formula allowance and the sum of the adjusted
2.10 marginal cost pupil units of the district for each pupil in average daily membership in
2.11 excess of 1.0 and less than ~~1.2~~ 1.5 according to section 126C.05, subdivision 8.

2.12 (b) A school district's extended time revenue may be used for extended day
2.13 programs, extended week programs, summer school, and other programming authorized
2.14 under the learning year program.

2.15 **EFFECTIVE DATE.** This section is effective for revenue for fiscal year 2014
2.16 and later.
