1.15 Section 1. Minnesota Statutes 2020, section 13.43, is amended by adding a subdivision

1.16 to read:

1.17 Subd. 5b. **Military personnel data.** All personnel data maintained by the Department

1.18 of Military Affairs on military forces called to state active service is private data on

1.19 individuals. All records of paid or unpaid military leave on employees of a government

1.20 entity outside the Department of Military Affairs is private data on individuals.

1.21 Sec. 2. **[13.91] NATIONAL GUARD.**

1.22 In lieu of classifying, creating, collecting, retaining, and handling data as prescribed in

1.23 this chapter, the National Guard as defined in section 190.05, subdivision 4, is exempt from

1.24 the provisions of this chapter. Access to data of the National Guard is governed by applicable

1.25 federal regulations, including but not limited to the Freedom of Information Act, United

2.1 States Code, title 5, section 552, et seq., as amended, and the Privacy Act of 1974, United
 2.2 States Code, title 5, section 552a, et seq., as amended, and United States Code, title 18,
 2.3 section 1905. Upon receipt of data, the National Guard is required to protect against
 2.4 unauthorized disclosure by classifying the data in accordance with federal executive orders,
 2.5 laws, regulations, and rules.

2.9 Subdivision 1. **Transfer to civil authorities.** When any ~~felony~~ criminal offense is
 2.10 committed by any officer or enlisted member of the military forces while on duty status
 2.11 other than ~~active state~~ federal duty, the officer or enlisted member shall be turned over by
 2.12 superior officers to the proper civil authorities of the county or municipality in which the
 2.13 offense occurred for punishment for such crime, but such trial and punishment by the civil
 2.14 authorities shall not preclude trial and additional punishment or dismissal from the service
 2.15 by court-martial for any military offense resulting from the commission of said crime.

2.16 Subd. 2. **Service member data.** Notwithstanding any provision of chapter 13 or other
 2.17 state law, all investigative reports and law enforcement data, including but not limited to
 2.18 all data collected and defined under section 13.82 pertaining to any service member of the
 2.19 military forces must be made accessible to the adjutant general of the Minnesota National
 2.20 Guard upon request of the Office of the State Judge Advocate. All information, data, and
 2.21 records obtained under this subdivision may be accessed, copied, transmitted, or provided
 2.22 to the adjutant general without a court order or request from the subject of the data when
 2.23 the matter involves any officer or enlisted member of the military forces. The adjutant
 2.24 general may only use data made accessible under this subdivision in support of military
 2.25 justice and Minnesota National Guard administrative and disciplinary actions.

2.29 Any commissioned officer of a United States state or territory military force who meets
 2.30 the following qualifications may be accepted by the state judge advocate to conduct any
 2.31 and all administrative or Minnesota Code of Military Justice activities under this code and
 2.32 is exempt from section 481.02:

3.1 (1) has served as a member of the Judge Advocate Generals Corps for not less than two
3.2 years;

3.3 (2) is currently certified as competent for such duty by the Judge Advocate General of
3.4 the military force of which the individual is a member; and

3.5 (3) is a member of good standing of the bar of the highest court of any state.

3.6 Sec. 2. Minnesota Statutes 2020, section 192A.15, subdivision 1, is amended to read:

3.7 Subdivision 1. **Establishment.** There is hereby established a military judge system for
3.8 the ~~state~~ military forces. The military judge system shall be in the Military Department
3.9 under the command of the adjutant general. It shall consist of at least two military judges,
3.10 a number of legal clerks equal to the number of judges and such additional military staff as
3.11 is necessary.

 4.15 regulations.

 4.20 assimilated under any Minnesota state law as referenced under section 192A.605, or by the
 4.21 Minnesota Code of Military Justice. Any person subject to this code who is charged with

4.28 **192A.20 GOVERNOR MAY PRESCRIBE RULES.**

4.29 The procedure, including modes of proof, in cases before military courts and other
 4.30 military tribunals organized under this code may be prescribed by the governor or the
 4.31 adjutant general by rules, which shall, so far as the governor or the adjutant general considers

5.1 practicable, apply the principles of law and the rules of evidence generally recognized in
 5.2 ~~the trial of criminal cases in the courts of the state~~ manual for courts-martial of the United
 5.3 States, but which may not be contrary to or inconsistent with this code.

5.4 Sec. 2. Minnesota Statutes 2020, section 192A.235, subdivision 3, is amended to read:

5.5 Subd. 3. **Three-year limitation.** Except as otherwise provided in subdivision 1, and
 5.6 section 628.26, a person charged with any offense is not liable to be tried by court-martial
 5.7 or punished under section 192A.0851 if the offense was committed more than three years
 5.8 before the receipt of sworn charges and specifications by an officer exercising court-martial
 5.9 jurisdiction over the command or before the imposition of punishment under section
 5.10 192A.0851. The limitation for violations of any offense prescribed under this section shall
 5.11 be the lesser of the limitation prescribed by the manual for courts-martial of the United

5.16 Section 1. Minnesota Statutes 2020, section 192A.343, subdivision 3, is amended to read:

5.17 Subd. 3. **Action on findings.** (a) The authority under this section to modify the findings
 5.18 and sentence of a court-martial is a matter of command prerogative involving the sole
 5.19 discretion of the convening authority. If it is impractical for the convening authority to act,
 5.20 the convening authority shall forward the case to a person exercising general court-martial
 5.21 jurisdiction who may take action under this section.

5.22 (b) Action on the sentence of a court-martial shall be taken by the convening authority.
 5.23 The action may be taken only after the consideration of any matters submitted by the accused
 5.24 under subdivision 2 or after the time for submitting the matter expires, whichever is earlier.
 5.25 The convening authority, in that person's sole discretion, may approve, disapprove, commute,
 5.26 or suspend the sentence in whole or in part.

5.27 (c) Action on the findings of a court-martial by the convening authority or other person
 5.28 acting on the sentence is not required. However, such person, in the person's sole discretion,
 5.29 may:

5.30 (1) dismiss any charge or specification by setting aside a finding of guilty; or

5.31 (2) change a finding of guilty to a charge or specification to a finding of guilty to an
 5.32 offense that is a lesser included offense of the offense stated in the charge or specification.

6.13 and Appellate Procedure. (a) A review of any final order of a special or general court-martial
6.14 proceeding may be had upon certiorari by the supreme court upon petition of any party to
6.15 the proceeding. The review may be had on the ground that: (1) the court-martial was without
6.16 jurisdiction, or (2) the findings of the court-martial and the final order of the convening
6.17 authority: (i) were not justified by the evidence; (ii) were not in conformity with this code,
6.18 military law or other law applicable to the proceedings, or the Classified Information
6.19 Procedures Act; or (iii) were affected by any other error of law.

6.25 administrator of the court-martial. No fee or bond is required for either obtaining a writ of
6.26 certiorari or the associated filings required under this paragraph.

8.3 Subdivision 1. **Punishment limits.** The punishment ~~that a court-martial may direct for~~
8.4 ~~an offense may not exceed limits prescribed by this code.~~ for a violation of this code is
8.5 limited to the lesser of the sentence prescribed by the manual for courts-martial of the United
8.6 States in effect at the time of the offense or the state manual for courts-martial, but in no

10.4 subdivision have the meanings given them.

10.5 (1) "Applicant for military service" means a person who, under regulations prescribed
10.6 by the secretary concerned, the Minnesota National Guard authority, or designee concerned,
10.7 is an applicant for original enlistment or appointment in the armed forces.

10.8 (2) "Military recruiter" means a person who, under regulations prescribed by the secretary
10.9 concerned, has the primary duty to recruit persons for military service.

10.10 (3) "Prohibited sexual activity" means, as specified in regulations prescribed by the
10.11 secretary concerned, the Minnesota National Guard authority, or designee concerned,
10.12 inappropriate physical intimacy under circumstances described in such regulations.

10.13 (4) "Specially protected junior member of the armed forces" means:

10.14 (i) a member of the armed forces who is assigned to, or is awaiting assignment to, basic
10.15 training or other initial active duty for training, including a member who is enlisted under
10.16 a delayed entry program;

10.17 (ii) a member of the armed forces who is a cadet, an officer candidate, or a student in
10.18 any other officer qualification program; and

10.19 (iii) a member of the armed forces in any program that, by regulation prescribed by the
10.20 secretary concerned or a Minnesota National Guard authority, or designee concerned, is
10.21 identified as a training program for initial career qualification.

10.22 (5) "Training leadership position" means, with respect to a specially protected junior
10.23 member of the armed forces, any of the following:

10.24 (i) any drill instructor position or other leadership position in a basic training program,
10.25 an officer candidate school, a reserve officers' training corps unit, a training program for
10.26 entry into the armed forces, or any program that, by regulation prescribed by the secretary
10.27 concerned, is identified as a training program for initial career qualification; and

10.28 (ii) faculty and staff of the United States Military Academy, the United States Naval
10.29 Academy, the United States Air Force Academy, the United States Coast Guard Academy,
10.30 and the Minnesota National Guard Regional Training Institute.

10.31 Subd. 2. **Abuse of training leadership position.** Any person subject to this code:

10.32 (1) who is an officer or a noncommissioned officer;

11.1 (2) who is in a training leadership position with respect to a specially protected junior
 11.2 member of the armed forces; and

11.3 (3) who engages in prohibited sexual activity with the specially protected junior member
 11.4 of the armed forces;

11.5 shall be punished as a court-martial may direct.

11.6 Subd. 3. Abuse of position as military recruiter. Any person subject to this code:

11.7 (1) who is a military recruiter and engages in prohibited sexual activity with an applicant
 11.8 for military service; or

11.9 (2) who is a military recruiter and engages in prohibited sexual activity with a specially
 11.10 protected junior member of the armed forces who is enlisted under a delayed entry program;
 11.11 shall be punished as a court-martial may direct.

11.12 Subd. 4. Consent. Consent is not a defense for any conduct at issue in a prosecution
 11.13 under this section.

11.15 Subdivision 1. Definitions. For purposes of this section, the terms defined in this
 11.16 subdivision have the meanings given them.

11.17 (1) "Broadcast" means to electronically transmit a visual image with the intent that it be
 11.18 viewed by a person or persons.

11.19 (2) "Distribute" means to deliver to the actual or constructive possession of another
 11.20 person, including transmission by mail or electronic means.

11.21 (3) "Intimate visual image" means a visual image that depicts a private area of a person.

11.22 (4) "Private area" means the naked or underwear-clad genitalia, anus, buttocks, or female
 11.23 areola or nipple.

11.24 (5) "Reasonable expectation of privacy" means circumstances in which a reasonable
 11.25 person would believe that a private area of the person, or sexually explicit conduct involving
 11.26 the person, would not be visible to the public.

11.27 (6) "Sexually explicit conduct" means actual or simulated genital-genital contact,
 11.28 oral-genital contact, anal-genital contact, or oral-anal contact, whether between persons of

15.3 Minnesota Statutes 2020, section 192A.385, is repealed.

192A.385 PERSONS TO BE TRIED OR PUNISHED.

Subdivision 1. **Duty status required.** No person may be tried or punished for any offense provided for in sections 192A.39 to 192A.605 unless it was committed while that person was in a duty status as a member of the state military forces not in federal active service.

Subd. 2. **Determination.** Duty status may extend to any soldier while acting in the line of duty or during any consecutive duty periods. Consecutive duty periods run from the time the soldier is required to be at the assigned duty station until the soldier is dismissed from duty. Duty status may be determined by weighing factors including, but not limited to, whether the soldier:

- (1) is in uniform;
- (2) is attending a unit endorsed event;
- (3) is drilling in excess of 50 miles from the soldier's normal duty station;
- (4) is involved in an activity which is service-connected;
- (5) has been released versus dismissed from duty; and
- (6) is staying at lodging provided by the military or at military expense.
