1.6	Section 1. [624.7139] LOST OR STOLEN FIREARMS.
1.7	Subdivision 1. Duty to report. A person who owns, possesses, or controls a firearm
1.8	shall report the loss or theft of the firearm to a law enforcement agency in the jurisdiction
1.9	in which the loss or theft occurred as soon as practicable but not later than within 48 hours
1.10	of the time the person knew or reasonably should have known of the loss or theft.
1.11	Subd. 2. Penalty. (a) A person who violates this section is guilty of a petty misdemeanor.
