1.6 Section 1. Minnesota Statutes 2017 Supplement, section 85.0146, subdivision 1, is amended

1.8 Subdivision 1. **Advisory council created.** The Cuyuna Country State Recreation Area

1.9 Citizens Advisory Council is established. Membership on the advisory council shall include:
