1.8	Subdivision 1. Discontinuance. Notwithstanding section 103C.225, the Ramsey Soil
1.9	and Water Conservation District is discontinued effective July 1, 2018, and its duties and

1.11	Subd. 2. Transfer of duties and authorities. The Ramsey County Board of
