Subp 2 **Plan review fee.** Plans submitted to the Department of Agriculture under part 4626 1720 must be accompanied by the appropriate fee and a plan review application form provided by the department. Fees are based on the square footage of the structure being constructed, remodeled, or converted as prescribed below

Square Footage	Review Fee
0 – 4,999	\$125
5,000 – 24,999	175
25,000 plus	275
