3700.0100 GENERAL REQUIREMENTS FOR POSTSECONDARY VOCATIONAL TEACHERS.

Subpart 1. **Listed or referred to here.** An applicant for a license to teach postsecondary vocational courses or programs must meet the requirements listed or referred to in this part. These requirements are in addition to the requirements:

A. for teaching in a particular occupational area (listed in the first part that covers licenses in that occupational area); and

B. for the requirements for a particular license (listed under the part that covers that particular license).

Subp. 2. **Requirements elsewhere.** The applicant must comply with parts 3515.0100 to 3515.4400 and 3515.5000.

Subp. 3. **Maximum substituted hours.** The total number of hours that may be substituted for occupational experience is 4,000.

3700.0140 GENERAL PROVISIONS FOR VOCATIONAL LICENSURE.

Subpart 1. **Licenses requirement.** Licensed personnel shall meet licensure requirements set forth in Minnesota Rules pertaining to the licensure of technical college personnel for the areas in which such personnel practice.

Subp. 2. **License issuance.** Licenses are issued by the licensure unit within the State Board of Technical Colleges.

Subp. 3. **Fees.** License fees are established by the State Board of Technical Colleges and are nonrefundable except in accordance with the rules of the State Board of Technical Colleges. A fee established by the State Board of Technical Colleges shall be charged to the applicant for each application. If a renewal and additional license category requests are submitted for review simultaneously, one processing fee covers both the renewal and the new categories. Effective after July 1, 1990, each application for the issuance, renewal, or voluntary surrender of a license to teach shall be accompanied by a processing fee in the amount of \$50. When an applicant requests review by committee, an application must be submitted to the State Board of Technical Colleges in accordance with parts 3515.4100 to 3515.4400 and shall be accompanied by an additional processing fee to apply to the cost of the review in the amount of \$100. Upon presentation of evidence by a government agency indicating that the applicant is unable to pay the petition fee, the fee may be waived by the State Board of Technical Colleges.

The fee shall be paid to the State Board of Technical Colleges who shall deposit it with the state treasurer, as provided by law, and report each month to the commissioner of finance the amount of fees collected.

The fees are nonrefundable for applicants not qualifying for a license. However, the fee is refundable when the applicant for a license already holds the license for which application is made and that license does not expire in the year the application is submitted.

Subp. 4. **License validity.** Licenses become valid on the date of approval by the State Board of Technical Colleges. An individual shall hold a license before receiving payment for services that require a license. If a processing error results in issuance of a license to an individual who does not meet rule requirements for the license, the license is invalid. It is the

applicant's responsibility to return the license for corrections to the licensing unit of the State Board of Technical Colleges. All licenses shall bear the date of issuance and shall expire the specified number of years from the July 1 nearest the date the license was approved.

Subp. 5. Correlation of expiration dates. If an applicant applies for and meets the requirements for an additional license which has the same renewal requirements as the applicant's existing license, the licensing unit will correlate the expiration dates.

When renewing an existing field, one of the following may occur for the purpose of correlating multiple expiration dates if the renewal conditions pertaining to both have been met and verified according to rules. Subsequent renewal will require compliance with customary renewal requirements.

A. Request renewal of another existing licensure field one year early.

B. Request that the expiring fields receive less than the full renewal period.

3700.0145 SUBSTITUTE LICENSE.

Subpart 1. Issuance. A substitute license in a specific occupational, related, or instructional special needs area shall be issued to meet the short-term need for an instructor substitute. The state chancellor shall issue a substitute license to an applicant qualified through academic preparation, technical training, or applied experience in the field to be taught.

Subp. 2. Authorizing signature. An authorized local technical college administrator shall recommend to the state chancellor applicants who are qualified through academic preparation, technical training, or applied experience in the specific area of licensure. Applications for initial and subsequent renewed substitute licenses shall be signed by the authorized local technical college administrator. The applications shall include evidence of the applicant having had academic preparation, technical training, or applied occupational or instructional experience in the requested licensure field.

Subp. 3. License validity.

A. Initial entrance substitute license shall remain valid for a maximum of five years. The maximum substitute assignment must not exceed 30 consecutive working days of employment in one assignment, 270 clock hours per fiscal year.

B. Renewed substitute licenses are issued for five-year periods upon the recommendation of the authorized local technical college administrator. The maximum substitute assignment must not exceed 30 consecutive working days of employment in one assignment or 270 clock hours per fiscal year.

C. A technical college license at the extension part-time level in parts 3700.1400 and 3700.1405 must not be used as a substitute license.

D. An instructor who is making use of an extension license on August 19, 1991, may continue to use the license until the license is first required to be renewed after August 19, 1991.

3700.0150 VOLUNTARY SURRENDER OF LICENSES.

Subpart 1. Materials required to surrender license. The person holding a technical college teaching license granted by the State Board of Technical Colleges may voluntarily surrender the license by submitting to the licensing unit the following:

A. An application for voluntary surrender which specifies the license category or categories to be surrendered. This application must include the signatures of the district superintendent and the technical college president. The signatures will serve as verification to the State Board of Technical Colleges that the district superintendent and the technical college president have been notified of the applicant's intent to remove a category or categories from a license.

B. The applicants copy of the most recently issued license.

C. The required processing fee.

Subp. 2. **Voluntary surrender date.** When the licensing unit receives the materials listed in subpart 1, postmarked by January 1, the date of surrender is July 1 of that year. When the materials are postmarked after January 1, the date of surrender is July 1 of the following calendar year.

Subp. 3. **Withdrawal of request.** A request may be withdrawn by the applicant on or before December 31 of the year in which the request was made without refund of fee.

Subp. 4. **Notification.** Upon receipt of the signed application for voluntary surrender, the State Board of Technical Colleges will request in writing the copies of the applicant's original license from the offices of the district superintendent and technical college president. It is the responsibility of the applicant to file with the offices of the district superintendent and the technical college president the revised license.

Subp. 5. **When voluntary surrender is prohibited.** A person may not voluntarily surrender a license under any of the following circumstances:

A. the school board has begun proceedings to terminate the continuing contract, pursuant to Minnesota Statutes, section 125.12, subdivision 6 or 8, or 125.17, subdivision 4;

B. the State Board of Technical Colleges or its designee has begun proceedings to suspend or revoke the license pursuant to part 8700.7500 or Minnesota Statutes, sections 125.09 and 214.10; or

C. any educational agency or board has begun proceedings which could result in alteration of the status of the teaching license due to the person's conduct.

Subp. 6. **Entrance license after voluntary surrender.** A person whose technical college license has been voluntarily surrendered may apply for entrance licensure in the category for which licensure was previously surrendered. An entrance license must be granted to the applicant if the following criteria are met:

A. a licensure rule exists in the category for which licensure was previously surrendered;

B. the applicant meets the entrance licensure criteria that are in effect for that category at the time of application; and

C. the required processing fee accompanies the application for entrance licensure.

Subp. 7. **Effect of voluntary surrender.** Nothing in subparts 1, 2, and 4 prohibits a person from holding or applying for a license in any other category upon surrender of a license in another category.

3700.0155 LETTERS OF APPROVAL.

Subpart 1. **Issuance.** The State Board of Technical Colleges may issue letters of approval under the conditions of subpart 3 that permit a licensed individual to undertake an assignment for which that individual is not currently licensed to resolve a hardship.

Subp. 2. **Hardship.** For letter of approval purposes, the chancellor's designee determines whether a hardship exists because of item A, B, or C subject to the conditions of subpart 3:

A. an immediate need exists due to an unexpected resignation, death, dismissal, or long-term leave of absence of a licensed staff member;

B. an immediate need exists due to the inability to recruit an individual who is licensable for the assignment and who is available for hire; or

C. an unavoidable situation exists that prevents the offering of needed instruction or service without resort to the letter of approval.

Subp. 3. **Conditions.** Letters of approval authorized by subpart 1 must be issued to a technical college president if the chancellor's designee finds that the conditions in this subpart are met:

A. the technical college president has requested a letter of approval in accordance with this part;

B. the technical college president has verified in writing that:

(1) a specific assignment vacancy exists that requires a technical college license in the licensure category for which a letter of approval is requested;

(2) reasonable recruitment efforts have been made, as specified by local policy;

(3) no person with appropriate technical college licensure who wishes to undertake the assignment is available for hire or reassignment to this area;

(4) no person who wishes to undertake the assignment and who has been placed on unrequested leave by the technical college has filed with the district a current technical college license that is valid for the assignment for which the letter of approval is requested; and

(5) the person for whom the request is made:

(a) holds a valid license issued by the State Board of Technical Colleges;

(b) is technically qualified for the assignment as evidenced by documentation of training or occupational experience of sufficient substance that in part would qualify for a full license in the requested licensure category without regard to the occupational recency and teacher education sequence provisions; and

(c) has had 12 clock hours of teaching techniques as determined by the local technical college if the request is in an instructional field.

Subp. 4. Duration, renewal of letters of approval. A letter of approval is valid for no longer than the rest of the fiscal year in which it is issued. A letter of approval involving the same individual and circumstance may be renewed only once and only if the conditions of subpart 3, items A and B, are met again. The renewal is valid for no longer than the rest of the school year in which the renewal is approved.

AGRICULTURAL OCCUPATIONS

3700.0200 LICENSES IN THE AGRICULTURAL OCCUPATIONAL AREA.

Subpart 1. Listed here. An applicant for a license to teach postsecondary vocational courses and programs in the agricultural occupational area must meet the requirements in this part. These requirements are in addition to the requirements listed in part 3700.0100 and the requirement for a particular license (listed under the part that covers that particular license).

Subp. 2. Recent occupational experience. An applicant for a license to teach in the agricultural occupational area must have 2,000 hours of occupational experience within the five years just before applying for the license.

Subp. 3. Does not apply. Parts 3515.9920 and 3515.9930 no longer apply.

3700.0205 FARM BUSINESS MANAGEMENT LICENSE.

Subpart 1. May teach. A teacher who has a farm business management license may teach in the farm business management program and may also teach courses in:

- A. agricultural financial management, marketing, and record keeping;
- B. goal setting in farming and agricultural business;
- C. agricultural financial statements and analysis;
- D. methods of marketing crops and livestock; and
- E. applied crop and livestock practices.

Subp. 2. Other requirements. The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the agricultural occupational area under part 3700.0200.

Subp. 3. Education requirement. A bachelor's or higher degree from an accredited postsecondary institution in agricultural education is required for this license.

Subp. 4. Occupational experience requirement. The applicant must have 4,000 hours of occupational experience. The 4,000 hours may include the 2,000 hours required under part 3700.0200, subpart 2 and must be in production or operations with plants or animals on a farm or ranch as a farmer or rancher; farm or ranch manager; or farm or ranch owner and operator.

Subp. 7. Substitution for occupational experience. The applicant may substitute teaching in programs and courses at an accredited secondary or postsecondary technical college in plant or animal science, agricultural education, farm operations and management, veterans cooperative farm management, or farm business management for up to 1,500 of the 2,000 hours of recent occupational experience required under part 3700.0200, subpart 2. The teaching must be done during the five years just before applying for the license. Two hours of teaching equals one hour of occupational experience.

3700.0210 FARM OPERATIONS AND MANAGEMENT LICENSE.

Subpart 1. May teach. A teacher who has a farm operations and management license may teach in the farm operations and management program and may also teach programs and courses in:

- A. plant growth and reproduction;
- B. animal production and management;
- C. animal nutrition;
- D. basic agricultural mechanics;
- E. agricultural structures, design, and maintenance;
- F. agricultural soil, water, and conservation management; and
- G. agricultural financial management, marketing, and record keeping.

Subp. 2. Other requirements. The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the agricultural occupational area under part 3700.0200.

Subp. 3. Education and occupational experience requirements. The applicant must have:

A. a bachelor's or higher degree from an accredited postsecondary institution in agricultural education, plant or animal science, agricultural economics, or technical agriculture and 4,000 hours of occupational experience in production or operations with plants or animals on a farm or ranch as a farmer or rancher; farm or ranch manager; or farm or ranch owner and operator; or

B. two years of education from an accredited postsecondary institution in technical agricultural education and 6,000 hours of occupational experience in production or operations with plants or animals on a farm or ranch as a farmer or rancher; farm or ranch manager; or farm or ranch owner and operator; and

C. the occupational experience required in items A and B may include the 2,000 hours required under part 3700.0200, subpart 2.

Subp. 4. Substitution for occupational experience. The applicant may substitute teaching experience in programs and courses at an accredited secondary or postsecondary technical college in plant or animal science, agricultural economics, agricultural education, farm operations and management, farm business management, agricultural mechanics, vocational agriculture, veterans cooperative farm management, or farm business management for up to 1,500 of the 2,000 hours of recent occupational experience required under part 3700.0200, subpart 2. The teaching must be done during the five years just before applying for the license. Two hours of teaching equals one hour of occupational experience.

3700.0215 DAIRY HERD MANAGEMENT LICENSE.

Subpart 1. **May teach.** A teacher who has a dairy herd management license may teach in the dairy herd management program and may also teach courses in:

- A. agricultural business management, marketing, and record keeping;
- B. dairy breeding, nutrition, health, and housing; and
- C. marketing of milk and breeding stock.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the agricultural occupational area under part 3700.0200.

Subp. 3. **Education and occupational experience requirements.** The applicant must have:

A. a bachelor's or higher degree from an accredited postsecondary institution in agricultural education or animal science and 4,000 hours of occupational experience in dairy herd management; or

B. two years of education from an accredited postsecondary institution in farm operations management, animal science, or dairy herd management, and 6,000 hours of occupational experience in dairy herd management; and

C. the occupational experience required in items A and B may include the 2,000 hours required under part 3700.0200, subpart 2.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute teaching experience in programs and courses at an accredited secondary or postsecondary technical college in agricultural education, farm operations management, animal science, vocational agriculture, farm business management, veterans cooperative farm management, or dairy herd management for up to 1,500 of the 2,000 hours of recent occupational experience required under part 3700.0200, subpart 2. The teaching must be done during the five years just before applying for the license. Two hours of teaching equals one hour of occupational experience.

3700.0220 LAMB AND WOOL MANAGEMENT LICENSE.

Subpart 1. **May teach.** A teacher who has a lamb and wool management license may teach in the lamb and wool management program and may also teach courses in:

- A. sheep breeding, nutrition, health, and housing;
- B. marketing of sheep by-products; and
- C. sheep financial management and record keeping.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the agricultural occupational area under part 3700.0200.

The education must be from an accredited postsecondary institution. If substitution is made, the applicant must still comply with the recency requirement of part 3700.0200, subpart 2.

A. A bachelor's or higher degree in forestry, forestry science, business management, or natural resources may be substituted for 4,000 hours.

B. An associate degree in logging business management, forestry, forestry science, farm business management, business management, or natural resources may be substituted for 2,000 hours.

C. A certificate or diploma in logging business management, forest harvesting, or forest business management may be substituted, if a one-year program, for 1,050 hours and if a two-year program, for 2,100 hours.

B. two years of education from an accredited postsecondary institution in forestry, forest harvesting, forest equipment maintenance, or logging and 6,000 hours of occupational experience in forest harvesting operations as a supervisor, manager, or logger; and

C. the occupational experience required in items A and B may include the 2,000 hours required under part 3700.0200, subpart 2.

Subp. 4. Substitution for occupational experience. The applicant may substitute teaching experience in programs or courses in an accredited secondary or postsecondary technical college in forestry, forest harvesting, forest equipment maintenance, forestry management, or logging business management for up to 1,500 of the 2,000 hours of recent occupational experience required under part 3700.0200, subpart 2. The teaching must be done during the five years just before applying for the license. Two hours of teaching equals one hour of occupational experience.

A. A bachelor's or higher degree in fish and wildlife management or natural resource technology may be substituted for 4,000 hours.

B. An associate degree in fish and wildlife management or natural resource technology may be substituted for 2,000 hours.

C. A certificate or diploma in natural resource technology may be substituted, if a one-year program, for 1,050 hours and if a two-year program, for 2,100 hours.

D. The completion of courses for credit or clock hours for credit in taxidermy, bird mounting, game head mounts, federal and state laws related to taxidermy, or reptiles and amphibians may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in programs and courses at an accredited postsecondary vocational program in taxidermy for up to 1,500 of the 2,000 hours of recent occupational experience required under part 3700.0200, subpart 2. The teaching must be done during the five years just before applying for the license. Two hours of teaching equals one hour of occupational experience.

B. two years postsecondary education in poultry production management from an approved postsecondary institution and 6,000 hours of verified occupational experience as an owner/operator, manager, supervisor, or service representative in turkey production, broiler production, breeder flock management, or egg production.

Subp. 4. **Substitution for occupational experience.** Teaching experience at an accredited postsecondary institution may be substituted for 1,500 of the 2,000 hours of recent occupational experience if the teaching is done during this five-year period. F. providing all reports required by the technical college and the state agricultural program specialists, including monthly activity reports and annual summaries fo instructor reports;

G. administering and coordinating farm business management programs in the technical colleges within the assigned geographical area; and

H. monitoring, identifying, and making recommendations for expansion, elimination, or addition of farm business management programs to the state agriculture program specialist.

Subp. 2. **Education requirement.** Bachelor's or above degree in agriculture education and nine quarter credits or 108 clock hours in vocational administration.

Subp. 3. **Teaching experience requirement.** The applicant must have three years of teaching experience as a licensed vocational, postsecondary, or full-time adult instructor. This teaching must be in farm business management.

Subp. 4. **Teaching experience recency.** Two thousand hours of the teaching experience required in subpart 3 must be within five years of application for licensure.

A. a bachelor's degree or above with a major in an agricultural field and 4,000 hours of occupational experience as an owner/operator, manager, supervisor, or service representative in the swine production areas of breeding, farrowing, nursery, and finishing; or

B. two years of postsecondary education from an accredited postsecondary institution in swine production management and 6,000 hours of occupational experience as an owner/operator, manager, supervisor, or service representative in the swine production areas of breeding, farrowing, nursery, and finishing.

Subp. 4. **Substitution for occupational experience.** Teaching experience at an accredited postsecondary institution or industrial setting may be substituted for 1,500 of the 2,000 hours of recent occupational experience if the teaching is done during the five-year period. The teaching must be in primary program content in swine production management. Two hours of teaching equal one hour of recent occupational experience.

C. A certificate or diploma in horticulture, golf course and grounds technology, or turf and landscape irrigation may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

3700.0296 GOLF FACILITIES MANAGEMENT.

facility with at least 30,000 rounds of golf annually. A minimum of 6,000 hours, including the 2,000 hours of recent occupational experience, must be in a public facility. The remaining hours may be in a private facility. The applicant must have overall responsibility for facility operations and management control of a minimum of five of the areas listed in items A to J:

- A. budgeting;
- B. personnel training;
- C. pro shop inventory control and operation;
- D. food service;
- E. facility planning and scheduling to include tournaments, leagues, and private parties;
- F. establishing and monitoring of policies for golf leagues and golf clubs;
- G. course scheduling, procedures and practices, staffing, regulations, and instruction;
- H. building and equipment maintenance;
- I. coordinating and disseminating information regarding governing board, agencies, and committees; or
- J. turf management and agronomy.

Subp. 4. Substitution for occupational experience. The applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours of the occupational experience described in subpart 3. The education must be from an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirement of subpart 2.

A. A bachelor's degree or above with a major in golf facilities management or business administration or business management may substitute for 4,000 hours of occupational experience.

B. An associate degree in golf facilities management or business administration or business management may substitute for 2,000 hours.

C. A diploma or certificate in golf facilities management or business administration or business management may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

D. Course or clock hours for credit in golf facilities management, business administration or management, or seminars, workshops, or courses given in management by the Allied Golf Association. One clock hour equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content in golf facilities management content for up to 1,500 of the 2,000 hours required in part 3700.0400 provided that experience occurred within the last five years. Two hours of teaching equal one hour of occupational experience.

3700.0298 AQUACULTURE.

Subp. 3. Educational and occupational experience requirements. An applicant must have the requirements as listed in item A, B, or C.

A. A bachelor's or higher degree from an accredited postsecondary institution with a major in aquaculture, fisheries, fisheries and wildlife, or natural resources, and 4,000 hours of occupational experience in an aquaculture or fish farm facility with experience in at least five of the following:

- (1) fish harvesting;
- (2) disease diagnosis;
- (3) design of fish culture systems;
- (4) hatchery maintenance;
- (5) nutrition and feeding analysis;
- (6) transportation and handling;
- (7) water quality management;
- (8) eggtaking;
- (9) brood stock management; and
- (10) chemical application and treatment.

B. An associate degree or two-year diploma or certificate from an accredited post-secondary institution in aquaculture, fisheries, fisheries and wildlife, or natural resources and 6,000 hours of occupational experience in an aquaculture, fish farm facility, or research laboratory with experience in at least five of the following:

- (1) fish harvesting;
- (2) disease diagnosis;
- (3) design of fish culture systems;
- (4) hatchery maintenance;
- (5) nutrition and feeding analysis;
- (6) transportation and handling;
- (7) water quality management;
- (8) eggtaking;
- (9) brood stock management; and
- (10) chemical application and treatment.

C. Eight thousand hours of occupational experience in an aquaculture or fish farm facility with experience in at least five of the following:

- (1) fish harvesting;
- (2) disease diagnosis;
- (3) design of fish culture systems;
- (4) hatchery maintenance;
- (5) nutrition and feeding analysis;
- (6) transportation and handling;
- (7) water quality management;
- (8) eggtaking;
- (9) brood stock management; and
- (10) chemical application and treatment.

Subp. 4. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in aquaculture programs or courses at an accredited postsecondary institution for up to 1,500 of the 2,000 hours of recent occupational experience required under part 3700.0200, subpart 2. The teaching must be in primary program content and must be done during the five years just before applying for the license. Two hours of teaching equals one hour of occupational experience.

D. The completion of courses for credit or clock hours for credit with an accounting or business administration title or prefix may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or in an industrial or military setting in advanced level accounting for 1,500 hours of the 2,000 required under part 3700.0300, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0300, subpart 2.

- D. accounts payable/receivable/cost clerk;

- F. bookkeeper;

- H. controller or assistant controller;
- I. payroll bookkeeper or clerk;
- J. internal, external, or government auditor; and
- K. cost, budget, managerial cost, public, or staff accountant.

D. The completion of courses for credit or clock hours for credit from an approved postsecondary institution or from professional accounting associations, with an accounting, bookkeeping, or business administration title or prefix may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or in an industrial or military setting in bookkeeping or accounting for 1,500 hours of the

2,000 required under part 3700.0300, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0300, subpart 2.

D. The completion of courses for credit or clock hours for credit with a banking title or prefix may be substituted. The courses for credit or clock hours for credit must be from an accredited postsecondary institution or sponsored by local, state, or national professional financial organizations. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institu-

tion or in an industrial or military setting in banking and finance/agriculture, banking and finance operations, or finance and credit for 1,500 hours of the 2,000 required under part 3700.0300, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0300, subpart 2.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of occupational experience with a minimum of 4,000 hours as a legal secretary. There is no substitution allowed for these hours in subpart 4, items A to D. The remaining hours may be in any secretarial field. The 8,000 hours must include the 2,000 hours required under part 3700.0300, subpart 2, and must be in legal secretarial experience.

Subp. 4. Substitution for occupational experience. The applicant may substitute education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3, other than legal secretarial. The education must be at an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A bachelor's or higher degree with a major in marketing, business administration or management, or finance may be substituted for 4,000 hours.

B. An associate degree in marketing, or business administration or management may be substituted for 2,000 hours.

C. A diploma in purchasing or inventory management may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit with a business administration or management, accounting, marketing, or economics title or prefix may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or in an industrial or military setting in purchasing or inventory management for 1,500

hours of the 2,000 required under part 3700.0300, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0300, subpart 2.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of occupational experience in one or more of the areas listed in items A and B. The 8,000 hours must include the 2,000 hours required under part 3700.0300, subpart 2:

- A. official court reporter; and
- B. freelance court reporter.

Subp. 4. Substitution for occupational experience. The applicant may substitute education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be at an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

Two hours of teaching equal one hour of the occupational experience required under part 3700.0300, subpart 2.

sonnel assistant in a personnel or human resources department. The 8,000 hours must include the 2,000 required under part 3700.0300, subpart 2.

Subp. 4. Substitution for occupational experience. The applicant may substitute education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be at an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A bachelor's or higher degree with a major in personnel, human resources, industrial relations, or business may be substituted for 4,000 hours.

B. An associate degree in a personnel assistant program may be substituted for 2,000 hours.

C. A diploma or certificate in a personnel assistant program may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit with a personnel title or prefix, or in human relations, labor relations, wage and salary administration, interviewing techniques, and training and development of personnel may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or an industrial or military setting in personnel assistant for 1,500 hours of the 2,000 required under part 3700.0300, subpart 2. Two hours of teaching experience equal one hour of the occupational experience required in part 3700.0300, subpart 2.

- D. microcomputer programming and operations;
- E. management information systems;
- F. operating system concepts and skills;
- G. work station operations;
- H. data communications;
- I. system analysis and design; and
- J. programming languages.

Subp. 2. Other requirements. The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the business and office area under part 3700.0300.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of work experience in one or more of the areas listed in items A to E. The experience must be in a mainframe or minicomputer environment. The 8,000 hours must include the 2,000 hours required under part 3700.0300, subpart 2:

- A. computer programmer;
- B. systems analyst;
- C. data communications programmer;
- D. data base programmer; and
- E. systems programmer.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be at an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A baccalaureate or higher degree with a major in business administration, management information systems, or computer science may be substituted for 4,000 hours.

B. An associate degree in computer programmer may be substituted for 2,000 hours.

C. A diploma in computer programming may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in computer: mainframe or minicomputer systems, programming, or operations may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or in an industrial or military setting in mainframe or minicomputer programming, for 1,500 hours of the 2,000 required under part 3700.0300, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0300, subpart 2.

- H. computer literacy.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the business and office area under part 3700.0300.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience in one or more of the areas listed in items A to D. This experience must be in mainframe or minicomputers. The 8,000 hours must include the 2,000 hours required under part 3700.0300, subpart 2:

- A. computer operator;
- B. computer operations manager;
- C. computer systems software support; and
- D. computer operations analyst.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be at an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A baccalaureate or higher degree with a major in business administration, management information systems, or computer science may be substituted for 4,000 hours.

B. An associate degree in computer operations or programmer may be substituted for 2,000 hours.

C. A diploma in computer operations may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in computer mainframe or minicomputer systems, programming, or operations may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or in an industrial or military setting in mainframe or minicomputer operations for 1,500 hours of the 2,000 required under part 3700.0300, subpart 2. Two hours of teaching experience equal one hour of the occupational experience required in part 3700.0300, subpart 2.

The recency listed in part 3700.0300, subpart 2, must be met with this experience. The remaining hours may be in an administrative support position.

Subp. 4. Substitution for occupational experience. The applicant may substitute the education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A bachelor's or higher degree in business, accounting, or financial aid administration may be substituted for 2,000 hours of experience in an administrative support position and a maximum of 2,000 hours of the experience in a financial aid position.

B. An associate degree in business, accounting, administrative support, or financial aid assistant may be substituted for 2,000 hours.

C. A diploma in accounting, administrative support, or financial aid assistant may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in administrative support or financial aid may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution in financial aid assistant for 1,500 hours of the 2,000 required in part 3700.0300, subpart 2. Two hours of teaching equal one hour of occupational experience required in part 3700.0300, subpart 2.

Subp. 2. Other requirements. The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the business and office area under part 3700.0300.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of business application occupational experience in two or more of the following areas: installation of and troubleshooting computers, computer trainer in a business or industrial setting, or programming. A minimum of 4,000 of these hours must be in microcomputers. The remaining experience may be in a nonmicrocomputer environment in any of the three areas described in this subpart. The 8,000 hours must include the 2,000 hours required under part 3700.0300, subpart 2 and must be microcomputer experience.

Subp. 4. Substitution for occupational experience. The applicant may substitute the education described in items A to D for up to 4,000 hours of the nonmicrocomputer occupational experience described in subpart 3. The education must be from an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A bachelor's or higher degree in management information systems, computer science, data processing, or telecommunications may be substituted for 4,000 hours.

B. An associate degree in computer science, data processing, microcomputer specialist, or advanced business communication may be substituted for 2,000 hours.

C. A diploma in business microcomputing, computer operator, or computer programmer may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in microcomputer or mainframe computer may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution, or at an industrial or military setting in microcomputer specific training for 1,500 hours of the 2,000 required in part 3700.0300, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0300, subpart 2.

- D. integrated services digital network;
- E. microcomputer system applications;
- F. asynchronous/synchronous communications; and
- G. modem technology.

Subp. 2. Other requirements. The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the business and office area under part 3700.0300.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of occupational experience in planning, designing, networking, engineering, managing, or installing and maintaining two or more of items A to C. The 8,000 hours may include the 2,000 hours required under part 3700.0300, subpart 2.

A. mainframe, minicomputers, or microcomputer systems analysis and operation in a business setting;

B. voice communications system; and

C. data communications system.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A bachelor's or higher degree in computer science, management information systems, microcomputer studies, electrical engineering, or voice data telecommunications may be substituted for 4,000 hours.

B. An associate degree in advanced business communications, electronics, microcomputer support specialist, or office information processing specialist may be substituted for 2,000 hours.

C. A diploma in business microcomputing or electronics may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in mainframe, microcomputers, or minicomputers; voice data or telecommunications; or electronics may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** An applicant may substitute teaching experience in primary core program content at an accredited postsecondary institution, or at an industrial or military setting in advanced business communications, microcomputer, telephony, data communications, or network design for 1,500 hours of the 2,000 required in part 3700.0300, subpart 2. Two hours of teaching equal one hour of occupational experience required in part 3700.0300, subpart 2.

D. application concepts/theory (SQ/SS/DB);

E. application design;

F. software evaluation; and

G. office desktop publishing.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the business and office area under part 3700.0300.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience in word processing supervisory responsibilities in an end user environment where systems and technical staff interact with nontechnical employees. This experience must include applications design involvement from conception to implementation and consisting of identifying office tasks, needs identification, development of software and hardware solutions, selection of staff who will use the system, and training of end users. The 8,000 hours must include the 2,000 hours required under part 3700.0300, subpart 2.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution. If

the substitution is made, the applicant must still comply with the recency requirements in part 3700.0300, subpart 2.

A. A bachelor's or higher degree in business management, business education, business administration, office management, office administration, or information processing (MIS) may be substituted for 4,000 hours.

B. An associate degree in secretarial science, secretarial, office information processing, personnel assistant, office administration, or office management may be substituted for 2,000 hours.

C. A diploma in general, legal, medical, or word processing secretarial programs may substitute for 2,000 hours. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in information processing, business, secretarial, or management may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution, or in an industrial or military setting in general office typist, general secretarial office information processing specialist, or word processing for 1,500 hours of the 2,000 required in part 3700.0300, subpart 2. Two hours of teaching equal one hour of occupational experience required in part 3700.0300, subpart 2.

3700.0400 LICENSES IN THE HEALTH OCCUPATIONAL AREA.

Subpart 1. **Listed here.** An applicant for a license to teach postsecondary vocational courses and programs in the health occupational area must meet the requirements in this part. These requirements are in addition to the requirements in part 3700.0100 and for a particular license (listed under the part that covers that particular license).

Subp. 2. **Recent occupational experience.** An applicant for a license to teach in the health occupational area must have 2,000 hours of occupational experience within the five years just before applying for licensure.

Subp. 3. **Substitution.** The total number of hours substituted for occupational experience must not exceed 4,000.

Subp. 4. **Does not apply.** Parts 3515.9920 to 3515.9930 do not apply to parts 3700.0400 and 3700.0435.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. **Educational and occupational experience requirement.** The applicant must have the educational and occupational experience described in item A, B, or C. The education must be from an accredited postsecondary institution.

A. Licensed chiropractor and 4,000 hours of occupational experience in a chiropractic office or chiropractic hospital. This experience must include office procedures, insurance coverage, physical agents application, X-ray, and examinations.

B. Diploma or 90 or more quarter credits from a two-year chiropractic technician or chiropractic assistant program and 6,000 hours of occupational experience as a technician or assistant in a chiropractic office or chiropractic hospital. The experience must include office procedures, insurance coverage, physical agents application, and assisting the chiropractor with X-ray and examinations.

C. Diploma or 45 or more quarter credits from a one-year chiropractic technician or chiropractic assistant program or an American Chiropractic Registered Radiologist technician and 7,000 hours of occupational experience as a technician or assistant in a chiropractic office or chiropractic hospital. The experience must include office procedures, insurance coverage, physical agents application, and assisting the chiropractor with X-ray and examinations.

Subp. 4. **Substitution for recent occupational experience.** The applicant may substitute teaching experience at an accredited postsecondary institution, or at an industrial or military setting for 1,500 of the 2,000 hours required in part 3700.0400, subpart 2, if the teaching is done during the five-year period. The teaching must be in primary program content in chiropractic assisting, chiropractic technician, or chiropractic practice. Two hours of teaching equal one hour of occupational experience.

3700.0410 EKG/CARDIAC TECHNICIAN.

Subpart 1. **May teach.** A teacher who has an EKG/cardiac technician license may teach in the EKG/cardiac technician program and may also teach cardiopulmonary resuscitation.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. **Occupational experience requirement.** The applicant must have current cardiopulmonary resuscitation instructor certification and 8,000 hours of occupational experience in one of the following:

A. registered nurse in critical care using 12 lead cardiograms, exercise stress testing of clients, care of clients with pacemakers, and interpreting basic and advanced cardiac rhythms; or

B. supervisory EKG/cardiac technician.

Subp. 4. **Substitution for occupational experience.** An applicant may substitute the education described under item A, B, C, or D for up to 4,000 hours of occupational experience required in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in medicine, nursing, or cardiac technology may be substituted for 4,000 hours.

B. An associate degree in nursing, perfusionist, echo cardiac sonographer, EKG/cardiac technician, cardiac technology, biomedical equipment, cardiopulmonary, medical laboratory, medical technology, medical imaging, or radiography, or a bachelor's degree in biomedical science or medical technology may be substituted for 2,000 hours.

C. A diploma in nursing, perfusionist, EKG/cardiac technology, or cardiac technician may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two- or three-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in cardiac care, cardiac conditions, or cardiac equipment use and maintenance may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

3700.0415 PHYSICAL THERAPIST ASSISTANT.

Subpart 1. **May teach.** A teacher who has a physical therapist assistant instructor license may teach in the physical therapist assistant program and may also teach courses in anatomy and physiology, medical terminology, exercise physiology, kinesiology, neuroanatomy and neurophysiology, and physical disability/rehabilitation.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. **Occupational and educational experience requirement.** The applicant must have the following experiences:

- A. a bachelor's or higher degree with a major in physical therapy from an American Physical Therapy Association accredited institution;
- B. physical therapist registration in the state of Minnesota; and
- C. 4,000 hours of occupational experience as a registered physical therapist in at least two of the following: acute care setting, outpatient physical therapy, long-term care, or rehabilitation setting.

Subp. 4. **Substitution for recent occupational experience.** The applicant may substitute teaching experience at an American Physical Therapy Association accredited institution for 1,500 of the 2,000 hours required in part 3700.0400, subpart 2, if the teaching is done during the five-year period. The teaching must be in primary program content in physical therapy or physical therapy assistant. Two hours of teaching equal one hour of occupational experience.

3700.0420 PRACTICAL NURSING.

Subpart 1. **May teach.** A teacher who has a practical nursing instructor's license may teach the following: practical nursing, health unit coordinator, homemaker/home health aide, nursing assistant, passenger assistance, human services and medical assistant/nursing component, and may also teach the following courses:

- A. integrated sciences/anatomy and physiology;
- B. integrated sciences/medical terminology;
- C. administration of medicines;
- D. human behavior and communications in health care;
- E. ethical/legal aspects of health care;
- F. disease conditions;
- G. maternal/child health care; and
- H. geriatric health care.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. **Educational and occupational experience requirements.** The applicant must have current Minnesota nursing registration and the experience as described in item A, B, or C. The education must be from an accredited postsecondary institution. The occupational experience may be as a registered nurse or licensed practical nurse.

A. A bachelor's or higher degree in nursing and 4,000 hours of occupational experience as a public health nurse, home health care nurse, or a nurse doing direct patient care in a hospital, skilled or intermediate nursing care facility, or in a hospice. Fifteen hundred of the hours may be in an independent clinic or a physician's office.

B. An associate degree in nursing and 6,000 hours of occupational experience as a public health nurse, home health nurse, or a nurse doing direct patient care in a hospital, skilled or intermediate nursing care facility, or in a hospice. Fifteen hundred of the hours may be in an independent clinic or a physician's office.

C. Diploma from a three-year nursing program and 4,000 hours of occupational experience as a public health nurse, home health nurse, or a nurse doing direct patient care in a hospital, skilled or intermediate nursing care facility, or in a hospice. Fifteen hundred of the hours may be in an independent clinic or a physician's office.

Subp. 4. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution in nursing programs that prepare individuals for state licensure as a practical nurse or registered nurse for up to 1,500 of the 2,000 hours required in part 3700.0400. Two hours of teaching equal one hour of occupational experience.

3700.0425 PUBLIC SAFETY COMMUNICATION (911).

Subpart 1. May teach. A teacher who has a public safety communication (911) license may teach in the public safety communication (911) program and may also teach emergency communications.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of occupational experience as an operator dispatcher or supervisor in a public safety communications center with a minimum of 6,000 of the 8,000 hours doing the job of an operator dispatcher. Operator dispatcher includes level III operator dispatcher or communication training operator (CTO). Supervisor includes lead dispatcher, head dispatcher, communications manager, assistant supervisor, or shift supervisor.

Subp. 4. Substitution for occupational experience. An applicant may substitute the education described under item A, B, C, or D for up to 4,000 hours of occupational experience required under subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in law enforcement, criminal justice, corrections, emergency medical services, or fire protection may be substituted for 4,000 hours.

B. An associate degree in emergency medical service, fire protection, law enforcement, public safety communications, or a bachelor's degree or higher in public administration may be substituted for 2,000 hours.

C. A diploma in law enforcement, public safety, fire protection, or communication may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two- or three-year program equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in the use of public safety emergency telecommunications equipment may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for occupational recency. The applicant may substitute teaching experience at an accredited postsecondary institution, or at an industrial or military setting, or public safety agency for 1,500 of the 2,000 hours required in part 3700.0400, subpart 2, if the teaching is done during the five-year period. The teaching must be in public safety communication. Two hours of teaching equal one hour of occupational experience.

3700.0430 RADIOLOGIC TECHNOLOGY.

Subpart 1. May teach. A teacher who has a radiologic technology license may teach in the radiologic technology program.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. **Occupational and educational experience requirement.** The applicant must:

- A. have a two-year certificate, associate degree or above in radiologic technology;
- B. be credentialed in radiography by the American Registry of Radiologic Technologists; and
- C. have 6,000 hours of occupational experience as a certified radiographer in a medical setting.

Subp. 4. **Substitution for occupational recency.** The applicant may substitute teaching experience at a postsecondary institution in an accredited program of radiographic technology for 1,500 of the 2,000 hours required in part 3700.0400, subpart 2, if the teaching is done during the five-year period. The teaching must be in radiologic technology. Two hours of teaching equal one hour of occupational experience.

3700.0435 ATHLETIC TRAINING TECHNICIAN LICENSE.

Subpart 1. **May teach.** A teacher who has an athletic training technician license may teach in the athletic training technician program and may also teach courses in:

- A. biomechanics;
- B. exercise physiology;
- C. sports injuries recognition, care, and management;
- D. strength conditioning;
- E. sports equipment fit, care, and use;
- F. sports training, testing, and conditioning;
- G. legalities of sports; and
- H. sports rehabilitation techniques.

Subp. 2. **Other requirements.** An applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. **Educational and occupational experience requirements.** An applicant must have the experiences as described in items A, B, and C. The education must come from an accredited postsecondary institution.

- A. Bachelor's or higher degree with a science major in health, sports, or exercise.
- B. Athletic trainer certification obtained from the Athletic Trainers Association (N.A.T.A.).

C. 4,000 hours of occupational experience as an athletic trainer.

Subp. 4. **Substitution for recent occupational experience.** An applicant may substitute teaching experience at an accredited postsecondary institution in primary program content in athletic trainer, athletic medicine technology, or physical education for 1,500 of the 2,000 hours required under part 3700.0100, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0400, subpart 2.

3700.0440 DENTAL HYGIENE INSTRUCTOR.

Subpart 1. **May teach.** A teacher who has a dental hygiene instructor's license may teach in the dental hygiene program and may also teach courses or content which are specific to dental hygiene anywhere in the technical colleges.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. Educational and occupational experience requirement. The applicant must meet the following requirements:

A. be a graduate of a dental or dental hygiene program accredited by the American Dental Association (ADA) Commission on Dental Accreditation;

B. be licensed to practice as a dentist or dental hygienist by the Minnesota Board of Dentistry;

C. have a bachelor's degree or above with a major in a health science or health occupation discipline; and

D. have 4,000 hours of occupational experience as a licensed dentist or dental hygienist in clinical practice providing direct dental hygiene patient care. A minimum of 2,000 of the hours must be in adult care and include the recency requirement of subpart 2.

Subp. 4. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content in an accredited ADA dental hygiene program for up to 1,500 of the 2,000 hours required in part 3700.0400, provided that experience occurred within the last five years. Two hours of teaching equal one hour of occupational experience.

3700.0450 DIAGNOSTIC MEDICAL SONOGRAPHER.

Subpart 1. May teach. A teacher who has a diagnostic medical sonographer instructor license may teach in the diagnostic medical sonographer program and may also teach courses in:

- A. sonography;
- B. cross sectional anatomy;
- C. medical terminology; or
- D. medical ethics.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. Occupational experience requirement. The applicant must have the experiences as described in items A and B.

A. Registered as a sonographer by the American Registry of Diagnostic Medical Sonographers (A.R.D.M.S.) in abdominal and obstetrics/gynecology sonography.

B. 8,000 hours of A.R.D.M.S. registered occupational experience in diagnostic medical sonography with a minimum of 2,000 of the required hours in abdominal and obstetrics/gynecology sonography. This 2,000 hours must include the recency requirement of part 3700.0400, subpart 2.

Subp. 4. Substitution for occupational experience. The applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours of the occupational experience required in subpart 3. The educational experience may not substitute for the 2,000 hours of abdominal and obstetrics/gynecology sonography.

A. A bachelor's or higher degree with a major in sonography, radiography, or nuclear medicine may be substituted for 4,000 hours.

B. An associate degree or two-year or above certificate or diploma in sonography, radiography, nuclear medicine, an associate degree or above, or a three-year diploma in nursing may be substituted for 2,000 hours.

C. A one-year diploma or certificate in sonography, radiography, nuclear medicine, or nursing may be substituted for 1,000 hours.

D. Courses for credit or clock hours for credit in AMA or AMA Category I content approved by the Society of Diagnostic Medical Sonographers (SDMS), Canadian Society of Diagnostic Medical Sonography (CSDMS), American Institute of Ultrasound Medicine (AIUM), Society of Vascular Technology (SVT), or Accreditation Council for Continuing Medical Education (ACCME). One hour of instruction equals one hour of occupational ex-

perience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for occupational recency. The applicant may substitute teaching experience in a program accredited by the American Medical Association Committee on Allied Health Education and accreditation for 1,500 of the 2,000 hours required in part 3700.0100, subpart 2, if the teaching is done during the five-year period. The teaching must be in abdominal and obstetrics/gynecology diagnostic medical sonography. Two hours of teaching equal one hour of occupational experience.

Subpart 1. May teach. A teacher who has a medical records technology license may teach in the medical records technology program and may also teach courses in:

- A. alternative health records;

- D. introduction to health records;
- E. legal aspects of health records;
- F. data processing of health record information;
- G. health care statistics and records; and
- H. diagnostic related grouping.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. Occupational experience requirement. An applicant must have 8,000 hours of occupational experience in one or more of the following:

- A. medical records administrator; or
- B. medical records technician in an acute care setting.

Subp. 4. Substitution for occupational experience. An applicant may substitute the education described in items A and B for up to 4,000 hours of occupational experience described in subpart 3. The education must be from an accredited postsecondary institution. If the substitution is made, the applicant must still comply with the recency requirements in part 3700.0400, subpart 2.

A. A bachelor's or higher degree in medical record administration may be substituted for 4,000 hours.

B. An associate degree in medical record technology may be substituted for 2,000 hours.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience at an accredited postsecondary institution or an industrial or military setting in medical record technology for 1,500 hours of the 2,000 hours required in part 3700.0400, subpart 2. Two hours of teaching experience equals one hour of occupational experience.

3700.0465 DENTAL ASSISTING.

Subpart 1. May teach. A teacher who has a dental assisting instructor's license may teach in the dental assisting program and may also teach courses or content which are specific to dental assisting anywhere in the technical colleges.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400.

Subp. 3. Educational and occupational experience. The applicant must meet the requirements in items A to C.

A. The applicant must be a dental assistant certified by the Dental Assisting National Board Inc., and registered by the Minnesota Board of Dentistry, or be licensed to practice as a dentist in Minnesota.

B. The applicant must be a graduate of an accredited program by the American Dental Association's Commission on Dental Accreditation in dental assisting, dental hygiene, or dentistry.

C. The applicant must have verified occupational experience and education as described in subitem (1) or (2). The education must be from an accredited postsecondary institution.

(1) A baccalaureate or above degree in health science or health education and 4,000 hours of occupational experience providing direct patient care which must include a minimum of 2,000 hours of four-handed chairside assisting and 1,000 hours of legalized intraoral dental care.

(2) An associate degree in a health science or health education area or a certificate or diploma in dental assisting and 6,000 hours of occupational experience providing direct patient care and must include a minimum of 2,000 hours of four-handed chairside assisting and a minimum of 1,000 hours of legal intraoral dental care.

Subp. 4. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content in an accredited ADA dental hygiene or dental assistant program for up to 1,500 of the 2,000 hours required in part 3700.0400, provided that experience occurred within the last five years. Two hours of teaching equal one hour of occupational experience.

3700.0470 EMERGENCY MEDICAL TECHNICIAN INSTRUCTOR.

Subpart 1. **May teach.** A teacher who has an emergency medical technician instructor license may teach in the emergency medical technician program and may also teach courses specific to emergency medical technician.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the health occupational area under part 3700.0400 unless superseded by this part.

Subp. 3. **Professional and occupational experience requirement.** The applicant must meet the experiences as described in items A, B, and C:

A. certified by the American Heart Association as an instructor in C.P.R. (cardio-pulmonary resuscitation); and

B. verified registration/certification as described in subitem (1), (2), or (3):

(1) initial registration by the national Registry of Emergency Medical Technicians and current registration as an emergency medical technician by the Department of Health;

(2) current Minnesota nursing registration (R.N.); or

(3) current licensure in Minnesota as a physician; and

C. verified occupational experience providing emergency patient care with responsibility for recognition, assessment, and management of that care. This experience must be within five years of the date of application for licensure. This experience may be documented by 4,000 hours of paid experience or a minimum of 60 documented medical runs as a volunteer and verified by an appropriate administrator of that service.

MARKETING OCCUPATIONS

3700.0500 LICENSES IN MARKETING OCCUPATIONAL AREA.

Subpart 1. **Listed here.** An applicant for a license to teach technical college courses and programs in the marketing occupational area must meet the requirements in this part. The

requirements are in addition to the requirements in part 3700.0100 and for a particular license (listed under the part that covers that particular license).

Subp. 2. Recent occupational experience. An applicant for a license to teach in the marketing occupational area must have 2,000 hours of occupational experience within the five years just before applying for that license.

Subp. 3. Does not apply. Part 3515.9921 does not apply to parts 3700.0505 to 3700.0515.

3700.0510 BUSINESS TO BUSINESS TELEMARKETING.

Subpart 1. May teach. A teacher who has a business to business telemarketing license may teach in the business to business telemarketing program and may also teach courses in:

- C. selling techniques;
- D. market research; and
- E. telemarketing customer service.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of occupational experience.

A. At least 4,000 of the hours must be experience as a manager/supervisor staffing and training in business to business telemarketing. No substitution is allowed for these hours.

B. 4,000 hours may be in any of the following: telemarketing consultant, business or industrial telemarketing trainer, telemarketing salesperson, telephone customer service representative, direct marketing project manager that includes marketing information systems, or business to business field sales.

Subp. 4. Substitution for occupational experience. The applicant may substitute the education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3, item B. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in business management, business administration, communications, marketing, or advertising may be substituted for 4,000 hours.

B. An associate degree in business administration, business management, marketing, or advertising may be substituted for 1,000 hours. An associate degree in business to business telemarketing may be substituted for 2,000 hours.

C. A diploma in business to business telemarketing may be substituted. A one-year program or a program of 45 or more credits equals 1,050 hours. A two-year program or a program of 90 or more credits equals 2,100 hours. A two-year program in marketing, management, supervision, advertising, or sales equals 1,050 hours.

D. The completion of courses for credit or clock hours in telemarketing content. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience at an accredited postsecondary institution, industrial or business setting in primary content of business to business telemarketing for 1,500 of the 2,000 hours required under part 3700.0500. Two hours of teaching equal one hour of the occupational experience.

3700.0515 COMPUTERIZING SMALL BUSINESS.

Subpart 1. **May teach.** A teacher who has a computerizing small business license may teach in the computerizing small business program and may also teach courses in:

- A. integration of computer hardware and software to business;
- B. introduction to personal computers; and
- C. principles or business management.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience with a minimum of 6,000 hours as a working proprietor or managerial level employee responsible for, and making decisions based on, sources and use of capital. The remaining 2,000 hours must be in one or both of the following:

- A. using a microcomputer system with multiapplication software for use in managing daily operations of a small business; or
- B. selling a combination of microcomputer hardware systems and software packages for use in managing the daily operations of a small business.

The 8,000 hours must include verification of experience in developing a combination of microcomputer hardware and software processes for computerizing small businesses. Computerizing a small business means to do a feasibility study that includes analyzing, prioritizing, researching availability, evaluating, and reviewing computer needs.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described under item A, B, C, or D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution. Notwithstanding this substitution, the applicant must not substitute for the experience developing a combination of microcomputer hardware and software processes for computerizing small business or the 2,000 hours of specialized experience as stated in subpart 3.

A. A bachelor's or higher degree with a major in business administration, business management, or accounting may be substituted for 4,000 hours.

B. An associate degree in accounting, business management, business entrepreneurship, or microcomputer sales and service may be substituted for 2,000 hours.

C. A diploma in business entrepreneurship, small business management, preparation for small business ownership, accounting, or computerizing small business may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in computer systems design, accounting, business management, and business computer applications may be substituted. One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or at an industrial setting for 1,500 of the 2,000 hours required in part 3700.0500, subpart 2, if the teaching is done during this five-year period. The teaching must be in computerizing small business, small business management, or preparation for small business ownership. Two hours of teaching equal one hour of occupational experience.

3700.0520 CUSTOMER SERVICE.

Subpart 1. **May teach.** A teacher who has a customer service license may teach in the customer service program and may also teach customer specific courses such as:

- A. consumer behavior;
- B. consumer credit and collections;
- C. introduction to customer service technology;

- D. consumer problem solving;
- E. customer service conflict and management; and
- F. customer service telemarketing.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience with a minimum of 4,000 hours at the management/supervisory level doing the hiring, training, and development of individuals for customer contact involving problem solving and proactive activities. The remaining experience may be in any of the following activities:

- A. budgeting and long-range planning for customer service;
- B. customer advocate liaison within a company;
- C. assessing, measuring, and defining customer expectation for future applications; and
- D. development and implementation of procedural processes and subsequent applications for customer service.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute education in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution. The education may not substitute for the 4,000 hours of management/supervisory level occupational experience.

A. A bachelor's or higher degree with a major in business, management, or marketing may be substituted for 4,000 hours.

B. An associate degree in business, customer service, management, marketing, or supervision may be substituted for 2,000 hours.

C. A diploma or certificate in business, customer service, management, marketing, or supervision may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in customer service specific content. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or industrial setting for 1,500 of the 2,000 hours required under part 3700.0500, subpart 2. The experience must be in customer service. Two hours of teaching equal one hour of the occupational experience required in part 3700.0500, subpart 2.

A. a minimum of 2,000 hours in commercial or industrial sales, installation, and maintenance or troubleshooting equipment; and

B. a minimum of 2,000 hours in customer needs analysis including equipment determination and selection, hardware configuration, product presentation, and demonstration or account management.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described in item A, B, or C for up to 4,000 hours of occupational experience required under subpart 3. The education must be from an accredited postsecondary institution. An applicant cannot substitute for the 2,000 hours of experience required in subpart 3, item A.

A. A bachelor's or higher degree with a major in applied electrical engineering may be substituted for 4,000 hours.

B. An associate degree in electronics or electronic service/sales may be substituted for 2,000 hours.

C. A diploma in electronics or electronic service/sales may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or at an industrial setting for 1,500 of the 2,000 hours required under part 3700.0500, subpart 2, if the teaching is done during the five-year period. The teaching must be in electronics or electronic service/sales. Two hours of teaching equal one hour of occupational experience. An applicant cannot substitute for the 2,000 hours of experience required under subpart 3, item A.

3700.0530 FASHION MANAGEMENT.

- C. human resource management;
- D. interpersonal relations;
- E. professional self-development; and
- F. the following courses in any technical college area:
 - (1) applied sales strategies;
 - (2) inventory planning and control;
 - (3) marketing research fundamentals;
 - (4) principles of management;
 - (5) retail buying;
 - (6) retail principles;
 - (7) retail trends;
 - (8) sales promotion/advertising;
 - (9) store layout and presentations;
 - (10) store operations;
 - (11) supervision fundamentals;
 - (12) telemarketing fundamentals; and
 - (13) visual merchandising.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience. Six thousand hours must be in all of the following:

- A. product and/or customer service presentation;
- B. supervision/management of human resources, and store or business operations;
- C. promotion or advertising with intent to sell the product or service; and

D. business operations planning, forecasting, and analysis.

B. An associate degree in management, marketing, merchandising, sales, or telemarketing may be substituted for 2,000 hours.

C. A diploma or certificate in management, marketing, merchandising, sales, or telemarketing may be substituted. A one-year program or a program of 45 quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in management, marketing, merchandising, sales, or telemarketing. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or industrial setting for 1,500 of the 2,000 hours required under part 3700.0500, subpart 2. The experience must be in fashion apparel and accessory sales and management. Two hours of teaching equal one hour of the occupational experience required in part 3700.0500, subpart 2.

3700.0535 POSTAL SERVICE MANAGEMENT.

Subpart 1. May teach. An instructor with a postal service management license may teach postal service specific content in the postal service management program and may also teach postal specific courses throughout the technical college system.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. Occupational experience requirement. The applicant must have occupational experience in a classified United States Postal Service position as described in item A, B, or C.

A. 3,000 hours as a bargaining unit employee and 5,000 hours in an initial level supervisor position or above. The recency experience described in part 3700.0500, subpart 2, must be as an initial level supervisor or above.

B. 3,000 hours as a bargaining unit employee and 5,000 hours as a postal service training technician with sole training responsibility in an office of 200 or more employees. The recency experience described in part 3700.0500, subpart 2, must be as a postal service training technician with sole training responsibility in an office of 200 or more employees.

C. An associate degree in postal service management with 3,000 hours as a bargaining unit employee and 3,000 hours as an initial level supervisor or above. The recency experience described in part 3700.0500, subpart 2, must be as an initial level supervisor or above.

D. An associate degree in postal service management with 3,000 hours as a bargaining unit employee and 3,000 hours as a postal service training technician with sole responsibility in an office of 200 or more employees. The recency experience described in part 3700.0500, subpart 2, must be as a postal service training technician.

Subp. 4. **Substitution for recent occupational experience.** An applicant currently employed by the United States Postal Service may substitute teaching experience in postal service content in a postal service management program at an accredited postsecondary institution for 1,500 of the 2,000 hours required under part 3700.0500, subpart 2. Two hours of teaching equal one hour of the occupational experience required in part 3700.0500, subpart 2.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience as a working proprietor or managerial level employee responsible for, and making decisions based on, sources and use of capital.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours required under subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in marketing, business, or finance may be substituted for 4,000 hours.

B. An associate degree in business or marketing may be substituted for 2,000 hours.

C. A diploma in business or marketing may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses or clock hours for credit in business or marketing may be substituted.

One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or industrial setting in accounting, business management, computer applications for small business management, and sales and marketing, for 1,500 of the 2,000 hours required under part 3700.0500, subpart 2, if the teaching is done during the five-year period. Two hours of teaching equal one hour of occupational experience.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience as a manager, facilitator, or trainer in two or more of the following:

The completion of courses for credit or clock hours for credit or seminars and workshops by professional organizations in transformation of American industry, manufacturing process, production and inventory management techniques, engineering drawings, quality assurance product development, work simplifications, organizational structure of business, material requirements planning, industrial master planning, capacity management, production activity management, inventory management, employee involvement, statistical process, problem solving, or socio-economic systems may be substituted. One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution, industrial or military setting for 1,500 of the 2,000 hours required in part 3700.0100, subpart 2, if the teaching is done during this five-year period. The teaching must be in production and inventory management, productivity technician, supervisory management, statistical process control, quality assurance or quality control systems, participation management/employee involvement process, problem solving/decision making techniques, just in time techniques, or production/inventory control. Two hours of teaching equal one hour of occupational experience.

- E. professional self development; and
- F. the following courses in any technical college area:
 - (1) applied sales strategies;
 - (2) inventory planning and control;
 - (3) marketing research fundamentals;
 - (4) principles of management;
 - (5) retail buying;
 - (6) retail principles;
 - (7) retail trends;
 - (8) sales promotion and advertising;
 - (9) store layout and presentations;
 - (10) store operations;
 - (11) supervision fundamentals;
 - (12) telemarketing fundamentals; and
 - (13) visual merchandising.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

A. A bachelor's or higher degree with a major in marketing, business administration, business management, merchandising, retailing, or distributive education may be substituted for 4,000 hours.

B. An associate degree in marketing, management, merchandising, telemarketing, or sales may be substituted for 2,000 hours.

C. A diploma or certificate in sales, marketing, merchandising, management, or telemarketing may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in sales, marketing, merchandising, management, or telemarketing. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or industrial setting for 1,500 of the 2,000 hours required under part 3700.0500, subpart

2. This teaching experience must be in retail sales and management. Two hours of teaching equal one hour of the occupational experience required in part 3700.0500, subpart 2.

- E. professional self-development; and
- F. the following courses in any technical college area:
 - (1) applied sales strategies;
 - (2) marketing research fundamentals;
 - (3) negotiation sales;
 - (4) principles of management;
 - (5) sales management;
 - (6) sales promotion and advertising;
 - (7) sales record management;
 - (8) supervision fundamentals;
 - (9) telemarketing fundamentals;
 - (10) territory management;
 - (11) visual merchandising; and
 - (12) wholesale buying and selling techniques.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience. Six thousand hours must be in all of the following:

- A. product and/or customer service presentation;
- B. supervision/management of human resources, and store or business operations;
- C. promotion or advertising with intent to sell the product or service; and
- D. business operations planning, forecasting, and analysis.

The remaining 2,000 hours must include the recency requirement in part 3700.0500, subpart 2, and be in a nonretail store environment, industrial or institutional setting in multi-level marketing or telemarketing sales. The activities must include three of the following: individual or group sales, territory management, trade show presentation, bid and proposal writing, sales contract negotiations, account management, and sales and personal records management. C. A diploma or certificate in management, marketing, merchandising, sales, or telemarketing may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in management, marketing, merchandising, sales, or telemarketing. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or industrial setting for 1,500 of the 2,000 hours required under part 3700.0500, subpart 2. The experience must be in sales representation, sales management, or wholesale and industrial sales. Two hours of teaching equal one hour of the occupational experience required in part 3700.0500, subpart 2.

- N. supervising for results;
- O. job coaching; and
- P. negotiations.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the marketing area under part 3700.0500.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience in a managerial level position including but not limited to budget development or control, employee selection and supervision, employee performance appraisal and evaluation, and assessment of employee training needs.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described under item A, B, C, or D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in business, marketing, or management may be substituted for 4,000 hours.

B. An associate degree in business, management, or marketing may be substituted for 2,000 hours.

C. A diploma in supervision or management programs. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in business administration, business management, finance, human resource management, accounting, training and development, supervisory management, manufacturing management, and productivity and management. One clock hour of instruction equals one hour of occupational experience.

One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content at an accredited postsecondary institution or at an industrial setting may be substituted for 1,500 of the 2,000 hours required in part 3700.0500, subpart 2, if the teaching is done during this five-year period. The teaching must be in management programs or courses that include supervision or management content. Two hours of teaching equal one hour of occupational experience.

The experience must include responsibility for making decisions on the source and use of capital. Responsibilities must have included the financial, marketing, and human resource management of the business.

Subp. 4. Substitution for occupational experience. The applicant may substitute the education described in items A to D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's degree or above with a major in business, marketing, or finance may be substituted for 4,000 hours.

B. An associate degree in business, marketing, or finance may be substituted for 2,000 hours.

C. A diploma or certificate in management, marketing, business, or finance may be substituted. A one-year program or a program of 45 or more quarter credits equals 1,050 hours. A two-year program or a program of 90 or more quarter credits equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in marketing, management, business, merchandising, or sales may be substituted. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary small business content at an accredited postsecondary or business or industrial setting for 1,500 of the 2,000 hours required under part 3700.0500, subpart 2. Two hours of teaching equal one hour of the recent occupational experience required in part 3700.0500, subpart 2.

Subp. 6. Special requirement. In addition to meeting renewal requirements described in subpart 2, an applicant must have completed or signed a preagreement to complete the small business management workshop in the first year of teaching.

The remaining 2,000 hours may be as any of the following: human services technician for the mentally retarded, activity director/assistant, social worker, community center program director for seniors, or as a counselor in adult day care, long-term care, or senior citizen housing.

Subp. 4. **Occupational recency substitution.** Teaching experience at an accredited postsecondary institution or at an industrial setting may be substituted for 1,500 of the 2,000 hours required in part 3709.0100, subpart 1, item A, if the teaching is done during this five-year period. The teaching must be in activity director, activity director assistant, or recreational therapy programs. Two hours of teaching equals one hour of occupational experience.

3700.0620 FRANCHISE RESTAURANT MANAGEMENT.

- B. food sanitation and safety;
- C. food service management skills; and
- D. food service accounting.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3709.0100.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours verified occupational experience in management that includes supervision in an operation with at least ten employees. A minimum of 4,000 hours must be in franchise restaurant management of which 2,000 hours must be as a general or unit manager or owner.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described in item A, B, or C for up to 4,000 hours of the occupational experience required in subpart 3. The applicant cannot substitute for the 4,000 hours of experience in franchise restaurant management. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in business or home economics may be substituted for 4,000 hours.

B. An associate degree in business or food service may be substituted for 2,000 hours.

C. A diploma in a business or food service program may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

Subp. 5. **Occupational recency substitution.** Teaching experience at an accredited postsecondary institution or at an industrial or military setting may be substituted for 1,500 of the 2,000 hours required under part 3709.0100, subpart 1, item A, if the teaching is done dur-

ing the five-year period. The teaching must be in foods, diet technician, or small business management. Two hours of teaching equal one hour of occupational experience.

A. two years or more of education from an accredited postsecondary institution in professional nanny or child development and 6,000 hours of occupational experience as a nanny or child care provider within the client's environment having responsibility for educational, physical, social, and psychological development of the child or children; or

B. a bachelor's or higher degree in consumer homemaking, family life, elementary education, child psychology, early childhood education, home economics, child development or professional nanny and 4,000 hours as a nanny or child care provider within the client's environment having responsibility for educational, physical, social, and psychological development of the child or children.

Subp. 4. **Occupational recency substitution.** Teaching experience at an accredited postsecondary institution for 1,500 of the 2,000 hours required under part 3709.0100, subpart 1, item A, if the teaching is done during this five-year period. The teaching must be in professional nanny programs. Two hours of teaching equal one hour of the occupational experience required in part 3709.0100, subpart 1, item A.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the technical area under part 3700.0700.

Subp. 3. **Educational and occupational experience requirement.** An applicant must have a combination of:

A. two years or more of postsecondary education from an accredited institution in engineering, computer science, electronics, chemistry, physics, or mathematics; and

B. 6,000 hours of verified occupational experience in engineering, programming, or electronics technology with a minimum of 500 hours programming artificial intelligence.

Subp. 4. **Occupational recency substitution.** Teaching experience at an accredited postsecondary institution or at an industrial setting may be substituted for 1,500 of the 2,000 hours required in part 3700.0700, subpart 2, if the teaching is done during the five-year period. The only substitution allowed for the 500 hours of programming artificial intelligence required under subpart 3, item B, is teaching programming artificial intelligence. Otherwise, the teaching of any programming may be substituted. Two hours of teaching equal one hour of occupational experience.

D. sound tracks for slide productions.

Subp. 2. **Other requirements.** The applicants must meet the requirements listed in part 3700.0100 and the requirement for a teacher in the technical area under part 3700.0700.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience as a primary audio engineer in multitrack recording of music and audio for television film and audio-visual and must have experience in three of the areas listed in this subpart:

A. audio time code lock;

B. musical instrument digital interface (MIDI);

C. audio location recording;

D. troubleshooting audio equipment; and

E. audio recording project planning and management.

Subp. 5. **Substitution for recent occupational experience.** Teaching experience in primary program content at an accredited postsecondary institution or industrial setting may be substituted for 1,500 of the 2,000 hours required in part 3700.0700, subpart 2, if the teaching is done during the five-year period. The teaching must be in audio recording. Two hours of teaching equal one hour of occupational experience.

- C. industrial electronics (nonconsumer);
- D. AC/DC motor controls;

- G. servo robots;
- H. manufacturing cells;
- I. computerized integrated manufacturing (CIM); and
- J. automated packaging technology.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the technical occupational area under part 3700.0700.

Subp. 3. **Educational and occupational experience requirement.** The applicant must have the educational and occupational experience as described in item A, B, or C. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in computer science, industrial technology, or the following fields of engineering: robotics, industrial process control, mechanical, electrical, computer, packaging, or motion control and 4,000 hours of occupational experience in automated manufacturing process application and industrial controls. This experience must be in at least two of the following areas: production planning, systems interfacing, manufacturing methods, programming systems, or system troubleshooting and repair of system, and system configuration and product process.

B. An associate degree in robotics, manufacturing technology, electronics, automated systems, automated manufacturing, automated machinery, automated packaging, instrumentation technology, or computer technology and 6,000 hours of occupational experience in automated manufacturing process application and industrial controls. A minimum of 4,000 hours in this area must be in at least two of the following: planning, systems interfacing, manufacturing methods, programming systems, or troubleshooting and repair of system and system configuration and product process. The 4,000 hours must include the 2,000 hours required in part 3700.0700, subpart 2. The remaining experience may be in any of the following: robotics/flexible automation application, flexible automation programming, quality control in a production environment, computer aided drafting (CAD), packaging technology, vision systems, mechanical power transmission, fluid power mechanics, computerized numerical controls (CNC), electronics technician, and electrician with voltage application in excess of 220 volts.

C. A two-year diploma program or a program of 90 or more quarter credits in artificial intelligence, automated equipment, automated packaging, automated systems, electronics, fluid power, instrumentation technology, or computer technology and 6,000 hours of occupational experience in automated manufacturing process application and industrial controls. A minimum of 4,000 of the hours in this area must be in at least two of the following: planning, systems interfacing, manufacturing methods, programming systems, or troubleshooting and repair of system and system configuration and product process. The 4,000 hours must include the 2,000 hours required in part 3700.0700, subpart 2. The remaining experience may be in any of the following areas: robotics/flexible automation application, flexible automation programming, quality control in a production environment, computer aided drafting (CAD), packaging technology, vision systems, mechanical power transmission, fluid power mechanics, computerized numerical controls (CNC), electronics technician, and electrician with voltage application in excess of 220 volts.

Subp. 4. **Substitution for recent occupational experience.** Teaching experience at an accredited postsecondary institution, industrial, or business setting in primary program content in automated systems technology may be substituted for 1,500 of the 2,000 hours required in part 3709.0700, subpart 2. Two hours of teaching equal one hour of occupational experience.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the technical area under part 3700.0700.

Subp. 3. **Educational and occupational experience requirement.** The applicant must have the educational and occupational experience described in item A, B, or C. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in electrical engineering or industrial technology and 4,000 hours of occupational experience designing printed circuit boards, which must include computer aided drafting (CAD).

B. An associate degree in industrial technology, electrical or electronic drafting, mechanical drafting, electro-mechanical technology, computer aided design, or electronics technology and 6,000 hours of occupational experience designing printed circuit boards, which must include computer aided drafting (CAD).

C. A diploma or certificate in a two-year program or a program of 90 or more quarter credits in electrical or electronic drafting, mechanical drafting, electro-mechanical technology, industrial engineering technology, printed circuit design technology, or electronics technology and 6,000 hours of occupational experience designing printed circuit boards, which must include computer aided drafting (CAD).

An associate degree in environmental technology, food science laboratory testing and management, chemical laboratory testing and management, water/waste treatment, or water and air analysis and 6,000 hours of occupational experience with a minimum of 2,000 hours in laboratory analysis in an energy research center, industrial environmental laboratory, chemical quality control laboratory, or in operational testing, sampling, and monitoring in effluent discharge and must include the 2,000 hours required in part 3700.0700, subpart 2. These experiences must be in a laboratory using Environmental Protection Agency standards. The remaining hours may be in evaluation and required process control outcome in a treatment center plant or on site sampling and analysis of stack emissions, ambient air, and noise pollution.

C. A two-year diploma or a program of 90 or more quarter credits in environmental technology, food science laboratory testing and management, chemical laboratory testing and management, water/waste treatment or water and air analysis and 6,000 hours of occupational experience with a minimum of 2,000 hours in laboratory analysis in an energy research center, industrial environmental laboratory, chemical quality control laboratory, or operational testing, sampling, and monitoring in effluent discharge and must include the 2,000 hours required in part 3700.0700, subpart 2. These experiences must be in a laboratory using Environmental Protection Agency standards. The remaining hours may be in evaluation and required process control outcome in a treatment center plant or on site sampling and analysis of stack emissions, ambient air, and noise pollution.

Subp. 4. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content, at an accredited postsecondary institution, industrial, or military setting in environmental laboratory analysis according to Environmental Protection Agency standards for 1,500 of the 2,000 hours required under part 3700.0700, subpart 2. Two hours of teaching equal one hour of the occupational experience.

The 4,000 hours must include the 2,000 hours required in part 3700.0700, subpart 2.

B. An associate degree in laser technology or electronics technology and 6,000 hours of occupational experience with a minimum of 4,000 hours in maintenance, testing, and operation of industrial laser systems, laboratory laser systems, or medical laser systems. The 4,000 hours must include the 2,000 hours required in part 3700.0700, subpart 2. The remaining hours may be in installation maintenance or testing of electronic equipment.

C. A diploma in laser electro optics technology or electronics technology. A two-year program or a program of 90 or more quarter credits and 6,000 hours of occupational experience with a minimum of 4,000 hours in maintenance, testing, and operation of industrial laser systems, laboratory laser systems, or medical laser systems. The 4,000 hours must include the 2,000 hours required in part 3700.0700, subpart 2. The remaining hours may be in installation, testing, or maintenance of electronic equipment.

Subp. 4. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content, at an accredited postsecondary institution, industrial, or military setting in laser electro optics technology for 1,500 of the 2,000 hours required under part 3700.0700, subpart 2. Two hours of teaching equal one hour of the occupational experience required.

A. A bachelor's or higher degree with a major in engineering, metallurgy, industrial technology, chemistry, or physics and 4,000 hours of occupational experience with a minimum of 2,000 hours in metallography, failure analysis of materials, and physical or mechanical testing of materials. The remaining hours may be in chemical analysis of metals, nondestructive testing, or quality control of metal manufacturing.

B. An associate degree in engineering, metallurgical technology, nondestructive testing, powder metal technology, or industrial laboratory technology and 6,000 hours of occupational experience with a minimum of 2,000 in metallography, failure analysis of material, and physical or mechanical testing of materials. The remaining hours may be in chemical analysis of metals, nondestructive testing, or quality control of metal manufacturing.

C. A two-year program or a program of 90 or more quarter credits in metallurgical technology, nondestructive testing, powder metal technology, or industrial laboratory technology and 6,000 hours of occupational experience with a minimum of 2,000 hours in metallography, failure analysis of materials, and physical or mechanical testing of materials. The remaining hours may be in chemical analysis of metals, nondestructive testing, or quality control of metal manufacturing.

Subp. 4. **Substitution for recent occupational experience.** The applicant may substitute teaching experience in primary program content, at an accredited postsecondary institution, industrial, or military setting in metallurgical technology or nondestructive testing for

A. A bachelor's or higher degree with a major in mathematics, industrial technology, physics, or engineering and 4,000 hours of occupational experience testing, calibrating, troubleshooting, and repairing precision measurement equipment.

B. An associate degree in engineering, instrumentation technology, metrology, electronics technician, or applied physics and 6,000 hours of occupational experience testing, calibrating, troubleshooting, and repairing precision measurement equipment.

C. A two-year program or a program of 90 or more quarter credits in metrology, instrumentation technology, or electronic technology and 6,000 hours of occupational experience testing, calibrating, troubleshooting, and repairing precision measurement equipment.

Subp. 4. Substitution for recent occupational experience. The applicant may substitute teaching experience in primary program content, at an accredited postsecondary institution, industrial, or military setting in metrology technology for 1,500 of the 2,000 hours required under part 3700.0700, subpart 2. Two hours of teaching equal one hour of the occupational experience.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the technical area under part 3700.0700.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of verified occupational experience in two or more of the following:

- A. installation and maintenance of electronic private branch exchange (PBX);
- B. underground and aerial construction of telecommunications equipment;
- C. cable or optic fiber splicing;
- D. central office telecommunications installation and maintenance;
- E. repair of carrier systems including "T" carrier, microwave, satellite, or optic fi-

ber;

F. cellular communications installation and maintenance;

G. data communications including installation and maintenance of network systems, interfacing and protocol of service, and maintenance of data terminals; and

H. installation and maintenance of interactive television systems.

Subp. 4. Substitution for occupational experience. An applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours of occupational experience required under subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in electrical engineering, computer science, or telecommunications may be substituted for 4,000 hours.

B. A bachelor's degree in industrial technology, engineering (other than electrical), or an associate degree in electronics or telecommunications may be substituted for 2,000 hours.

C. A diploma in electronics or telecommunications may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in telecommunications hardware or systems may be substituted. One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Occupational recency substitution. Teaching experience at an accredited postsecondary institution, or at an industrial or military setting may be substituted for 1,500 of the 2,000 hours required in part 3700.0700, subpart 2, if the teaching is done during the five-year period. The teaching must be in telecommunications. Two hours of teaching equal one hour of occupational experience.

Subp. 4. Substitution for occupational experience. An applicant may substitute the experience described in item A, B, or C for up to 4,000 hours of the occupational experience described in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in engineering or applied physics may be substituted for 4,000 hours.

B. An associate degree in vibroacoustics technology may be substituted for 2,000 hours.

C. A diploma or certificate in vibroacoustics technology may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

Subp. 5. Occupational recency substitution. Teaching experience at an accredited postsecondary institution or at an industrial or military setting may be substituted for 1,500 of the 2,000 hours required in part 3700.0700, subpart 2, if the teaching is done during the five-year period. The teaching must be in vibroacoustics specific technology. Two hours of teaching equal one hour of occupational experience.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the technical occupational area under part 3700.0700.

Subp. 3. **Educational and occupational experience requirement.** The applicant must have the educational and occupational experience described in items A and B:

A. a minimum of two years of education in electronics technology from an accredited postsecondary institution resulting in a diploma, certificate, or degree; and

B. 6,000 hours of occupational experience in installation, maintenance, troubleshooting, and repair of electronic circuitry in any of the following areas:

- (1) computer systems;
- (2) industrial electronics;
- (3) manufacturing electronics;
- (4) electronic communications;
- (5) biomedical electronics; or
- (6) consumer electronics.

Subp. 4. **Substitution for recent occupational experience.** Teaching experience at an accredited postsecondary institution, industrial, business, or military setting in primary program content in electronics technology may be substituted for 1,500 of the 2,000 hours required under part 3700.0700, subpart 2. Two hours of teaching equal one hour of occupational experience for purposes of part 3700.0700, subpart 2.

3700.0768 GEOGRAPHIC INFORMATION SYSTEMS/AUTOMATED CARTOGRAPHY.

Subpart 1. **May teach.** A teacher who has a geographic information system instructor's license may teach in the geographic information system program and may also teach courses in geographic information systems.

Subp. 2. **Other requirements.** The applicant must meet the requirements listed in part 3700.0100 and the requirements in the technical area under part 3700.0700.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of occupational experience with a minimum of 1,000 hours in computer aided drafting and design (C.A.D.D.) or in analyzing data models and manipulation of data using geographic information systems. Substitution for the 1,000 hours of C.A.D.D. or analyzing data using geographic information systems is not allowed. The remaining experience must include experience in at least one other skill described in items A to E:

- A. use of coordinates to determine map scale and location;
- B. photo interpretation (photogrammetry);
- C. land surveying;
- D. use of global positioning system for data input and evaluation; or
- E. management of information systems.

The 2,000 hours of occupational recency must include 1,000 hours of computer aided drafting and design or geographic information systems for data input and evaluation.

Subp. 4. **Substitution for occupational experience.** The applicant may substitute the education described under item A, B, or C for up to 4,000 hours of occupational experience required in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree with a major in civil engineering, environmental engineering or environmental science, geography, land surveying, landscape architecture, or computer science may be substituted for 4,000 hours.

B. An associate degree or two-year diploma or certificate in geographic information systems, civil engineering, drafting, environmental analysis, surveying, computer science, or technology may be substituted for 2,000 hours. A one-year program may be substituted for 1,000 hours.

C. The completion of courses for credit or clock hours in computer sciences, drafting, map making, photogrammetry, legal land descriptions, or geographic information systems. One clock hour equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** An applicant may substitute teaching experience in geographic information systems primary program content for 1,000 hours of the required recent occupational experience. The 1,000 hours of computer aided drafting and design or analyzing data models and manipulation of data using geographic information systems may not be substituted. The applicant must also still have additional experience in at least one of the items in subpart 3, items A to E. Two hours of teaching equals one hour of occupational experience.

3700.0770 SURFACE FINISHING AND PLATING TECHNICIAN LICENSE.

Subpart 1. **May teach.** A teacher who has a surface finishing and plating technician license may teach in the surface finishing and plating technician program and may also teach courses in surface finishing and plating anywhere in the technical college system.

Subp. 2. **Other requirements.** An applicant must meet the requirements listed in part 3700.0100 and the requirements for a teacher in the technical area under part 3700.0700.

Subp. 3. **Occupational and educational experience requirements.** An applicant must have the educational and occupational experience as described in item A, B, or C. The education must be from an accredited postsecondary institution.

A. Bachelor's or higher degree with a major in chemistry, chemical engineering, electrochemistry, material science, or metallurgy; occupational experience of 4,000 hours in surface finishing and electroplating, including bath make-up and maintenance including wet analysis, surface finishing and plating processes and equipment, physical testing for quality control of product and process, and waste management for plating; and certification by the American Electroplating and Surface Finishing Society.

B. Two years of postsecondary education with a degree, diploma, or certificate in surface finishing and electroplating including 15 quarter credits in chemistry; occupational experience of 6,000 hours in surface finishing and electroplating, including bath make-up and maintenance including wet analysis, surface finishing and plating processes and equipment, physical testing for quality control of product and process, and waste management for plating; and certification by the American Electroplating and Surface Finishing Society.

C. One year of postsecondary education including 15 quarter credits of chemistry; occupational experience of 7,000 hours in surface finishing and electroplating, including bath make-up and maintenance including wet analysis, surface finishing and plating processes and equipment, physical testing for quality control of product and process, and waste management for plating; and certification by the American Electroplating and Surface Finishing Society.

Subp. 4. **Occupational recency substitution.** Teaching experience at an accredited postsecondary institution, industrial, or military setting may be substituted for 1,500 of the 2,000 hours required in part 3700.0700, subpart 2, if the teaching is in primary program content in surface finishing and electroplating technology. Two hours of teaching equal one hour of occupational experience.

3700.0800 LICENSES IN TRADE AND INDUSTRIAL AREA.

Subpart 1. **Listed here.** An applicant for a license to teach technical college courses and programs in the trade and industrial occupational area must meet the requirements in this

part. The requirements are in addition to the requirements in part 3700.0100 and for a particular license listed under the part that covers that particular license.

Subp. 2. Recent occupational experience. An applicant for a license to teach in the trade and industrial occupational area must have 2,000 hours of occupational experience within the five years just before applying for that license.

Subp. 3. Does not apply. Part 3515.9921 does not apply to licenses issued under this part.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the trade and industrial area under part 3700.0800.

Subp. 3. Occupational experience requirement. The applicant must have 8,000 hours of verified occupational experience in both:

- A. diesel engine operation, repair, and maintenance; and
- B. diesel fuel injection system operation, repair, and maintenance.

Subp. 4. Substitution for occupational experience. An applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours of occupational experience required under subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in automotive engineering may be substituted for 4,000 hours.

B. An associate degree in diesel technology, truck and diesel mechanics, agricultural equipment mechanics, heavy equipment mechanics, or diesel fuel injection may be substituted for 2,000 hours.

C. A diploma in diesel fuel injection, truck and diesel mechanics, agricultural equipment mechanics, or heavy equipment mechanics may be substituted. A two-year program equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in diesel fuel injection may be substituted. One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. The applicant may substitute teaching experience at an accredited postsecondary institution, or at an industrial or military setting for 1,500 of the 2,000 hours required in part 3700.0800, if the teaching is done during the five-year period. The teaching must be in diesel fuel injections. Two hours of teaching equal one hour of occupational experience.

3700.0810 ELECTRONIC PUBLISHING/INFORMATION SPECIALIST.

Subpart 1. May teach. A teacher who has an electronic publishing/information specialist license may teach in the electronic publishing/information specialist program and may also teach courses in:

- A. introduction to typography and publishing;
- B. desktop publishing;
- C. page makeup techniques; and
- D. corporate electronic publishing.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the trade and industrial area under part 3700.0800.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of verified occupational experience in all of the following:

- A. layout and design;
- B. typography and electronic prepress; and
- C. electronic desktop publishing that integrates text and graphics.

Subp. 4. **Occupational experience substitution.** The applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours of occupational experience required in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in graphic arts, commercial art, advertising art, or data processing may be substituted for 4,000 hours.

B. An associate degree in graphic arts, commercial art, or data processing may be substituted for 2,000 hours.

C. A diploma in electronic publishing/information specialist, computer typesetting, graphic arts, commercial art, or data processing may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

D. The completion of courses for credit or clock hours for credit in computer typesetting, graphic arts, keylining, commercial art, desktop publishing, color separation, advertising art, printing, or data processing may be substituted. One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience at an accredited postsecondary institution, or at an industrial or military setting for 1,500 of the 2,000 hours required in part 3700.0800, if the teaching is done during the five-year period. The teaching must be in typography, layout and design, electronic prepress, or desktop publishing that integrates text and design. Two hours of teaching equal one hour of occupational experience.

3700.0815 FIRE TECHNOLOGY AND ADMINISTRATION.

Subpart 1. **May teach.** A teacher who has a fire technology and administration license may teach in the fire technology and administration program and courses in firefighting.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the trade and industrial area under part 3700.0800.

Subp. 3. **Occupational experience requirement.** An applicant must have 8,000 hours of verified occupational experience as a career firefighter, volunteer firefighter, or paid on-call firefighter with a minimum of 2,000 of the 8,000 hours as a fire officer. The experience must be verified by the chief fire executive.

Subp. 4. **Substitution for occupational experience.** An applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours of occupational experience as a firefighter required in subpart 3. The education must be from an accredited postsecondary institution. An applicant cannot substitute for the 2,000 hours of experience required as a fire officer.

A. a bachelor's or higher degree in fire science, fire protection engineering, fire administration, or fire department management may be substituted for 4,000 hours.

B. An associate degree in firefighting may be substituted for 2,000 hours.

C. A two-year diploma in firefighting may be substituted for 2,100 hours.

D. Completion of courses or clock hours for credit in fire service, fire administration, fire department management, fire safety and engineering technology, fire protection engineering, or fire department management may be substituted. One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** The applicant may substitute teaching experience as a licensed instructor at an accredited postsecondary institution or

at a military setting for up to 1,500 of the 2,000 hours required under part 3700.0800, if the teaching is done during the five-year period. The teaching must be in a firefighter I or II course. Two hours of student contact equal one hour of occupational experience as a firefighter. An applicant cannot substitute for the 2,000 hours of experience required as a fire officer.

3700.0820 LOCKSMITHING TECHNICIAN.

Subpart 1. **May teach.** A teacher who has a locksmithing license may teach in the locksmithing program and may also teach courses in locksmithing; systems and placement planning, lock and key identification, retail application, life safety codes, master keying, automotive, application for retailing, and internal and external controls.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the trade and industrial area under part 3700.0800.

Subp. 3. **Occupational experience requirement.** The applicant must hold a Certified Professional Locksmith (CPL) certification and have verified occupational experience of 8,000 hours as a locksmith.

Subp. 4. **Substitution for occupational experience requirement.** An applicant may substitute the following education from an accredited postsecondary institution for up to 2,100 hours of occupational experience required under subpart 3.

A. An associate degree in locksmithing may be substituted for 2,000 hours.

B. A diploma in a two-year locksmithing program may be substituted for 2,100 hours.

C. The completion of courses or clock hours for credit in locksmithing may be substituted.

One clock hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. **Substitution for recent occupational experience.** An applicant may substitute teaching experience at an accredited postsecondary institution or at an industrial or military setting for 1,500 of the 2,000 hours required under part 3700.0800, if the teaching is done during the five-year period. The teaching must be in locksmithing. Two hours of teaching equal one hour of occupational experience.

3700.0825 NEON AND SIGN FABRICATIONS.

Subpart 1. **May teach.** A teacher who has a neon and sign fabrication license may teach in the neon and sign fabrication program and may also teach courses in:

B. sign erection and service; and

C. sign electricity.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the trade and industrial area under part 3700.0800.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of verified occupational experience in production and repair of neon signage, in neon bending and bombarding, or sign fabrication and installation.

Subp. 4. **Substitution for occupational experience.** An applicant may substitute the education described in item A or B for up to 2,100 hours of occupational experience required under subpart 3. The education must be from an accredited postsecondary institution.

A. A diploma or certificate in neon and sign fabrication. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

B. The completion of courses for credit or clock hours for credit in neon patterns and layout, sign electricity, sign and letter fabrication, and sign erection and service. One hour of instruction equals one hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. An applicant may substitute teaching experience at an accredited postsecondary institution, or at an industrial or military setting for 1,500 of the 2,000 hours required in part 3700.0800, if the teaching is done during the five-year period. The teaching must be in neon and sign fabrications. Two hours of teaching equal one hour of occupational experience.

3700.0830 PLASTIC COMPOSITES TECHNOLOGY.

Subpart 1. May teach. A teacher who has a plastic composites technology license may teach in the plastic composites technology program and may also teach courses in polymer: chemistry, materials, applications, and composites. Composites: technology, tooling, mold-making, repair, and manufacturing.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the technical area under part 3700.0800.

Subp. 3. Occupational experience requirement. An applicant must have 8,000 hours of verified occupational experience in polymer composites. This experience must be in at least two of the following: research and development, design, formulations, and manufacturing and must include the 2,000 hours of occupational experience within the five years just before applying for licensure.

Subp. 4. Occupational experience substitution. The applicant may substitute the experience described in items A, B, or C for up to 4,000 hours of occupational experience described in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in materials science, polymer chemistry, chemical or mechanical engineering, or applied physics may be substituted for 4,000 hours.

B. A bachelor's degree in an engineering field not listed in item A or an associate degree in plastic composites technology may be substituted for 2,000 hours.

C. A diploma or certificate in plastic composites technology may be substituted. A one-year program equals 1,050 hours. A two-year program equals 2,100 hours.

Subp. 5. Substitution for recent occupational experience. An applicant may substitute teaching experience at an accredited postsecondary institution or at an industrial or military setting in plastic composites technology for 1,500 of the 2,000 hours required in part 3700.0800, if the teaching is done during the five-year period. The teaching must be in plastic composites technology. Two hours of teaching equal one hour of occupational experience.

3700.0840 SECURITY MANAGEMENT.

Subpart 1. May teach. A teacher who has a security management license may teach in the security management program and may also teach courses in security: contemporary issues, legal ethical issues, and principles of physical security.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the trade and industrial area under part 3700.0800.

Subp. 3. Occupational experience requirement. An applicant must have 8,000 hours of verified occupational experience in a manager or supervisory position in plant protection or security in an industrial, institutional, governmental, public utility, corporate, or retail setting, exclusive of general law enforcement.

Subp. 4. Substitution for occupational experience. The applicant may substitute the education described in item A, B, C, or D for up to 4,000 hours of the occupational experience required in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in criminal justice, criminology, security, or law enforcement may be substituted for 4,000 hours.

B. An associate degree in criminal justice, security management, or law enforcement may be substituted for 2,000 hours.

C. A diploma in security management or law enforcement may be substituted. A two-year program equals 2,100 hours; a one-year program equals 1,050 hours.

D. The completion of courses or clock hours for credit in security, emergency procedures, or substance use and abuse may be substituted. One clock hour of instruction equals one clock hour of occupational experience. One quarter credit equals 20 hours of occupational experience. One semester credit equals 30 hours of occupational experience.

Subp. 5. Substitution for recent occupational experience. An applicant may substitute teaching experience at an accredited postsecondary institution for 1,500 of the 2,000 hours required under part 3700.0800, if the teaching is done during the five-year period. The teaching must be in industrial security or security management. Two hours of teaching equal one hour of occupational experience.

3700.0845 SAFETY AND HEALTH ADMINISTRATION.

Subpart 1. May teach. A teacher who has a safety and health administration license may teach in the Safety and Health Administration program and content in the Mine, Safety and Health Administration (MSHA) and may also teach courses specific to industrial safety.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100, subparts 1 and 2.

Subp. 3. Does not apply. Parts 3700.0800, subpart 2, and 3515.9921 do not apply to part 3700.0835.

Subp. 4. Educational and/or occupational experience. The applicant must be an MSHA approved instructor and have the experiences described in item A, B, C, or D.

A. A bachelor's degree or higher in industrial safety or industrial hygiene and 2,000 hours of maintenance, service, or production process industrial experience where an employee is exposed to industrial hazards and the employer maintains and implements a safety and health standard or program.

B. A bachelor's degree in engineering, public health, industrial psychology, industrial technology, management/supervision or two years postsecondary education in industrial safety. Option B must also include 4,000 hours of maintenance, service, or production process industrial experience where an employee is exposed to industrial hazards and the employer maintains and implements a safety and health standard or program.

C. One year of postsecondary education in industrial health safety and 6,000 hours of maintenance, service, or production process industrial experience where an employee is exposed to industrial hazards and the employer maintains and implements a safety and health standard or program.

D. Thirty-six credit hours of course content recognized by a national or state accrediting body in industrial health and safety and 6,000 hours as a safety and health supervisor, manager or administrator, or industrial safety and health instructor or trainer.

Subp. 5. Recent experience. Five hundred hours of the experiences described in subpart 4, item A, B, C, or D must be within five years of application for licensure.

Subp. 6. Current licensees. The title of the license of mine safety and health automatically becomes safety and health administration on September 16, 1991.

3700.0850 MACHINE TOOL CAREER LICENSE.

Subpart 1. May teach. A teacher who has a machine tool career instructor license may teach in the machine tool career programs and may also teach:

A. machine tool core; and

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100 and the requirements for a teacher in the trade and industrial occupational area under part 3700.0800.

Subp. 3. **Occupational experience requirement.** The applicant must have 8,000 hours of verified occupational experience in blueprint reading, machine set up, machine troubleshooting, and machine operation of both manual and computerized numerical control equipment.

Subp. 4. **Occupational experience substitution.** The applicant may substitute the education described in item A or B for up to 2,000 hours of occupational experience required in subpart 3. The education must be from an accredited postsecondary institution.

A. A bachelor's or higher degree in engineering or a two-year degree, diploma, or certificate in machine tool technology may be substituted for 2,000 hours; or

B. A one-year diploma or certificate in machine tool technology may be substituted for 1,050 hours.

Subp. 5. **Occupational recency substitution.** Teaching experience at an accredited postsecondary institution or industrial or military setting may be substituted for 1,500 of the 2,000 hours required in part 3700.0100 if the teaching is done during the five years just before application for licensure. The teaching must be in primary program content in machine tool technology. Two hours of teaching equal one hour of occupational experience.

ADMINISTRATIVE AND INSTRUCTIONAL LICENSES

3700.0900 GENERAL REQUIREMENTS.

An applicant for a license for postsecondary president or assistant director of a technical college must meet the requirements listed or referred to in this part. These requirements are in addition to the requirements of the specific license requested.

A. An applicant shall meet the general provisions and procedures for licensure of instructional and supportive personnel except when superseded by parts 3700.0900 to 3700.0903.

B. The applicant must comply with parts 3515.7400 to 3515.8300.

C. Parts 3515.8400 to 3515.8800 and 3515.9000 no longer apply for parts 3700.0901 to 3700.0903.

3700.0902 ASSISTANT DIRECTOR IN DISTRICTS WITH TECHNICAL COLLEGE.

Subpart 1. **Assistant director; when position and license required.** A district designated and approved by the State Board of Technical Colleges to operate a technical college shall employ an assistant director in addition to a president if at the institute more than 40 percent of a person's time is spent assisting the president, and the person is assigned by the president to be responsible for four or more of the activities in subpart 2. The person is an assistant director and must have an assistant director's license.

Subp. 2. **Activities requiring a license.** The activities referred to in subpart 1 are:

A. policy: recommend and implement institute policy in accordance with governing law and policy;

B. planning: plan according to community needs to meet the goals of the institution;

C. programs and curriculum: identify, develop, implement, and revise all programs and courses;

D. services: provide leadership, development, and supervision of services to all students and staff;

E. personnel: recruit, recommend for employment, assign, orient, supervise, evaluate, or recommend terminations;

F. fiscal: develop, prepare, revise, and manage institution finances;

G. public relations:

(1) plan, develop, and implement all marketing and public relations activities; and

(2) develop and maintain a liaison with labor, business, and community agencies;

H. facilities: plan for the short or long term, acquire, maintain, and account for all property, facilities, equipment, and services; and

I. evaluation: conduct ongoing evaluations of items A to F via consultations with staff, industry, pertinent community resources, and State Board of Technical Colleges staff.

Subp. 3. **Licensure requirement.** A person holding the position of assistant director of a postsecondary technical college, regardless of the title of the position at the technical college, must be licensed under this part.

Subp. 4. **Licensure criteria.** An applicant for licensure as a technical college assistant director shall meet the following requirements:

A. Education.

(1) Baccalaureate or graduate level degree from an accredited college.

(2) Three quarter credits of pedagogy in each of the following: educational tests and measurements, methods of instruction, and course construction or development.

(3) Three quarter credits in philosophy of vocational technical education.

(4) Nine quarter credits or 135 clock hours in educational administration or supervision/management of institutional operations that must include three quarter credits or 45 clock hours in instructional supervision in vocational technical education.

B. Experience in vocational education. An applicant must have three years of verified vocational educational experience in an accredited postsecondary institution or state agency functioning in a position that has vocational education as its focus.

C. Occupational experience. Four thousand hours of verified occupational experience outside of education with no recency requirement.

3700.0903 EXISTING LICENSES; CONVERSION TO NEW LICENSES.

Five working days following the publication in the State Register of adopted parts 3700.0900 to 3700.0903, the state board shall convert the adult vocational education license category to the license category of assistant director in a district with a technical college. At the licensee's next renewal date, the renewed license must show the new license category. A person holding a license as president, assistant director, or adult vocational education director before November 29, 1988, may renew the license by complying with parts 3515.7300 to 3515.8300 and upon compliance must be issued the revised license designated in parts 3700.0901, 3700.0902, or 3700.0903, as applicable.

3700.0910 PRESIDENTS IN DISTRICTS OPERATING A TECHNICAL COLLEGE.

Subpart 1. **Must have a president.** A district designated and approved by the state Board of Technical Colleges to operate a technical college shall employ a president who shall have a president's license.

Subp. 2. **President's responsibilities.** A president:

A. Internally:

(1) recommends and implements college policy in accordance with governing laws and policy;

- (2) plans according to regional/state needs to meet the goals of the technical college system;
- (3) directs evaluation to meet state, regional, and national accreditation standards;
- (4) manages the identification and planning of current and future program majors;
- (5) directs all human resource activity;
- (6) directs student developmental services;
- (7) manages college finances; and
- (8) directs implementation of marketing plans.

B. Externally:

- (1) directs, develops, and maintains liaisons with business, labor, higher education, secondary education, and external agencies; and
- (2) directs implementation of marketing plans.

Subp. 3. Licensure requirement. An applicant for a license as a technical college president must meet the following requirements:

A. Education:

- (1) master's degree or higher from an accredited college; and
- (2) six quarter credits or 90 clock hours in the following subjects: effective supervision and management and strategic planning.

B. 8,000 hours of administrative, supervisory, or managerial level experience in education, business, industry, government, or social service agencies. Three thousand of the 8,000 hours must be experienced within five years before applying for a license.

C. 2,000 hours of occupational experience outside education without regard to recency.

D. Six quarter credits in philosophy of vocational education and education law for the first two-year renewal.

NOTE: Part 3700.0901 continues to apply to the application, qualification, or criteria for initial licensure of technical college president until December 16, 1992. When both procedures apply, an applicant may proceed under either procedure.

NOTE: On December 17, 1992, part 3700.0901 is repealed. Then an applicant may only proceed under part 3700.0910.

3700.1050 TECHNICAL COLLEGE COUNSELOR.

Subpart 1. Activities requiring a license. A person referred to as a counselor in a technical college must be licensed under this part when responsible for the following activities:

- A.** assist students and prospective students in making appropriate career decisions by applying career development theories;
- B.** assist students and prospective students in obtaining information and resources necessary for attaining academic, career, and personal goals;
- C.** select, administer, and interpret psychometric assessment instruments including achievement, ability, aptitude, values, interest, and personality;
- D.** assist students and prospective students with resolving issues relating to interpersonal relationships, personal barriers, and social situations that may interfere with their academic and career objectives by applying personal development and counseling theories;
- E.** serve as a student advocate through consulting with technical college staff, staff of other educational institutions, and community agencies to make the environment as beneficial to the educational, emotional, and physical development of students as possible;
- F.** plan, facilitate, and implement training workshops and support groups to assist individuals in their career and personal development; and
- G.** supervise and administer the activities necessary to meet the specialized transitional needs of students during the admissions, retention, and placement process.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100, except that the applicant need not comply with part 3515.1400, items A to D.

Subp. 3. Educational experience requirement. The applicant must have the experiences as described in items A to C:

A. master's or higher degree with a major in counseling;
 B. degree must include or have added college credits in all of the following content:

- (1) supervised practicum/internship in counseling;
 - (2) group counseling; and
 - (3) career development theory and occupational information; and
- C. college credits with content in two of the following:
- (1) cultural diversity;
 - (2) adult development;
 - (3) ethics;
 - (4) family systems theory; or
 - (5) chemical dependency.

3700.1060 INTERPRETER FOR HEARING-IMPAIRED.

Subpart 1. License required. A person must be licensed as an interpreter for the hearing-impaired under this part if the person is responsible for any of the following activities:

- A. classroom, shop, and laboratory interpretation for hearing-impaired students;
- B. interpretation for activities related to course or program content for preenrolled or enrolled students in a technical college;
- C. provision of communication services between individuals who are hearing-impaired and other individuals; or
- D. service as a professional resource for information regarding hearing impairment.

Subp. 2. Other requirements. The applicant must meet the requirements in part 3700.0100, except that the applicant need not comply with part 3515.1400, items A to D.

Subp. 3. Educational experience requirement. An applicant for a license as an interpreter for the hearing-impaired must meet the following requirements:

- A. must be certified by the Registry of Interpreters for the Deaf; or
- B. must have completed one or more years of an interpreter training program resulting in a diploma or degree at an accredited postsecondary institution.

Subp. 4. First license renewal. An applicant must complete six hours of special needs in-service before the applicant's first renewal.

3700.1100 FINANCIAL AID ADMINISTRATOR.

Subpart 1. License required. A person must be licensed as a financial aid administrator under this part if the person is responsible for any of the activities listed in this subpart:

- A. serving as a primary resource person on financial aid and providing information on financing higher education to current and prospective students, parents, secondary counselors, social service agencies, and technical college staff members;
- B. completing all institutional applications and reports for program participation required by the institute, the state and federal government, or other agencies;
- C. interpreting state and federal regulations for the development of policies and procedures in administering financial aid programs and services;
- D. establishing uniform procedures and standards for the awarding and disbursing of financial aid and the monitoring of student academic progress;
- E. complying with federal, state, and local audit requirements for financial aid administrators;

F. coordinating the integration of agency funding into the awarding process; and

G. developing forms and brochures providing student consumer information regarding applications and rights and responsibilities, as well as all documents necessary for program management.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3700.0100, except that the applicant need not comply with part 3515.1400, items A to D.

Subp. 3. **Educational and occupational experience requirement.** An applicant for a license as financial aid administrator must meet the requirements listed in item A, B, C, or D. The education must be from an accredited postsecondary institution.

A. 4,000 hours of verified occupational experience as a financial aid office administrator/director and a bachelor's or higher degree with a major in educational counseling and guidance, postsecondary student personnel administration, federal aid administration, or business administration.

B. 6,000 hours of verified occupational experience providing administrative support to a financial aid administrator/director and a two-year program or a program of 90 or more quarter credits or associate degree in financial aid assistant.

C. 8,000 hours of verified occupational experience as a financial aid administrator/director.

D. 8,000 hours of verified occupational experience providing administrative support to a financial aid administrator/director, and 60 hours of beginning or intermediate student financial aid administration workshops sponsored by professional national, state, or regional financial aid administrator associations or 15 quarter credits in student financial aid and administration theory and practice.

Subp. 4. **Initial renewal requirements.** An applicant must submit verification of completion of philosophy of vocational education and an approved human relations course before the applicant's first license renewal.

Subp. 5. **Conversion of current financial aid officers.**

A. A current financial aid officer license converts to a financial aid administrator license on June 25, 1990, and upon the next renewal the applicant's license will indicate financial aid administrator.

B. Applicants verifying one year of experience within a Minnesota technical college performing the duties listed in part 3700.0350, subpart 1, within five years before June 25, 1990, are eligible for a license as a financial aid administrator.

3700.1290 DISCOVER LICENSE.

Subpart 1. **May teach.** A person holding a technical college Discover license may teach personal development, career development, and applied issues courses in Discover.

Subp. 2. **Other requirements.** The applicant must meet the requirements in part 3709.0100, subpart 2.

Subp. 3. **Licensure requirements.** The applicant must have the educational and occupational experience described in items A to D. The education must be from an accredited postsecondary institution.

A. A minimum of two years of postsecondary education resulting in completion with a certificate, diploma, or degree.

B. Four thousand hours of verified experience. The experience must be from two areas or more of the areas listed in this item:

- (1) counselor;
- (2) support group facilitator;
- (3) advocate within an educational or social service institution;
- (4) human service caseworkers;
- (5) employment counselor;
- (6) affirmative action coordinator or officer;

- (7) career counselor; and
- (8) teacher in an educational institution.

C. A total of 12 quarter credits from two or more of the areas listed in this item:

- (1) career development;
- (2) group process;
- (3) interpersonal communications;
- (4) behavioral sciences;
- (5) women's studies;
- (6) family life education; and
- (7) counseling techniques.

D. Upon the first renewal, evidence of completion of 12 hours of state sponsored workshops in teaching Discover.

Subp. 4. **Substitution for required experiences.** The applicant may use the substitutions as described in items A and B.

A. The applicant may substitute up to 1,000 hours of occupational experience required in subpart 3, item B, through verified volunteer activity that occurred under supervision of paid professional staff within a human service agency. This experience may be in a shelter for the homeless, battered woman program, chemical dependency program, head start program, crises center, displaced homemaker program, handicapped program for special populations, minority advocacy agency, and legal advocacy program.

B. The applicant may substitute up to six credits of educational experience as required in subpart 3, item C, at the ratio of 12 clock hours for each quarter credit in the following topics: sexual harassment, decision making techniques, personal development, stress management, group facilitation, equal opportunity/affirmative action, career assessment, assertiveness training, interpersonal communications, financial planning, and human behavior.

Subp. 5. **Recent occupational experience.** An applicant for a license to teach in Discover must have 1,000 hours of the occupational experience within the five years before applying for the license.

Subp. 6. **Conversion of current Discover instructors.** Applicants verifying the teaching of a complete session of Discover to include personal development, career development, and applied issues within four years before March 12, 1990, and who verify completion of 12 hours of state-sponsored workshops in teaching Discover are eligible for a license as a Discover instructor.

3700.1400 QUALIFICATION FOR LICENSURE.

An applicant, other than an extension part-time license applicant, must meet technical college continuous program licensure requirements and conform to the general provisions and procedure for licensure of instructional and supportive personnel employed over 500 hours annually.

3700.1405 EXTENSION PART-TIME INSTRUCTOR LICENSE.

Subpart 1. **Personnel who must be licensed.** Any person holding a position teaching extension part time from 61 to 500 hours in a technical college, must be licensed according to this part.

Subp. 2. **Authorizing signature.** An application for an initial extension part-time instructor license or for its renewal must be signed by the authorized technical college administrator, subject to review by the chancellor of the technical college system.

Subp. 3. **Issuance of an initial license.** The chancellor of the technical college system shall issue an initial extension part-time license to an applicant recommended for licensure

by the authorized technical college administrator. A recommended applicant must be technically and professionally qualified for the assignment through preparatory occupational or educational training experiences, or both, which must be verified and on file at the local technical college. When a professional board requires a credential to practice, this credential must be submitted with the application. Extension part-time licenses will be issued and renewed for five-year time periods.

Subp. 4. Part-time extension licensure fields. An applicant may be recommended for licensure in the following licensure fields:

- A. agribusiness and agricultural production;
- B. renewable natural resources;
- C. management practices;
- D. personnel supervision;
- E. business office operation and practices;
- F. marketing and distribution;
- G. nursing-related;
- H. allied health;
- I. E.M.T. (emergency medical technician);
- J. cardiopulmonary resuscitation;
- K. first aid;
- L. protection and safety;
- M. fire service;
- N. mine safety and health;
- O. consumer education;
- P. service occupations;
- Q. food production and service;
- R. parenting and family education;
- S. personal communications;
- T. computations;
- U. personal professional development;
- V. communications technology;
- W. manufacturing and engineering technologies;
- X. hand precision occupations;
- Y. construction trades;
- Z. mechanics and repairers; and
- AA. occupational special topics.

Subp. 5. Renewal of licenses. The applicant must meet the requirements of items A and B to renew a part-time extension license.

A. Signature of the authorized technical college administrator.

B. Upgrading activities recommended by the technical college administrator to maintain license currency in the assigned field.

3700.1410 PART-TIME CONTINUOUS OR GENERAL STUDIES INSTRUCTORS.

Subpart 1. Listed here. An applicant for a license to teach, part-time, in a postsecondary continuous program or general studies courses shall meet the requirements in this part if the applicant is not licensed to teach the offering full time. The requirements are in addition to the requirements for a particular license (listed in the part that covers that particular license).

Subp. 2. Who must be licensed. A person holding a position as a part-time continuous program or part-time general studies instructor must be licensed according to this part if the person is not licensed for full-time instruction in the offering. A part-time continuous pro-

gram or part-time general studies instructor is responsible for teaching credit-based or hour-based course content that has been identified for incorporation into an approved continuous program by a qualified full-time continuous program or general studies instructor.

Subp. 3. Scope of practice. Part-time personnel licensed in this part cannot provide more than 16 quarter credits of instruction in a fiscal year.

Subp. 4. Length of issuance. Initial licenses are granted for five years upon submission of an application bearing the signature of a recommending authorized postsecondary administrator as evidence of completion of six clock hours of teacher training. Five-year renewals are granted upon submission of an application bearing the signature of a recommending authorized administrator as evidence of completion of 24 clock hours of teacher training and maintenance of currency in the respective field of licensure.

Subp. 5. General requirements. The applicant:

A. must complete six clock hours of teaching techniques as determined by the local technical college administrator before issuance of initial license;

B. must get the signature of the recommending local authorized postsecondary technical college administrator; and

C. need not comply with the human relations and teacher education sequence provisions in parts 3515.1400, 3515.2100, 3515.5700, and 3515.5800.

3700.1415 PART-TIME CONTINUOUS OCCUPATIONAL PROGRAM INSTRUCTOR.

Subpart 1. Listed here. An applicant for a license to teach part time in a continuous occupational program must meet the requirements in this part and part 3700.1410.

Subp. 2. Specific license requirements. An applicant must meet the requirements in item A, B, C, or D.

A. The applicant must verify meeting the full-time requirements for licensure in the specific field including the recency requirements without regard to parts 3515.1400 and 3515.2100.

B. The applicant must have a bachelor's or higher degree with a major acceptable for full-time licensure. The degree must include or the applicant must add 15 quarter credits in the specific field of licensure. The recency requirement may be satisfied if the degree is received, or if any of the following are accumulated within five years of applying for the license:

(1) 15 quarter credits;

(2) 180 clock hours of training in content specific to the field for which the applicant is seeking the license;

(3) 150 clock hours of secondary, postsecondary, business, industrial, or military teaching in the primary program content; or

(4) 500 hours of the required occupational experience.

C. The applicant must have 4,000 hours of vendor, business, or industrial training and development experience or 4,000 hours teaching primary program content in the specific field of licensure in an accredited postsecondary, business, industrial, or military setting. A minimum of 2,000 of the required hours must be experienced within five years of applying for the license.

D. The applicant must have a minimum of one year of the technical training or education that is required for full-time licensure or is listed as a substitute for occupational experience in the requested license field and one-half of the total occupational experience as required for that license. The recency requirement of the requested license field also must be met.

3700.1420 PART-TIME GENERAL STUDIES CONTINUOUS PROGRAM LICENSE.

Subpart 1. **Listed here.** An applicant to teach in a part-time general studies continuous program area must meet the requirements in this part and part 3700.1410.

Subp. 2. **General requirements.** The applicant must have the academic preparation required for a full-time license in the field.

3700.1425 NEW PROGRAM INSTRUCTIONAL STAFF.

Subpart 1. **Requirements.** A license may be issued in a specified approved new program area, valid to teach content only within that program. An individual may teach full time in an authorized new program offering when the individual:

A. is determined to be technically and professionally qualified through:

(1) approval and signature of the approved hiring technical college administrator;

(2) education and/or occupational experience as described in a qualifications description developed by the new program advisory committee; and

(3) approval and signature of the chancellor of the State Board of Technical Colleges;

B. has submitted for record with the licensing unit of the State Board of Technical Colleges the approved qualifications description and credentials to substantiate compliance with item A; and

C. submits evidence of complying with the teacher education course: introduction to vocational teaching.

Subp. 2. **Duration; not renewable.** A license issued under this part is valid for only four years from the date it is issued and is not renewable.

3700.1595 RENEWED REGULAR FIVE-YEAR TECHNICAL COLLEGE LICENSE.

Subpart 1. **Authorizing signature.** Applications for renewed initial and subsequent five-year technical college licenses shall be approved through the local technical college relicensure committee established pursuant to parts 3515.2200 to 3515.3200, and signed by the chair.

Subp. 2. **Issuance.** A regular five-year technical college license holder who completes the continuing education requirements for relicensure in parts 3515.2200 to 3515.3200 shall be issued a renewed regular five-year technical college license.

Subp. 3. **Exception.** Subparts 1 and 2 do not apply to part-time extension, part-time continuous occupational, part-time continuous general studies, or substitute licensure.

Subp. 4. **Discontinued programs.** A license to teach a program that is removed from the state board's inventory of active programs cannot be renewed if the program is removed before or at the time the license renewal would otherwise be effective.
