

### INDEX USER'S GUIDE

For newly adopted rule parts, the index coverage is complete. For amended parts, a reference is included only if the existing references in the main volume index are inadequate to cover the amendments. Therefore, it is suggested that the user always begin an index search with the volume 11 index of Minnesota Rules 2005.
