

**USER'S GUIDE FOR TABLE OF
AMENDMENTS OF RULES**

The table of amendments lists all rules that are contained in Minnesota Rules 2008 Supplement Number 2 that have been affected by changes adopted from August 27, 2007, to November 17, 2008. In addition, the table lists the action taken on each part, and the cite where the notice of adoption of the action taken was published in the State Register or the Session Laws cite where legislative action affecting a change in Minnesota Rules occurred.

The table consists of three columns. The first column lists the rules in decimal order. The second column indicates the action taken, whether the part was repealed, renumbered, amended, or is new. The third column contains the State Register cite where the notice of adoption of the action taken on a rule was published or the citation to Laws of Minnesota where the direction for a rule change can be found.
