

**USER'S GUIDE FOR TABLE OF
AMENDMENTS OF RULES**

The table of amendments lists all rules that are contained in Minnesota Rules 2012 Supplement that have been affected by changes adopted from May 2, 2011, to October 29, 2012. In addition, the table lists the action taken on each part. It also lists either the cite where the notice of adoption of the action taken was published in the State Register or the Session Laws or Minnesota Statutes cite to legislative action directing a change in Minnesota Rules.

The table consists of three columns. The first column lists the rules in decimal order. The second column indicates the action taken, whether the part was repealed, renumbered, amended, or is new. The third column contains the State Register cite where the notice of adoption of the action taken on a rule was published, or the citation to text in Laws of Minnesota or Minnesota Statutes that directed a change.
