

USER'S GUIDE FOR TABLE OF AMENDMENTS

The table of amendments lists the rule parts affected in Minnesota Rules 2024 Supplement that were adopted or enacted between December 26, 2023, and November 12, 2024. It also lists a citation to either the State Register in which the rule part's notice of adoption was published, or to Laws of Minnesota if the rule part was subject to legislative action.

The table consists of two columns. The first column lists the rules in decimal order. The second column contains the State Register cite where the notice of adoption of the action taken on a rule was published, or the citation to text in Laws of Minnesota that directed a change.

Example:

6100.5000 48 SR 697

This example shows that action was taken on Minnesota Rules, part 6100.5000, and that the notice of adoption appeared on page 697 of volume 48 of the State Register.
