There is no need for competitive bidding in the purchase of certain materials for construction work on a state teachers college building in the case of an emergency where delay would result in irreparable damages to the building by approaching cold weather. OAG Aug. 10, 1938 (980a-11).

Tuition rates are established by the state to all, including discharged veterans. OAG Oct. 3, 1944 (316).

The federal government need not pay in veteran tuition in advance, except in cases where the board by resolution so requires. OAG Sept. 14, 1944 (316).
