BASIC SCIENCE ACT

146.01 BASIC SCIENCES; PRACTICING HEALING AND PRACTICE OF HEALING.

Laws 1927, Chapter 149 requiring those licensed to practice the healing art to obtain certificates of having passed an examination in the basic sciences, is not violative of any constitutional provision, either state or federal, on the ground that the classified obligations therein are arbitrary, oppressive or unreasonable. *State v Groden*, 181 M 340, 232 NW 517.

The plaintiff, a layman, in conducting a "health audit" for a fee in which he charged his subscribers with the results of urinalysis and blood pressure tests, and passed on with the report of said test the findings of the pathologist who made the tests, was practicing medicine in violation of the code, and is guilty of unlawful practice not having complied with the provisions of section 146.01. *Granger v Adson*, 190 M 23, 250 NW 722.

The basic science law is not unconstitutional as a denial of equal privilege, due process, or equal protection under the law. *Shenk v State Board*, 189 M 1, 250 NW 353.

An information examined and found to charge defendant with practicing healing without a certificate under the basic science act. The requirements of that act are germane to the protection of the public as applied to the acts charged against the defendant. *State v Mielke*, 202 M 114, 277 NW 420.

It is unlawful for a fraternal corporation to employ a doctor of medicine and an osteopath for treatment of members on a salary basis, or on a basis of percentage of dues paid by the members. OAG Aug. 8, 1939 (303).
