This section applies only to a town which has within its territorial limits a platted portion on which there reside 1,200 or more people, and such platted portion is not incorporated in a city or village. OAG May 10, 1935 (440c).

A platted portion may consist of contiguous plats made by different companies, OAG July 13, 1935 (434a-6).
