## 39.14 STALLIONS AND JACKS

336

STATUTORY LIENS can be perfected only in the manner prescribed by the statutes creating and providing therefor, and then only when the statute is strictly followed. *State ex rel v Johnson*, 111 M 10, 126 NW 480.

LIEN FORECLOSED. The statute limits the time during which the lien may be foreclosed and the general statute of limitations does not apply. 1936 OAG 290.

### 39.15 VIOLATIONS; PENALTIES.

Where a justice imposes a fine under the stallion law, he can be called upon to collect the fine or enforce the sentence imposed. If the justice neglects to do so, complaint may be made to the governor for the justice's removal. There is no way to force a justice to pay a fine which he neglects to collect. 1934 OAG 276, Nov. 26, 1934 (266b-9).
