City furnishing the services of its fire department outside its limits is acting in a governmental capacity, as affecting its liability for injuries. OAG Oct. 4, 1938 (688a).

Village is not liable for the negligence of its fire department for failure to respond to calls outside the village limits in accordance with a contract. OAG March 28, 1939 (688a).

A city is not liable for the negligent acts of its fire department members, and there is no necessity for a contract of indemnity as between municipalities involved in a fire protection agreement. OAG May 4, 1939 (688a).

**438.09 MUNICIPALITIES TO ARRANGE FOR COMPENSATION AT OUTSIDE FIRES.**

Cities and villages cannot recover for services in answering fire calls outside their corporate limits, in the absence of an agreement, express or implied. OAG March 23, 1937 (688a).

Towns may enter into an agreement with a near-by municipality or with individuals in groups living in adjoining townships. OAG Aug. 19, 1938 (688k).

Village furnished with service may contract to reimburse the city for loss of or damage to equipment. OAG Oct. 4, 1938 (688a).
