

CHAPTER 442

WINONA SEWAGE DISPOSAL PLANT; VILLAGE WATER AND SEWAGE SYSTEMS.

442.01 PROPERTY OWNERS REQUIRED TO CONNECT WITH WATER AND SEWER SYSTEMS IN VILLAGES.

Reasonableness of ordinance requiring connections with water mains to be of copper is for the determination of the village officials. OAG Sept. 3, 1936 (624d-3).

The legislature did not intend to exclude a village owning its water and sewer distribution system installed in its streets or alleys within its corporate limits even though the sources of such water supply and septic tank of the sewer system might be located outside of the corporate limits. OAG April 22, 1937 (624c-16).

A lot owner with his house four-fifths within the village limits was entitled to water connection upon the payment of the usual charges and assessments, and could not be compelled to have his entire lot attached to the village. OAG Aug. 3, 1936 (624d-3):

A village may not make water rent a lien against the real property of user in the absence of statute or charter authorization. OAG Aug. 7, 1936 (477h-36).
