Assuming, but not deciding, that a contagious hospital is a public utility plant within the meaning of the city charter of Duluth, the council would not be authorized, under section 55 of the charter, to issue bonds for the acquisition of such a hospital, unless such issue be submitted to and approved by the voters at an election called for that purpose. *Rose v City of Duluth*, 153 M 68, 189 NW 429.
