A village would have power to provide a public rest room in a building to be erected jointly by the American Legion and the band of the village, such rest room to be provided on the first floor and to be kept and maintained by the village at public expense. OAG March 25, 1931.

Village may take over a memorial hall constructed by an American Legion post, and use such building as a combined memorial hall, city hall, council room, and rest room, and may rent the premises for public purposes, for entertainment, public dances, or other gatherings, providing such renting does not interfere with the public use of the property, and does not tie the hands of succeeding governing bodies of the village, but cannot assume a mortgage thereon, payment of the purchase price in cash or bonds being necessary. OAG March 2, 1937 (476b-8).

Village rest rooms must be kept open, heated, and lighted between 10:00 A.M. and 6:00 P.M., but need not be kept open at other hours. OAG Feb. 11, 1932.
