The power to fill a vacancy does not include the power to declare one. An election to fill an anticipated vacancy may not be validly held. *State ex rel v Holm*, 202 M 500, 279 NW 218.

Judge Roeser resigned September 30, 1936, his resignation to take effect November 15, 1936. The governor accepted the resignation and on October 1, 1936, appointed Judge Himsl, the appointment effective November 16, 1936. At the general election held November 3, 1936, votes were cast for Dosland. Held, that there was no vacancy at the time of the election, and only a negligible number of votes were cast and Dosland was not legally elected. *State ex rel v Holm*, 202 M 500, 279 NW 218.
